

There Are No “Statute of Limitations” On FRAUD!

Part 16

It has been almost a month since I finished Part 15 of this series. I have been waffling on whether to end the series with Part 15. I have been greatly troubled by the fact that even though I believed this is the biggest story of the year, if not the century; I kept hitting the wall over a number of points that were running around in my head for more than two years, if not longer. President Donald J. Trump has been at the center of this issue, as to my ambiguity. I am less convinced that President Trump is able to honor his pledge to his voting-base.

Despite what you hear about the southern border, thousands are crossing with little or no resistance daily. A few days before Palm Sunday, nearly 16,500 were dropped off in El Paso and two other communities. So much for Trump’s pledge to shut the border down! By the time you finish this chapter, you will understand why I believe we have been had. On April 15th, a public health official said twenty Congolese were being held in precaution, being monitored for Ebola at the border town of Nuevo Laredo, Tamaulipas. This is an invasion and President Trump has dropped the ball. Furthermore, this invasion is a public health crisis that will eventually over-whelm the system.

One of the key issues that have been like flashing “red” lights for so long has been the fact that John Bolton, a Neo-con carryover from the Bush administrations has been the point man for the Trump administration as National Security Adviser, along with Mike Pompeo as Secretary of State. Both Bolton and Pompeo are Christian-Zionists, and staunch supporters of the state of Israel. Since President Trump was elected, he has left no doubts that he wanted a regime change in Iran. His decision to declare the Iranian Revolutionary Guard a terrorist organization is a big deal; in fact it is a huge deal! This will motivate significant moves to further strain relations with Iran, and even more than our withdrawal from the Obama P5+1 Iranian Treaty. This will lead to war. This can of worms will ultimately lead to the Ezekiel 38/39 scenario. This will most likely lead to World War III.

President Trump recently had dinner with Sheldon Adelson, the richest American Jew, ranked #15 on the ‘Forbes’ 400 richest Americans. He is ranked 24th among the world’s richest billionaires. Adelson demolished the Sands in 1996 and built in its place the towering Venetian Resort Hotel Casino (later called the Las Vegas Venetian), which opened in 1999. A themed hotel-casino like many others in the city, the Venetian came complete with its own Grand Canal and gondoliers. With subsequent additions, it became one of world’s largest hotel complexes. Even though the original Sands hotel was no more, Adelson’s Casino Company retained the Las Vegas Sands name. Adelson gained even greater prominence in the Las Vegas community by purchasing the city’s largest daily newspaper, the Las Vegas Review-Journal, in 2015.

Adelson saw an opportunity for expansion in Macau, a tiny (11.7 square mile slightly larger than the District of Columbia) gambling destination on the southern coast of China. The LVS obtained one of the first new gaming licenses to be issued after Macau passed from Portuguese to Chinese jurisdiction in 1999. The Sands Macao opened in May 2004 and was an immediate success, earning back its investment in less than a year. The Venetian Macao, modeled on the Venetian Las Vegas, opened in 2007, and several other casinos in the Macau region followed. Macau soon surpassed Las Vegas as the world's highest-grossing gambling center. In 2010 LVS opened the Marina Bay Sands, a large casino and hotel in Singapore. The Asian casinos and the LVS Company's initial public offering of shares in December 2004 propelled Adelson—at a fairly advanced age—into the ranks of the world's wealthiest people.

In the early 1990s Adelson began to cultivate strong political views, and in subsequent years he became known as a “mega-donor” to the Republican Party. Taking full advantage of Supreme Court decisions that effectively removed limits on political contributions, he reportedly gave nearly \$100 million in traceable donations during the 2012 elections. His contributions in 2016 were reportedly more than \$50 million to the Trump presidency. Apart from strictly partisan politics, Adelson also spent heavily in support of the War on Drugs and in opposition to the legalization of online gambling.

A strong supporter of Israel, Adelson began to involve himself in that country's internal politics after his marriage to an Israeli woman, Miriam Ochshorn, in 1991. The main beneficiary of his largesse was the two-time Prime Minister Benjamin Netanyahu. At great expense, Adelson founded a free newspaper, *'Israel Hayom'* (“*Israel Today*”), in 2007. Offering consistent support for Netanyahu and his conservative policies, *'Israel Hayom'* became the most widely circulated paper in the country. At age 85, Adelson is not likely to be around much longer, but in the meantime, his deep pockets support many Jewish causes, some that do not have the best interests of the United States. One group in particular – Chabad Lubavitchers plays a heavy role in this story. I will be coming back to the Chabad shortly, often referred to as the Jewish Mafia as they are relevant to what is coming to significance in the Israeli so-called Peace Plan!

I will come back to this subject of President Trump's ties with Jewish bankers and their use of money as to buying influence and policy. From all that we know about President Trump's wealth, by comparison with others, his assets are really minor. His net worth is given to be \$3.3-billion. *'Forbes'* Magazine has done a detailed summary in February, 2019, showing all his assets. Granted \$3.3-billion is not pocket change, but even at its inflated figures touted the past three years, it had been stated at \$10+ billion. One thing we can say about President Trump as President, he is entitled to an annual salary of \$400,000. He donates all but \$1 of that salary to charity. However, by comparison, other presidents are mere paupers. For example look at these recent presidents:

- Bill Clinton \$80-million
- Barack Obama \$40-million
- George W. Bush \$40-million

The Center for Responsive Politics has produced a liabilities page on Donald J. Trump's debts for mortgages and loans. For the year of 2015, the President had liabilities of between \$315,350,016 and \$500,750,005. Assuming these figures are relatively within range for the years since, they do not raise question about the overall financial strength of the Trump name and brand. Likewise, the *'Forbes'* conservative figures suggest a strong financial page.

The U.S. Office of Government Ethics released President Donald Trump's most recent financial disclosure, and it shows that the former real estate mogul carries at least \$315 million in liabilities — \$130 million to Deutsche Bank alone.

The financial disclosure, a 98-page document, details how much money Trump has made, as well as what he's liable for, through April 15. The president's reported income, including asset sales, is at least \$594.57 million.

The disclosure also shows that Trump earned nearly \$20 million from his Washington, D.C. luxury hotel, the Trump International Hotel Washington, D.C., which only opened in September of 2016. Since Trump won the election, the hotel has become a central symbol of the president's potential conflicts of interest, as some worry it is a route through which the Trump family could receive payments from foreign governments.

Trump promised to donate all profits earned from foreign governments to the U.S. Treasury, but the Trump Organization admitted that it is not tracking all potential payments that are coming from foreign governments.

Other notable elements of the disclosure include:

- \$7 million earned from book royalties, including "Art of the Deal," "Art of the Comeback" and other publications
- \$37.2 million earned from his private club Mar-a-Lago, located in Palm Beach, Florida
- \$19.7 million earned through golf related revenue from his golf club in Bedminster, New Jersey
- \$20.1 million earned through golf related revenue from his golf club in Jupiter, Florida
- \$14.4 million earned through golf related revenue from his golf course and resort in Turnberry, Scotland
- \$115.9 million earned from his golf course and resort, Trump National Doral Golf Club, in Miami, Florida
- \$84,000 earned from a Screen Actors Guild pension

The bottom line of the Trump business ventures earns him a very comfortable income of \$200+-million a year for his enterprises. If there are concerns about the President's finances, it is not evident in what is known. But there is real concern about the Trump presidency, and I am not referring to the scandals caused by the DOJ, FBI, for all intent and purpose giving the Clinton's a free-pass in covering for their efforts to spy, defeat, intimidate, and even attempt to usurp Donald J. Trump. We have seen all the efforts of the Clintons and Obamas to do everything possible to go so far as to seek impeachment of Donald J. Trump; while all along the scandals were so well known and publicized by magazines such as the *'Atlantic'*, David A. Graham wrote a lengthy piece titled in the January 2017 issue, as *"The Many Scandals of Donald Trump: A Cheat Sheet"*.

Our concern about the Trump presidency has nothing to do with any of this. We ought to be disturbed about something far more serious: issues relative to his ties to the Benjamin Netanyahu government, particularly the involvement of his son-in-law Jared Kushner and the long forthcoming Peace Proposal for the issue that has kept Israel on the front page of the news for seventy years.

When President Trump publicly recognized Jerusalem as the Capital of Israel, critics were quick to note that Israel controls Washington, D.C. Relocation of the U.S. Embassy from Tel Aviv to Jerusalem heightened global attacks. For decades the Israeli lobby has leveraged the Jewish bloc of U.S. senators and representatives on behalf of Israel and Jewish issues. That reality is no surprise and frankly we would expect it to be the norm. The U.N. and the Arab League condemned Trump for recognizing the occupation of the Golan Heights as belonging to Israel. They called it illegal but the world refuses to recognize Israel took the Golan Heights as a result of the Syrians attacking Israel back in the Six-Day War of 1967. Israel's Prime Minister Benjamin Netanyahu intensified a push for U.S. recognition of Israeli control over disputed

territory with Syria, hoping that President Donald Trump would deliver a major diplomatic victory during his visit to Washington two weeks before his toughest election yet.

Israel has sought international recognition of its sovereignty in the disputed Golan Heights for decades, but in the last three months has recruited powerful allies in a renewed campaign to influence Trump, including Sens. Ted Cruz of Texas, Marco Rubio of Florida and Lindsey Graham of South Carolina.

Trump did the right thing by recognizing both Jerusalem as the capital of Israel along with the move of the U.S. Embassy to Jerusalem, and that Israel was entitled to keep the Golan Heights, regardless of what the U.N. and the nations of the world have chosen to ignore, that being it was Syria along with neighboring states of Israel tried to do in the June 1967 Six Day War. Previous U.S. presidents were more interested in maintaining a negotiating role of guarded neutrality when it came to Israel and its neighbors. They attempted to avoid offending any country. They did not want to offend the Jews or their Arab/Muslin neighbors, and in reality failed all concerned. History has certainly confirmed what was to be inevitable and confirmed by the Bible. Peace would never be achieved until the return of the Prince of Peace, Himself, Christ Jesus. Since our own nation has been in a state of war at the moment, the Biblical concept of peace takes on a new urgency or weight.

One of the titles for the Messiah is that of "Prince of Peace." Daniel 9:27 in the Hebrew text makes it clear that a peace treaty will be (confirmed) signed with the Antichrist. The text implies that there is an existing treaty, and in my opinion, it is likely the Oslo II Accords of 1993/94. It was the optimal treaty but Yasser Arafat knew if he signed it, he would be signing his own death sentence.

U.S. President Donald Trump officially congratulated Prime Minister Netanyahu on his re-election win, the leaders holding a phone conversation on the elections, regional threats and bilateral ties on Wednesday. The Office of the Prime Minister confirmed on Thursday morning, *"US President Donald Trump called Prime Minister Benjamin Netanyahu today from Air Force One to congratulate him on his election victory. The President warmly congratulated the Prime Minister and the people of Israel. Prime Minister Netanyahu thanked US President Trump for his great support of Israel, including the recognition of Jerusalem and the Golan Heights, as well as for the strong stand against the Iranian regime, including the President's recent decision against the Iranian Revolutionary Guards."*

It added, *"The two leaders again expressed their appreciation for the abiding friendship between them and their countries. They agreed to continue closely working together in the coming years for both Israel and the United States."*

The United States recently declared Iran's Revolutionary Guard Corps as a terrorist organization. It is the first country to designate an entire foreign government entity as a terrorist organization. U.S. sanctions have crippled Iran's economy, Iran accusing Israel and the United States of "economic war" on the Islamic Republic.

President Trump's "Deal of the Century" will reportedly be published only after Prime Minister Netanyahu forms a coalition government, according to White House sources on Wednesday. The government could take anywhere from one week to a month and a half to form following President Rivlin's authorization set for next week. A "Unity" government is in question as the Blue and White Party stated over the Palm Sunday weekend, it would not join the Netanyahu Likud Party to weaken Netanyahu's victory. He remains under investigation for fraud related to kick-backs from German-built Dolphin submarines for Israel.

In yet another sign of the strong and growing ties between Israel and the United States, Florida Governor Ron DeSantis announced he would head a trade mission to Israel in May of this year. The governor confirmed on Wednesday, *"I promised to be the most pro-Israel governor in America and that the first delegation I would lead would be to the State of Israel...Our delegation will bring business, academic and political leaders to help strengthen the bond between Florida and Israel."*

Pastor Dr. Chuck Baldwin made the following comments on April 11th following the Israeli elections:

"At the time of this writing, reports out of Israel say that Benjamin Netanyahu is narrowly winning reelection as Israel's Prime Minister. Should Netanyahu go on to win, it would guarantee more war for the United States and the world. No one on the planet personifies war and corruption more than Benjamin Netanyahu."

Two years ago, I wrote this:

Benjamin Netanyahu is one of the most corrupt political leaders on the planet. He is also one of the most heavily financed political leaders on the planet.

In spite of his billionaire friends and supporters, however, he is facing almost certain political destruction. His many crimes are being intensely investigated by Israeli authorities. The only reason he hasn't been removed from office already is due to the immense political and financial support he has from bankers, casino owners, land developers, etc., from other countries—especially in the United States.

But it is doubtful that Bibi will be able to tread water much longer. It appears that his political demise is inevitable. And you haven't heard a word about it from the controlled mainstream media in the U.S., have you? Of course not. The men who own the mainstream media are among Bibi's largest contributors.

Neither have you heard anything about it from the so-called conservative publications, periodicals and websites. There is one common denominator that links the mainstream media with the so-called conservative media: infatuation with the modern State of Israel.

Without a doubt, Netanyahu's plummet in popularity at home is one of the reasons (maybe the MAJOR reason) why he is pressuring Donald Trump to ratchet up a war against Iran and why he

South Carolina Senator Lindsey Graham said Saturday he wanted the United States to enter into a mutual defense agreement with Israel.

Graham said at the annual meeting of the Republican Jewish Coalition in Las Vegas Saturday that it's time for the US to declare to the world how important its relationship is with Israel.

The pact would show the international community that "an attack against Israel would be considered an attack against the United States," he said.

The Republican said America should tell Israel's enemies that if they seek "to destroy the one and only Jewish state, you have to come through us to get them."

The US currently supplies Israel with \$3.8 billion annually in defense aid. While US President Donald Trump has complained about other countries in NATO not paying their share and has grumbled about defense aid to foreign allies, Israel has mostly escaped his ire.

Graham is a key ally of Trump and a member of the Senate Committee on Foreign Relations. He spoke after Trump addressed the same crowd and touted his pro-Israel bona fides.

The only thing a Netanyahu loss might accomplish is to slow down the escalation of war a LITTLE BIT. But those 20 mega-rich Zionist families controlling Israel are not going to let any Israeli Prime Minister thwart their war ambitions or their goal of a Greater Israel too much.

But a Netanyahu victory will guarantee a rapid escalation of war in the Middle East. The Netanyahu/Trump axis puts the Zionist mafia at the helm of America's War Machine. A proposed Trump/Netanyahu "peace plan" (designed by staunch Zionist Jared Kushner) will paint the Palestinians/Lebanon/Iran/Syria, etc., into such a small corner that it will leave them almost no alternative but to fight—which is what Trump and Bibi want.

War and conquest have been Plan A since the Rothschild Zionist State of Israel was founded in 1948. There weren't supposed to be any survivors who could tell the story. As it was, 34 American Sailors and Marines were killed, and 174 were gravely wounded in that Israeli attack.

Afterward, the U.S. government, including President Johnson, Secretary McNamara, Admiral John S. McCain Sr. and top military brass (along with a complicit mainstream media) completely covered up the attack and even had the audacity to make up excuses (lies) for Israel so as to not shame the Zionist leaders in public.

My point is, Zionist Israel has always attempted to use the United States for its own expansionist purposes. Now, Israel has a bona fide Zionist in the White House. Add that to a totally corrupt warmongering Israeli Prime Minister, and it is the perfect storm for perpetual war.

A foreign naval vessel is lumbering in international waters. It is flying a brand new 8'x5' flag, which unmistakably identifies it as a major ally of the country whose coastline is nearest the ship. The ship's markings are ten feet high on both sides. It is not a warship. It is an intelligence-gathering ship. For all intents and purposes, it is defenseless against any warship or attack aircraft, having but four .50-calibre Browning machine guns without shrapnel shields as its only offensive weapons. On board are 286 souls.

The only thing that saves that ship and those survivors that day is eight warplanes from a nearby aircraft carrier that had heard the initial "Mayday" cry from the ship. This caused the attacking country to withdraw. As it was, 34 of the ship's officers and crew are killed, and only a divine miracle and superhuman Herculean effort from the sailors in the bowels of that steel graveyard keep that ship afloat. When the attack first began, one general from the attacking country protested to his commanding officer saying, "This is pure murder."

But what the country whose ship was attacked and whose men were killed did is most curious. It did NOTHING. In fact, the government of that country immediately declared that the attack had been a "mistake" and then proceeded to completely cover up what had happened. "Behold, I will make them of the synagogue of Satan, which say they are Jews, and are not, but do lie; behold, I will make them to come and worship before thy feet, and to know that I have loved thee." -(Revelation 3:9).

These two passages when fully understood speak to a group of people who have chosen to be identified as Jews in the latter times. Most would why anyone would want to do that given the history of the Jewish nation? The Jews have had the curse of being referred to as "The Wandering Jew", a popular novel of the 19th century. Written in 1845, just 3 years before revolutions swept Europe, "The Wandering Jew" is a classic French novel that became an international bestseller. Originally serialized in a French newspaper, the novel created an instant controversy with it. I read the novel as part of a required readings list in one of my college classes back in the mid-1960s. I can't say at the time whether the book affected me in

any way but it provides a backdrop to the issue of the Jewish people throughout the past two millennia.

When examining the story of the wandering Jew there may be obscure elements that will hold some importance to some groups of Christians. Since it is a work of fiction, not all Christians would agree that the story holds any significance for them.

The story may come from Christian traditions but again those traditions are not the same for every segment of the faith. One lesson that can be gleaned from the encounter of Ahasuerus with Jesus would be the consequences of sinful actions. So anti-Semitism bubbles up in the novel.

Ahasuerus decided to mock and sin against Jesus whereby he was given an immediate judgment and sentence. But even with that moral lesson the story does not fit with the nature and character of Jesus who forgave his tormentors and executioners.

Surely, they were more eligible for such a curse than a lowly shoemaker who only said a few words to Jesus as he passed by. The curse by Jesus also goes against his teaching found in the Gospels. As it stands, it is a legend only; One that does not fit the nature of New Testament thinking or teaching. *'The Wandering Jew'* is often seen as a comparison with Cain.

It is inevitable that there would be some comparisons with Cain. Like the wandering Jew who was cursed by Jesus, Cain was cursed by God. Genesis 4:12 says, ***"When you cultivate the ground, it will no longer yield its strength to you; you will be a vagrant and a wanderer on the earth..."***

The only difference between the two curses is that we have record of God's curse on Cain. We do not have any record of Jesus' curse on Ahasuerus. The life of Cain is not really known after he takes his wife and leaves his family.

All we know is the name of a few of his descendants and that he built a city. Genesis 4:16-17 give us those details. But there is no mention of how long Cain would live in his curse. It can be concluded that he died in old age, but we cannot be sure.

Ahasuerus was given a life sentence and said to have been condemned to live until Christ returns. No one knows when that event will take place. If Ahasuerus was a real person, then he should be alive today and spotted more frequently than just to times in 2,000 years.

It all started with a curse.

"As Jesus sank beneath the load, He turned his pitying eye to the unfeeling child of Israel, and, pointing up on high, said, "yes, I go for it needs must be, but until I do return, thou must go, to and fro..." (Eugene Sue, from the original novel *'The Wandering Jew'*, 1881)

With these words, the sage of the wandering Jew begins its journey. It is said that the story is based on Matthew 16: 28 which reads: ***“Truly I say to you, there are some of those who are standing here who will not taste death until they see the Son of Man coming in His kingdom.”***

Where am I going with this has undoubtedly entered your mind. First, all History is about “His-Story”, the Lord Jesus Christ. From time memorial past, to the soon Second Coming of Christ, Jesus over shadows all understanding of life. It is imperative that in order to understand life, we must look through the lens of the Bible. Unfortunately so, many Christians have not had the benefit of higher education framed through a Biblical World View. I probably should note that even some who have a Biblical World view there understanding has been corrupted by the father of lies!

Do not forget those words of Revelation 2:9 and 3:9, especially in their context of Bible prophecy. They confirm the story that goes back a thousand years. Those who call themselves Jews today are not all descendants of Abraham, Isaac, and Jacob. 85% of Jewry today is what Jesus Christ referred to as being of the ***“Synagogue of Satan”***. The two major groups of Jews are the Sephardic’s (15%) and the Ashkenazi’s (85%). The Sephardic Jews can trace their roots back to the lineage of Abraham, Isaac, and Jacob. Not so with the Ashkenazi Jews.

The Jewish blogs offer the view that the term "Ashkenazi" refers to Jewish settlers who established communities along the Rhine River Valley in Western Germany and in Northern France dating back to the Middle Ages. Once there, they adapted traditions from Babylon, The Holy Land, and the Western Mediterranean to their new environment. Ashkenazi Jews are popularly contrasted with Sephardi Jews (also called Sephardim), who descend from Jews who settled in the Iberian Peninsula, and Mizrahi Jews, who descend from Jews who remained in the Middle East.

The two main pillars on which all of Jewish scholarship rests are Rashi and the Rambam (a/k/a Maimonides). They differed not only on issues of philosophy but in overall style and approach. Part of the reason for this is that Rashi was Ashkenazi and the Rambam was Sephardi. Each was a product of a distinct tradition.

Generally speaking, the Sephardic commentators looked at the broad picture of Judaism, the forest and not the trees. The Ashkenazim, on the other hand, focused more on the trees than the forest. They concentrated on words, nuances, and the nitty-gritty of the Talmudic give-and-take. Therefore, the Rambam’s writings are quintessentially intellectual and philosophical, whereas Rashi’s greatness is his ability to take you through the Torah and Talmud detail by detail, word by word.

These differences did not grow in a vacuum. They developed from specific historical forces. In terms of time, the Sephardic and Ashkenazic communities developed simultaneously, but in terms of experience, they lived in two completely different worlds. In order for us to really get a handle on them, we have to look at each one separately.

After the Jews were sent into exile in 70 A.D., the main Jewish community in the Diaspora was Babylonian. It was the only place in the world where Christianity did not take over, and therefore, the Jews thrived there. They built their own yeshivas and lived autonomously. Thus, they were free to engage in the centuries of scholarship that produced the Talmud.

In the 9th century, the Jewish community in Babylonia began to decline, so many Jews went to North Africa, which was populated by two Moslem tribes: the Berbers and the Moors. The Berbers were fierce warriors, while the Moors were artisans, mathematicians, and merchants – the cutting edge of civilization. Together, they became a tremendous force in the world.

The Jews saw they had opportunity with them, particularly with the Moors, who were less religious and therefore, more tolerant. In other Moslem countries where the Jews lived, they had to accept the status of dhimmi, second-rate citizen. Their synagogues had to be unobtrusive, and they had to keep a low profile. All that changed with the Moors. Their alliance with the Jews lasted almost 400 years, and by the time the Moors were emigrating from North Africa into Spain, they brought along the Jews not as “dhimmis”, but as equals.

Thus, the Sephardic Jews lived in an open and intellectually advanced society. The study of philosophy abounded, so Sephardic Jewish scholarship became philosophical. The Jews also rose in public life, becoming government ministers. Maimonides was court physician to the Sultan of Egypt. Individual Jews sometimes suffered assaults from their Moslem neighbors, but there were no Crusades, no pogroms per se, no Holocaust.

The Ashkenazic Jew, on the other hand, never had a good day. He lived in a primitive world full of constant danger. Western Europe had sunk into the Dark Ages; less than 1% of the population was literate. Even the great king Charlemagne, the first to invite the Jews to Europe, could not sign his own name.

Charlemagne extended his invitation to the Jews with the offer of land, equal rights, and imperial protection. A small group of Jews left Babylon and settled in the German Rhineland Valley, mostly in the cities of Worms, Speyers, and Mainz. But because the Church converted the native pagans, Christianity became a religion full of superstition and brutality. This, in part, gave rise to the Crusades and the pogroms of the Black Death. It's mind-boggling that Ashkenazic Jewry survived those early centuries, but not only did it survive, it actually grew.

So, while the Sephardim viewed their Moslem neighbors as equals, the Ashkenazim looked at their illiterate Christian neighbors with disdain bitterness. They led an insular existence, and their sole intellectual pursuits were the Torah and Talmud. And this is what accounts for the different traditions and characteristics of Sephardim and Ashkenazim.

A recent 2014 genetic study concludes that all Ashkenazi Jews can trace their ancestry to a “bottleneck” of just 350 individuals, dating back to between 600 and 800 years ago, between 1100 A.D. and 1200 A.D..

The study, published in the *‘Nature Communications’* journal, was authored by Shai Carmi, a computer science professor at Columbia University, and more than 20 medical researchers from Yale, Columbia, Yeshiva University’s Albert Einstein College of Medicine, Memorial Sloan-Kettering Cancer Center, Hebrew University of Jerusalem and other institutions.

Researchers analyzed the genomes of 128 Ashkenazi Jews and compared them to those of non-Jewish Europeans in order to determine which genetic markers are unique to Ashkenazi Jews. They found that the Ashkenazi Jews’ genetic similarities were so acute that one of the study’s researchers, Columbia professor Itzik Pe’er, told the “Live Science” website that among Ashkenazi Jews, *“everyone is a 30th cousin.”*

The findings will enable researchers to catalog nearly all of the genetic variations from the founding population, the study’s authors said. Such thorough genetic cataloging could help clinicians interpret individual genetic mutations, improve disease mapping and provide insight into the histories of Middle Eastern and European populations, the study said.

The catalog of complete Ashkenazi Jewish genomes should help identify the disease-causing mutations that the progenitors of Ashkenazi Jewry they passed on. Until now, data has only been available for a small subset of common Ashkenazi DNA markers – about one in every 3,000 letters of DNA. The findings are also expected to help with disease research in other ethnic groups.

“Our study is the first full DNA sequence dataset available for Ashkenazi Jewish genomes,” said Itzik Pe’er, an Israeli computer scientist at Columbia University, who led the study. *“With this comprehensive catalog of mutations present in the Ashkenazi Jewish population, we will be able to more effectively map disease genes onto the genome and thus gain a better understanding of common disorders. We see this study serving as a vehicle for personalized medicine and a model for researchers working with other populations.”*

Ashkenazi Jews are known to have origins in the Levant, which Israel is smack dab in the middle of. But exactly who “European” Ashkenazi Jews are has long been debated. An analysis of the gene database shows that the original Ashkenazi Jews were about half European and half Middle Eastern. They lived in the medieval era, about 600 to 800 years ago, according to the analysis – and numbered just 350 or so people.

“Our analysis shows that Ashkenazi Jewish medieval founders were ethnically admixed, with origins in Europe and in the Middle East, roughly in equal parts,” said Shai Carmi, a post-doctoral scientist who works with Pe’er and conducted the analysis. *“[The] data are more*

comprehensive than what was previously available, and we believe the data settle the dispute regarding European and Middle Eastern ancestry in Ashkenazi Jews.”

The analysis also suggested that today’s Europeans are descended primarily from migrants from the Middle East after the last ice age, about 20,000 years ago, not from the first humans to arrive to the continent about 40,000 years ago. The researchers are now looking into where the Middle Eastern and European Jews first met and who their closest descendants are today.

Because the Ashkenazi community started out so small, and remained genetically isolated, it developed a higher load of disease-causing mutations. Even today, Ashkenazi Jews are known to be at higher risk for many diseases, including breast and ovarian cancer and Tay-Sach’s disease. But many potentially disease-causing Ashkenazi mutations remain unknown. They were the group that became the focus of a measles epidemic in certain areas of New York City. Mayor De Blasio issued an order for mandatory vaccination for Rockland County children or thirty-day home isolation for non-vaccinated individuals. The Court stayed the mandatory vaccination order that got national news coverage.

To address this problem, Pe’er and a team of researchers at the Ashkenazi Genome Consortium (TAGC) did high-depth sequencing of the Ashkenazi genomes. Finding that the genomes had almost 50 percent more mutations than did European samples on average, they compiled a comprehensive catalog of genetic mutations found among Ashkenazi Jews.

The catalog is already proving useful for carrier testing the genetic analyses prospective parents undergo to see what diseases they risk passing onto future children. They are also working to sequence some 500 more Ashkenazi genomes to further strengthen the catalog.

“TAGC advances the goal of bringing personal genomics to the clinic, as it tells the physician whether a mutation in a patient’s genome is shared by healthy individuals, and can alleviate concerns that it is causing disease,” said Lencz. *“Without our work, a patient’s genome sequence is much harder to interpret, and more prone to create false alarms. We have eliminated two thirds of these false alarms.”*

By revealing genetic information unique to Ashkenazi Jews, the catalog should also allow the pinpointing of genes behind more of the diseases that plague the population. The researchers are already studying specific Ashkenazi diseases to this end, including schizophrenia, Parkinson’s disease, Crohn’s disease, and cancer, as well as other traits, such as longevity. The researchers expect many of these medical insights to be relevant to the general population as well.

The advent of DNA discovery led to testing of Jews first began back around 1990 when authorities at the Temple Mount Institute began searching for those with the names of Cohen, Cohanin, Coln, Kohen, associated with those of the Tribe of Levi, or the Levites. The testing was conducted world-wide in hopes of identifying and locating potential individuals that might

serve in the coming near-future Third Temple. The Ashkenazi Jews constitute about 85% of all Jews in Israel today. The very fact that only 15% of Jews in Israel are Sephardic is no minor or insignificant fact, raising question whether enough Levites could be found and willing to serve in a third Temple worship program.

The majority of Ashkenazi Jews are descended from prehistoric European women, according to study published in 2013 in *'Nature Communications'*. While the Jewish religion began in the Near East, and the Ashkenazi Jews were believed to have origins in the early indigenous tribes of this region, new evidence from mitochondrial DNA, which is passed on exclusively from mother to child, suggests that female ancestors of most modern Ashkenazi Jews converted to Judaism in the north Mediterranean region around 2,000 years ago and later in west and central Europe.

The new findings contradict previous assertions that Ashkenazi mitochondrial lineages originated in the Near East or from mass conversions to Judaism in the Khazar kingdom, an empire in the north Caucasus region between Europe and Asia lasting from the 7th century to the 11th century whose leaders adopted Judaism. *"We found that most of the maternal lineages don't trace to the north Caucasus, which would be a proxy for the Khazarians, or to the Near East, but most of them emanate from Europe,"* said coauthor Martin Richards, an archaeogeneticist at the University of Huddersfield in the U.K.

Richards and colleagues' story "seems reasonable," said Harry Ostrer, a human geneticist at Albert Einstein College of Medicine of Yeshiva University in New York City who was not involved in the study. *"It certainly fits with what we understand about Jewish history."*

The Ashkenazi Jews make up the majority of Jews today and most recently have ancestry ties in central or Eastern Europe. Previous work has demonstrated that just four mitochondrial types, passed down from four mothers, account for 40 percent of variation in Ashkenazi Jews' mitochondrial DNA, and some researchers have published evidence of Near Eastern origins for these Ashkenazi mitochondrial types.

To further investigate the matrilineal lines of the Ashkenazi Jews, Richards and colleagues looked at mitochondrial genome sequences in living Jews and non-Jews from the Near East, Europe, and the Caucasus. Based on the results, the team concluded that, in contrast to the evidence for many Ashkenazi males, whose Y chromosomal DNA suggests a likely origin in the Near East, the female lineage of Ashkenazi Jews have substantial ancestry in Europe. Specifically, the researchers found that the four main Ashkenazi founder mitochondrial types were nested within European mitochondrial lineages, not Near Eastern ones, and an analysis of more minor haplogroups indicated that an additional 40 percent of mitochondrial variation found in Ashkenazi Jews' mitochondrial DNA was likely of European origin. The remaining variants appeared to be from the Near East or are of uncertain origin, and there was no evidence for Ashkenazi Jewish origins in the Khazar kingdom, according to the authors.

Historical evidence indicates that Jewish communities began to spread into Europe during classical antiquity and migrated north during the first millennium A.D., arriving in the Rhineland Valley by the 12th century. Local European women could have begun to join the Jewish population around 2,000 years ago or earlier, Richards and colleagues suggest, and the Ashkenazis may have continued to recruit additional women as they headed north.

But some scientists question these conclusions. *“While it is clear that Ashkenazi maternal ancestry includes both Levantine [Near Eastern] and European origins—the assignment of several of the major Ashkenazi lineages to pre-historic European origin in the current study is incorrect in our view,”* physician-geneticists Doron Behar and Karl Skorecki of the Rambam Healthcare Campus in Israel, whose previous work indicated a Near Eastern origins to many Ashkenazi mitochondrial types, wrote in an e-mail to *‘The Scientist’*. They argue that the mitochondrial DNA data used in the new study did not represent the full spectrum of mitochondrial diversity.

Eran Elhaik, a research associate studying genetics at the Johns Hopkins University School of Public Health, is split. He agreed with the study authors that the study rules out a Near Eastern origin for many mitochondrial lineages of the Ashkenazis but disagreed that it rules out a Khazarian contribution. *“Jews and non-Jews residing in the regions of Khazaria are under-represented, which biases the results toward Europe as we have seen in many other studies,”* he said in an e-mail to *‘The Scientist’*. Elhaik recently concluded from autosomal DNA that European Jews did, in fact, have a Khazarian background.

David Goldstein, a geneticist and director of the Center for Human Genome Variation at the Duke University School of Medicine, said that the questions of whether there was a Khazar contribution to the Ashkenazi Jews’ lineage, or exactly what percentage of mitochondrial variants emanate from Europe, cannot be answered with certainty using present genetic and geographical data. Even if a set of variants are present in a specific region today, that doesn’t mean that the region always had that set of variants. Some variants could have been lost due to drift, or perhaps migration altered the balance of variants present in the population.

“These analyses really do not have any formal statistical inference about evolutionary history in them,” Goldstein wrote in an e-mail to *The Scientist*. *“They are based on direct interpretations of where one finds different [mitochondrial DNA] types today. And so the analyses are largely impressionistic.”*

Nevertheless, Goldstein noted that the new study *“does offer better resolution of the [mitochondrial DNA] than earlier ones, and so the suggested interpretation could well be right.”*

Strangely so, all of this genetic evidence has not affected the teaching of Bible prophecy teachers. As a whole, of those who teach Bible prophecy, such as Gary Stearman, Hal Lindsey, Robert Jeffress, Barry Stagner, Perry Stone, Dave Reagan, Arnold Fructenbaum, Gary Frazer, Ed Hindson, Thomas Ice, Mark Hitchcock, Don Perkins, and many others, in spite of what Jesus has said in Revelation 2:9 and 3:9, no Bible prophecy teacher ever makes any reference to this

distinction of genetics. Is it important? Should it be a subject of relevance today? All of those that I mentioned here apparently do not think so. Many of these men routinely lead tours to the sites in Israel associated with the Bible. If it is not important, then why did Jesus note it in Revelation 2:9 and 3:9?

Judaism can be both a cultural and a religious identity, and in the case of Ashkenazi Jews, it is possible for someone to be culturally or ethnically descended from the Ashkenazim without practicing Judaism, or for someone to adopt Ashkenazic traditions without being ethnically related to the Jews of Central and Eastern Europe. Around 80-85% of the Jewish people around the world are Ashkenazim, including most American Jews.

The history of the Ashkenazi Jews began with migration from the Middle and Near East to Central Europe. The term “Ashkenazi” actually comes from the Hebrew word for “Germany,” reflecting the fact that many of them settled in Germany and along the Rhine River Valley. Over time, the Ashkenazim were pushed back into Eastern Europe, developing close-knit communities and a rich cultural and religious tradition. They have historically been persecuted, banned from working in many professions and sometimes prevented from living in specific regions.

Genetically, the Ashkenazi Jews are clearly descended from people of Middle Eastern ancestry who intermarried with Central and Eastern Europeans, as ample studies on the Ashkenazim have demonstrated. Many Ashkenazim in Europe spoke Slavic languages, but they also developed their own language, Yiddish. They also developed a unique approach to the Jewish liturgy and to Jewish religious traditions. While Ashkenazim follow the same religious texts that other Jews do, there are a few distinctive variations in the Ashkenazic tradition which distinguish Ashkenazi Judaism from Sephardi Judaism and Mizrahi Judaism. Chiefly, is their reverence for the Talmud, a collection of writings during the Babylonian period of captivity.

The Ashkenazi population in Europe was devastated by the Holocaust of the 1930s and 1940s, when an estimated six million Jews (more closer to two million) were slaughtered under the regime of Adolf Hitler. Fortunately, many Ashkenazim had settled outside Europe, primarily in the United States, and kept their traditions and history alive. With the foundation of Israel in 1948, many Ashkenazi Jews relocated to the Middle East, and they make up a sizable proportion of the Jewish population of Israel today.

Because Ashkenazi Jews make up such a huge percentage of the Jews around the world today, many people who are unfamiliar with Judaism think specifically of Ashkenazi traditions when they hear the word “Jewish,” and they also assume that most Jews are of Central and Eastern European descent. In fact, Judaism is practiced in a variety of ways, and the ethnic heritage of the Jewish people is also quite diverse, with distinct lineages from the Mediterranean and Middle East.

From all of this information about the two branches of Judaism we would think the issue is a non-starter; however, for example, 75% of Jews are lactose intolerant, and almost half of

Ashkenzai Jews carry at least 1 of 38 known genetic diseases. This begs the question is there such a thing as a “Jewish gene”? No, there isn't but it doesn't keep Jewish researchers from seeking a “Jewish gene”. Jews and all other humans are 99.9 percent identical in their genetic make-up, and there is no gene known to exist in Jews that does not exist in other population groups of in world.

Then what about the so-called priestly genes? About 50 percent of all Cohanim (the Jewish priestly class) harbor a distinct element on their Y-chromosome called the Cohen Modal Haplotype or CMH. Because this sex chromosome is passed down unchanged from father to son, geneticists have used this element to trace the patrilineal priestly dynasty to a common ancestral chromosome found 2,100–3,250 years ago, before the destruction of the First Temple. But it is not exclusive to Jews, either: CMH is also found among Bedouins, Yemenites, and Jordanians, lending support to “a Near Eastern origin of this lineage,” according to a 2009 report. The Palestinians are merely cousins of the Jews.

What about the Jews and Khazar Theory. A few years after the publication of the genetic study, the molecular biologist Eran Elhaik argued quite differently, that the data actually supported the conclusion that Ashkenazi Jews came from the Caucasus Mountains. This seemed to confirm, he argued, what has come to be known as the Khazar theory that Ashkenazic Jews descend from a Turkic people known as the Khazars who inhabited the region between Europe and Asia and converted en masse to Judaism during the Middle Ages rather than convert to Islam.

This theory goes back to the 19th century, but was made popular in the United States by Arthur (Tony) Koestler in a 1976 book called *'The Thirteenth Tribe'*. It continues to have advocates to this day, including the Ku Klux Klan Leader Dr. David Duke, who only recently began to question the theory when he realized that its earlier advocates included communist Jews like Arthur Koestler. Historians, relying on textual sources, have exposed many weaknesses in the Khazar theory, but with Elhaik's research, it seemed to find a new scientific footing, the data suggesting that Ashkenazic Jews do not descend from Middle Eastern founders but from a Turkic population in the Russian steppe region, as argued by the Khazar theory.

I first became aware of this issue back thirty years ago when a member of the church where I was pastor raised this point about Revelation 2:9 and 3:9, that was brought up in discussion at my Wednesday night Bible study. I was sharing the news that the Jews were seeking out those with Cohanim “markers” as part of a larger plan to bring back temple worship, in anticipation of a future 3rd Temple.

When DNA was first discovered, it opened the door for research in identifying many diseases, as well as doing ethnic studies. In my own case, my interest was tied to the fact that my first wife had been diagnosed and subsequently died from Huntingdon's Disease. Today, it has become a joke in politics among those who would identify themselves as American Indian to get a well-known female Senator admitted to Harvard, even if she was only 1/1064th

thousandth Cherokee Indian. Even her Indian tribe denied that she was a descendant of their tribe. Senator Pocahontas (Elizabeth Warren) had been exposed to the public for having checked off as being American Indian at the time of her applying for enrollment at Harvard.

As we look forward to the President Trump "Peace Plan" for Israel and its neighbors, leaks suggest that it is a "dud" and DOA (dead on arrival) with the PLO. The specific concern that I have, centers on the President's son-in-law, Jared Kushner. Jared Kushner has significant ties with the Chabad Lubavitchers, a radical messianic sect of Hasidic Jews. For twenty years he labored on his magnum opus, Tanya, in which he outlined the Chabad philosophy and ethos. First published in 1796, Tanya is the "bible" of Chabad Chassidism, upon which the hundreds of books and thousands of maamarim (discourses) by seven generations of Chabad Rebbes are based."

The Alter Rebbe was a violent criminal who was arrested in 1797 and 1798. The Alter Rebbe declared himself to be the Moshiach, the "King of the Jews". But after his death in 1812 his followers altered some of his writings, including the Tanya, to correct some obvious problems. All subsequent Chabad Rebbes have also declared that they are the Moshiach.

Basic Problem #1: The Tanya. Chabad "Rabbis" and members of Chabad study the Tanya over and above other traditional Jewish texts. Traditional Jewish texts include the Torah, Neviim, Ktuvim, and the Talmud, but NOT the Tanya. What if there is a problem with what is written in the Tanya? Only followers of Chabad give so much weight to the Tanya over traditional Jewish texts. Most Jews have never even heard of the Tanya. Many people say that the Tanya is the "New Testament" of Chabad, because Chabad sees itself as an improvement upon traditional Judaism. The Tanya is also considered to be a very racist book, which defines all Jewish souls as good, and all non-Jewish souls as evil. It is this philosophy that grates on those of the outside world.

The main difference between the Jewish religion and the Chabad religious cult is that the Jewish People study the Torah, which was given to the Jewish People on Mount Sinai more than 3,300 years ago. On the other hand, followers of the Chabad messianic cult study the Tanya, which was written by a crazy criminal, to get money and power, just 200 years ago. The Tanya directly contradicts the teachings of the Torah.

Basic Problem #2: Recognition. The Chabad movement has never been recognized as a valid Jewish ideology by the mainstream Jewish Rabbis. In 1792 the Alter Rebbe tried to meet with the Gaon of Vilna, the recognized leading Rabbi at the time, to obtain his support for the new movement. The Gaon of Vilna refused to even meet with the Alter Rebbe, and never recognized

the new movement as a valid Jewish ideology. From the Gaon of Vilna to Rav Shach and beyond, Chabad has never been recognized as a valid Jewish ideology. Chabad ideology is NOT Jewish.

During the French invasion of Russia, while many Jewish leaders supported Napoleon or remained quiet about their support, Rabbi Shneur Zalman openly and vigorously supported the Tsar. He wrote in a letter to another Rabbi: "Should Napoleon be victorious, wealth among the Jews will be abundant... but the hearts of Israel will be separated and distant from their father in heaven. But if our master Alexander will triumph, though poverty will be abundant... the heart of Israel will be bound and joined with their father in heaven... And for God's sake: Burn this letter."

Some argue that Rabbi Shneur Zalman's opposition stemmed from Napoleon's attempts to arouse a messianic view of himself in Jews, opening the gates of the ghettos and emancipating their residents as he conquered. Thus his opposition was based on a practical fear of Jews turning to the false messianism of Napoleon as he saw it. Some argue that Rabbi Shneur Zalman believed that suffering was good for the Jews. Suffering would inspire asceticism and bolster the Hassidic cause.

Basic Problem #3: Messianism. Some people believe that messianism became a problem with Chabad following the death of the Rebbe in 1994. Actually, messianism was always a problem with Chabad. The founder and first Rebbe of Chabad claimed to be the Moshiach, and every subsequent Chabad Rebbe has also claimed to be the Moshiach. The 7th Chabad Rebbe said that Chabad ideology predicted that the 7th Chabad Rebbe would be the Moshiach. This is the reason Menachem Mendl Schneerson did not appoint a successor, he was the 7th Chabad Rebbe and believed that he was the Moshiach. This is the reason Chabad members still say the Chabad Rebbe, who died in 1994, is the Moshiach, and an 8th Chabad Rebbe was never chosen. At the death of Menachem Schneerson, over 100,000 attended his funeral, and for days awaited his return to fulfill his role as the messiah. It is more than a quarter-century and many still believe Menachem Schneerson will return! Rebbe Schneerson said the Messiah visited him in a dream, and that the Messiah was Jesus Christ; and he wrote this down in a letter before his death. The contents of the letter was not to be read until a year after Schneerson's death. The letter and its contents were revealed on schedule to his request, but the Chabad virtually went silent after the content was revealed.

A similar story occurred 300 years before. Shabtai Tzvi publicly declared himself to be Moshiach around 1665, and a large percentage of the Jewish population at the time believed him. The Chabad Lubavitch Rebbe publicly declared himself to be Moshiach around 1985 and many Jews believed him. There is no doubt that the Chabad Lubavitch movement promoted its leader as the Moshiach. This was not the doing of wayward Hasidim, it was instigated, orchestrated and encouraged by their Rebbe. In the late 1970s, the Chabad Lubavitcher Rebbe began alluding to the "fact" that the Moshiach was "living among us" and left none of his listeners in any doubt as to his meaning. This inane campaign became increasingly frenzied and irrational. Rather than faltering at the time of his death in 1994, the insanity continues to

spread. At Chabad headquarters in New York the expectation is that their rebbe will miraculously reappear. Shacharit (the morning prayer) is delayed each morning for 5 minutes just in case, at which point the gabai announces that "the rebbe" is apparently unable to make it today, and Shacharit begins.

This outrageous phenomenon is not as surprising as it may at first seem. Shabtai Tzvi's followers were known as "Zoharisten", an allusion to the fact that they, like their leader and demigod, were heavily influenced by the Zohar. The Zohar is a book of mystical writings, many clearly Satanic in content. Chabad Lubavitch Hasidism is rooted in a literalistic reading of the Zohar and Lurianic Kabala, which when uncritically combined with the radical and pernicious notions spawned by the speculative school of Hasidic thought founded by the Magid of Mezritch, could only have led to the present heretical state of affairs. This, is probably why the Vilna Gaon refused to meet with the original Chabad Lubavitcher Rebbe even when the latter came to Vilna to convince him to rescind the cherem (religious ban) the Vilna Gaon had signed against Chabad Lubavitch and similar movements. In his great and profound wisdom the Vilna Gaon saw that these Jews had crossed the point of no return. The Vilna Gaon was able to be "HaRoe et haNolad" (One who sees that which is yet to come).

A majority of those who openly identify themselves as Chabad Hasidim (followers) believe that their last rebbe IS the Moshiach. A significant percentage consider him to be God in human form, a shocking fact about which no more need to be said.

Basic Problem #4: Religious Cult. Chabad was a religious cult from the very beginning of the movement. Chabad is a very dangerous Messianic Cult. Chabad Rabbis communicate with their Rebbe, who died in 1994, by taking pieces of paper out of a hat. They claim that their Rebbe tells them what to do. They pray to their dead Rebbe at his grave and they write letters to him with their wishes that they place in their grave. Also at Chabad weddings, they read a letter sent by the Chabad Rebbe, who died in 1994, to the couple getting married... Mazal Tov!!!

Basic Problem #5: Violence and Crime. Chabad engaged in criminal activities from the very beginning. Several of Chabad Rebbes and followers were constantly getting arrested. Chabad has always been a violent movement. Whenever a Rebbe dies there is always a violent fight for succession among the "eligible" candidates.

Basic Problem #6: Money. The only reason Chabad did not cease to exist after the death of the Rebbe Schneerson in 1994 was because of the huge amount of money being made by the Chabad enterprise. Chabad is a multi-billion dollar operation active in several countries around the world. Since the Rebbe died in 1994, members of the Chabad organization have been fighting for the control of this operation, and the money left behind by their Rebbe. Chabad Rabbis appear to have an unlimited amount of money that they use, among other things, to pay bribes to politicians, judges, law enforcement officials, and Rabbis. Where is all this money coming from? Mostly from illegal operations which include drug trafficking and money laundering.

Basic Problem #7: Fantasy. Chabad theology is full of lies and fantasy about their seven Chabad Rebbes. For example, some say that the Rebbe explained to Albert Einstein the theory of relativity. Of course these stories are all false. In reality, mainstream Rabbis have always considered Chabad Rabbis as fake Rabbis. Chabad members are considered to be completely ignorant about the Torah. Chabad followers are considered stupid, crazy, and criminal, starting with their so called Chabad "Rabbis".

There are many other problems with the Chabad ideology. All of them started from the very beginning and have been magnified through the years. One of the sons of the Alter Rebbe converted to Christianity. Some people have noticed great similarities between the Chabad movement and the initial years of the Christian movement. In fact, Chabad theology is strikingly similar to early Christian theology. They include the basic same ideas and principles, but a different Moshiach.

It might seem odd for a Modern Orthodox Jewish family to join a Chabad synagogue. But Ivanka Trump and her husband Jared Kushner are already quite invested in the ultra-Orthodox outreach movement – or to be more precise, their parents are. That said, it is an omen of what the Trump Peace Plan portends.

A *'Haaretz'* examination has revealed that Charles and Seryl Kushner have been major benefactors of Chabad over the years. Between 2003 and 2013, their family foundation donated a total of \$342,500 to various institutions and projects associated with the movement, their tax records show.

Chabad has benefited not only from Kushner's side of the family. It turns out that President Donald Trump has also contributed to the movement – even before his daughter, who converted to Judaism, was married. Altogether, the Donald J. Trump Foundation has donated \$11,550 to three Chabad institutions.

According to a recent report in *'The Forward'* and on Washington, D.C. Channel 10 news, Ivanka Trump and Jared Kushner are considering joining a Chabad synagogue when they move from New York to Washington D.C. Their newly purchased \$5.5 million home in the Kalorama neighborhood (the same area Barack Obama's home is located) is said to be less than a 10-minute walk from the local Chabad congregation, known as TheSHUL. Rabbi Levi Shemtov, who founded the synagogue and serves as its spiritual leader, would not confirm or deny the reports.

Kushner and Trump both identify as Orthodox, and the other two Orthodox synagogues in town are farther way. This can pose a problem for Jews who don't drive on Shabbat. The family is moving in order to be closer to the White House, where the couple is expected to fill important, if not official, advisory roles in the next administration.

Three days before the 2016 presidential election, the two made a pilgrimage to the grave of the Chabad rebbe, Menachem Schneerson, where they reportedly made a special

prayer for Ivanka's father. The gravesite, which is known as the Ohel, is considered holy by followers of Chabad (also known as the Lubavitcher movement) and is visited by thousands annually.

Another key beneficiary was the Chabad center at Harvard University, which received \$150,000 in 2007 (the foundation's single biggest donation to a Lubavitch-affiliated enterprise) and then another \$3,600 in 2013. Jared Kushner, who serves on the board of his parents' charitable foundation, is a graduate of Harvard.

The Kushner's have also contributed to a Chabad-run institution in Israel: the vocational school at Kfar Chabad, a town near Ben-Gurion International Airport. The school, which works with troubled youths, has received \$7,500 from the family over the years. Various Chabad centers in Florida, Manhattan and New Jersey have also been supported by the Kushner's.

Chabad makes a practice of soliciting unaffiliated Jews and trying to turn them onto Orthodox Judaism. Its emissaries often approach men in the street and, after confirming that they are Jewish, offer to teach them how to don tefillin and recite prayers. In Israel, the movement is affiliated with the political right wing, and its followers tend to be staunch supporters of the settler movement.

In 2008, a year before Ivanka Trump married Kushner, the Donald J. Trump Foundation made two donations to Chabad – \$6,750 to the Lubavitch Youth Organization in Brooklyn and \$1,800 to Chabad of Southampton Jewish Charity. In 2011, the foundation donated \$3,000 to Chabad of East Boca Raton – an institution also supported by the Kushner's.

The Trump charitable foundation has made numerous donations to Jewish causes over the years. In 2003, for instance, it handed over a check for \$10,000 to Friends of Beit El Institutions, the American fundraising arm of one of the oldest and more radical West Bank settlements. David Friedman, the bankruptcy lawyer who was Trump's nominee for ambassador to Israel, serves as the organization's president; Trump made the donation in Friedman's honor. Beit El has its own Chabad envoy who heads a small congregation in the settlement. This shows a tight relationship between Chabad and the Trump family.

In 1996, when Benjamin Netanyahu was running for his first term as prime minister, the Chabad movement rallied behind him with an aggressive and well-funded campaign. "*Netanyahu. It's good for the Jews*" was its controversial slogan. The campaign was financed by Josef Gutnick, a wealthy Australian businessman with close ties to the late Chabad Lubavitcher rebbe and a major supporter of the settlement movement.

Chabad rebbes, have been recorded on camera, asking when Netanyahu was a U.N. delegate, "what are you going to do to bring us the messiah?" Ethnically, Jared Kushner nationality is American and his ethnicity is Ashkenazi Jewish. This becomes very important in forthcoming events that are spoken of in the Bible. Dr. David Duke exposed the Jewish extremist and corrupt fraudster who is the most powerful person in the United States

Government other than the President. A man who supports a Jewish racist – extremist organization of hatred against all non-Jews!. He also shows how the Zionist-controlled media never even points out these connections when talking about Jared Kushner. For those unfamiliar with Dr. David Duke, he served two terms as a congressman from the state of Louisiana from 1989-1993.

Dr. Duke is an outspoken critic of the Chabad movement, and he pulls no punches. In turn, he is accused of being a rabid anti-Semite. That fact is not unusual as the Jews are super-sensitive to criticism, be it true or false. Organizations such as B'nai B'rith, ADL, JDL, and others wage a propaganda war on any criticism of Jews in the media. I suspect that most of those reading this are unfamiliar with the various distinctions and beliefs within Judaism. I have been a student of Jewish studies going back to my college days and so I am familiar with the many variants of Judaism. It is not a monolithic body as some want you to believe. It is for this reason, I take most of the TV prophecy teachers to task of ignoring this dangerous element of fanatical Jewry.

This is why I believe Dr. Chuck Baldwin's op-ed piece is so important and pertinent to what we face in the very near future. Benjamin Netanyahu, is also an ethnic Ashkenazi Jew, as well as a 33rd degree Freemason born in the USA. 
What most Evangelical Christians fail to realize is that when the Bible speaks prophetically about Israel, it is objective factual history told in advance. The present-day church is divided needlessly. We are currently in a "time out" in between week 69 and week 70.



Throughout the Old Testament God referred to the Jewish people as "my people" (e.g., Exodus 3:7, 10:6:7; Leviticus 26:12; 1st Samuel 2:29; 2nd Samuel 3:18; 1st Kings 6:13; 2nd Kings 20:5; 1st Chronicles. 11:2; 2nd Chronicles 1:11; Psalms 50:7; Isaiah 1:3; Jeremiah 2:11; Ezekiel 11:20; Hosea 4:6; Joel 3:2; Amos 7:15; Obadiah 1:13; Micah 6:3; Zephaniah 2:8; Zechariah 8:7-8), despite their frequent rebellion against Him.

'NewsPunch' posted a story on their web site back in early 2017. These were the headlines:

"Trump's son-in-law and senior advisor Jared Kushner belongs to an elite doomsday cult that boasts the Rothschild's as members and is trying to foment a "prophesied" third world war."

'NewsPunch' dares go where other new media are afraid to tread and comment on.

“Chabad Lubavitch is a Jewish supremacist cult that serves the Illuminati. Despite only having 200,000 elite followers, it has intimate ties to nearly every powerful government leader on earth.

The cult believes Jews are God’s chosen people and everyone else is trash. In the book *‘Gatherings of Conversations’* Rebbe Schneerson tells his followers that Jewish people are an extension of God and Gentiles are destined to serve the Jews.

The Rothschild’s belong to this cult. Historian Wolfgang Eggert says Chabad Lubavitch is the real face of the Illuminati. He says this cult intends to initiate a nuclear holocaust in order to fulfill biblical prophecy and hasten the return of the Messiah:

“History and politics are a big movie, and they are the directors, bringing old-testament-prophecy into reality. They captured freemasonry by building up the illuminati (through Rothschild/Jacob Frank/Weishaupt); they made a pact with the British monarchy when they financed William III to become king; they placed the British royals at the head of the Freemasons; they made the modern banking system and the Fed (through Rothschild); they made Zionism, the world wars, the European union and so on. Christian writer Chris Bjerkness agrees: Redemption requires the “King of the Jews” (the Rothschild’s) to rule the world after a nuclear holocaust.

Jared Kushner attended Chabad House at Harvard. “Israel wasn’t a political discussion for him; it was his family, his life, his people,” said Hirschy Zarchi, rabbi at the Chabad House at Harvard.

In 2006, Kushner’s father Charles was sentenced to 24 months in prison for making illegal campaign donations and witness tampering.

Chabad’s power derives from two services they provide the Illuminati:

1. They work with Israeli intelligence in criminal and intelligence operations.
2. They promote a supremacist ideology that encourages Zionists to do dirty deeds.

The Canadian web site *‘Global Security’* has hypothesized that Donald Trump may be a Manchurian Candidate planted by the Russian mafia in collusion with the Russian government. Using a network of hackers and Internet trolls controlled by the Russian mob, the Russian government was able to influence the 2016 US Presidential election in favor of Trump. The basis of Trump’s cooperation in the plot has been alluded to in 35-page report, known as the Trump Dossier, first reported by CNN and then published by *‘BuzzFeed’* on January 11, 2017,

which alleges that Russia has gathered damaging intelligence on Trump which it is using to blackmail Trump. In fact, a series of studies by the *'Financial Times'* has shown how after he suffered a string of six successive bankruptcies, Trump was bailed out by Russian crime lords. Recently, the Mueller Report summary given to AG Barr revealed the \$35-million spent by FBI special prosecutor which some say exonerated President Trump.

Despite his alignment with the racist right, Trump has professed ultra-right views on Israel. His connections with Israel also extend to his broad ties with the Russian mafia, many of whom hold dual citizenship in Israel. The Russian mafia is closely associated with Chabad-Lubavitch, a Hasidic movement that derived originally from Sabbateanism. The Zohar and the Kabbalah of Rabbi Isaac Luria, are frequently cited in Chabad works. Although the Chabad Lubavitcher movement is often listed as a part of Orthodox Judaism, it has often been condemned as heretical by traditional Jews.

Rabbi David Berger, a highly popular figure in Modern Orthodox circles, wrote *The Rebbe, the Messiah, and the Scandal of Orthodox Indifference*, criticizing Lubavitcher messianism as *"precisely what Jews through the generations have seen as classic, Christian-style false messianism."* His views are shared and supported by many prominent Orthodox authorities. In the 1980's and early 1990's, Rabbi Eliezer Menachem Schach, a leader of the strictly Orthodox Jews in Israel who wielded powerful influence over the country's politics for more than two decades, waged a campaign against the Chabad Lubavitcher movement. The messianic claim, Rabbi Schach said, was "total heresy," adding that those making it "will burn in hell."

Lubavitch messianism involves the belief in the coming of the Messiah and a goal of raising awareness that his arrival is imminent. In addition, the term also refers more specifically to the hope that Rabbi Menachem Mendel Schneerson (1902–1994), known too many as the Rebbe, could himself be the Messiah. Schneerson was a Russian Empire-born American Orthodox Jewish rabbi, and the last Lubavitcher Rebbe, and considered one of the most influential Jewish leaders of the 20th century. Schneerson transformed the Chabad-Lubavitch movement that almost came to an end with the Holocaust, into one of the most influential movements in world Jewry, with an international network of thousands of educational and social centers, known as Chabad Houses. Chabad's goal, explains Sue Fishkoff, author of *'The Rebbe's Army'*, is to reach every Jew in the world. Chabad seeks out the support of the rich, famous and powerful, including celebrities like Bob Dylan, Jon Voigt, Whoppi Goldberg and Al Gore. Schneerson's grave attracts thousands of Jews and non-Jews for prayer.

David Livingstone, author and investigative journalist has spent years studying the relationship between Donald Trump, Chabad-Lubavitch and the Oligarchs. With no risk of capital punishment for such total insubordination directly against the Jews themselves from their Rothschild would-be rulers, the only tool the Rothschild's really have is to take away their toys and salt their fields in the form of creating all kinds of conflict within the white nations in the form of open borders and uncontrolled illegal and legal immigration of savages, who will make the Jews favorite farming grounds undesirable and create hatred towards the Jews living in these white nations from their white European hosts, in the hopes that the goyim will throw the Jews out and make them move to Israel or at least scare the Jews into moving to the Rothschild sh#thole in the desert.

The problem is the Jews know all these tricks because they are not idiots like the goyim, who will fall for every trick in the book and do whatever the Rothschild's want, with one exception. It has been shown that no matter how outrageous and violent and evil the Jews are

to the point that they have committed genocides against the goyim, the morality of the goyim makes them incapable of genociding the Jews through either fear or a sense of empathy or code of honor.

This has become an embarrassing problem for the Rothschild's because the Germans and Hitler were supposed to follow Rothschild's plan and actually holocaust the Jews who did not leave Europe for Palestine and make an example of them. Instead they tucked the Jews safely away from the cities, which were being firebombed and holocausted and put them in work camps, paid them German currency to build war materials even though 86% of the Jews in these camps opted out of working with no reprisals. The Germans were clearly not onboard with the Jewish extermination program that Rothschild's and the Zionists had designed and agitated for even before the March 1933 Jewish declaration of war on Germany. Fortunately for the Rothschild's, their allied minions did a better job of killing everyone, including the Jews, with total destruction of all logistics and the onset of starvation and disease across all of Europe, including the work camps that contained Jews where the losses to disease and starvation were reported by the Red Cross presence in all the camps.

With the Second World War coming to an end and still no actual holocaust of Jews being committed by the Germans, the Rothschild's set their Jewish Bolsheviks to task in Eastern Europe to frame up the Germans with the extermination of 6 million Jews. The 6 million figure was manufactured for propaganda purposes. The actual number exterminated is around 2 million. Naturally the Jewish Bolshevik commanders ordered the Russians under their boot to strip bunkers and build chimneys in places like Auschwitz as proof of German genocide of Jews.

For some strange reason they abstained from suggesting the simple starvation method that was so effective in all the Jewish orchestrated genocides of goyim throughout the ages. Instead, for this fantasy, they reached deep into their imagination for the most terrifying weapon from the First World War and chose gas for its emotional impact with zero account for its impracticality. And thus the legend of the gas chambers was created.

The Russians probably knew what was going on and what their Jewish Bolshevik enforcers were making them do when they were refurbishing Auschwitz after the war to make it look like a death camp. The Russians had the courtesy to build the brick chimney quite some distance from anything without any opening or access thus rendering it obviously a prop consisting of nothing but a large pile of bricks to anyone who saw it.

In spite of all the monetary and psychological success of the holohoax propaganda in terms of maintaining a victim complex in the Jews, extracting wealth from the goyim and giving the goyim a guilt complex for something their ancestors didn't do, there was one small problem.

Rothschild's had exposed to the Jews themselves that they were, in spite of everything, absolutely invulnerable to reprisal from the Rothschild's or the Goyim, and with a sh#thole in the desert to escape to if things ever really got bad, it made the Jews living abroad even more

comfortable and complacent than ever after World War Two, even with the holohoax legend being promoted endlessly.

And in the midst of the desert the Rothschild's grand project of Israel languished in spite of all the wealth being poured into it. Israel sat there as a ghost town with a skeleton crew. The Rothschild's orchestrated both world wars along with impossible reparations on the German nation. The infinite cliché or slogan was "WWI prepared the land for the Jews, WWII prepared the people for the land."

World War One, with all its bluster of the Balfour Declaration, had been a failure for the Rothschild's, with barely 80,000 Jews in Palestine surrounded by 600,000 Muslims and 70,000 Christians in the 1922 British census.

World War Two was an improvement for the Rothschild's, with the 1947 census showing 540,000 Jews surrounded by 1 million Muslims and 200,000 Christians, but Rothschild was expecting 6 million Jews, from all their efforts and expenditures, to be colonizing Palestine. Things were clearly not going to plan as all the Jews had escaped to the United States in spite of all the Rothschild's efforts to block them and force them to Palestine before and during World War Two. President Roosevelt blocked Jewish refugees from landing in America at the close of the war. Even worse the United States had become the land of milk and honey after the war. However, the Jewish population did increase to 1 million as of 1950 due to Russian Jews, so gains in colonization were made, but still 5 million Jews were missing from the target of 6 million, which would not be reached until the end of the 20th century. This time period also showed 3 million Palestinians in what had officially become Israel.

The goyim of the United States and the Jews farming these goyim were in a state of such prosperity that the very idea of leaving this paradise was considered insanity and Jews all over the world, including those in Palestine, were clamoring to get to the new Promised Land with endless fields of prosperous goyim to farm for unlimited wealth and prosperity.

As of 2014 6.1 million Jews live in Israel but they are becoming outnumbered by Palestinians who have 4.4 million in Israel and an additional 5.5 million in refugee camps and surrounding countries, wanting to get back into Israel when they have the power to do so. Today, they number 7 million Jews in Israel. Isaiah 66:8 as a prophecy holds a much different understanding as a link to the Rothschild's as the *'Renegade Tribune'* is quick to note.

Immigration contributed greatly to the rapid growth of Israel's Jewish population, but today it is estimated that more than half — about 58 percent — of the world's Jewish population lives outside Israel, mainly in the US, at about 40 percent, followed by France, Canada and Britain, each under 4 percent. As large-scale Jewish emigration from these developed countries to Israel is considered unlikely, most of Israel's current and future demographic growth will be the result of natural increase.

The Palestinian population is outgrowing the Jewish population and has been for quite some time. The Palestinians procreate larger families. Projections indicate the Jewish population in Israel/Palestine will drop to 46% by 2035 from its 75% level of 2016.

Coincidentally the white population of the United States is expected to be under 50% by 2040, at which point many legacy aspects of the United States will have become unsustainable and undesirable to Jews, as the alien non-white population and blacks takeover all major areas and cities and force white flight to occur en masse. It is quite possible the stage has been set for Israel to look very enticing to Jews in the U.S.A. right when Israel will need an infusion of Jews the most. The New York boroughs of Brooklyn and the Bronx are hot spots of tension between Jews and Muslims.

If we study history with a close eye on the demographics of Israel, we will find the chance of bad things happening to the Jews' favorite human cattle farmlands (the white nations) has a very large chance of increasing the more dire Israel's Jewish population problem becomes, so the coincidence factors of this combined demographic data are very likely not a coincidence.

What is also significant is that the Rothschild's are most likely the actual Learned Elders of Zion and have a reputation for planning ahead in terms of not only decades but centuries, so this would indicate this plan has been in progress for a very long time already with the 1960's being a likely starting point for this phase of a world population terra-forming project by the Learned Elders of Zion a/k/a the Rothschild's.

The only real question is what gimmick will the Rothschild's employ to get the Jews to move to Israel when they are loath to do so? The two world wars were not terribly effective for the amount of effort involved, so it seems that the current favorite is pouring vinegar in the milk in the promised land of milk and honey in the form of the 1965 immigration act, civil rights, drugs and every other effort the Rothschild's can devise to coax the Jews to Israel.

The migrant and refugee epidemic in Europe stemming from the 9/11 False Flag 17 year War on Terror may be an impetus to get Jews to Israel, while at the same time annexing and balkanizing Arab territory in the Middle East for the final Greater Israel expansion plan. Continued weakening of their Arab enemies will make escalated military action and genocide of the Palestinians a viable military solution to their monolithic Jewish-only goals for the population of Israel.

It would seem that the Rothschild's are trying to corner the Jews like rats in a maze and force Israel to look like appetizing cheese by poisoning every white country simultaneously to the point of it becoming unsuitable for Jewish human cattle farming. Much of the present-day influx of Muslims is in fact part of the effort to drive the Jews back home to Israel. The Rothschild's use their lieutenant George Soros as their cut-out using money to get Muslims to settle in the U.S. They know this mix like oil and water doesn't. This replacement of entire populations is Luciferian; however few can grasp the big picture.

It might sound strange to think that all this suffering being inflicted on the goyim might actually have very little to do with the goyim at this point, as the Rothschild's seem quite confident in their absolute mastery over all the world's races with one exception – the Rothschild's complete inability to get the Jews to move to Israel.

The Jewish *‘Daily Forward’* reported a talk given by Chabad Rabbi Mani Friedman. And when asked how he thinks Jews should treat their Arab neighbors Friedman responded, *“The only way to fight a moral war is the Jewish way: Destroy their holy sites. Kill men, women and children (and cattle).”*

From all that I have shared in this chapter, consider where does this put President Trump in the picture of the forces of evil at work. Is Donald J. Trump really God’s chosen president, or perhaps are their other subtle forces at work on behalf of the House of Rothschild?



In chapter 2, I identified the 189 countries that have a Rothschild-owned or controlled central bank.
