

There Are No “Statute of Limitations” On FRAUD!

Part 4

Unveiling all of what has been well-hidden for decades, is a methodically orchestrated revelation, where timing has been everything. As I have noted, I began following “Q” posts and drops back in late 2017, as it was being referred to by sites such as Infowars.com with Alex Jones and Dr. Joseph Corsi, Dave of X22 Report, Jason Goodman, and other patriotic alternative right news sites. At first, I considered them to be something of a hoax or game being played on the Internet.

The question “Who is “Q” appeared on various sites. What convinced me somewhat that there was something about this that seemed to ring true, and that someone was sending a message to us, was that of a picture taken from inside Air Force One. A close up photo showed the cabin window, and clouds that indicated it was in the air somewhere. Framed in the picture was the left arm of a suit, which revealed the cuff of a white shirt and the wrist area. The cuff links on the shirt had the initials DJT, assumed to be that of President Donald J. Trump. The window in the back-ground showed a portion of the Presidential shield on the sun screen that appears when lowered to the closed position. This confirmed that “Q” was someone aboard Air Force One while in flight, and likely in the Presidents aerial office of Air Force One. Although persuasive, and almost convincing, I have seen “Q” posts that have also raised red flags.

I am re-writing portions of this chapter on the “Biggest Story of 2019, and this century,” because I have serious reservations about “Q”. In the process of researching various videos, articles, and so-called interpreters of “Q” posts and drops, it has led me to change my mind. After several days of researching, I have come to the conclusion that “Q” has been one huge Psyops ambush being deliberately waged as some sort of CIA masquerade. **Intuition tells me that “Q” is a Psyops deception being foisted upon the Internet community.** What’s a “Psyops” you ask? Psychological operations (PSYOP) are planned operations to convey selected information and indicators to audiences to intentionally influence their emotions, motives, and objective reasoning which ultimately leads to a changed behavior of governments, organizations, groups, and individuals. I am not saying that “Q” posts and drops are false information. To the contrary, some may be true, but not all might be correct or true. I do suggest caution be followed in reading “Q” posts and drops.

The entire “Q” phenomenon has spread far and wide. Several have postulated that “Q” is John Kennedy, Jr., based on photos of an individual who kept showing up in disguise at Trump rallies. This conjecture ignores the “Gemstone Files” in which JFK Jr. was given evidence confirming the names of those people responsible for the assassination of his father, and former President of the United States of America. The speculations reflect an absence of knowledge on the part of those trying to infer that JFK Jr. is still alive. This is not so!

The 38-year-old Kennedy was killed to silence him - and to keep him from bringing his dad's TRUE assassins to justice, charges Utah businessman True Ott. *"There is no doubt whatsoever, why John was killed,"* reveals Ott, who secretly obtained the file and says he then gave it to JFK Jr. "It was NOT an accident!" JFK Jr., his wife Carolyn and her sister Lauren died when the plane he piloted plunged into the ocean on their way to a family wedding on Martha's Vineyard on July 16, 1999. It is wishful thinking at best to believe JFK Jr. faked his death. With that bit of history off the table, I will minimally explore the reasons why I believe a Psyops game is being played out on a number of well-known names in Internet news.

We all know that President Trump sends "tweets" out to his followers at all hours of the night. A few months ago, while campaigning for various Republicans who were running for re-election in the mid-term elections, President Trump noted "Q" by saying that he saw a number of "Q" followers in the audience thereby acknowledging "Q" was real. When the President even acknowledges folks in the audience who were wearing T-shirts, and jackets emblazoned with large "Q's" on them, this has not helped our collective discernment.

The "offline for a reason" statement by "Q" was the first time my "flag was raised" over a question pointing to the fact that "Q" had been quiet since December 22, 2018. Then on January 5th, 2019, "Q" spoke once again. Posts #2643-#2646 were posted. To read the "Q" posts live, go to the website – <https://qposts.online>. This is a complete file of "Q" posts and drops in order of the most recent. "Q" post #2643. *"It is about FBI Mueller and his attempt to stall for time on Joseph Corsi's law suit against Mueller. The Corsi suit was a few days ago and Judge Leon denied Mueller's attempt to stall for time. Mueller pressured Joseph Corsi to lie and Corsi refused. Corsi then filed a \$350-million dollar lawsuit against Mueller. FBI Mueller is likely to be found guilty of prosecutorial misconduct, and thus lose any credibility in the Mueller witch hunt against President Donald J. Trump"*

About the same time, I read that other fake "Q's" were posting in an attempt to either debunk the real "Q" or to act as disinformation with the goal of discrediting whoever "Q" really is when "Q" is posting and dropping a variety of cryptic messages. A web site "Q" Anon posts & drops at <https://qposts.online> contains the complete list of "Q's" posts. They numbered to 2,642 as of my last check.

That said, regardless of what we believe about "Q", the 71,000+ sealed indictments are genuine indictments. The reactions of key Bush family members and various individuals were video-taped at the funeral of George H. W. Bush. Each of their reactions was clearly noticeable and they were visibly affected as cameras were trained on them while they opened their envelope. The facial reactions of the immediate family of the deceased president clearly revealed apparent shock and their facial expressions were completely unrelated to that of grieving family members attending a funeral.

George W. Bush received a note from a Secret Service person at his father's funeral, most likely saying that he was under arrest

(video here: <https://www.youtube.com/watch?v=G1MDbiyQ80g>) . He shows the note to wife Laura (who looks like she is ready to cry) and brother Jeb (who looks like he's ready to faint). Searching the Twitter accounts of some of the top evildoers, here is the list of each criminal's last day of posting on Twitter:

- Hillary (Rockefeller) Clinton: January 12, 2018
- Michelle (Michael) Obama: December 19, 2018 (normally posted every 2-3 days)
- George W. Bush: his Twitter page has been deleted (is he already dead?)
- Laura Bush: October 11, 2018, about a month after the arrest and condemnation to death of George H. W. Bush, her father-in-law.
- Donald Rumsfeld: June 12, 2018
- Joe Biden: December 21, 2018
- George Soros: December 15, 2018
- William (Rockefeller) Clinton: December 21, 2018
- Peter Strzok (FBI): August 13, 2018
- Huma Abedin (Hillary's secretary and lover): September 2, 2018
- Cindy McCain (daughter of John McCain): December 18, 2018

Our readers are aware of the fact that John McCain (the co-founder of ISIS/ISIL/Daesh) was condemned to death and was executed by lethal injection a few months ago. It focused on the Trump appointment of General Mark Milley as the next Chief of the Joints Chiefs, and it contained several posts by "Q" about a coming Martial Law and mentioned special envelopes that were included in the funeral program of George H.W. Bush. The envelopes were given to former presidents and their wives, with one lone exception, that being James E. Carter and his wife Rosalind. Video taken at the funeral in the National Cathedral revealed troubled facial reactions by those receiving these small envelopes. Former President Jimmy Carter appeared baffled as he looked through his funeral program after having taken notice of others who received small envelopes but not him.

My after thoughts about the envelopes in the funeral service program is that it was not so much about what the small envelopes contained, as much as it was more about capturing the physical and facial reactions of those while they were receiving their envelopes and recording this on video tape.

Those receiving small envelopes included the Obama's, the Clinton's, George W. Bush and his wife, Jeb Bush and his wife, Vice President Pence, Vice President Biden. A "lip reader" read Laura Bush as she turned to George W. Bush, and asked him, "*Is this true?*" George W. then said, "*Yep!*" Several Internet sites have offered their interpretation of the events recorded on video (filmed in the National Cathedral), and all sites drew similar conclusions: the mourners were clearly affected by the contents of the envelope. Jeb Bush appeared to be the most affected.

I viewed the official public 4-1/2 hour video of the funeral train coverage to its destination for internment. The Union Pacific Railroad says the special Bush Funeral Train will run from its Westfield Auto Facility at Spring, Texas, on the north side of Houston to College Station at a location across from Kyle Field. The special was scheduled to depart at 1 p.m. and arrive 70 miles later at 3:25 p.m. The train is the last portion of the multi-day funeral that begins in Washington, D.C., and moves to the Bush family church in Houston on Thursday.

Meanwhile, over the weekend, the Union Pacific hustled to paint SD70ACe No. 4141, painting it like Air Force One and named it for Bush and his presidential museum and library. It was taken from storage in North Little Rock, Ark., and moved to Houston, where the specially painted veterans unit No. 1943 led the funeral train which traveled from Council Bluffs, Iowa, to Houston.

The Union Pacific Railroad hauled the Bush Funeral Train from College Station, Texas to Spring, Texas, 70 miles southeast. The Bush casket was then placed in a Union Pacific baggage car, with its doors opened, but were covered with a laminated Plexiglas viewing window designed to protect the casket from the rain, while permitting a public viewing as the train

made the journey to its final destination. The Union Pacific provided an additional 11 or 12 railroad passenger cars which were reserved by the railroad for special occasions such as railroad business trips when touring the Union Pacific Railroad system for family, friends, and dignitaries who would also be attending the former President's funeral. A camera was mounted on the handrail stanchions just behind the cab portion of locomotive number 4141. During the first portion of the trip the camera was facing toward the train. At about the halfway point in the trip, the camera was turned in the direction of the locomotive's movement.


The locomotive was painted to resemble Air Force One, but George H.W. Bush joked that if it had been around during his presidency, he may have preferred to ride the rails rather than take to the skies. *"I might have left Air Force One behind,"* Bush quipped during the 2005 unveiling of 4141, a blue and gray locomotive commissioned in honor of the 41st president and unveiled at Texas A&M University.

On Thursday, that very same 4,300 horsepower machine was carrying Bush's casket, along with relatives and close friends, for approximately 70 miles (113 kilometers). The journey through five small Texas towns was expected to take about two and a half hours. It will deliver the casket from suburban Houston to College Station.



The entire distance of the 70 mile trip was lined with people taking pictures. Tens of thousands lined the right of way while police and highway patrol cars protected the many grade crossings along the funeral train route, see map below.

Other than the events that occurred inside the National Cathedral during the funeral service, where the service was held in Washington, D.C., one would not have observed anything unusual that would indicate anything was wrong in the events that had lead up to a former president's funeral service.



The rail route from Spring, Texas, to College Station is approximately 70 miles long and takes about 2½ hours to travel.

The map shows the Bush funeral train route and burial events scheduled for Thursday. Bush, who died at his Houston home at age 94, was eulogized Wednesday at a funeral service at the National Cathedral. By evening, his casket was at St. Martin's Episcopal Church in Houston.

There have been at least two Internet sources stating that George W. Bush provided testimony that exposed the "Deep State," in an effort to procure a lenient sentence for himself and so gave authorities all they wanted to learn and know. Late last year, former President George W. Bush stayed at the Blair House, and had a meeting with President Trump. It was in that meeting that he revealed his father's the dirty laundry and that of Dick Cheney as well. It seems Bush #43 was seeking the best deal he could get in advanced of the war crimes trials.

Many are unaware that George W. Bush purchased 98,840 acres of land in in Chaco, Paraguay. The purchase raised questions back in October of 2006 when it became known. Bush is remembered, either for his public life, or for what most of the public do not know him for, as was revealed in Part 3.

No one will ever say that George H.W. Bush received anything less in the way of respect and honors in that which was given in remembrance to his office as the 41st President of the USA. The last funeral train for a president was in 1969. Presidential funeral trains began with William Henry Harrison in 1841 and ended with Dwight D. Eisenhower in 1969, according to Bob Withers' landmark 1996 book, *'The President Travels by Train.'* Abraham Lincoln's funeral train followed most of his 1861 route from Illinois to Washington, D.C., in reverse and lasted almost two weeks. Franklin Delano Roosevelt's 1945 funeral train traveled from Warm Springs, GA., to Washington, D.C. and was perhaps the best known of these moves that have been forgotten by all except presidential history fans.

Bush campaigned by train in the Midwest and Southeast in his unsuccessful re-election bid for the White House in 1992. For that train a CSX unit was repainted 1992 and emblazoned with a giant American flag on its sides.

The funeral train has been part of the official planning for his death for years, Bush spokesman Jim McGrath said. *"Union Pacific was contacted by federal officials in early 2009 and asked, at Bush's request, about providing a funeral train at some point,"* company spokesman Tom Lange said. *"We said, 'Of course and also we have this locomotive that we would want to have obviously be part of it,'"* Lange said. He noted that trains were the mode of transportation that first carried Bush to his service as a naval aviator in World War II and back home again.

Eisenhower was the last president to travel by train regularly. A key reason was his wife, Mamie, who hated to fly. During the 1952 campaign, Eisenhower traveled more than 51,000 miles and made 252 stops. And while he often flew, his wife rode the train the whole time, Union Pacific said.

Still, when Bush beat Democrat Michael Dukakis and won the presidency in 1988, both candidates used trains to make some campaign stops. Bush also occasionally traveled by train in 1992, when he was defeated by Democrat Bill Clinton, including making Midwest stops aboard a train dubbed "The Spirit of America."

Years ago I read Webster Tarpley's 1992 book, *'George Bush: The Unauthorized Biography'*. Professor Tarpley actually became known as the result of his work on former President George H.W. Bush. As many historians know, most heads of state and leaders are blended and mixed personalities, and such was the case in the life of George H.W. Bush. In addition, their ability to communicate to other members of the satanic deep state has been cut according to this General who has provided good intelligence to Tom in the past. At the close of the presentation, the form used to complete the certification process for a “Concealed Carry” permit was posted for my printer, completion, and was to be returned with a payment of \$65. My wife was texting back and forth with our daughter-in-law. She had just sent my wife a text saying that she passed her “Board Exams” for her Ph.D. work. Jokingly, I said to my wife to tell her that I had also passed an exam of my own moments earlier. I went into the living room and my wife was in a state of mild shock! She had just received a text that stated that I [she] needed to complete the paperwork and attach a check for \$65 and mail it in. Now, how is it that my wife received a text on her Facebook page yet she has never searched for information on a gun, or a license, etc.

I am not on Facebook, never have, and never will be. The common link is that we have Wi-Fi in our home, and Facebook listens in on verbal communications without our knowing it. I have enough friends and IT contacts to know with absolute certainty, that we are being surveilled even when we are not engaged in person-to-person communications. My wife had not texted our daughter-in-law to tell her what I said to tell her. Yet she received notification on her Facebook page reminding her to complete the application process for a “Concealed Carry” permit. Her cellphone picked up and recorded my verbal statement to my wife without either of us knowing the cellphone was listening in on our conversation. My wife has a smart phone, and I don’t. She uses her cellphone as her computer and does all kinds of things with it, i.e., ordering, online banking, preparing her grocery list at Kroger’s, etc. My phone is a nine years old iPhone, and is just a plain cellphone for emergency need.

Then a few days later on January 10, 2019, I saw a report on Mike Adams Natural News site saying that Google has been busted for spying on your devices. Google has allegedly been tapping into the mobile devices of Android users’ to secretly record private conversations, in an article the ‘Sun’ reported.

According to the report, the technology giant’s Google Assistant — which works in the same manner as Apple’s Siri — purportedly records conversations without the user’s knowledge. Google has insisted that its new virtual assistant only switches on and commences recording when users say “OK Google.”

“We only process voice searches after the phone believes the hot word ‘OK Google’ is detected. Audio snippets are used by Google to improve the quality of speech recognition across

Search...[and] improving speech recognition against all Google products that use your voice," a company spokesperson said.

However, an investigation carried out by the British newspaper showed that Google's audio assistant jams up in some instances. The report noted that in some cases, just saying "Ok" in a random conversation will prompt the system to switch the phone on and record about 20 seconds of audio.

The system was also found to switch the microphone on as users go about their usual activities day-in and day-out. Once the virtual assistant finishes recording, the system uploads the audio files to its computer servers often referred to as "the cloud."

According to the report, these audio files can be accessed anywhere in the world as long as internet connection is available. This means that any device that is signed into a user's personal Gmail or Google account can access these files and allow the user(s) to listen to the recordings.

The audio recording typically lasts around 10 to 20 seconds on average. The tech giant has also been found to save text versions of private conversations. The report noted that these audio files will help artificial intelligence that is designed to oversee Google Home by teaching it how humans naturally communicate with each other.

The article confirmed that Google saves the users' voice search entry. The tech giant saves these entries to improve the system's search capacity and ad placement.

"Q" becomes a threat to all media outlets. If you Google "Who is Q?", the top results will be articles that call "Q" a conspiracy. As the awareness of "Q" increases, we can expect the media to attack "Q" and those who follow "Q" regularly. Here is an example of the Main Stream Media is attempting to warn viewers not to listen to anyone other than the MSM because it is dangerous to our system of government. "Q" uses different ways to validate his legitimacy.

One of the huge questions concerns where the gold is that President Trump will replace the Federal Reserve Notes with. These were notes that were issued by the Federal Reserve System. I wondered that as well; however, I have read *'Gold Warriors: America's Secret Recovery of Yamashita's Gold'*, by Sterling and Penny Seagrave. Part 3 of this series mentions Ferdinand Marcos as having recovered a portion of Yamashita's gold, buried in the Islands of the Philippines, during the waning years of World War II. Furthermore, "Q" has posted that we have the gold, and has stated this more than a few times.

Various authoritative sources familiar with the Japanese stolen gold, suggest there were upwards of 150,000 tons buried in the Philippine Island. It was apparently scattered around the jungle islands where the caves were often below sea level during high tide. Part 3 of this series confirms the existence of the Marcos gold and that it was used to finance many criminal

ventures by the Bush Crime Family. Two days before the destruction of the World Trade Center, people reported dump trucks entering and leaving the basement parking area of the twin towers and this went on for several hours and the dump trucks were riding heavy on their axle springs which is indicative of the fact that they were carrying a heavy load up and out of the towers. It took more than a month for the molten steel fires to go out in the basement the towers, and when they were finally able to remove gold and silver from WTC#4, only a small portion of what was reported stored there was actually recovered. Unknown to most people at the time, there was \$650 million in gold and silver was being kept in a special vault four floors beneath Four World Trade Center.

\$240 billion dollars in fraudulent Brady Bonds were issued under a national security directive by George H.W. Bush in September of 1991. They were 10-year Brady Bonds that came due and payable on September 12th, yet they were fraudulent bonds created for a national security event. The trial, confession, and lethal injection of George H.W. Bush noted that the U.S. Treasury had “clawed back” \$10-Trillion of Bush/CIA stolen assets. If the Trump presidency has recovered Yamashita’s Japanese stolen gold, then there is more than enough to eliminate the \$22-Trillion National Debt. This does not include the Nazi stolen gold of World War II, which ended up in the Vatican and Swiss banks of Switzerland. Victims of the Holocaust tried in vain to get restitution of stolen assets taken by the Nazis after the War in 1945.

Definition of Brady Bonds

Brady bonds are bonds that are issued by the governments of developing countries. Brady bonds are some of the most liquid emerging market securities. The bonds are named after former U.S. Treasury Secretary Nicholas Brady, who sponsored the effort to restructure emerging market debt. The price movements of Brady bonds provide an accurate indication of market sentiment toward developing nations. Most issuers were Latin American countries.

Brady bonds were introduced in 1989 after many Latin American countries defaulted on their debt. The idea behind the bonds was to allow commercial banks to exchange their claims on developing countries into tradable instruments, allowing them to get nonperforming debt off their balance sheets and replacing it with a bond issued by the same creditor. Since the bank exchanges a nonperforming loan for a performing bond, the debtor government’s liability becomes the payment on the bond, rather than the bank loan. This reduced the concentration risk to these banks. The program, known as the Brady Plan, called for the U.S. and multilateral lending agencies, such as the International Monetary Fund (IMF) and The World Bank, to cooperate with commercial bank creditors in restructuring and reducing the debt of those developing countries that were pursuing structural adjustments and economic programs supported by these agencies. The process of creating Brady bonds involved converting defaulted loans into bonds with U.S. Treasury zero-coupon bonds as collateral.

Brady bonds were mostly denominated in U.S. dollars. However, there are minor issues in other currencies, including German marks, French and Swiss francs, Dutch guilders, Japanese

yen, Canadian dollars, and British pounds sterling. The long-term maturities of Brady bonds make them attractive vehicles for profiting from spread tightening.

In addition, the payment on the bonds were backed by the purchase of U.S. Treasuries, encouraging investments and assuring bondholders of timely payments of interest and principal. Brady bonds are collateralized by an equal amount of 30-year zero-coupon Treasury bonds. Issuing countries purchase from the U.S. Treasury, zero-coupon bonds with a maturity corresponding to the maturity of the individual Brady bond. The zero-coupon bonds are held in escrow at the Federal Reserve until the bond matures, at which point the zero-coupons are sold to make the principal repayments. In the event of default, the bondholder will receive the principal collateral on the maturity date.

While Brady bonds have some features which make them attractive to investors interested in emerging market debt, investors are exposed to interest rate risk, sovereign risk, and credit risk. Interest rate risk is faced by all bond investors. Since there is an inverse relationship between interest rates and bond prices, fixed income investors are exposed to the risk that prevailing interest rates in the markets will rise, leading to a fall in value of their bonds. Sovereign risk is higher for debt issued by countries from developing or emerging countries, given that these countries have unstable political, social, and economic factors in terms of inflation, interest rates, exchange rates, and unemployment statistics.

Since emerging market securities are hardly rated investment grade, Brady bonds are classified as speculative debt instruments. Investors are exposed to the risk of the issuing country defaulting on its credit obligations – interest and principal payments on the bond. In view of these risks, emerging market debt securities generally offer investors a potentially higher rate of return than is available from investment-grade securities issued by U.S. corporations. In addition to the higher yield on Brady bonds, the expectation that the issuing country's credit-worthiness will improve is a rationale that investors use when purchasing these bonds.

Mexico was the first country to restructure its debt under the Brady Plan. Other countries soon followed including Argentina, Brazil, Bulgaria, Costa Rica, Cote d'Ivoire, the Dominican Republic, Ecuador, Jordan, Nigeria, Panama, Peru, the Philippines, Poland, Russia, Uruguay, Venezuela and Vietnam. The success of these bonds in restructuring and reducing the debt of participating countries was mixed across the board. For example, in 1999, Ecuador defaulted on its Brady bonds, but Mexico retired its Brady bond debt completely in 2003.

Certain key unknown figures in the Federal Reserve may have 'conspired' with key unknown figures at the Bank of New York to create a situation where \$240 billion in off balance sheet securities created in 1991 as part of an official covert operation to overthrow the Soviet Union, could be cleared without publicly acknowledging their existence. These securities, originally managed by Cantor Fitzgerald, were cleared and settled in the aftermath of September 11th through the BoNY. The \$100 billion account balance bubble reported by the

'Wall Street Journal' as being experienced in the BoNY was the tip of a three day operation, when these securities were moved from an off-balance-sheet to the balance sheet.

[As reported on page 12 of a Federal Reserve document] "In the absence of complete information on deliveries into and out of its account at BoNY on September 11, and as a result of its assumption of settlement fails on the starting legs of blind-brokered RPs, GSCC recorded (after the close of business on September 11) \$266 billion in transactions that apparently failed to settle.... Continuing connectivity problems prevented GSCC from giving BoNY delivery instructions after the close of business on September 11 and prevented it from acquiring information on activity in its account at BoNY during the day on September 12. Consequently, GSCC recorded \$440 billion in settlement fails as of the close of business on September 12." GSCC stands for Government Securities Clearing Corporation.

What appears to be the case is that the Federal Reserve imbalances reported on three consecutive days in the aftermath were largely concentrated at the Bank of New York, which is reported to represent over 90% of the imbalance, suggesting the Bank had been the recipient of massive fund transfers, and was unable to send out transfers. Overall transactions for the day of 9/11 were seemingly down even more significantly than volume, but the transactions that came in after closing were extremely large, averaging in size in packages or tranches of \$35 million or more each. This would be consistent with a hypothesis that \$240 billion of securities were being pushed surreptitiously into the money supply.

The Federal Reserve, without providing the detail required to substantiate its claims, would have the public believe that there were widespread liquidity issues, when in fact the issues were very concentrated primarily, if not singularly, in the BoNY, which has been the subject of an ongoing major money-laundering investigation for many years. These account balance issues resulted in the defacto expansion of the monetary supply, details of which are no longer reported by the Federal Reserve.

The reported cause of this market malfunction is seemingly suspect. By comparison, the Deutsche Bank which sat inside the World Trade Center reported no such account balance increase, and JP Morgan, the other of two clearing banks which uses the same traders and communications hub, reported no such increase in account balance. Additionally, while problems were being documented between the BoNY and GSCC, no other institution had those problems noted or similar issues.

There is a contention that at the core of the September 11th attack, someone was planning to cover the 1991 issuance of \$240 billion in covert securities used to finance the collapse of the Soviet Union. The facts surrounding the financial aftermath of September 11 suggest this is not only possible, but that reports describing the aftermath have deliberately been misleading.

- The US dollar money supply was significantly increased in the aftermath of 9/11

- The bank at the core of the illegal money laundering by ex-Soviet criminals was the source of the increased money supply (BoNY)
- The generally disseminated rationale for BoNY's operational problems seems to have affected no other bank in a similar manner or magnitude and is inconsistent with reports on the BoNY operations in the aftermath
- A key witness who might have provided insight into these issues is a statistically aberrant death
- The source of the BoNY's \$330 billion increase in assets is cloaked under the privilege of "private banking"
- The only alleged "severe" disruption to the financial systems was the Federal Reserve's account balance and the securities trading fails – both systems required to hide the laundering of \$240 billion in covert securities

This is not a 'proof' that \$240 billion was laundered, but it provides probable cause for paying serious attention. But keep in mind that the Federal Reserve System at the closing of daily activity, knows to the very penny, the total amount of money in circulation. That said, a discrepancy of \$240 billion sets off alarm bells at the highest office of the Federal Reserve as well as other key sites.

History has many interpretations, and this report has been just one of many – an interpretation pieced together from the bold admissions and revelations of insiders, whose stories have been ignored and suppressed by the major media organizations. It is an interpretation of history that suggests a few very determined men strove to change the world in defense of Western capitalism in ways which they felt needed to be hidden from the public. Whatever emotion or logic that was adequate to cause them to hide their actions from the public was not strong enough to prevent them from committing the acts.

When the World Trade Center towers were imploded, the \$240-billion Brady bonds went up in smoke with the 2,985 people who were vaporized or died on 9/11/2001. Collateral deaths as a result of various types of cancers are estimated to be close to a thousand at this point in time. The towers were vaporized by the explosive known as nanothermite or thermite.

Some theories about the controlled demolition of the World Trade Center rely upon the use of a speculative material called "Nanothermite". Nanothermite is basically regular thermite with the constituents (iron oxide and aluminum) mixed together more completely, using very small particles - even down to mixing together individual molecules. The close proximity of the particles means they combine more efficiently, and so the reaction is much quicker and more powerful.

One method by which nanothermite is believed to have been applied was in the form of a paint applied to floors at ten floor intervals. The paint was applied to the 17-massive core

columns via access through the many elevators located in the center of the WTC towers. Fuses and timers were then connected to a master controller/timer system exploding in such a pattern to appear the towers were exploding in free-fall time. Both towers were collapsed in their own footprint in under eleven seconds. This is virtually impossible without an intricate system of implosion.

This is the official summary of sealed indictments through the end of December, 2018. As shown in the lower right corner, the total is 70,887. Most will be prosecuted through Federal courts in the states in which the sealed indictments are filed by Federal District. Military War Tribunals will be held at Guantanamo, (Gitmo), Cuba.

“Q” sources said that Military War Tribunals would begin on January 2nd, 2019. However, other sources have indicated that the trials will not begin until the end of January. The process will be methodical and thorough, and for that reason we should not expect the proceedings to be as speedy as we might like. Keep in mind that there are at least 28 individuals faced with charges of treason, the highest crime in the United States. Consequential to crimes of treason, the accused face execution by hanging if found guilty.

Those monitoring aviation radar sites have reported the levels of flights in and out of Guantanamo Naval Base have been more than average. The picture on the next page shows the limited airport runway facilities. Taxi runway and storage of aircraft is limited at GITMO, and so flights in and out are tightly regulated to handle the high level being reported in January, 2019.

A little background on the FEMA prison barges is helpful since they were originally used by the New York City Department of Corrections. A few years ago there were around 800 prisoners floating on the East River, housed inside of the Vernon C. Bain jail barge (named for a warden who died in a car accident). The Department of Corrections used this to battle overcrowding in the Rikers Island jail complex, and has since 1992 when it built for \$161 million. The barge, which was built in New Orleans and brought here, sits approximately one mile west of the SUNY Maritime College.



The inmates on board were medium to maximum security prisoners, and were contained within 16 dormitories and 100 cells. There's also a law library, recreation rooms, and a basketball court on the top deck!

This wasn't the first of its kind in New York City, either... in 1989 (when there was an influx of arrests), the NY Times reported that locals were outraged when the city proposed "to moor a prison barge on the Greenwich Village waterfront for up to five years." Eventually, "the Army Corps of Engineers denied a permanent mooring application and issued a one-year permit instead" for the 386-inmate barge, called the Bibby Venture. At the time of their report, it was sitting abandoned and waiting to be transported to Pier 40 on the Hudson River. It is currently listed on the DoC's website as being closed, but when it was open it was referred to affectionately by inmates as the Love Boat—one NY Times article painted the scene:

The inmates on board are medium to maximum security, and are contained within 16 dormitories and 100 cells. There's also a law library, recreation rooms, and a basketball court on the top deck! We've reached out to the Department of Corrections with some more questions about this floating prison, and will update when we have more information.

"We live large on the barge," declared an inmate, Angel Velazquez, 37 years old, who smiled as he stood on the sunbaked recreation deck watching other prisoners play a loping game of basketball as a sailboat fluttered by on the water below.

The FEMA prison barge was sold to England by New York City DoC, and was subsequently acquired by FEMA and DHS.

Reports of an aircraft carrier being deployed to GITMO may not be exactly correct. The U.S. Navy currently has no deployed aircraft carriers in the Atlantic southern coast or in the Caribbean waters. The U.S. Navy has eight (LHA) Amphibious Assault ships, with flat tops for U.S. Marine helicopters and Vertical takeoff aircraft such as the Marine Harrier fighter-bomber, and the V-22 Osprey twin tilt-rotor aircraft.

The (LHA) Amphibious Assault ships carry a Marine compliment of approximately 2,500-3,000 U.S. Marines. At the time of this writing, the USS Kearsarge, similar to the USS Essex in the photo below, and the 22nd MEU, with 2,200 U.S. Marines were transiting the northbound corridor of the Dardanelles Strait, enroute to the Black Sea to make a port call in Bulgaria. The deployment of one of the eight (LHA) Amphibious Assault ships to GITMO is more suitable and practical for such a mission as prosecuting war criminals and inmates awaiting prosecution and/or sentencing.

As of Christmas, 2018, all Norfolk-based Navy nuclear-carriers were in port for normal maintenance, repairs, and those that were undergoing major repairs or needed a complete overhaul. None are in the Caribbean waters off Gitmo, Cuba or nearby.

It has been reported that President Trump has assigned Marine Corp 4-star General James Mattis to manage the operations of the incoming arrival of corrupt politicians that will be prosecuted at Gitmo, under the guise of a forced retirement as Secretary of Defense. Marine Corp General John Kelly and former Attorney-General Jeff Sessions were deployed to Gitmo to oversee the War Tribunals. Since Thanksgiving of 2018, there has been a lot of intentional misinformation put out to the media that has been used to provide cover for what “Q” refers to as “The PLAN”. President Trump has held several meetings with South Carolina’s Senator Lindsey Graham, and has included the Senator into the loop, to minimize any statements that would disrupt the execution of “The PLAN”. On July 30, 2018, an amended petition, The First Amended Petition, was delivered to U.S. Attorney Geoffrey Berman in Manhattan, NY. This First Amended Petition references all of the same evidence presented in their original petition, but also has added three additional federal crimes that the Lawyers Committee allege the submitted evidence shows were committed and which are related to the tragic events of 9/11.

The three new federal crimes are:

- Federal Law Criminalizes Acts of Terrorism Transcending National Boundaries
- Federal Law Criminalizes Providing Material Support to Terrorists
- Federal Law Criminalizes the Killing of a Federal Government Agent or Employee

It is important to raise awareness of this petition among the citizenry, because although federal law mandates that this evidence be presented to a grand jury for investigation, the DOJ will likely not do so without oversight from the public. In anticipation of this, the Lawyers Committee is now preparing a writ of mandamus to file with the court on September 10th, which in effect will sue the DOJ to compel them to carry out their obligations under the law. Just a few weeks ago the Southern District of New York Federal Court agreed to look at the evidence that was never seen by the Official 9/11 Commission.



World Trade Center Building 7

An honest investigation into the destruction of the World Trade Center is long overdue. For example, the 9/11 Commission completely ignored the third skyscraper to fall on 9/11, the 47 story WTC Building 7, which was not hit by an airplane. When the final report on Building 7 was finally produced in 2008 by the National Institute of Standards and Technology, the investigating authorities blamed normal office fires for its collapse.

However, Building 7 achieved the speed of free-fall acceleration while falling symmetrically through the path of greatest resistance into its own footprint, which has been acknowledged and verified by the NIST authorities themselves as shown in 'Stage 2' of Figure 2. NIST then obfuscated this fact in their report by averaging in the time associated with 'Stage 1' and 'Stage 3' to get average acceleration. However, Stage 2 is nothing less than proof of the use of demolitions to accomplish this otherwise unobtainable feat of physics known as free-fall acceleration.

The proof behind this statement is the fact that in order for a falling object to achieve free-fall acceleration, all available energy must be put into motion, with none of it being diverted to the removal of resistance. With 47 floors which were bolted and welded together, Building 7 provided multiple layers of solid resistance to be overcome by any falling mass, rendering the achievement of symmetrical free-fall acceleration impossible without numerous explosive devices perfectly synchronized to simultaneously remove the resistance which the floors provided. It should be noted that WTC #1 and #2 also collapsed in what is believed to be a "free fall" in 10 or 11 seconds, a clear indicator that 110 story high rise skyscrapers, were imploded.




Figure 3-15. Downward velocity of north face roofline as WTC 7 began to collapse.

Evaporated Steel

That this crucial evidence of free-fall speed collapse was omitted from consideration in NIST's final official report on Building 7 is, in itself, evidence of falsification. Yet this is only one of many examples of proof beyond a reasonable doubt which points to what was an inadequate investigation by government authorities. While debate on the internet raged for years over whether fires from jet fuel could burn hot enough to 'melt' steel columns, the evidence indicates that in small localized places the steel in the World Trade Center towers didn't just melt, but it actually boiled and evaporated.

This claim of extremely high temperatures, much hotter than can be achieved by office fires or the kerosene which was stored in the bottom of Building 7, can be attributed to numerous sources. One comes from professor Jonathan Barnett of Worcester Polytechnic Institute, who analyzed a section of steel from WTC 7 and said that fire would not explain steel members in the debris pile that appear to have been partly evaporated in extraordinarily high temperatures.

Another source can be attributed to civil engineering professor Abolhassan Astanch-Asl, with the University of California at Berkeley. He spent two weeks at ground zero studying steel from the buildings, one of which was a horizontal I-beam from WTC 7. Professor Astanch-Asl reported that “parts of the flat top of the I, once five-eighths of an inch thick, had vaporized.” This phenomenon would require temperatures of 5,182 degrees Fahrenheit.



Temperatures required to melt steel occur between 2,500-2,700 degrees F. Jet fuel, which is primarily kerosene, cannot burn much hotter than around 1,500 degrees F. Normal office fires are known to be capable of reaching temperatures of around 1,100 degrees F. Key to understanding how office fires could not have contributed to the collapse of Building 7, is the fact that steel has a terrific capacity as a heat sink. Heat applied to one section will travel and disperse that heat to whatever other steel it is attached to, necessitating many, many hours to achieve temperatures hot enough to even begin to bend steel, let alone melt it. Never in the history of modern architecture, before or after 9/11, has a steel framed skyscraper collapsed due to fire alone. Moreover, video evidence shows only a few small fires still burning at the time of Building 7's collapse around 5:20 pm on the afternoon of 9/11.

When steel is poured into ingot molds, the molds are then cooled to a temperature of about 1,300-degrees, at which time they will be placed into gas-fired “soaking” pits. Each soaking pit can hold a number of ingots depending on size and heat-treatment requirements. The molds are removed and then the red-hot ingots remain for various lengths of time according to their metallurgical requirements. The red-hot ingots remain standing in the soaking pit for up to 8 to 12 hours at a temperature of 1,200-1,300-degrees, and at which time the cover of the soaking pit is rolled away, then they are removed by overhead crane and moved to the rolling mill for semi-finishing as slabs, billets, or rounds. This is the intermediate phase of producing steel. From what I have shared proves airplanes did not bring the WTC towers down.

Each ingot is passed back and forth through a series of hot rolls to achieve the desired semi-finished shape size. Slab are then subsequently reduced down to either sheet-rolled coils or cut sheets of steel as specified for the customer's final production needs.

The point of sharing this information is to refute the deceptive lie that airplanes brought the WTC towers down. They were imploded! I have worked in steel mill production and know metallurgy, steel chemistry, and the government story is a fabricated lie!

Extremely High Temperatures

Evidence of extremely high temperatures is corroborated by multiple independent and government reports. In 2004 the RJ Lee Group issued its final report "WTC Dust Signature" in which it stated the lead must have become hot enough to volatilize (boil). Their initial report in 2003 explicitly referred to evidence of temperatures "at which lead would have undergone vaporization." For this to happen it would require temperatures of 3,180 degrees F.

Another scientific report was published by Brigham Young University Professor Steven Jones and seven other scientists entitled "Extremely High Temperatures during the World Trade Center Destruction." Using dust samples collected right after the collapse of the WTC buildings,

they reported finding “an abundance of tiny solidified droplets roughly spherical in shape” which were “iron rich.” The formation of iron rich spherules would have required temperatures of 2,800 degrees F, and the fact that they were spherical indicates they could have only been formed while falling through the air.

Using data obtained in a FOIA request, Stephen Jones and his coauthors also learned that the United States Geological Survey “had observed and studied a molybdenum-rich spherule”. Molybdenum has an extremely high melting point of 4,753 degrees F. Equally revealing is that although the USGS spent considerable time and study on the discovery of this molybdenum-rich spherule, it was not included in their “Particle Atlas of the World Trade Center Dust.”

More evidence of temperatures high enough to boil metal was brought forward by Dr. Thomas A. Cahill at the University of California at Davis. His Delta Group researched the light blue smoke rising from the debris field and discovered extremely small ultra-fine metallic aerosols in extraordinarily high concentrations. Dr. Cahill said “Ultra fine particles require extremely high temperatures, namely the boiling point of the metal.”

These facts are also substantiated by eyewitness reports and video evidence of molten iron at ground zero, both falling from the South Tower before it collapsed, and in the oxygen-starved debris pile for weeks after the attacks. “Firemen reported seeing “molten steel” running in the rubble like “lava in a volcano” for weeks after.

Government investigators at the National Institute of Standards and Technology (NIST) claimed they knew of no evidence that explosives had been used. But the facts show they actually ignored abundant evidence by qualified professional researchers showing the WTC

dust and smoke contained particles that could only have been created by extremely high temperatures, which office fires alone are simply incapable of producing.

For these reasons, and for many more which space here does not allow, a grand jury investigation with subpoena power into the destruction of the three World Trade Center towers is warranted. Three thousand licensed or degreed building professionals at “Architects & Engineers for 9/11 Truth” agree, as well as tens of thousands of their supporters (ae911truth.org). There also exists an encyclopedic collection of credible and well-referenced reports, books and video documentaries by respected researchers and authors which disprove the government’s official 9/11 story. Architects and Engineers for 911 Truth produced a video providing evidence that the official story of 911 never took into consideration.

The mass media will one day be excoriated, or worse, for not reporting all the factual and scientific evidence discovered by governmental and independent 9/11 investigators since that tragic day. It’s been said before, but it bears repeating: 9/11 changed everything alright, but so will the truth.
