

There Are No “Statute of Limitations” On FRAUD!

On Friday, September 25th, 2018, the Democrats led the country to believe they had President Trump over a barrel, and that the President had caved in on his determination to shut the government down until the Democrats were willing to come to the table and negotiate funding to build a border wall between Mexico and the US. The airline worker had been given the word that the shutdown of the government would be briefly stopped. Super Bowl ‘LIII’ is estimated to generate \$800-billion in business world-wide as a whole. It was agreed upon that nothing should blemish Super Bowl 53! The biggest event of the year would continue on February 3rd as scheduled, free of disruptions.

With a base price slightly higher than \$5 million in U.S. currency for a 30-second ad, the cost of Super Bowl commercials remains even with the previous three events. As of early January, most of the ad inventory had sold out, with a limited number of second-half advertisements still available.

Anheuser-Busch made its largest-ever advertising purchase for the Super Bowl, with a total of eight different commercials of various lengths (covering 5-and-a-half minutes of airtime) across 7 products, including three being advertised during the game for the first time.

Soaring TV revenue over the past half-century have goosed the value of NFL franchises. The Cincinnati Bengals sold for \$7.5 million in 1967. Today the average NFL franchise is worth \$1.9 billion. The NFL has turned into big business with some arguing that the NFL is all about the money. Football fans in St. Louis wouldn’t disagree after losing its franchise last month to Los Angeles.

Both BBC Sport and Sky Sports will broadcast Super Bowl LIII in the United Kingdom. In Canada, CTV (along with CTV2 and all TSN stations) will simulcast CBS’ broadcasting of the game. In Australia, the event will be broadcast on Seven Network and 7mate. TrueVisions’ flagship channel, True Sport HD will screen live in Thailand.

ATLANTA (FOX 5 Atlanta) - Many people are hoping to cash in on Super Bowl LIII. There will be tens of thousands of people in Atlanta and they're going to need a place to stay. So many folks are offering their homes, for a fee of course.

Kristina Hudson lives in midtown. She's hoping to rent it for about \$3,800 a night Super Bowl weekend so she's been sprucing it up. *"This is my primary residence, I live in it, so we want to make it fresh and clean, fresh paint, new sheets,"* said Hudson.

A lot of people have the same plans. Airbnb held a forum in Atlanta Wednesday night to talk about renting during big events and giving hosts some tips and tricks to opening up their homes to visitors. *"The big game is going to attract a lot of people and we're excited to see our hosts attract people from around the world,"* said Brandon Hatton with Airbnb. A spokeswoman for Airbnb says even though Super Bowl LIII is less than two weeks away, it is not too late to try and rent your place. In fact, they expect to see a surge in people looking for accommodations once we know the final two teams who will be playing.

As I saw it, Trump's decision to re-open the government for 3-weeks is a win-win situation. Super Bowl fans can expect busy but normal transportation for their big event. It will be a busy period at Hartsfield-Jackson International Airport just a few miles south of Atlanta. Atlanta has been the world's busiest airport by passenger traffic since 1998.

Hotels, motels, home rentals, driveways, and yards, all will be generating big bucks for their owners in this the yearly top revenue producing sports event. Government employees got paid, politicians and staffers got a breather from constituents, and nearly everyone saw their stress and blood pressure subside. Folks can thank President Trump for his class act regard for those in Law Enforcement and elsewhere in government when he could have simply waited out his opposition over at the House of Representatives. While Chuck Schumer and Nancy Pelosi showed their appreciation by verbally attacking the President's plan for a border wall, Las Vegas book-makers will continue to benefit from billions in gambling bets made on the outcome of the Super Bowl.

With all this underlying subterfuge going on in the background concerning who won and who lost, we move on to President Trump's nemesis. I am referring to the game between America's number one Mafia Princess and America's number one spokesperson for the Art of the Deal. She will soon join the others who are facing indictment for corruption, sex trafficking, pedophilia, money laundering, and Treason. Despite the beating he takes from the mainstream media on a daily basis, President Trump is not the most unpopular politician in America. It turns out that Nancy Pelosi is. A new survey of Americans finds the House Speaker — who considers herself an equal to the President — suffers from a -19 difference between total positive and total negative approval. The NBC/Wall Street Journal poll finds Pelosi enjoys a 28 percent positive approval rating, while suffering a 47 percent negative rating. That means she's under water by 19 points.

The *'National Journal's*, Josh Kraushaar notes the House Speaker's negatives "shot up" during the government shutdown, and she is now is the most unpopular politician tested in the

NBC/WSJ survey. The poll results are surprising given the generally positive coverage Pelosi receives from the mainstream media.

Senate Majority Leader Mitch McConnell's numbers are both lower, and his net disapproval is 18 points.

President Trump's positive rating is 39 percent, while his negative is 51 percent, for a net -12. It could be worse.

There is someone, however, who needs to be impeached, fired, and removed from office. This is a very particular leader in our country that is refusing to do the job that she was elected to do by the American people. Not only is she refusing to do her job, her policies are dangerous and treasonous to America. We can no longer sit idly by and be abused by this woman and her selfish ideas of how she thinks America should be run.

But many people that were most impacted by this temporary deal were Law Enforcement Officers (LEO's). The real issue at hand is identifying which side really has the best interests at heart towards the American people. Is it Trump or is it Pelosi? Who was willing to give in on what they were demanding in order to re-open the government so that the 800,000 federal workers who were not getting paid could receive their paychecks? Nancy Pelosi is not only a traitor to LEO's, she is a traitor to the American people. Let's look at the numbers.

These are the estimates from the Senate Appropriations Committee on the number of LEO's that were not getting paid while the government was shut down.

Law enforcement: More than 41,000 federal law enforcement and correctional officers were not getting paid, including:

- 2,614 Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) agents
- 16,742 Bureau of Prisons correctional officers
- 13,709 FBI agents
- 3,600 Deputy U.S. Marshals
- 4,399 Drug Enforcement Administration (DEA) agents
- Homeland security

Up to 88 percent of the **Department of Homeland Security** employees were not getting paid, including:

- 53,000 Transportation and Security Administration employees
- 54,000 Customs and Border Protection agents and customs officers
- 42,000 Coast Guard employees

President Trump's decision to sign a temporary deal to re-open the government without receiving House and Senate approval for the funding of the border wall shows how much

compassion he feels towards these federal employees. The complete unwillingness of Nancy Pelosi, Chuck Schumer, and the Democrats to negotiate over the past 35 days shows they don't care at all about the people who were still working but not getting paid to do their jobs. Worse than not caring about LEO's getting paid, Nancy Pelosi also votes and passes laws that are dangerous to our security as well as to the lives of LEO's.

At the same time, Pelosi, Schumer and all of Congress received their paychecks the entire time the government was shut down. Remember President Trump works for free because he donates every one of his Presidential paychecks; his motivation was not related to money.

Nancy Pelosi's Sanctuary Policies that provide aid, comfort, and protection to illegal aliens make it extremely difficult for LEO's to perform their jobs, yet they took an oath and swore to uphold and enforce the laws of this land. Shouldn't their needs be considered a priority over and above those of illegal aliens?

While accusing the Trump administration and ICE agents of carrying out "cowardly attacks" on illegal immigrants, in March, 2018, Nancy Pelosi issued a statement after the Justice Department filed a lawsuit against California, claiming that three recently passed state laws are deliberately interfering with federal immigration enforcement. Her disdain for ICE is obvious from the following statement.

"The people of California will not be bowed by the Trump administration's brazen aggression and intimidation tactics," the California Democrat said. *"Californians will continue to proudly keep our doors open to the immigrants who make America more American. We will fight this sham lawsuit and will fight all cowardly attacks on our immigrant communities."*

Nancy Pelosi clearly chooses illegals over ICE agents. Her support of sanctuary and protection for illegal criminals is truly unreal for an elected representative of the American people, and her treasonous behavior puts ICE agents in danger and makes their ability to do their jobs extremely difficult.

Perhaps one of the most infuriating examples of how Nancy Pelosi and her sanctuary policies have hurt LEO's is the recent murder of Corporal Singh. Singh was a legalized immigrant to the US and was living his American dream of being a police officer in the state of California. Corporal Singh was murdered by illegal alien, Gustavo Perez Arraiga, who was a dangerous gang member.

California's sanctuary law includes more than 800 exceptions for violent crimes and felonies and bars police from asking people about their citizenship status. These are laws that Nancy Pelosi supports because she cares more about illegal aliens than she cares about legal citizens or about LEO's being able to perform their jobs safely.

Do you know what Nancy Pelosi's response to the murder of Corporal Singh was? Nothing! Not a peep. No response to the murder of a legal immigrant who was serving the people of California as a police officer. Zero!

However, Nancy Pelosi did issue comments that day. She decried the deaths of two illegal immigrant children that died the same day, bashed the government shut down, and on New Year's Eve she promoted her upcoming MSNBC special.

Corporal Singh worked for Newman Police Department which was not far from her district in San Francisco. President Trump called the family of Corporal Singh expressing his condolences and again cried out for the need for a border wall and stressing the dangers of illegals.

At this point, can we just say that Nancy Pelosi seems to care less about lives of LEO's? To her, Blue Lives don't matter. It seems only illegal lives matter... or should we say illegal votes. I will go further. Nancy Pelosi needs to be arrested for treason!

This House Majority Leader, Nancy Pelosi, was first elected to the House of Representatives in 1987, some 32 years ago, and is now 78-years-old. The average age of retirement in the US is 62-years-old. Americans can start collecting Social Security at age 62. Yet Nancy Pelosi refuses to retire or to remove her grip from the powerful seat she seems determined to hold onto - California's 12th Congressional District. At this point, it would be easy for me to make a case for term limits for all elected Congressional Representatives. However in this case, I'm actually going to argue for a case of treason.

First and foremost, our elected Representatives take an oath of office swearing to support and defend the Constitution of the United States against all enemies, foreign and domestic.

5 U.S. Code § 3331 – Oath of office states:

"An individual, except the President, elected or appointed to an office of honor or profit in the civil service or uniformed services, shall take the following oath: "I, _____, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on which I am about to enter. So help me God." This section does not affect other oaths required by law."

This week on January 29th, Nancy Pelosi introduced new House Rules, deleting the phrase "*So help me God*" and the oath given before testifying in Congress.

Article 1, Section. 6 of the United States Constitution states this about why Senators and Representatives can be arrested:

The Senators and Representatives shall receive a Compensation for their Services, to be ascertained by Law, and paid out of the Treasury of the United States. They shall in all Cases, except Treason, Felony and Breach of the Peace, be privileged from Arrest during their Attendance at the Session of their respective Houses, and in going to and returning from the same; and for any Speech or Debate in either House, they shall not be questioned in any other Place.

According to 18 U.S. Code § 2381 – Treason is defined as follows:

Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States.

The U.S. Constitution and U.S. Code of Law tells us that treason is a serious crime, even punishable by death. There are only three crimes that United States elected Representatives of the House or the Senate can be arrested for: treason, felony, and breach of peace.

Given that Nancy Pelosi, upon taking her oath of office, swore to support and defend the U.S. against all enemies, why has she engaged in passing laws that provide Sanctuary to illegals, continue to oppose funding for a border wall to protect our national security, and obstruct any negotiations to fund the border wall thereby ending the government shut down? Let's break this down.

Nancy Pelosi is worth \$150-million and is elected to SERVE America and Americans, yet every decision she makes using American tax dollars, is about making sure our southern border is open to drug cartels, human trafficking, and a full on illegal invasion. Her salary as Speaker of the House is \$223,500. It was \$193,900 when she was the Minority Leader of the House of Representatives. She has raised hundreds of millions of dollars for the Democratic Party. Since I monitor both Democratic and Republican web sites, I get as many as two requests a day from sites bearing her name, asking for \$1 from me. The ads plead urgency and desperation for the Democratic Party. They are just as bad for the Republican pitches seeking contributions. Back in 2012, Nancy Pelosi was taken to task by CBS '60-Minutes' for what amounted to as insider trades in at least 6 IPO's. An IPO is an "Initial Public Offering" of a stock that goes public.

In the state of California, she is a major ring leader of the political organized crime ring that is destroying the beautiful state of California with their traitorous Sanctuary policies. These anti-American policies are designed to destroy the state and our country financially, guarantee illegal Democrat votes, and ruin beyond repair the sovereignty of the United States of America!

Not only that, but Nancy Pelosi voted "Nay" on H.R. 3004 "Kate's Law", which was a bill that increases criminal penalties of undocumented immigrants reentering the United States after being deported once already. 



The **Mala del Brenta**, also known as **Mafia veneta** (*Venetian mafia*) or **Mafia del Piovese**, is an **organized crime** group based in the Veneto and Friuli-Venezia Giulia, north-eastern Italy.

The criminal organization's structure is like a **Cosa Nostra** and **Camorra** model, but more violent.^[1] It is considered by the Italian government and Prefecture of Venice as including all the characteristics of *Article 416 bis-cp*,^[2] the legislative definition of a mafia-type organisation with Mafia (**Cosa Nostra**, **'Ndrangheta**, **Camorra**) affiliations within Italy.^[3]

The “MAFIA-like brotherhoods” throughout the Middle East that formed before those in Northern Italy were the original terrorist groups which have operated over millennia. The Northern Italian banksters simply perfected the art of terrorism since they had the money to do so. After all, taking down the Twin Towers right into their own footprint took a big chunk of change (Yes, we know Israeli-Saudi connection, but they were merely the hitmen and bagmen, respectively, for the all-powerful **Black Nobility**).

Baltimore, Maryland

There's no question that Maryland was the state the Roman Catholic Church essentially took over as soon as it was identified as the only safe haven for Catholics in the 13 colonies.

"One of the original Thirteen Colonies of Great Britain, Maryland was founded by George Calvert, a Catholic convert who sought to provide a religious haven for Catholics persecuted in England."

Baltimore, in particular, was the hub of Catholic activity in the beginning days of Maryland. The Carroll family was the largest and richest land owners in the State of Maryland. Chief among them were three members of the Carroll family of Maryland: Charles Carroll, the only Catholic signer of the Declaration of Independence; his cousin Daniel Carroll; and Daniel Carroll's brother John Carroll, who became America's first Catholic bishop. At the time he signed the Declaration, it was against the law for a Catholic to hold public office or to vote. Although Maryland was founded by and for Catholics in 1634, in 1649 and, later, in 1689 after the Glorious Revolution placed severe restrictions on Catholics in England, the laws were changed in Maryland, and Catholicism was repressed.


"Maryland has been historically prominent to American Catholic tradition because the English colony of Maryland was intended by George Calvert as a haven for English Catholics. Baltimore was the seat of the first Catholic bishop in the U.S. (1789), and Emmitsburg was the home and burial place of the first American-born citizen to be canonized, St. Elizabeth Ann Seton. Georgetown University, the first Catholic University, was founded in 1789 in what was then part of Maryland. The Basilica of the National Shrine of the Assumption of the Virgin Mary in Baltimore was the first Roman Catholic cathedral built in the United States, and the Archbishop of Baltimore is, albeit without formal primacy, the United States' quasi-primate, and often a cardinal. Among the immigrants of the 19th and 20th century from eastern and southern Europe were many Catholics."

This is where the D'Alesandro family set up shop — Baltimore, Maryland — so that daughter Nancy could be groomed for high office. In point of fact, her otherwise improbable ascension within the House is a clear indication that the Black Nobility has taken overt control of the U.S. Corporation. Maryland was settled by the Catholics so that the Jesuits would be close to the locus of power in America. The Jesuit's Georgetown University is the premier law school and school for international relations in Washington, D.C. and is attended by many of the elites since its founding. Early life and education

Pelosi was born in [Baltimore](#) to an [Italian-American](#) family, the youngest, and only girl, of seven children of Annunciata M. "Nancy" D'Alesandro (née Lombardi),^[7] and Thomas D'Alesandro Jr.^[8] Both of Pelosi's parents had Italian roots.^[8] Her mother was born in [Campobasso](#),^[9] in [South Italy](#), and her father could trace his ancestry to the Italian cities of Genoa, Venice and Abruzzo.^[8] When Nancy was born, her father was a Democratic Congressman from Maryland and he became [Mayor of Baltimore](#) seven years later.^{[8][10][11]} Pelosi's mother was also active in politics, organizing Democratic women and teaching her daughter the value of social networking.^[2] Pelosi's brother, [Thomas D'Alesandro III](#), also a Democrat, was Mayor of Baltimore from 1967 to 1971.^[12]


Pelosi and the U.S. presidency

Her transportation, liquor, and food bills to the U.S. Air Force were obscene for a ranking member of the house living on the public tax payer dole!

House Speaker Nancy Pelosi's use of military aircraft came under scrutiny last week after President Donald Trump **cancelled her congressional delegation** trip to Belgium, Egypt, and Afghanistan.

Pelosi's use of government aircraft is not new. In fact, documents obtained and released by government watchdog Judicial Watch last week reveal the extent to which Pelosi has used military aircraft in the past, costing taxpayers millions.

What are the details?

One trip in particular — to Milan, Rome, Naples, and Kiev — has received considerable scrutiny. The 2015 trip, from July 30 to Aug. 6, cost the Air Force \$184,587.81, documents obtained via the Freedom of Information Act show.

Pelosi, along with several other Democratic members of Congress, made the trip with members of their families.

We're finally getting a fuller picture of how much Nancy Pelosi's travel expenses are costing the American taxpayer, and it's not a pretty sight. For starters, in one two-year period Pelosi set the United States Air Force back \$2,100,744 in travel costs.

Judicial Watch, the group that obtained these documents through Freedom of Information Act requests, reveals that the average cost for Pelosi to fly back to her district is over \$28,000 *per flight*. To put that in perspective, a single economy seat from Washington, D.C. to Pelosi's home of San Francisco cost roughly \$250. Although a five-figure domestic flight seems absurd, it isn't the most questionable expense of those two years.

Over \$100,000 was spent on in-flight expenses, which included food and alcohol. Although this sum wasn't spent entirely on booze, one example of an impressive liquor store **receipt** would make a fraternity house green with envy.

Yes, you're reading that right. Cognac, Johnny Walker, two bottles of Grey Goose, and more — all paid for with the taxpayer's dollar. Who says Democrats can't have fun? When the flights go international, things get even more expensive.

The average cost of an out-of-country congressional delegation (CODEL) is over \$200,000. The **Brookings Institution** confirms that while some of these CODEL's are useful and beneficial, there is also the potential for abuse.

Do you think these travel costs are excessive? This likely comes as a natural result of spending someone else's money.

Another trip exposed by **Judicial Watch** is a 2015 tour of Italy and the Ukraine. Pelosi and a few fellow representatives brought their spouses on this trip. And what a trip it was — the itinerary reads like a whirlwind tour of cosmopolitan Italian cities, complete with fine dining. Compared to previous CODELs, however, this was an outright bargain at just over \$134,000.

Democrats are not the only ones taking these trips. According to **USA Today**, four GOP congressmen spent \$90,000 on a trip to Albania. A high number, but still practically rookie numbers compared to Pelosi's expenditures.

While congressional delegations play an important role in our nation's diplomacy, the excesses need to stop. Given the fact that lawmakers are safely using taxpayer money for the trips, this is not likely to happen anytime soon. Would flying coach kill them?

Guzmán, 61, has been on trial in Brooklyn since November after he was extradited from Mexico to face charges of trafficking cocaine, heroin and other drugs as leader of what the US has called the world’s largest drug cartel.

The timing of the former Mexican President’s connected with Mexican cartels is rather significant. A former Democrat believes the real reason that Democrats don’t want a wall on the US – Mexican border is related to the story. Jeffrey Peterson says the real reason the Democrats will never support the border wall – is that they are being paid off by the Mexican cartels.
