

There Are No “Statute of Limitations” On FRAUD!

Part 9

Right from the beginning in Part 1, I’ve been saying that this is the **“Biggest Story of the Year, If Not the Century.”** To be honest, I did not expect that it could get much bigger than what I had to share back several chapters ago, but it is a very complex puzzle and you will be utterly amazed by what this segment reveals. You will be impacted by what is coming very soon. This will without a doubt add another dimension to the Reset coming to all of our lives.

In the past few days, suddenly the internet is abuzz with speculation that “Q” is actually John F. Kennedy Jr. The claim is that he faked his own death in 1999 and was close friends with Donald Trump. The evidence continues to accumulate to this truth!

There are many things that have been revealed since the announcement of Donald Trump’s candidacy in June of 1996. Whether one likes President Trump or not, he was selected by a cadre of loyal American Patriots in our military, who have taken their oath of office seriously and pledged their all to restoring the Constitution, the Rule of Law, and re-establishing our Sovereignty once again, which had been surrendered when President Woodrow Wilson surrendered our Sovereignty to the International Bankers led by the House of Rothschild. When I first saw the photo of President Trump sitting at his desk in the Oval Office, and seeing the portrait of President Andrew Jackson just to his left, what was about to unfold dawned on me and the whole picture came alive. His referral to the “PLAN” and what it was all about suddenly made sense to me. For most of you, unless you knew how this country has been ripped off by the Rothschild’s you would not understand the importance of what is in play here.

In a previous segment I noted that a forced military audit of the Fed revealed a stash of **\$800-Trillion dollars**. Since the Federal Reserve took over the nation’s currency and credit in 1914, the Fed has robbed and pillaged the nation to the tune of **\$800-Trillion dollars**, an amount that has left anyone with an understanding of the nation’s currency system in shock! We knew the Fed had a slush fund, known as the **“Exchange Stabilization Fund.”** However, no one had any idea about how extensive it was. Since 1914, the Federal Reserve System has stolen **\$800-Trillion dollars** from the American people.

It is impossible to understand the world today without knowing what the (ESF) is and what it has been doing. Officially, the Fed was in charge of defending the dollar, the (ESF) is the government agency which controls the New York Fed, runs the CIA's black budget, and is the architect of the world's monetary system (IMF, World Bank, etc.). Financing of the **“Exchange Stabilization Fund”** (through the OSS and then the CIA) has built the worldwide propaganda network up to such an extent that it has badly distorted history today (including erasing awareness of its existence from popular consciousness). It has been directly involved in virtually

every major US fraud and scandal since its creation in 1934: the London gold pool, the Kennedy assassinations, Iran-Contra, CIA drug trafficking, HIV, and worse... All presidents since Jimmy Carter and up to Donald Trump used the (ESF) to do whatever they wanted to do without the world knowing about it. When it comes to the fabled President's Working Group on Capital Markets, also known as the "Plunge Protection Team," the myths about the subject is certainly far greater than any underlying reality. So we thought. On February 7th, WikiLeaks revealed U.S. Military use of the IMF, World Bank, as "Unconventional" Weapons. That term "Plunge Protection Team" is a subtle reference to the fact that the government rigs the stock markets through its (ESF) funds to create boom or bust cycles. It uses the (ESF) to overthrow sovereign states, force regime changes, replace governments, etc.

In a leaked military manual on "unconventional warfare" recently highlighted by WikiLeaks, the U.S. Army states that major global financial institutions – such as the World Bank, the International Monetary Fund (IMF), and the Organization for Economic Cooperation and Development (OECD) – are used as unconventional financial "weapons in times of conflict up to and including large-scale general war," as well as in leveraging "the policies and cooperation of state governments." The manual is officially titled Field Manual (FM) 3-05.130, "Army Special Operations Forces Unconventional Warfare" and was originally written in September of 2008. The document is 248 pages long.

As to what is "Unconventional Warfare," it notes that the U.S. government applies "unilateral and direct financial power through persuasive influence to international and domestic financial institutions regarding availability and terms of loans, grants, or other financial assistance to foreign and state as well as non-state actors." It specifically names the World Bank, IMF, and The Organization for Economic Cooperation and Development, as well as the Bank for International Settlements (BIS), as "U.S. diplomatic financial venues to accomplish" such goals.

What does this mean? Though the unconventional warfare manual is notable for stating so openly that "independent" financial institutions like the World Bank and the IMF are essentially extensions of the U.S. government power, analysts have notated for decades that these institutions have consistently pushed U.S. geopolitical goals abroad.

Indeed, the myth of the World Bank and the IMF "independence" is quickly eroded by merely looking at the structure and funding of each institution. In the case of the World Bank, the institution is located in Washington, D.C. and the organization's president has always been a U.S. citizen chosen directly by the president of the U.S. In the World Bank's entire history, the institution's Board of Governors has never rejected Washington's pick.

In addition to choosing its president, the U.S. is also the bank's largest shareholder making it the only member nation to have veto rights. Indeed, as the leaked unconventional warfare manual notes, "As major decisions require an 85% supermajority, the U.S. can block any major changes" to the World Bank policy or the services it offers. Furthermore, the U.S.

Treasury Secretary, former Goldman Sachs banker and “foreclosure king,” Steve Mnuchin, functions as the World Bank’s governor.

Though the IMF is different from the World Bank in several respects, such as its stated mission and focus, it too is largely dominated by U.S. government influence and funding. For instance, the IMF is also based in Washington, D.C. and the U.S. is the company’s largest shareholder – the largest by far, owning 17.46% of the institution – and also pays the largest quota for the institution’s maintenance in IMF financial commitments annually. Though the U.S. does not choose the IMF’s top executive, it uses its privileged position as the institution’s largest funder to control IMF policy by threatening to withhold its IMF funding if the institution does not abide by Washington’s demands.

This manual serves as a salient reminder that the so-called “independence” of these financial institutions is an illusion and they are among the many “financial weapons” regularly used by the U.S. government to bend countries to its will and even overthrow U.S.-disfavored governments. Why is this so important to you, the American taxpayer? In Part 10, I will show the links and how we are paying for all this through the annual April 15th deadline date for filing your “income” taxes. It’s all part of the huge con game that rips American’s off year after year.

At the beginning of the Trump administration, I considered the task facing the President as something that was virtually impossible; that is, until we learned that he was recruited by a Patriotic Group of “Flag” officers, generals and admirals wanting to restore America’s Sovereignty. One of the reasons, among many now, that I have changed my view on the death of JFK Jr., his wife, and sister-in-law, is tied to a common signoff on "Q" posts and drops comes back to a bell that is found on the Kennedy family boat. The bell on the boat was engraved with a Kennedy expression.



"Q" frequently signs off his "Q" posts with the acronym WWG1WGA. *"Where We Go One, We Go All,"* and it was engraved on the bell of President Kennedy's Boat. This is an important indicator and a curiosity hard to ignore. Where have you ever heard that expression used? I am well read and I saw it as a unique term associated with the Kennedy family.

"Q" has called into Field McConnell at the Abel Danger site several times. In one of his calls to Field McConnell, the person in the room with Field McConnell said it was JFK Jr. in the background, not realizing the person's statement was picked up on Field McConnell's open mic! That's 2, and there are many more. I happened to be watching that program, heard it myself, and thought I was imagining it. After replaying that call, it seemed more as an off the cuff remark by Field's wife.

“Q” posts have so many references to the Kennedy’s that it resonates clearly that it is a member of the Kennedy family somehow associated with John Jr.

Other web sites have done computer facial recognition software in which facial hair is removed slowly so as to retain the original image with both side-by-side and overlaid images that offer perfect image matches even after 19 years when he was 38.

It was Liz Crokin who first suggested that **John F. Kennedy Jr. Faked His Death and Is Now QAnon**. There was an article by Kyle Mantyla - August 1, 2018 10:58 am: It reads:

Last weekend, right-wing “journalist” and fringe conspiracy theorist Liz Crokin did an interview with online psychic and YouTube host Jenny Moonstone in which she laid out her theory that John F. Kennedy Jr. faked his own death in 1999 and is now behind the QAnon account.

QAnon is an anonymous figure at the center of a right-wing conspiracy theory known as “The Storm” that alleges that high-ranking members of the Trump administration have been using the 8Chan forum board to drop hints revealing that Robert Muller’s special counsel investigation into Russian interference in the 2016 election is really cover for a secret operation to take down a global network of satanic pedophile cannibals. Proponents of this conspiracy theory have increasingly been making their presence known at Trump rallies.

In a video posted by Moonstone on Sunday, Crokin explained her theory that JFK Jr. has been running the QAnon account all along, insisting that any mockery she receives, or attacks she endures, for promoting her absurd ideas is proof that she is right.

Crokin asserted that when she first heard the theory of JFK Jr. being behind the QAnon account, “it immediately resonated with me, I got goosebumps everywhere. I’m a very intuitive person and usually when that happens, that’s confirmation that there is truth to it.”

“Q” at one point said, **‘You’re not going to believe who you are talking to here,’** Crokin said. “When Q wrote that, I thought it’s going to be someone that’s so crazy that even people that are woke and know what’s going on are going to be like, ‘Oh my lord, this is insane’ ... John F. Kennedy Jr., that would be shocking because we all think he’s dead.”

Crokin went on to assert that, as a writer, she has an amazing ability to understand handwriting and uncover the truth simply by examining the things that people write, which leads her to believe that JFK Jr. is, in fact, the main force behind QAnon.

“The one thing that always struck me about Q’s posts is the passion for John F. Kennedy Sr.,” she said. *“When I say passion, I’m talking the passion for JFK Sr. is so intense, I don’t see how this passion could come from anyone that: A) didn’t know him and B) didn’t love him. So you have to think about, well, who could that be? Well, if John F. Kennedy Jr. was still alive, that would make perfect sense.”*

"The way that "Q" talks about JFK Sr. in the posts, it is with such love and passion, it makes me think that it is someone that is close to him," Crokin added. "If JFK Jr. faked his death and was alive, it would make sense that he was "Q.""

This story even was mentioned in the 'Washington Post' and certainly got the attention of the Democratic Deep State. More importantly, it got eye coverage by others in the Clinton Cabal and the Obama criminal family.

A nagging story that goes back over a long period is even stranger. Note these three dates below and hold them in your memory as we find a common thread that is linked to Stanley Kubrick. There is an incredible message linking these three dates and events together.

- **July 16, 1969** - *"Apollo 11, the first mission to land astronauts on the Moon, is launched from the Kennedy Space Center at Cape Kennedy, Florida."*
- **July 16, 1999** - *"John F. Kennedy, Jr., piloting a Piper Saratoga aircraft, dies when his plane crashes into the Atlantic Ocean off the coast of Martha's Vineyard."*
- **July 16, 1999** - *"Eyes Wide Shut opened in the United States"...*

The Kubrick - Kennedy connection

Jay Weidner showed us that the movie "The Shining" is Stanley Kubrick's "veiled confession" of his involvement in staging the Apollo moon landings. President Kennedy created the Apollo program. JFK is represented in "The Shining" by Overlook Hotel manager Stuart Ullman.

Chartist Friend demonstrated that "Full Metal Jacket" is Kubrick's "veiled confession" of his involvement with the President Kennedy assassination hoax. JFK started the Vietnam War and he is represented in "Full Metal Jacket" by the Private Joker. Chartist Friend somehow concluded Stanley Kubrick believed President Kennedy somehow faked his death in 1963, despite evidence to the contrary.

In 1980 Kubrick used his movie "The Shining" to reveal information involving the Kennedy family and the Apollo program that he could not disclose publicly. In 1987 Kubrick used his movie "Full Metal Jacket" to reveal information involving the Kennedy family and the assassination of a wildly popular president that he could not disclose publicly.


On July 16, 1999, the EXACT SAME DAY JFK Jr. was killed in a plane crash, Kubrick released his movie "Eyes Wide Shut."



All of what the media said about JFK Jr.'s flying qualifications was either a lie or a huge distortion of the truth.

John F. Kennedy Jr. was married to Carolyn Bessette, a statuesque beauty who worked in the fashion industry. It was rumored that Carolyn Bessette was a recreational drug user. In the movie "Eyes Wide Shut," Dr. Bill Harford is married to Alice Harford, a statuesque beauty who worked at an art gallery. Alice is a recreational drug user.



Like his father, JFK Jr. had a reputation for being extremely attractive to women. In 1988 'People' magazine named him the "sexiest man alive". Two years later Tom Cruise, the actor picked by Stanley Kubrick to represent JFK Jr. in the movie "Eyes Wide Shut," was also named the "sexiest man alive" by 'People' magazine.



"As soon as [JFK Jr.] died, right-wing mouthpiece William Safire attributed his death to "bad judgment." The media rumor mill predictably called him reckless." In the movie "Eyes Wide Shut," the character meant to represent JFK Jr. initially acts recklessly by crashing a private orgy and then by attempting to investigate the events surrounding the orgy.

In the accepted narrative of the JFK Jr. airplane crash, he "was planning to drop his sister-in-law off at the Vineyard, then fly his wife to the family compound in Hyannis Port" where the Kennedy compound is located. The Kennedy family compound "consists of three houses on six acres of waterfront property on Cape Cod." In the movie "Eyes Wide Shut" the character representing JFK Jr.'s wife Carolyn specifically mentions Cape Cod:

- **Alice Harford:** Do you... do remember last summer at Cape Cod?
- **Dr. Bill Harford:** Yes.

"Christopher Andersen wrote that Kennedy's mother had worried he would die in a plane crash, which she tried preventing by having longtime companion Maurice Tempelsman 'do whatever it took to keep John from becoming a pilot'. Maurice Tempelsman is a wealthy Jewish businessman who lives in New York City.

In "Eyes Wide Shut" Victor Ziegler is also a wealthy Jewish businessman who lives in New York City. Ziegler scolds the JFK Jr. character for crashing the orgy and has him followed.

- **Dr. Bill Harford:** How do you know that?
- **Victor Ziegler:** Because I had you followed.
- **Dr. Bill Harford:** You had me followed?
- **Victor Ziegler:** I - Okay. Okay, I'm sorry. All right? I owe you an apology. This was for your own good, believe me. Now look, I know what the desk clerk told you, but what he didn't tell you is all they did was put Nick on a plane to Seattle.

In the Chartist Friend article on the hidden meaning of "Full Metal Jacket" Dr. Bill Harford's dialogue at the end of the movie is cited as evidence for the theory that the JFK assassination was a "charade."

- **Dr. Bill Harford:** The woman lying dead in the morgue was the woman at the party. Well, Victor, maybe I'm missing something here. You call it fake, a charade... Do you mind telling me what kind of f..kin' charade ends up with somebody turning up dead?

In that same scene Victor Ziegler explains to Harford that *"all of that... was staged. That it was a kind of charade. That it was fake."* This statement refers to the faked Apollo moon landings, the JFK assassination hoax and to the JFK Jr. death hoax - the charade of a plane crash ending up with John Fitzgerald Kennedy Jr. and his two female passengers turning up dead.

The JFK Jr. Death Hoax ♦ Directed by Stanley Kubrick ♦ Revealed in "Eyes Wide Shut"



Stanley Kubrick (July 26, 1928 - March 7, 1999) was an accomplished, renowned, film director of American birth. His films were widely received and known for their innovative cinematography, creativity and ingenuity. The subjects of his films were diverse and infused with cleverly infused messages directed to his audiences for informational edifications.

- **The Shining**, one of his more mainstream films, darkly portrayed isolation, the seduction of demonic evil, supernatural cognition, and a man's descent into homicidal madness. The insular debauchery, and classism of the 'elite' were also touched upon as well.

- **Full Metal Jacket** accurately depicted the rigors of basic training, military mental indoctrination, peer-terrorism and soldier as gang-member. Also delineated was the resilience and tenacity of an invaded peoples, and the contextual utter absurdity of war.

By far Kubrick's **Eyes Wide Shut**, was his most cinematically expositional. With insightful aplomb he reflected the realities of the most taboo of subjects: satanic cults composed of elites, human sacrifice and pedophile networks. The front drop dealt with a professional, bored with his life and specifically his marriage, until his curiosity brings him in full contact with the realities of an underworld that slithers all about him. Eyes Wide Shut was a commentary on disaffected decadence as a lifestyle, as much as it was an exposure of the organized evil lurking about just beneath the surface.

Shortly after screening a final cut of Eyes Wide Shut for his family, Tom Cruise, Nicole Kidman and Warner Brothers executives, Kubrick suffered a sudden myocardial infarction in his sleep. What makes his untimely and sudden death suspicious is the nature of the very verboten subject he covered. For those unfamiliar with the real crimes, personalities and the institutionalized power of satanic groups, Eyes Wide Shut's depiction presented it in very real terms. I would imagine that in the circles of Hollywood this would not be something desired whatsoever, especially when Kubrick had full artistic control and final editing. To the powers that be, this would be yet another in the series of exposures into the realities of their operations.

Something to be mindful of is how relatively simple it is to induce a heart attack in a targeted person. There are a number of chemicals, some of them classified, which can be used to perform the deadly task of producing premature heart failure. (Ex?) In his book, Mossad agent Victor Ostrovsky detailed how a network team of Mossad agents once drugged a target and induced a heart attack by immersing him in freezing cold water while he was unconscious. Depending on limitations of time, resource constraints and credible backstory engineering, assassinations of this type are not only technically possible, but have been historically implemented as expedient methods of untraceable murder.

Viewed in the abstract the suggestion of Stanley Kubrick's possible murder seems incredible at first glance. However when placed in the context of the premature demise of many extraordinary and charismatic individuals it is perfectly plausible. For the extraordinary individual is a threat not for what they know, but for their potential influence on the masses. A prime example of this would be John Lennon and Bob Marley.

Kubrick was quoted as often stating a very revealing credo of his: "**Be suspicious of people who have, or crave, power.**" He added, "**Never, ever go near power. Don't become friends with anyone who has real power. It's dangerous.**"

The questions surrounding the death of John F. Kennedy Jr. continue almost 20 years after his private plane vanished on its way to Martha's Vineyard. Why was there no autopsy

photos allowed? Why were the alleged recovered bodies buried at sea by the Navy? Did JFK Jr. fake his own death? Is he alive and living in disguise as a Trump supporter named Vincent Fusca, who has been seen at many of Trump's rallies? Is JFK Jr. the infamous "Q", helping the president through cryptic messages to take down the deep state whose goal is to overthrow our constitutionally limited republic? In a special two part report, David Zublick unlocks the mystery of JFK Jr.

We have an uncanny group of parallels all tied to that date I asked you to keep in your memory – July 16th. Just thinking!

John Hankey is a long-time investigator who has focused much of his attention on the assassination of President John F. Kennedy in 1963. He produced a documentary setting forth his views on that event. Hankey has also turned his attention to the death of John F. Kennedy, Jr. caused by a plane crash that occurred off the coast of Martha's Vineyard, Massachusetts on Friday, July 16, 1999. Hankey has produced a 104-minute DVD documentary entitled "The Assassination of John F. Kennedy, Jr." Much as I liked the earlier documentary, I liked this one even better. According to the widely accepted explanation, Kennedy was a reckless pilot who died because of his own carelessness. But Hankey shows that Kennedy was actually a careful pilot who was most likely the victim of foul play. Persons who are interested in the death of John Kennedy, Jr should watch Hankey's documentary, the basic outline of which I summarize here.

Hankey takes as his point of departure two overlooked pieces of evidence in the official report that the National Transportation Safety Board published one year after the crash. First, the radar data describing the path of Kennedy's plane showed that just as Kennedy was making his final approach to the Martha's Vineyard Airport, his plane, in the absence of any explosion or engine malfunction, suddenly plunged headfirst into the ocean, falling 2500 feet in 45 seconds. Secondly, the fuel selector valve on Kennedy's plane was found to have been turned to the off position.

The bizarreness of Kennedy's sudden dive into the ocean is obvious, but the equally bizarre fact that the fuel selector valve had been turned off requires an explanation that the official NTSB report did not provide. The fuel selector valve has two functions, one a pilot uses frequently and the other infrequently. The first and frequently used function is to tell the engine from which fuel tank to draw its fuel. Kennedy's airplane contained two 51-gallon fuel tanks, one in the right wing and the other in the left wing. Inasmuch as fuel is heavy, if the engine uses fuel from only one of the two wings, that wing becomes much lighter than the other wing and the airplane as a whole becomes lopsided or leans toward the wing with the most fuel. To avoid this unsafe weight distribution, a pilot sees to it that as his engine burns fuel, each tank still has approximately the same amount of fuel as the other tank. He does this by moving the switch on the fuel selector valve back and forth between the right tank and the left tank during the course of a flight.

The second and much less frequently used function of the fuel selector valve is to cut off all fuel to the engine from both tanks. It is obvious that a pilot would not ordinarily want to do this in the course of a flight, as it would shut down the engine, but he might have to do it if the engine caught fire. By turning the fuel selector valve to the off position and cutting off the flow of inflammable fuel to the engine, a pilot could see to it that the fire burned itself out. A fuel selector valve is constructed in such a way as to prevent a pilot's turning it off by mistake.

Whoever turned the fuel selector valve off on Kennedy's plane knew what he was doing and did so deliberately!

The fact that Kennedy's airplane inexplicably dove straight into the ocean together with the fact that somebody turned off the fuel selector valve suggests that someone aboard Kennedy's plane committed suicide. Whoever he was, he probably first grabbed the controls and forced the airplane into a headfirst dive at 200 mph. He next turned the fuel selector valve off, not to force any engine fire to burn itself out, as indeed there was no fire, but to make it impossible for anyone else on board to correct the situation. With all fuel cut off, the engine stopped working. Without a working engine, no one could redirect the aircraft in time to prevent a crash. Of course this is pure supposition and JFK Jr. would have no reason to commit suicide.

This scenario may seem fantastic until we realize that only about 100 days later and only about 50 miles away from the site of Kennedy's crash, this is precisely what happened aboard Egypt Air Flight 990. On October 31, 1999, not long after takeoff from JFK Airport in New York City, Gamil al-Batouti, a member of the Egyptian Air flight crew with no apparent reason to commit suicide, suddenly forced the Egyptian Air Boeing 757 jet into a headfirst dive and then turned off the fuel selector valve. The plane crashed helplessly into the ocean, taking over 200 passengers, including many Egyptian military officers, to their deaths.

But skeptics might say that we cannot compare the crash of Kennedy's plane with the crash of Flight 990 because there was no one on board Kennedy's plane who would conceivably do what Gamil al-Batouti did on Egyptian Air Flight 990. Certainly neither John Kennedy, his wife, nor his wife's sister would commit such a senseless act, and they were the only ones on Kennedy's plane. Or were they?

Strong evidence suggests that there was a fourth passenger, a flight instructor, on Kennedy's plane. Now there were no eyewitnesses to the boarding of Kennedy's airplane, so there is no one who could tell us for certain how many persons he saw boarding it. But we have eyewitnesses who saw Kennedy, his wife, and his sister-in-law waiting for about 45 minutes in the airport lounge before takeoff. Given that time was passing, visibility was declining, and darkness was falling, what were they waiting for? Hankey believes that they were waiting for a flight instructor. But what if the flight instructor failed to show up? Would Kennedy have had no choice but to take off without a flight instructor? Not at all! Kennedy could easily have gotten

another flight instructor on short notice. We also have eyewitnesses on the Coast Guard rescue team who state that when they arrived at the crashed airplane, they found one of the seats to be missing. Perhaps the rescuers had to remove a body that was still strapped to its seat.

Kennedy's own comments to friends before his flight also suggest that a flight instructor likely boarded the airplane. For example, on the day of his fatal crash, Kennedy had lunch with Richard Blow, Kennedy's co-editor at *'George'* Magazine. Noticing that Kennedy was nursing a broken foot and was still on crutches, Blow expressed concern about the wisdom of Kennedy's flying. Kennedy told Blow not to worry because he was taking a flight instructor. Similarly, Kennedy had told a Canadian acquaintance that he would continue to fly with a flight instructor until his broken foot healed. Immediately after the crash, Carol Ratowell, a friend of the Kennedy Family, told Channel 5, the ABC affiliate in Boston that Kennedy was flying with an instructor.

Indeed, the NTSB could not find any evidence that Kennedy had ever flown his two-month-old Piper Saratoga airplane without a flight instructor. The reason for his always taking a flight instructor is not difficult to find. His new airplane contained many advanced safety and other features that he had not had on his previous airplane. He would have benefitted from having a flight instructor to familiarize him with the new bells and whistles.

And if that were not enough, there were at least three additional reasons for Kennedy to hire a flight instructor. First, Kennedy was not flying by himself, but was also taking his wife and sister-in-law along with him. Would not these two women have felt safer with a flight instructor, especially since Kennedy was still on crutches? Secondly, Kennedy was trying to add an instrument rating to his private pilot's single-engine land license. He had already passed both the written examination and the performance evaluation, but he still needed to log more hours with a flight instructor to fulfill his requirements for his instrument rating. Thirdly, Kennedy must have known that difficult weather conditions could arise between New Jersey and Martha's Vineyard that would require a flight instructor. His license permitted him to fly according to visual flight rules (VFR), but what if he had to use instruments? In that event, it would have been illegal for Kennedy to fly without a flight instructor. Kennedy had flown the same route from Caldwell, New Jersey to Martha's Vineyard, Massachusetts 8 times that summer. Kennedy took a flight instructor on all 8 of those flights, and for good reason, because on 5 of them, visibility was too poor to fly without instruments. As it turned out, visibility was so good on July 16 that Kennedy did not need a flight instructor, but he could not have known that in advance. It would have made sense to bring one just in case.

Now a skeptic might say that all the logical reasoning suggesting Kennedy had a flight instructor is vain because investigators recovered no bodies other than those of Kennedy, his wife, and his sister-in-law. Therefore, Kennedy must not have had a flight instructor because no one recovered any flight instructor's body. Or did they?

Between the time that Kennedy's plane went missing and the time that the Coast Guard arrived at the wreckage, over 15 hours passed, time for all sorts of things to happen. Curiously,

the circumstances of the case were such that the Federal Aviation Administration should have ordered a search within minutes after Kennedy failed to land at Martha's Vineyard. According to Coast Guard Petty Officer Todd Burgun, Kennedy contacted the Martha's Vineyard control tower at 9:39 p.m. on Friday night, shortly before what was to be his landing. If Burgun is right, the control tower would undoubtedly have picked up Kennedy's transponder signal and responded by assigning Kennedy's airplane a transponder code. That code would automatically have been entered into FAA computers so that the FAA could track Kennedy's plane for the remainder of its flight. If Kennedy's plane had either dropped below 100 feet or failed to land within 5 minutes, an alarm would automatically have sounded at the FAA, which would then have ordered a search. Inasmuch as Kennedy's plane crashed into the ocean and never landed at all, the FAA had two reasons to order a search, and to focus that search on the approaches to Martha's Vineyard. Instead it did nothing.

According to the official explanation, the FAA did nothing because it did not know that Kennedy's plane had crashed because Kennedy had not contacted the FAA at the Martha's Vineyard control tower. The official explanation thus implies that Burgun was in error when he said that Kennedy had contacted the control tower. But Burgun's statement that Kennedy had contacted the tower at 9:39 p.m., made to Channel 5 News on live television, had a ring of truth to it because it dovetailed so well with proven FAA data. The latter showed that Kennedy had still not contacted the Martha's Vineyard tower by 9:38 p.m. and that his airplane plunged into the ocean at 9:40 p.m. Therefore, if Kennedy had contacted the control tower at all, he must have done so at exactly 9:39 p.m. Unless Burgun was an incredibly lucky guesser, he must have gotten his information from the FAA itself. We can therefore assume that the information Burgun passed on to Channel 5 News was correct.

Despite the failure of the FAA to order a search after Kennedy's plane failed to land, members of the Kennedy Family kept pressing the FAA for action throughout the night, all to no avail. Around 9:30 p.m. on Friday, just before Kennedy's plane was to land, several of Lauren Bessette's friends had gathered at the Martha's Vineyard Airport to greet the airplane. When the plane failed to land, they notified Adam Budd, an airport employee and licensed pilot, who in turn telephoned both the FAA in Bridgeport, Connecticut and the Martha's Vineyard Airport control tower. But the FAA did nothing. At 11 p.m., Senator Ted Kennedy, John Kennedy's uncle, telephoned the FAA to report the missing plane. But even though he was a United States Senator, he had no luck either. Around 2 a.m. on Saturday morning, the aforementioned Carol Ratowell gave up on the FAA and called the Coast Guard. Now the FAA, facing grave embarrassment, had to do something, so it called the Air Force, which in turn ordered the Coast Guard to search for Kennedy's plane but at the same time ordered the Coast Guard to do only what the Air Force told it to do. Specifically, the Air Force told the Coast Guard to search an area that was far away from the approaches to Martha's Vineyard. Needless to say, the Coast Guard, which did not know the precise location of the crash, came up with nothing. Around 7 a.m. on Saturday morning, a desperate Senator Kennedy telephoned John Podesta, President Clinton's Chief of Staff, and explained his frustration. Podesta then telephoned Clinton immediately. Clinton responded by telling Podesta to call the Air Force and demand that it begin a search within 15 minutes. The Air Force responded by telling the Coast Guard to take 2

boats and 2 helicopters on a wild goose chase across 20,000 square miles of ocean. Once again, the Coast Guard, which still did not know the precise location of the crash, came up with nothing.

The Air Force defended its failure to help the Coast Guard narrow down its search with precise information by claiming that it did not have that information, but Hankey provides ample evidence that the Air Force did have it. We have already seen that Kennedy had contacted the Martha's Vineyard control tower, and that the FAA must have known that Kennedy's airplane had gone down in the approaches to Martha's Vineyard. But other sources of information available to the FAA also located the crash site. Indeed, anyone watching Hankey's documentary can see the site pinpointed on the same Channel 5 television picture that viewers in the Boston area saw on that Friday night. The captioning on the Channel 5 screen makes it clear that it was the crash-activated emergency locator transmitter aboard Kennedy's plane that had pinpointed the wreckage. But even if the emergency locator transmitter had not done so on Friday night, the FAA radar analysis did so when it was completed at 5 a.m. on Saturday morning. Despite all the tools now at its disposal, the Air Force still refused to order a focused search on Saturday morning. Instead it kept the Coast Guard spread out over a vast expanse for another 5.5 hours. In the end, of course, the Coast Guard did get to the crash site, but not with any help from the FAA or the Air Force. Around 1 p.m. on Saturday afternoon, a piece of luggage from the crashed airplane washed up on the beach, and it was this that enabled the Coast Guard to pinpoint the site and to get to the wreckage.

Hankey believes that there was a conspiracy behind both Kennedy's death and the 15-hour delay. After successfully getting Kennedy's plane to crash, the conspirators persuaded confederates at high levels of both the Air Force and the FAA to delay the Coast Guard search so that the conspirators could get to the scene first and remove any incriminating evidence. Indeed, there is evidence that someone arrived well before the Coast Guard. Around noon on Saturday, Lieutenant-Colonel Richard Stanley of the Civil Air Patrol said that he had seen helicopters that he assumed belonged to the Coast Guard near the crash site at around 7 a.m. that morning. But since the Coast Guard did not arrive until 1 p.m. that afternoon, the Coast Guard was not what Stanley saw. Then what did he see? Probably persons sent to do three things: first, remove the body of the flight instructor, who Hankey suspects was a Manchurian Candidate hypnotized into crashing Kennedy's plane. This would explain why the Coast Guard did not recover the body of the flight instructor. Secondly, remove Kennedy's flight log, which would have listed all persons on board the airplane. This would explain why Kennedy's flight log, which might have proven that there was a flight instructor aboard, disappeared even though the turquoise duffel in which Kennedy always kept his flight logs was intact. Thirdly, remove the backup battery from the cockpit voice recorder. This would explain why although investigators recovered the cockpit voice recorder, they were not able to get any information out of it. A cockpit voice recorder records whatever the crew says in the last few minutes of a flight, but it needs a backup battery to retain this information. Once the battery goes, so does all the data.

An extensive cover-up followed the mysterious death of John Kennedy, Jr that resembled other cover-ups over the years. Hankey has studied many other cover-ups, and has learned that although the details in each case are different, they all followed a common pattern. In each case, honest eyewitnesses provide the initial evidence to reach the public. Soon, however, certain government officials in league with the conspirators step in and remove these eyewitnesses from public view, seeing to it that no one hears from them again. Next they manufacture evidence to support a previously agreed-upon and different version of events while omitting all further mention of the initial evidence. Compliant members of the mainstream media then sell this new version to the public. This happened after the assassination of President Kennedy in 1963, and it happened again after the death of his son, John Kennedy, Jr. in 1999.

It all started with the Pentagon's telling reporters and others curious about the crash of Kennedy's airplane that they could not expect any more information from the government agencies that had helped them earlier. Henceforth, they must take all their questions to the Pentagon. Why the Pentagon? Kennedy was not a member of the military. He was not flying a military aircraft. His flight had no military purpose. Hankey believes the conspirators chose the Pentagon because it had previously signed on to the cover-up.

The Pentagon got right to work by telling a long series of lies designed to portray John Kennedy Jr. as a reckless pilot. Among other things, it insisted that there had been no flight instructor on Kennedy's plane despite the testimony of Carol Ratowell that there had. It insisted that Kennedy had not contacted the control tower before landing, in spite of the testimony of Todd Burgun that he had. It also made the dubious assertion that Kennedy had not filed a flight plan with the FAA in spite of the fact that he had done so on all 8 of his previous flights along that same route that summer. The Pentagon insisted that nobody reported the plane missing until 2 a.m. on Saturday morning, in spite of the fact that members of the Kennedy Family and others had been calling the FAA starting as early as 10 p.m. Friday night and continuing into Saturday morning. Honest reporters who tried to make sense of what was happening, like Linda Killian of *'People'* Magazine, were cut off.

Coast Guard Petty Officer Todd Burgun was mysteriously reassigned in the wee hours of Saturday morning. Burgun's earlier statement to Channel 5 that Kennedy had called the Martha's Vineyard FAA control tower at 9:39 p.m. on Friday night had been very damaging. If Burgun were right, then the FAA would have had to explain its decision not to order an immediate search. If given an opportunity to speak, Burgun would probably have disputed the Pentagon's claim that Kennedy had not contacted the Martha's Vineyard control tower. But no one heard from Burgun again.

On the Saturday morning after the crash, the perception that Kennedy was a reckless pilot was given a big boost when persons identifying themselves only as "the family" told Channel 5 both that Kennedy may not have had a proper license to fly an airplane and that he did not have a flight instructor on board. These two pieces of information, the first of which was certainly false and the second almost certainly false, strengthened the belief that Kennedy's

own carelessness was the cause of his crash. Of course, in the heat of the moment and without time to do research, the Channel 5 understandably accepted this information at face value. But inasmuch as we have more time than Channel 5 had to reflect on this matter, we should ask some questions that they did not ask. Just who were these mysterious persons who identified themselves as "the family?" Why did they not give their names? Were they even members of the Kennedy Family at all? If they were really members of the Kennedy family, did they know that Kennedy had a private pilot's license? Did they believe that Kennedy had been flying for seventeen years without a license?

The NTSB had a full year to clear up these questions before it issued its final report, but it did not make constructive use of that time. In the end it merely repeated all the contradictions and inconsistencies that had been there from the beginning. The NTSB should at least have investigated the telephone call Kennedy made on his cell phone just before takeoff. The NTSB undoubtedly had a record of that call. Under normal circumstances it would have investigated it and included its findings in the final report, yet it did not do so this time.

To top it all off, the NTSB report seemed to put all doubters of the official version on the defensive with a stunning revelation. It said that Robert Merena, one of Kennedy's flight instructors, had told the NTSB six months after the crash that he had offered to fly with Kennedy. According to Merena, Kennedy turned down Merena's thoughtful offer with the explanation that he wanted to "do it alone." This revelation made headlines and confirmed the view of Kennedy as a reckless pilot. But quite apart from the fact that Merena's own lawyer later denied that Merena had made that statement, there are reasons to be skeptical about Merena's revelation. For one thing, the NTSB memorandum in which Merena revealed that Kennedy wanted to "do it alone" was suspiciously irregular. It did not say when and where Merena gave this interview, nor did it have Merena's signature. These were all serious violations of standard protocol. And why did Merena wait 6 months after the crash to come forward? Why did he not mention it in the earlier interview he gave the NTSB five days after the crash? Merena's statements there imply that Kennedy did have a flight instructor on board. For example, Merena did say that to the best of his knowledge, he never saw Kennedy flying his plane without a flight instructor, and left it at that. Since Merena did not say anything about Kennedy's either wanting or not wanting to "do it alone" this one time, one would infer that Kennedy had a flight instructor on July 16 as well. Merena tried to clear up the confusion by saying that he did not mention Kennedy's statement that he wanted to "do it alone" in his interview five days after the crash because he had already mentioned it in his letter to the NTSB earlier on the same day that he gave the interview. Yet that letter contained no mention of it either.

Thus we have seen strong evidence that the death of John Kennedy, Jr. was the result of a conspiracy. But who were the conspirators? There have been rumors that the Clintons might have had something to do with Kennedy's death, but the evidence Hankey provides seems unlikely. Hankey, who has a bias against Republicans in general and the Bushes in particular, believes that George W. Bush is the chief suspect. Unfortunately, the only evidence that Hankey can give in support of his position is that on the morning of Kennedy's death, Bush, who had

been campaigning in Iowa, boarded a bus and disappeared for several days. Beyond that Hankey offers only conjecture and speculation. Unless someone can provide more evidence than that, it will take an extensive criminal investigation to clear the mystery up involving Kennedy's death. But that a criminal investigation is necessary, there is no doubt in the mind of anyone who bothers to watch Hankey's documentary.

There is a video report that noted the U.S. Navy protection had been afforded to John F. Kennedy Jr, from his days as that little 3-year old saluting the passing of his father's funeral. From various sources, the information is that in preparation for attending a wedding on Martha's Vineyard, John Jr. asked for his flight instructor to accompany him in a flight to the Cape. The flight instructor was sick and unable to join him. John Jr. then requested another flight instructor to accompany him and when the flight instructor met him at the Essex County Airport. On July 16, 1999, John Fitzgerald Kennedy Jr. took off from Essex County Airport in Caldwell, New Jersey, at 8:39 p.m. As custom, the new flight instructor did a routine checkout of the Piper Saratoga, at which time he came across a strip of what was C-4 explosives.

JFK Jr. was about to announce his candidacy for Senator of NY, the former seat of Daniel Moynihan. The Piper Saratoga had an altimeter switch attached to the C-4 explosives, designated to activate upon its descent over Cape Cod. This meant that the C-4 explosives would be detonated as the plane began descending over the Cap in approach to the runway. It in no way would have gone off during takeoff or normal flight for the 135 miles or so to the Cape. The flight instructor and JFK Jr. called in his security on this. The next day the Piper Saratoga took off, but this time with a Navy pilot and a parachute and a tape recorder with JFK Jr's voice recorded with specific messages that would have been recorded and heard on approach to landing, making it seem as if it was JFK Jr. at the controls of the aircraft. The Navy pilot bailed out and parachuted into the Atlantic Ocean close to the shore of Cape Cod.

At 9:41 p.m., he allegedly crashed his Piper Saratoga into the Atlantic Ocean seven and one-half miles short of his goal, Martha's Vineyard, Massachusetts, killing himself; his wife, Carolyn; and sister-in-law, Lauren Bessette. This is the story given to the public, along with a lot of reasons for the crash. JFK Jr's Navy security took over from the point of discovery of the attempt to assassinate JFK Jr. and his two passengers, and for the past 19 years has been living in anonymity with his wife. I have read and seen numerous pictures and campaign rally videos of what is reported to be his 18-year old son at the Trump rallies in 2016.

Going back to 1998, Dr. A. Tru Ott turned the "Gemstone Files" over to JFK Jr. This is from his online manuscript titled: "Free at Last" available in PDF format. Most of the book seems to be about Mormonism. I have only read portions of the book.

The "Las Vegas" Files are Examined

"In 1995, I was going through my safe and file cabinets, and came across the sealed, manila envelope that had been placed in my trust by my financial planning client a decade earlier. I had completely forgotten about it. I called his home to see what he wanted me to do

with it. His wife informed me that Mr. C. had suffered a stroke a year earlier, and was confined to a nursing home. He was in his 70's now, and was not doing very well. In short, she didn't know anything about the "file" and suggested that I could just dispose of it.

I tossed it into the trash bin, but then thought that I should at least see what all the fuss was about. In many ways, I wish I had never opened it. It was a true "Pandora's Box," and I was shocked to read its contents. It was "file #5" of a group of 7 files called the "Gemstone" files. I don't know what the other six files contained, but this one was a literal ball-buster. It was the FULL STORY of the CIA-planned and executed contract "hit" of John Fitzgerald Kennedy, president of the United States. It was full of very complete specifics, including such things as photostats of cancelled checks, travel vouchers, orders on CIA letterhead, personnel "lists" of participants, disposition of witnesses and evidence, etc. The problem was, I recognized the names of many of the key men who participated in the assassination, as well as the massive cover-up that followed.

Like I said, it was a definite "pandora's box," one that I soon realized was too big for me. I kept thinking I ought to shred its contents, but I couldn't bring myself to do so."

The File Goes Home to John John

"During the summer of 1998, I was involved in actively protesting the expansion of Circle 4 Farm's gigantic hog factory farm into Iron County. My grass-roots citizen's organization CRSA (Citizens for Responsible and Sustainable Agriculture) had received a bit of national notoriety, with a number of AP wire stories circulating the nation. One such story caught the eye of a publication called '*George*' Magazine. The editor and staff contacted me and scheduled an appointment to meet and review my story.

The editor of '*George*' Magazine flew into Cedar City in his private jet to meet me, and shoot a photo spread. We spent the entire day, a Saturday, together.

At the end of the day, at a local steak house, we sat down for a concluding meal. Over salad, I had to confess to the editor that I had never even heard of, much less read a copy of 'George' Magazine until he had called me. He reached into his briefcase and produced a copy. Looking at it, I was surprised to see that it was owned and founded by John Kennedy Jr.

I asked him about "John, and his politics." I was told that John was a real "champion of the under-dog" and that was why they were producing the story on CRSA and me.

I commented: *"I believe that my image of John is like most Americans. The enduring image of little 'John-John' courageously stepping forward and giving his best salute as the caisson carrying his father's body slowly rolled by. Tell me, does John accept the 'official Warren Commission' account of the assassination, or does he think there was more to it? At this late date, does it even matter?"*

The editor nodded and said: *"Of course he doesn't accept the Warren Commission, but there is not a lot he, or anyone else can do about it! And I guarantee you, it DOES INDEED matter, at least to him. It is one of his major goals in life to find out the Truth!"*

I replied: *"Has he ever heard of something called the 'Gemstone Files'?"*

With that, the air became electrified. The editor laid down his salad fork and said: *"What do YOU know about the 'Gemstone'?"*

"Oh, it just might be that I have a copy of file #5. Does that interest you?" I casually volunteered.

"You can't be serious! Are you serious? Don't kid about something like that! Where did you get it?" he almost screamed.

The dinner was immediately over, even though our steaks were just coming in from the kitchen. We had them placed into containers to take with us. The editor had to SEE the infamous Gemstone immediately. He couldn't wait until the meal was finished.

It was late on a Saturday night in Cedar City, Utah. I handed him the file, and he offered to compensate me for it. I refused. I asked him only one thing in return; if the information proved out to be genuine, that I needed to know. I just wanted justice to be served, and the guilty parties prosecuted.

I was awakened the next morning at 5:00. John's editor explained that he had been up all night reading the file. He had called John directly, and he was told to fly it immediately back to John. John had again offered to compensate me up to \$10,000 for the lead. He felt it was that good. I politely refused, and gently reminded him of my earlier request. I just wanted to know if the information was genuine. To me, that would be payment enough.

The rest of 1998 went by quickly. The national political stage was being set. It looked like George W. Bush was seeking to secure the nomination to run against Al Gore. On the 5th of July, 1999, my home phone rang. Joan answered it and said:

“True, it’s for you.” As I answered it, a very polite masculine voice on the other end said: *“Hello, True Ott, do you have a moment to speak? This is John Kennedy calling!”*

I immediately asked him to hold while I went to the privacy of my home office to take his call. After a few minutes of small talk, he told me: *“Well, I understand that you want to know what I think of your file. I want you to know that I have spent over six figures in private investigators to verify its contents. I can say to you without hesitation that its contents are indeed factual. As a matter of fact, because of this file, a federal grand jury will be convening within the next few weeks. It is my opinion, as well as my attorneys, that this federal grand jury will pass down an indictment against George Herbert Walker Bush for conspiracy to commit murder against my father, and will also indict others as the evidence unfolds. If George W. thinks he can run for dogcatcher after this grand jury convenes and his father indicted, he is sorely mistaken.”*

A little over two weeks later, on July 16, 1999, John Kennedy Jr., along with his wife and her sister, were killed in a plane crash in route to Hyannis port for a family wedding. My new friend was gone, and the guilty involved in BOTH murders have still not been punished. I know the truth, however. There is no doubt whatsoever, why John was killed. It was NOT an accident!"

I had read specific chapters of the book *'Inside the Gemstone File'* by Kenn Thomas and David Childress and so when Dr. A. Tru Ott related his association with John F. Kennedy Jr., my interest again picked up. In 2001, I had stopped following the details of the plane crash and JFK Jr.

A suspicion had already existed over Hillary Rodham Clinton. I thought she might have had something to do with the Kennedy plane crash; this created a cloud over the issue of the New York Senate seat which both JFK Jr. and Hillary were considering a run to fill the seat of Thomas Moynihan who was retiring. However, we cannot rule out President George H.W. Bush with JFK Jr. snooping around into Bush Senior's matters.

Hillary Rodham Clinton seems to always come up in the big picture, and if what I am about to share is true, she no longer matters. With JFK Jr. out of the picture, Hillary had an uncontested path to Thomas Moynihan's seat.

David Zublick reported in an hour-and-a-half video that Hillary died on September 11, 2016, following her visit at the memorial service at Ground Center in New York. A doctor who accompanied Hillary during the campaign, testified at the Gitmo War Crimes tribunals that Hillary was declared clinical dead and was kept on life support for a disease related to cannibalism. Larry Nichols, a former ranking Bill Clinton staffer, who goes back to the days of Clinton as governor of Arkansas, has said he had a hard time explaining and hiding Hillary's trips from Washington, DC when Bill Clinton was the President. THE TRIBUNAL CHAMBER

Long-ago, around 2011, the Pentagon built a \$14 million Expeditionary Legal Complex atop an abandoned runway on the U.S. Navy base's Windward side. At the center is a snoop-proof courtroom capable of trying six alleged co-conspirators before one judge and jury. Media and other observers are sequestered at the rear in a mostly soundproofed room behind three-layers of Plexiglas, and hear the court audio feed on a 40-second delay. The judge at the front, and a court security officer has mute buttons to silence the feed to the observers' booth, if they suspect someone in court could spill classified information.

Pentagon workers have installed a blue curtain inside the spectator's gallery to separate victims, chosen by lottery, from the other observers at the back of the courtroom. Construction of the compound began in the summer of 2007 after a C-130 Hercules cargo plane landed on the McCalla field, the current site of Camp Justice, and delivered three trailers specially equipped for legal staff to handle Top Secret material. Called "Razors," they look like shipping containers. More materials came by barge, and ground was broken for the court itself on Sept. 11, 2007. In early 2018 the Pentagon disclosed that the trial judiciary had about 730 hours of audio recordings of war court hearings, and that the U.S. military even considered audio of open-court proceedings to be classified. An up to \$19 million expansion is underway. The contractor also helped rebuild the World Trade Center after 9/11.

In a previous segment, I noted the upgrading of the GITMO Detention Center made since President Trump's election in 2016. 13,000 cells for largely pedophiles and sex trafficking crimes, a 5-bed emergency hospital, barracks for approximately 900 Army Reservist and Army National Guard military police activated and deployed in late 2018. In addition to the new \$14.5-million dollar court room, and soundproof medias room, thirteen cells have been built for high-profile individuals being tried for "high crimes and misdemeanors"* against the State such as Treason. ***What is HIGH CRIMES?**



Above photo of the War Crimes Tribunal court room recently constructed for prosecution of high profile members of the government. Thirteen special cells were constructed for the likes of former Presidents George W. Bush, William Clinton, and Barack Hussein Obama.

Former President George Bush Jr. evidently has agreed to be executed for his part in the 9/11 crimes according to intelligence coming out of GITMO's Military Tribunals that began on January 2, 2019. The trials would be filmed and released at a later date, although at some point transcripts would be made available. Evidently former President Bush Jr. met with President Trump and was granted the choice of embarrassment of going through a trial. On January 28, Pre-trials at GITMO began on five defendants of the 9/11 crimes – trials that were subsequently delayed until March because of Military Court Judge Colonel Parrella's medical problems.

It was well known that the US Press was controlled by the Rothschild's and George Soros-owned organizations. Multiple sources have confirmed that former Clinton Campaign chief, Tony Podesta and his brother John were among 17 D.C. indictments. The Podesta brothers were said to be under investigation for child kidnapping, pedophilia and their involvement in selling the country's Uranium.

Among Soros' other suspected many crimes were illegally influencing US elections (he was said to own the software for many state voting machines), organizing and funding illegal

immigrants to force their way across the US border and was a reported leader of child trafficking and exploitation for the Ninth Circle Child Sacrifice Cult run out of the Vatican.

Bacani and Forsythe would place transcripts of the Military Tribunals for authorized media representatives.

On September 14 2001 and after 9/11 Congress passed the basis for Martial Law and Military Tribunals signed into law by then President George W. Bush. I wonder, when President George W. Bush signed the law, whether he thought that he would one day be tried by the same act he signed into law! An Executive Order for Military Tribunals was signed by President Trump and went into effect January 1, 2019. The pre-trials began on January 2, 2019. The tribunals were to be held in secret locations, at GITMO, various military bases and federal courts across the nation, (some are known to be going on right now in Fort Jackson, South Carolina). US Attorney, John Huber and his several hundred investigators had spent over two years investigating and filing over 71,000 indictments against pedophiles, sex-traffickers, political and global elites in federal courts.
