The Beast Empire

There is mounting evidence that The Roman Catholic Church leadership has allowed hideous sin and heresy to corrupt their Church from within. Former Alaska State Judge Anna Von Reitz posted this statement on her blog site: *"This morning I have read the "Crimen Sollicitationas" openly published since 1929 and included in the Vatican II Reforms."*

What is "Crimen sollicitationis" you ask? It (Latin: crime of solicitation) is the title of a 1962 document ("Instruction") of the Holy Office codifying procedures to be followed in cases of priests or bishops of the Catholic Church accused of having used the sacrament of Penance to make sexual advances to penitents. The eleven-page document states the 1922 and 1962 documents did not create this culture. They arose out of it and gave legal force to the culture of secrecy. If the 1922 and 1962 documents have been used as a justification for any cover-up or intimidation then we possibly have what some of the more critical commentators have alleged, namely, the distinct appearance of a blueprint for a cover-up.

"This is nothing more or less than a policy to protect criminals and ordering members of the Church to keep silent", said the Judge. It's all about Church secrecy and cover-up.

Judge Anna points out, "That this order, "Crimen Sollicitationas" is described as "a Pontifical secret" again gives credence to my published assertion that the Office of Pontiff charged with the Secular Duties of the Church has in fact been abused to operate a Temple of Ba'al in parallel and within The Church of Rome, perhaps as far back as the Council of Nicea."

The Office of Pontiff was vacated in 2011, together with the liquidation of the Romanus Pontifex Trust, but the end of the so-called "pontificate" does not in itself cleanse the Church of heresy and evil. That is a much more difficult process, which many faithful members of the clergy and local parish members have undertaken, despite the crushing pain of these revelations. Judge Anna Von Reitz has been at the forefront to expose and break the Vatican Trust that goes back centuries, where the Roman Catholic Church claims to own you and every-thing in the world. As such her words here are a confirmation of the corrupt nature of the Roman Catholic Institution to keep mankind enslaved to the Vatican.

Judge Anna says, "If my surmises are correct and Ba'al worship was allowed within The Roman Catholic Church as a "Secular Religion" in keeping with Roman practices at the time of the Council of Nicea--- and that such "worship"has been part of the Pontificate ever since--- this is a very entrenched, protected, and intricately interwoven "secret" which has served to undermine the mission and performance of the Church for seventeen centuries."

The structural proof exists that the Office of the Pontiff used the Church as a storefront to hide crimes of unimaginable proportions, and even went so far as to order church members

to keep quiet about it on pain of Excommunication. How would you like to be a sincere Catholic waking up to that reality?

"So I have urged everyone of all the denominations to pray for the sincere Followers of Jesus Christ who are members of The Roman Catholic Church. They need our prayers and support far more than ever now. Share the fight with them and encourage them in their calling to cleanse their Church of this great evil once and for all ---- and do not turn away from them because of the sins that have been perpetuated "in the name of" The Roman Catholic Church."

These are not the sins of Catholics, but are the sins of Satanists --- Ba'al Worshipers embedded within the Church.

Today, there is credible news and evidence that the necessary cleansing process has begun in earnest. Members of the Catholic Clergy from many countries have taken a stand and broken with the Code of Silence imposed by the "Crimen Sollicitationas".

What the world does not understand is that all of this was foreseen, even prophesied in the Bible. The facts are that this code of silence existed long ago and its exposure is long overdue. It certainly was foreseen. As the following comments by Roman Catholics reveal, it was within the view of many that apostasy and heresy would one day devour the institution.

"Rome will lose the Faith and become the seat of the Antichrist." – Our Lady of La Salette

The Illuminati, Freemasonry, a New World Order, a One World Religion and the Vatican State can all be found in the Eternal City of Rome. Rome in Italian means "love"

At this hour, and for centuries past, ancient pagan monuments and portals are given new life and being raised from the dead in a city at the center of all that is soon to come.

Thirteen obelisks, an ancient pyramid, and the occult number 33 thrive within the city upon the seven hills which chose to make the number of the beast 666, its calling card.

Anne Catherine Emmerich, an 1800 mystic once said: "I saw how baleful would be the consequences of this false church. I saw it increase in size; heretics of every kind came into the city of Rome. The local clergy grew lukewarm, and I saw a great darkness...I saw again the strange big church that was being built there in Rome. There was nothing holy in it. I saw this just as I saw a movement led by Ecclesiastics to which contributed angels, saints, and other Christians. But there in the strange big church all the work was being done mechanically according to set rules and formulae. Everything was being done according to human reason." The Papacy declared Anne Catherine Emmerich a saint if my memory is correct.


Venerable Bartholomew Holzhauser said: "God will permit a great evil against His Church: Heretics and tyrants will come suddenly and unexpectedly; they will break into the *Church. They will enter Italy and lay Rome waste; they will burn down churches and destroy everything."*

Henry Edward Cardinal Manning said: "The apostasy of the city of Rome from the vicar of Christ and its destruction by Antichrist may be thoughts so new to many Catholics, that I think it well to recite the text of theologians of greatest repute. First Malvenda, who writes expressly on the subject, states as the opinion of Ribera, Gaspar Melus, Biegas, Suarrez, Bellarmine and Bosius that Rome shall apostatise from the faith, drive away the Vicar of Christ and return to its ancient paganism. ...Then the Church shall be scattered, driven into the wilderness, and shall be for a time, as it was in the beginning, invisible hidden in catacombs, in dens, in mountains, in lurking places; for a time it shall be swept, as it were from the face of the earth. Such is the universal testimony of the Fathers of the early Church."

One ought really not to be surprised of Lucifer's infiltration into the Church, especially the Church that would rise to the pinnacle of religious power in the world. But it would require more than a millennium before Lucifer's clutches would capture the Roman Catholic Institution. In 1784 Adam Weishaupt, a jesuit-trained professor of canon law, defected from Christianity, and embraced the Luciferian ideology while teaching in Ingoldstadt University.

In 1770 the money lenders (who had recently organized the House of Rothschild), retained him to revise and modernize the age-old 'protocols' designed to give the **"Synagogue of Satan"** ultimate world domination so they can impose the Luciferian ideology upon what remains of the Human Race, after the final social cataclysm, by use of satanic despotism.

Weishaupt [under the direction of Baron Amschel Mayer von Rothschild (Knight of Malta, the real Architect of the Bavarian Illuminati)] completed his task May 1st, 1776.



The plan required the destruction of ALL existing governments and religions. This objective was to be reached by dividing the masses, whom he termed Goyim (meaning human cattle) into opposing camps in ever increasing numbers on political, racial, social, economic and other issues.

In 1776 Weishaupt organized the Illuminati to put the plot into execution. The word **Illuminati is derived from Lucifer, and means 'holders of the light'**. Using the lie that his objective was to bring about a one world government to enable men with proven mental ability to govern the world he recruited about two thousand followers.

These included the most intelligent men in the field of Arts and Letters, Education, the sciences, finance and industry. He then established Lodges of the Grand Orient to be their secret headquarters. Adepts seeking advancement in Freemasonry, as part of the rites and rituals of the Lodge, are asked, "What is it that you seek?" The adept is expected to reply, "More light!"

Weishaupt's revised plan required his Illuminati to do the following things to help them accomplish their purpose:

(1) <u>Use monetary</u> and <u>sex bribery</u> to obtain control of people already occupying positions in high places in the various levels of ALL governments and other fields of human endeavor [especially <u>pedophilia at the highest levels of power</u>].

Once an influential person had fallen for the lies, deceits, and temptations of the Illuminati they were to be held in bondage by application of political and <u>other forms of blackmail</u> and threats of financial ruin, <u>public exposure</u>, and physical harm and even death to themselves and their loved ones.

(2) Illuminati on the faculties of colleges and universities were to recommend students possessing exceptional mental ability belonging to well-bred families with international leanings for special training in internationalism.

This training was to be provided by granting scholarships to those selected. They were to be educated (<u>indoctrinated</u>) into accepting the 'Idea' that only a <u>One World Government</u> can put an end to recurring wars and tribulations.

They were to be at first persuaded and then convinced that men of special ability and brains had the RIGHT to rule those less gifted, because the Goyim (masses of the people) don't know what is best for them physically, mentally and spiritually.

Today three such special schools are located in Gordonstoun in Scotland; Salem in Germany; and Anavryta in Greece.

Prince Phillip, the husband of Queen Elizabeth of England, was educated at Gordonstoun at the

instigation of Lord Louis Mountbatten, his Uncle, who became Britain's Admiral of the Fleet after <u>World War Two</u> ended.

(3) Influential people trapped into coming under the control of the Illuminati, and students who had been specially educated and trained were to be used as agentur and placed behind the scenes of ALL governments as "Experts" and "Specialists" so they could advise the top executives to adopt policies which would in the long run, serve the secret plans of the One Worlders and bring about the ultimate destruction of the governments and religions they were elected or appointed to serve.

(4) The Illuminati were to <u>obtain control of the Press and all other agencies which distribute</u> <u>information to the public</u>. News and information was to be slanted so that the Goyim would come to believe that a <u>One World Government</u> is the ONLY solution to our many and varied problems.

Because Britain and France were the two greatest powers at the end of the 18th Century, Weishaupt ordered the Illuminati to foment the Colonial Wars to weaken the British Empire and organize the Great Revolution to weaken the French Empire. The latter he scheduled should start in 1789.

A German author named Zwack put Weishaupt's revised version of the age-old conspiracy into book form and named it "Einige Original-Scripten."

In 1784 a copy of this document was sent to the Illuminists Weishaupt had delegated to foment the French revolution. The courier was struck dead by lightning as he rode through Ratisbon on his way from Frankfurt to Paris. The police found the subversive documents on his body and turned them over to the proper government authorities.

After careful study of the plot the Bavarian Government ordered the police to raid Weishaupt's newly organized lodges of the Grand Orient and the homes of some of his most influential associates, including the castle of Baron Bassus-in-Sandersdorf.

Additional evidence thus obtained convinced the authorities the documents were a genuine copy of a conspiracy by which the "*Synagogue of Satan*", who controlled the Illuminati <u>AT THE</u> <u>TOP</u>, planned to use wars and revolutions to bring about the establishment of one kind or another of a One World Government, the powers of which they intended to usurp as soon as it was established.

In 1785, the Bavarian Government outlawed the Illuminati and closed the lodges of the Grand Orient. In 1786, they published the details of the conspiracy. The English title is "The Original Writings of the Order and Sect of The Illuminati". Copies of the conspiracy were sent to the heads of church and state. The power of the Illuminati was so great that this warning was ignored, as were the warnings Christ had given the world.

The Illuminati went underground. Weishaupt instructed his Illuminists to infiltrate into the lodges of Blue Masonry and form a secret society within secret societies.

Only Masons who proved themselves Internationalists, and those whose conduct proved they had defected from God, are initiated into the Illuminati. Thus the conspirators used the cloak of philanthropy to hide their revolutionary and subversive activities.

In order to infiltrate into masonic lodges in Britain Illuminists invited John Robison over to Europe. He was a high degree mason in the Scottish Rite: Professor of natural philosophy at Edinburgh University; and Secretary of The Royal Society of Edinburgh.

John Robison did not fall for the lie that the objective of the one-worlders was to form a benevolent dictatorship. He kept his reactions to himself however, and was entrusted with a copy of Weishaupt's Revised Conspiracy for study and safe keeping.

Because the heads of church and state in France were advised to ignore the warnings given them the revolution broke out in 1789.

In order to alert other governments to their danger, in 1798 John Robison published a book, entitled '*Proof of a Conspiracy to Destroy All Governments and Religions*'. But his warnings have been ignored, as were the others.

Thomas Jefferson had become a student of Weishaupt's. He was one of his strongest defenders when he was outlawed by his government. Jefferson infiltrated the Illuminati into the newly organized Lodges of The Scottish Rite in New England.

Realizing this information will shock many Americans I wish to record the following facts:

In 1789, John Robison warned Masonic leaders the Illuminati had infiltrated into their lodges.

On July 19th, 1798, David Pappen, President of Harvard University, issued the same warning to the graduating class and lectured them on the influence illuminism was having on American politics and religion.

John Quincy Adams had organized the New England Masonic Lodges. In 1800 he decided to oppose Jefferson for the presidency.

He wrote three letters to Colonel Wm. L. Stone exposing how Jefferson was using Masonic lodges for subversive purposes. The information contained in these letters is credited with winning Adams the election. The letters are in Rittenburg Square Library, in Philadelphia.

In 1826 Captain Wm. Morgan decided it was his duty to inform other Masons and the general public what the TRUTH is regarding the Illuminati, their secret plans and intended purpose. The

Illuminati obtained the services of Richard Howard, an English Illuminist, to carry out their sentence "That Morgan be EXECUTED as a traitor."

Captain Morgan was warned of his danger. He tried to escape to Canada but Howard caught up with him near the border. He was murdered near the Niagara Gorge.

INSIGNIA of the **ORDER OF ILLUMINATI** THAT ILLUMINIST JEFFERSON MADE the REVERSE of U.S. SEAL

The above insignia of the Order of Illuminati was adopted by Weishaupt at the time he founded the Order, on May 1, 1776. It is that event that is memorialized by the MDCCLXXVI at the base of the pyramid, and not the date of the signing of the Declaration of Independence, as the uninformed have supposed.

The significance of the <u>design is as follows</u>: the pyramid represents the conspiracy for destruction of the Catholic (*Universal Christian*) Church, and establishment of a "One World", or UN dictatorship, the "secret" of the Order; the eye radiating in all directions, is the "all-spying eye" that symbolizes the terroristic, Gestapo-like, espionage agency that Weishaupt set up under the



name of "Insinuating Brethren", to guard the "secret" of the Order and to terrorize the populace into acceptance of its rule. This "Ogpu" had its first workout in the *Reign of Terror of the French Revolution*, which it was Instrumental in organizing. It is a source of amazement that the electorate tolerates the continuance of use of this insignia as part of the Great Seal of the U.S.

"ANNUIT COEPTIS" means "our enterprise (conspiracy) has been crowned with success". Below, "NOVUS ORDO SECLORUM" explains the nature of the enterprise : and it means "a New Social Order", or "New Deal".

It should be noted that this insignia acquired Masonic significance only after merger of that Order with Order of Illuminati at the Congress of Wilhelmsbad, in 1782.

Benjamin Franklin, John Adams (Roosevelt kinsman) and Thomas Jefferson, ardent Illuminist, proposed the above as the reverse of the seal, on the face of which was the eagle symbol, to Congress, which adopted it on June 20, 1782. On adoption of the Constitution, Congress decreed, by Act of September 15, 1789, its retention as seal of the United States. It is stated however, by the State Department in its latest publication on the subject (2860), that "the reverse has never been cut and used as a seal", and that only the observe bearing the eagle symbol has been used as official seal and coat of arms. It first was published on the left of the reverse of the dollar bills at the beginning of the New Deal, 1933 by order of President F.D. Roosevelt.

What is the meaning of the publication at the outset of the New Deal of this "Gestapo" symbol that had been so carefully suppressed up to that date that few Americana knew of its existence, other than as a Masonic symbol ?

It can only mean that with the advent of the New Deal the Illuminist-Socialist-Communist conspirators, followers of <u>Professor</u> <u>Weishaupt</u>, regarded their efforts as beginning to be crowned with success.

In effect this seal proclaims to the <u>One Worlders</u> that the entire power of the U.S. Government is now controlled by the Illuminati's *agentur* and is persuaded or forced to adopt policies which further the secret plans of the conspirators to undermine and destroy it together with the remaining governments of the so-called 'Free World', ALL existing religions, etc., etc., so that the Synagogue of Satan will be able to usurp the powers of the first world government to be established and then impose a *Luciferian* totalitarian dictatorship upon what remains of the Human Race.

Research proved that one Avery Allyn made a sworn affidavit in the City of New York to the effect that he heard Richard Howard report to a meeting of Knights Templars in St. John's Hall, New York, how he had 'Executed' Morgan. He told how arrangements had then been made to ship Howard back to England.

Very few people today know that **general disapproval and disgust over this incident caused nearly 40% of Masons belonging to the Northern Jurisdiction of the United States to secede**. I have copies of minutes of a meeting held to discuss this particular matter.

The power of those who direct the Luciferian conspiracy against God and Man can be realized by the ability of their agentur to prevent such outstanding events of history being taught in our public schools.

In 1829, the Illuminati held a meeting in New York which was addressed by a British Illuminist named Wright. Those in attendance were informed that the Illuminati intended to unite the Nihilist and Atheist groups with all other subversive organizations into an international organization to be known as Communism.

This destructive force was to be used to enable the Illuminati to foment future wars and revolutions. Clinton Roosevelt (a direct ancestor of F.D.R.) Horace Greeley, and Charles. Dana were appointed a committee to raise funds for this new venture. The fund they raised financed Karl Marx and Engels when they wrote "**Das Capital**" and "**The Communist Manifesto**" in Soho, England.

In 1830, Weishaupt died. He carried the deception that the Illuminati was dead to his own death-bed where, to convince his spiritual advisers, he pretended to repent and rejoin the Roman Catholic Church. According to Weishaupt's revised version of the Age-Old conspiracy the Illuminati were to organize, finance, direct and control ALL international organizations and groups by working their agentur into executive positions AT THE TOP.

Thus it was that while **Karl Marx was writing the Communist Manifesto** under direction of one group of Illuminists, Professor Karl Ritter of Frankfurt University was writing the antithesis under direction of another group, so that those who direct the conspiracy AT THE TOP could use the differences in these two ideologies to start dividing larger and larger numbers of the Human Race into opposing camps so they could be armed and then made to fight and destroy each other, together with their political and religious institutions.

The work Ritter started was continued by the German so-called philosopher **Friedrich Wilhelm Nietzsche** (1844-1900) who founded Nietzscheism. Nietzscheism was developed into Fascism and later into Naziism and used to enable the agentur of the Illuminati to foment World Wars One and Two.

In 1834 the Italian revolutionary leader Gussepi Mazzini was selected by the Illuminati to be director of their revolutionary programme throughout the world. He held this post until he died in 1872.

In 1840, **General Albert Pike** was brought under the influence of Mazzini because he became a disgruntled officer when President Jefferson Davis disbanded his auxiliary Indian troops on the grounds they had committed atrocities under the cloak of legitimate warfare.

Pike accepted the idea of a one world government and ultimately became head of the Luciferian Priesthood. Between 1859, and 1871, he worked out the details of a military blueprint, for three world wars, and three major revolutions which he considered would further the conspiracy to its final stage during the twentieth century.

Most of his work was done in the 13 room mansion he built in Little Rock, Arkansas, in 1840. When the Illuminati, and the lodges of the Grand Orient, became suspect, because of Mazzini's revolutionary activities in Europe, Pike organized the New and Reformed Palladian Rite of Freemasonry.

He established three supreme councils; one in Charleston, SC, another in Rome, Italy and another in Berlin, Germany. He had Mazzini establish twenty-three subordinate councils in strategic locations throughout the world. These have been the secret headquarters of the "world revolutionary movement" ever since.

Long before Marconi invented wireless (Radio), the scientists who were of the Illuminati had made it possible for Pike and the Heads of his councils to communicate secretly. It was the discovery of this secret that enabled intelligence officers to understand how apparently

unrelated 'incidents' took place simultaneously throughout the world which aggravated a situation and developed into a war or revolution.

Pike's plan was as simple as it has proved effective. He required that Communism, Nazism, Political Zionism, and other International movements be organized and used to foment the three global wars and three major revolutions.

The first world war was to be fought so as to enable the Illuminati to overthrow the powers of the Tzars in Russia and turn that country into the stronghold of Atheistic-Communism. The differences stirred up by agentur of the Illuminati between the British and German Empires were to be used to foment this war. After the war ended, Communism was to be built up and used to destroy other governments and weaken religions.

World War Two, was to be fomented by using the differences between Fascists and Political Zionists. This war was to be fought so that Nazism would be destroyed and the power of Political Zionism increased so that the sovereign state of Israel could be established in Palestine.

During World War Two International Communism was to be built up until it equaled in strength that of united Christendom. At this point it was to be contained and kept in check until required for the final social cataclysm.

Can any informed person deny Roosevelt and Churchill did not put this policy into effect?

World War Three is to be fomented by using the differences the agentur of the Illuminati stir up between Political Zionists and the leaders of the Moslem world.

The war is to be directed in such a manner that Islam (the Arab World including Mohammedanism) and Political Zionism (including the State of Israel) **will destroy themselves** while at the same time the remaining nations, once more divided against each other on this issue, will be forced to fight themselves into a state of complete exhaustion physically, mentally, spiritually and economically.

Can any unbiased and reasoning person deny that the intrigue now going on in the Near, Middle, and Far East isn't designed to accomplish this devilish purpose?

On August 15, 1871, Pike told Mazzini that after World War Three is ended, those who aspire to undisputed world domination will provoke the greatest social cataclysm the world has ever known. I quote his own written words (taken from the letter catalogued in the British Museum Library, London, England:

"We shall unleash the Nihilists and Atheists, and we shall provoke a formidable social cataclysm which in all its horror will show clearly to the nations the effect of absolute atheism,

origin of savagery and of the most bloody turmoil."

"Then everywhere, the citizens, obliged to defend themselves against the world minority of revolutionaries, will exterminate those destroyers of civilization, and the multitude, disillusioned with christianity, whose deistic spirits will be from that moment without compass (direction), anxious for an ideal, but without knowing where to render its adoration, will receive the true light through the universal manifestation of the pure doctrine of Lucifer brought finally out in the public view, a manifestation which will result from the general reactionary movement which will follow the destruction of Christianity and atheism, both conquered and exterminated at the same time."

When Mazzini died in 1872, Pike made another Italian revolutionary leader, named Adriano Lemmi, his successor. Lemmi was later succeeded by Lenin and Trotsky.

The revolutionary activities of all these men were financed by British, French, German, and American international bankers. The reader must remember that the International Bankers of today, like the Money-Changers of Christ's day, are only tools or agents of the Illuminati.

While the general public has been lead to believe that Communism is a movement of the workers (soviets) to destroy Capitalism, 'Pawns In The Game' and 'The Red Fog Over America' prove that both British and American Intelligence Officers obtained authentic documentary evidence which proved that internationalist capitalists operating through their international banking houses had <u>financed both sides in every war and revolution fought since 1776</u>.

Those who to-day comprise The *"Synagogue of Satan"* direct our governments, whom they hold in usury, to fight the wars and revolutions so they further Pike's plans to bring the world to that stage of the conspiracy when Atheistic-Communism and the whole of Christendom can be forced into an all-out war within each remaining nation as well as on an international scale.

There is plenty of documentary evidence to prove that Pike, like Weishaupt, was head of the Luciferian Priesthood in his day. In addition to the letter he wrote Mazzini in 1871, another he wrote to the heads of his Palladian Councils July 14th, 1889 fell into hands other than intended. It was written to explain the Luciferian dogma, concerning worship of Satan and worship of Lucifer. In it, he said in part:

"That which we say to the crowd is 'we worship God'. But it is the God that one worships without superstition. The religion should be, by all us initiates of the high degrees, maintained in the purity of the Luciferian doctrine ... <u>Yes! Lucifer is God</u>."

"And unfortunately Adonay (the name given by Luciferians to the God we worship) is God also ... for the absolute can only exist as two Gods. Thus, the doctrine of Satanism is a heresy: and the true, and pure philosophical religion is the belief in Lucifer, the equal of Adonay: but Lucifer, God of Light, and God of Good, is struggling for humanity against Adonay the God of Darkness and Evil."

Research dug up letters from Mazzini which revealed how the High Priests of the Luciferian Creed keep their identity and true purpose secret. In a letter Mazzini wrote to his revolutionary associate, Dr. Breidenstine, only a few years before he died he said:

"We form an association of brothers in all points of the globe. We wish to break every yoke. Yet, there is one unseen that can be hardly felt, yet it weighs on us. Whence comes it? Where is it? No one knows... or at least no one tells. This association is secret even to us the veterans of secret societies."

In 1925 Cardinal Caroy Rodriguez, Archbishop of Santiago, Chile, published a book '*The Mystery of Freemasonry Unveiled*', to expose how the Illuminati, the Satanists, and the Luciferians had imposed a secret society upon a secret society.

He produces a great deal of documentary evidence to prove that not even 32nd and 33rd degree Masons know what goes on in the Lodges of the Grand Orient and Pike's New and Reformed Palladian Rite and the affiliated Lodges of Adoption in which female members of the conspiracy are initiated. On page 108 he quotes the authority Margiotta to prove that before Pike selected Lemmi to succeed Mazzini as Director of the World Revolutionary Movement Lemmi was a rabid and confirmed Satanist. But after he had been selected he was initiated into the Luciferian ideology.

Weishaupt's plot requires:

- 1. Abolition of ALL ordered national governments.
- 2. Abolition of inheritance.
- 3. Abolition of private property.
- 4. Abolition of patriotism.
- 5. Abolition of the individual home and family life as the cell from which all civilizations have stemmed.
- 6. Abolition of ALL religions established and existing so that the Luciferian ideology of totalitarianism may be imposed on mankind.

The headquarters of the conspiracy in the late 1700s was in Frankfurt, Germany, where the House of Rothschild had been established and linked together other international financiers who had literally "Sold their souls to the devil".

After the Bavarian Government's exposure in 1786, the High Priests of the Luciferian Creed established their headquarters in Switzerland; since World War Two the headquarters

have been in the Harold Pratt Building New York. The Rockefellers have replaced the Rothschild's as far as the manipulation of finances is concerned.

In the final phase of the conspiracy the government will consist of the king-despot, the *"Synagogue of Satan"*, and a few millionaires, economists, and scientists who have proved their devotion to the Luciferian cause. All others are to be integrated into a vast conglomeration of mongrelized humanity, by artificial insemination practiced on an international scale.

On pages 49-51 '*The impact of Science on Society*', Bertrand Russell says that ultimately **less than 30 percent of the female population and 5 percent of the male population will be used for breeding purposes**. Reproduction will be strictly limited to the type and numbers required to fill the needs of the state.

Because the rulings of the courts are so much in the public mind today, we will conclude the introduction by quoting from a lecture given to the members of the Grand Orient Lodge of Paris, France, by a top executive of Pike's Palladian Rite, at the turn of the present century. He said:

"Under our influence the execution of the laws of the Goyim has been reduced to a minimum. The prestige of the law has been exploded by the liberal interpretations introduced into this sphere."

"In the most important and fundamental affairs and questions judges decide as we dictate to them: see matters in the light where with we enfold them for the administration of the Goyim, of course through persons who are our tools though we do not appear to have anything in common with them. Even Senators and the higher administration accept our council..."

Can any thinking person deny that the conspiracy as revised by Weishaupt in the latter 1700s, and the plans drawn up by Pike in the latter 1800s, haven't matured exactly as intended?

The empires of Russia and Germany have been destroyed. Those of Britain and France reduced to third class powers. The crowned heads have fallen like over-ripe fruit. The world's population has twice been divided into opposing camps as the result of propaganda put out by the Illuminati.

Two world wars have seen Christians kill each other off efficiently by the tens of millions without any person engaged having the slightest personal animosity towards the other. Two of the major revolutions, those of Russia and China, are accomplished facts. Communism has been built up until it is equal in strength to the whole of Christendom.

Intrigue now going on in the East and Middle East is fomenting World War Three. After that, unless stopped right now by sheer weight of informed public opinion, will come the final

social cataclysm; then absolute physical, mental, and spiritual slavery will follow.

Can any informed person deny that Communism is being tolerated in the remaining socalled free countries? The British special branch of intelligence; the Canadian R.C.M.P., and the U.S. F.B.I. could arrest every Communist leader within twenty four hours of the order being given, but they are not allowed to act. The answer is simple. Communism is being 'Contained' on the national and international levels of government on the 'ADVICE' of the Illuminati's agentur who give a great many utterly unconvincing excuses for the present policy of Britain, Canada, and the United States towards national and international Communism. But this leads us to ask the question, where did *Lucifer* come from and what does his name mean? Who is his world representative today?

ORIGIN and MEANING of the word LUCIFER

<u>LUCIFER</u> (/ˈluːsɪfər/ or /ˈljuːsɪfər/) is the King James Version rendering of the Hebrew word from Isaiah 14:12. This word, transliterated *hêlêl* or *heylel*, occurs only once in the Hebrew Bible and according to the KJV-influenced '*Strong's Concordance'* means "*shining one, morning star, light bearer*". The word *Lucifer* as a noun is taken from the Latin Vulgate, which translates as *lucifer* from the same Isaiah 14:12 passage, meaning "the morning star as the planet Venus". As an adjective, *lucifer means "light-bringing*". The Septuagint renders *icwapópoç* (*heōsphoros*), a name which literally translates into "bringer of dawn" as the "morning star".

In the following passage, Isaiah applies to a king of Babylon the image of the morning star fallen from the sky, an image he is generally believed to have borrowed from a legend in Canaanite mythology.

Isaiah 14:12 (Latin Vulgate) "quomodo cecidisti de caelo lucifer qui mane oriebaris corruisti in terram qui vulnerabas gentes"

The Hebrew word translated as "Lucifer" in Isaiah 14:12 in the KJV is heylel (hay-lale', Strong's #1966), and literally means "shining one", "morning star", "light bearer". Isaiah 14:12 is the only place in Scripture where this Hebrew word appears. Since the word does not appear elsewhere in the Bible, it becomes an issue in determining its meaning and origin.

The use of the name "Lucifer" is ancient in Latin, referring to the *planet Venus* as the first appearing *star in the morning*. Although some early Christian Latin writings seem to refer to the devil as "Lucifer", it was the Latin Vulgate to be the most responsible factor for its current widespread use. The Vulgate was produced by Jerome (cira 347-420 A.D.) while translating the available Greek and Hebrew manuscripts into Latin. Started in approximately 382 A.D. and completed around the year 405 A.D., this version was used as Scriptures for almost 1,000 years by the Catholic Church. In the Vulgate version above, the word "lucifer" is

used with a lower case: "quomodo cecidisti de caelo lucifer qui mane oriebaris corruisti in terram qui vulnerabas gentes". In this segment, I draw upon many Catholic sources that help us understand Lucifer's roots become clear as we seek to gain understanding.

The meaning of the Hebrew word **heylel** as **"light bearer"** was conveyed by Jerome through the parallel and literal concept which, in Latin, was expressed by the word **lucifer**. Indeed, this word was utilized in reference to the *planet Venus*, which was considered the **light bearer** as it was the first visible light after each night. The word **lucifer** composed of the Latin **lux** (*light*) and the Latin **ferre** (to bear or to bring), was used from Jerome's time up until the era of the King James Version translation (405 A.D. to 1611 A.D.). The genitive version of the word **Lux** is **Lucis** (possessor of the light). Please take a look at the United Nations based organization Lucis Trust (formerly Lucifer Publishing Company), headquartered at the United Nations.

Since Jerome believed that the Isaiah passage pertained to the evil king of Babylon, he made the connection with Satan by morphing the two together and igniting the evolutionary meaning of the word *lucifer* from a representation of Venus to today's representation of Satan. Therefore, we could declare that due to a common popular interpretation of the passage, *"Lucifer"*, additionally to the morning star Venus, began to be perceived as Satan.

Early church fathers believed that "Lucifer" was not to indicate the formal name of the devil, but rather the former state from which he fell. Because of all these variations and evolutions, "lucifer" can be utilized in disparate fashions and for very different purposes such as Jesus Christ, Satan, Venus, a pagan deity, a light bearer, an enlightened person, an angel, the morning depending on the context.

The Pseudepigrapha writings of pre-Christian Enoch Judaism, the form of Judaism witnessed to in 1st Enoch and 2nd Enoch, which enjoyed much popularity during the Second Temple period, gave Satan an expanded role, interpreting Isaiah 14:12-15, with its reference to the morning star, as applicable to him, and presenting him as a fallen angel cast out of heaven for refusing, according to Jewish writings, to bow to Adam, of whom Satan was envious and jealous of the power over the earth granted to Adam, motives to which Christians were to add pride, which they mention more frequently than envy or jealousy with regard to humanity.

The word *"lucifer"* as an adjective in Latin: As an adjective, the Latin word *lucifer* meant "*light-bringing*" and was applied to the moon.

The word "*lucifer*" as a noun in Latin: As a noun, the Latin word *lucifer* meant "*morning* star".

The word was also used in reference to the Greek mythological goddess "*Eos*", the goddess of dawn giving birth to the morning star Phosphorus.

In Roman mythology, its divine personification meant "the fabled son of Aurora and Cephalus, and father of Ceyx" while in poetry it meant "*day*". Isaiah 14:12 is not the only place

where the Vulgate uses the word *lucifer*. It uses the same word seven more times, in contexts where it clearly has no reference to a fallen angel:

2 Peter 1:19 – meaning "morning star" Job 11:17 – meaning "the light of the morning" Job 38:32 – meaning "the signs of the zodiac" Psalms 110:3 – meaning "the dawn" The Apocryphal book of Sirach 50:6 – referring to the actual "morning star" Revelation 2:28 – of uncertain reference Revelation 22:16 – referring to "Jesus"

Indications that in Christian tradition the Latin word *lucifer*, unlike the English word, did not necessarily call a fallen angel to mind and exist also outside the text of the Vulgate. In the works of Latin grammarians, Lucifer, like Daniel, was discussed as an example of a personal name.

Two Roman bishops bore that name: Saint Lucifer of Cagliari, and Lucifer of Siena. In Latin, the word is applied to John the Baptist and is used as a title of Christ Himself in several early Christian hymns. The morning hymn Lucis largitor spendide of Hilary contains the line: "Tu verus mundi lucifer". Some interpreted the mention of the morning star (lucifer) in Ambrose's hymn Aeterne rerum conditor as referring allegorically to Christ and the mention of the cock, the herald of the day (praeco) in the same hymn as referring to John the Baptist. Likewise, in the medieval hymn Christe qui lux es et dies, some manuscripts have the line "Lucifer lucem proferens". The Latin word lucifer is also used of Christ in the Easter Proclamation prayer to God regarding the paschal candle:

'Flammas eius lucifer matutinus inveniat: ille, inquam, lucifer, qui nescit occasum. Christus Filius tuus, qui, regressus ab inferis, humano generi serenus illuxit, et vivit et regnat in saecula saeculorum'

'May this flame be found still burning by the Morning Star: the one Morning Star who never sets, Christ your Son, who, coming back from death's domain, has shed his peaceful light on humanity, and lives and reigns for ever and ever' In the Litany of Loreto, the Blessed Virgin Mary is invoked as "Stella matutina", Morning Star, and a popular English hymn addressed to her has the stanza:

'Mary Immaculate, Star of the Morning, Chosen before the creation began, Destined to bring, through the Light of your Dawning, Conquest of Satan, and rescue to Man'.

A clarification on POPE FRANCIS' INVOCATION of LUCIFER:

One of the reasons for having such an introduction about the use and meanings of the word **'lucifer'** and of the word **'Lucifer'** is due to the viral sensationalism caused by a video displaying the Easter Mass celebrated in 2013 – soon after Francis' election. Due to the 'scandal' it caused among many believers of other denominations, there was a call to provide an explanation. It is also important to underline that Pope Francis is certainly not the first to



celebrate the Easter Mass through the use of the perceived 'scandalous' text, as other popes have done the same for long before. Without either defending, or attacking such ritual and/or the head of the Catholic Church, some further objective explanation down below, narrating the meanings of the word **'lucifer'** within the different Bible versions and throughout the centuries.

Although the choice of such language can easily be questionable as the use of the adjective '*lucifer*' can somewhat confuse when compared to the use of '*Lucifer*' as a noun, we also confirm that whenever used in Catholic prayers, the word is always printed with a lowercase "*I*" at its beginning, therefore remaining only an adjective referring to Christ as the "*light bringer*". Such makes this use perfectly in line with Scriptures, as we read: "*The people who walked in darkness have seen a great light; those who dwelt in a land of deep darkness, on them has light shined*" from Isaiah 9:1, and "*An angel of the Lord appeared to them and the glory of the Lord shone around them*" from Luke 2:9.

For the sake of considering all possibilities, we can speculate that whether the introduction of such term was done by some Satanists who infiltrated the Catholic Church centuries ago (with the intent of purposely worshiping the angel Lucifer and to create confusion between his role and Christ's), or whether it was done with the pure intention of using the adjective 'lucifer' to solely honor Jesus Christ (as the Light Bearer) remains unknown to us, veiled in obscurity and yet visible in its results. And, as it remains a mystery, here is a quote from a message contained in The Warning Second Coming given to Maria Divine Mercy and which might have something to do with it:

"There is to be a particular insult, which will be inflicted upon My Holy Name, in an effort to desecrate Me, during Holy Week. This wicked gesture, during Holy Week, will be seen by those who keep their eyes open and this will be one of the signs by which you will know that the

imposter, who sits on the throne in My Church on earth, does not come from Me." Message of Jesus – Thursday, March 14th, 2013 – from The Book of Truth

NOTE: By having used the above quote, we do not mean to confirm such occurrence as the 'fulfilled prophecy' contained therein; in this case, we do admit our inability to give such information as absolutely true.

Here is a bit more information in regards to the confusing and fascinating usage of the word *'lucifer'*.

Erasmus might have been the first person to utilize the Latin version of the word *Lucifer* from the Latin Vulgate signifying "*Bringer of the morning*" – what we consider in current English *planet Venus* or *Morning Star*.

The old 1300's Wycliffe's Bible, made from the Latin Vulgate may have been the first English Bible to introduce the Latin word *lucifer* into English at Isaiah 14:12. The 1395 edition of the Wycliffe Bible presented the word *Lucifer* more than once since it was also used at Job 38:32: "Whether thou bringest forth Lucifer, that is, day-star, in his time, and makest evening star to rise on the sons of earth".

The Oxford English Dictionary pointed out, at the entry word *Lucifer*, the following: "*The Latin word was adopted in all the English versions down to 1611*" (IX, p. 81). This source noted that this word was "used as a proper name of the morning star" (Ibid.). Many may be unaware of the fact that Cambridge editions of the KJV (along with some others) took away the capitalization of "*Lucifer*" at Isaiah 14:12, making it a common noun instead of a proper noun, for around 100 years. This was done in the 1629 and 1638 standard Cambridge KJV editions in which two of the KJV translators were said to be involved as editors.

Isaiah 14:12 [capitalization]

O lucifer (1675, 1679, 1709, 1715, 1720, 1747, 1754, 1765, 1768 Oxford) [1629, 1637, 1638, 1683, 1743, 1747, 1756, 1760, 1762, 1765, 1767, 1768, 1783 Cambridge] {1672, 1711, 1735, 1741, 1747, 1750, 1760, 1764, 1767, 1795 London} (1755 Oxon) (1722, 1760, 1769 Edinburgh) (1762 Dublin) (1746 Leipzig) (1782 Aitken) O Lucifer (1758, 1769 Oxford, SRB) – 1769 Cambridge, DKJB- 1611 London

Many KJV advocates might be unaware of the historical evidence concerning the meaning of "*Lucifer*" in the 1500's and 1600's.

The 1534 Luther's German Bible, which is on the KJV-only line of good Bibles, has **'morgen stern'** (morning star) at Isaiah 14:12. In his lectures on Isaiah concerning this verse, Martin Luther indicated that the Hebrew word "denotes the morning star, called *Lucifer* and the son of Dawn" -(Luther's Works, Vol. 16, p. 140). According to this translation of his own comments, Luther's rendering was likely the result of the influence of the Latin Vulgate or at the very least his rendering "morning star" was intended to mean the same as "*Lucifer*." Of the

earlier English Bibles of which the KJV was a revision, the 1535 Coverdale's Bible first used "Lucifer" at Isaiah 14:12. Miles Coverdale is believed to have translated primarily from German (while making use of some Latin) without working from the old Wycliffe's Bible version. Is it possible that Coverdale's rendering 'Lucifer' was his translation for Luther's German Bible's 'morgen stern?' Does this evidence suggest that the rendering 'Lucifer' may have been first introduced into the English Bible from the direct or indirect influence of the Latin Vulgate?

Since the Hebrew word in this verse occurs only once in the whole Old Testament, it was perhaps easy for English translators to follow this interpretation from Latin translators. *Lucifer* was the Latin name for the planet Venus when it appears as the morning star.

The Liberty Annotated Study Bible confirmed that "*the name Lucifer* is actually the Latin designation for the morning star" on page 1038.

The 1968 Cassell's New Latin Dictionary indicated that the Latin word **'lucifer'** comes from two root words meaning "light-bearing, light-bringing" and that it would be translated into English as **"Lucifer, the morning star, the planet Venus."** According to the English-Latin section of this dictionary, the translation of "morning-star" in English is given as **"lucifer"** in Latin.

The Oxford Latin Dictionary gave two definitions for '*lucifer*': "*light-bringing, light-bearing*" and "*the morning star*" on page 1045.

The Oxford Dictionary of Word Histories affirmed that Lucifer is "*a Latin word originally, meaning light-bringing and morning star*" on page 309.

At its entry for day-star, John White listed '*lucifer*' as its meaning in Latin (*Latin-English Dictionary, p. 100*). For **Lucifer,** the definition '*the morning-star, the planet Venus*' is given on page 355.

At the end of Isaiah 14, the 1549 A.D. edition of Matthew's Bible has some notes that include these words: "*Lucifer, the morning star, which he calleth the child of the morning, because it appeared only in the morning.*"

The marginal note in the 1560 and 1599 editions of the Geneva Bible for this word included the following: *"For the morning star that goeth before the sun is called Lucifer."* These two notes from two pre-1611 English Bibles that are on the KJV-only view's line of good Bibles provide some information concerning the meaning of the word *"Lucifer"* in English during the 1500's.

The 1657 English translation of the 1637 Dutch States-General Version and Dutch Annotations also indicated the same meaning with its rendering "*O morning-star*" in Isaiah 14:12.

What did the KJV translators themselves mean by the choice of the word Lucifer in

Isaiah 14:12? The 1611 KJV gives in its margin the literal meaning or acceptable alternative translation for *Lucifer* as *"day-star."* The KJV translators were aware of the marginal note in the Geneva Bible, and they would have recognized that their marginal note about given verse would have associated such meaning (daystar or morning star) with this rendering *'Lucifer'*.

During a sermon, KJV translator Lancelot Andrewes referred to "St Peter's Lucifer in cordibus – *daystar* in your hearts" (*'Hewison, Selected Writings'*, page 112). Clearly, Andrewes used the word *Lucifer* in his sermon with the understood meaning of *'daystar'*. *Daystar* is Old English for *morning star*.

A 1672 edition of the KJV has the following note at Isaiah 14:12: "For the morning-star that goeth before the sun is called Lucifer".

Thus, several credible sources from the 1500's and 1600's clearly establish how the word **'Lucifer'** was commonly used and understood in that time period.

In understanding Scripture, any well-trained student will look closer at the context of the word as used in adjoining passages. This for us today reveals Isaiah 14 is about the king of Babylon. Isaiah 14:12-14 becomes our contextual reference to *"Lucifer's"* agenda. We are clearly shown that *"Lucifer"* is God's nemesis or adversary. That said, the Revelation references in Revelation 2:28 and 22:16 are referring specifically to the Lord Jesus Christ. When the New International Version (NIV) translating team removed the word *"Lucifer"* and substituted the word *"Morning Star"*, they did so likely at the influence of Jesuit Cardinal Carlo Montini, drawing upon the Latin background origin in deceiving his fellow translators.

LUCIFER AND FREEMASONRY



Jesuit Léo Taxil (1854–1907) in the "Taxil Hoax" claimed that Freemasonry was associated with worshiping *Lucifer* and that leading Freemason Albert Pike had addressed "*The 23 Supreme Confederated Councils of the world*", instructing them that *Lucifer* was God, and was in opposition to the evil God Adonai. Albert Pike was Roman Catholic and thought to have been a Jesuit as well. His Jesuit handler or superior was believed to be Jesuit Pierre De Smet of Minnesota. Pierre De Smet instructed Masonic Mormon leader Brigham Young to move his Mormon Church north to the Great Salt Lake Valley that became the state of Utah. <u>The Scottish Rite of Freemasonry was a Jesuit Pierre De Smet as was Albert Pike, the only Confederate General to have a memorial in the Nation's capital, Washington, D.C.</u>

In his book 'Morals and Dogma', Albert Pike spoke of Lucifer in these terms:

"Lucifer, the Light-bearer! Strange and mysterious name to give to the Spirit of Darkness! Lucifer, the Son of the Morning! Is it he who bears the Light, and with its splendors intolerable, blinds feeble, sensual, or selfish souls? Doubt it not!"

Another quote from the same book speaks of Lucifer in the following statement:

"The Apocalypse is, to those who receive the nineteenth Degree, the Apothesis of that Sublime Faith which aspires to God alone, and despises all the pomps and works of Lucifer. LUCIFER, the Light-bearer! Strange and mysterious name to give to the Spirit of Darkness! Lucifer, the Son of the Morning! Is it he who bears the Light, and with its splendors intolerable blinds feeble, for traditions are full of sensual or selfish Souls ? Doubt it not! Divine Revelations and Inspirations: and Inspiration is not of one Age nor of one Creed. Plato and Philo, also, were inspired. The Apocalypse, indeed, is a book as obscure as the Sohar. It is written hieroglyphically with numbers and images; and the Apostle often appeals to the intelligence of the Initiated. "Let him who hath knowledge, understand! let him who understands, calculate !" he often says, after an allegory or the mention of a number. Saint John, the favorite Apostle, and the Depositary of all the Secrets of the Saviour, therefore did not write to be understood by the multitude." When a Mason rises to the 19th Degree, he is informed that Lucifer is God!

Although apologists of Freemasonry contend that Albert Pike and other Masonic scholars referred to the (*the energies of Lucifer*) as the "Morning Star" (*the light bearer as the very antithesis of the dark, satanic evil*), Freemasonry was infiltrated and corrupt by 'subgroups'. These factions, such as the order of the *Illuminati*, the *P2*, or *Skull and Bones*, are just a few of the many branches of secret societies sprawling throughout the hidden net.

Taxil acquired very truthful information from the faction of the *Illuminati*, which infiltrated the Jesuit order prior to being reabsorbed into the Catholic Church in 1814. Although Taxil's "Hoax" was publicly known in the 1790's, it was only released from the Masonic archives (in which they were kept secret) in 1924. And, although he promoted a book written by *Diana Vaughan* (but that he actually wrote himself, as he later confessed publicly) his information

seems to be very accurate. In fact, he speaks of a third world war conflict between the Muslims and the Zionists, in the Middle East and at a time *prior* to the unimaginable formation of the state of Israel in 1948.

The information he revealed in his writings, although dismissed by many as he selfadmittedly denied its veracity in regards to Freemasonry during a press conference on April 19 1897, is still an important key to understand the relationship between the corrupt parts and individuals in the Jesuit Order and the corrupt individuals of the Zionist Order forming the Illuminati. They secretly came together and infiltrate the world's governments and high positions of power in all major industries, above all the banking cartel.



The Sigil of Lucifer (Seal of Satan) a magical sigil used occasionally as an emblem by Satanists. In the modern occultism of Dolores North (alias Madeline Montalban), Lucifer's identification as the Morning Star (Venus) equates him with Lumiel, whom she regarded as the Archangel of Light, and among Satanists he is seen as the "Torch of Baphomet" and Azazel. The Bible says that Satan comes as an angel of light. "And no marvel; for Satan himself is transformed into an angel of light." -(2nd Corinthians 11:14).

In the Satanic Bible of 1969, Lucifer is acknowledged as one of the Four Crown Princes of Hell, particularly that of the East. Lord of the Air, Lucifer has been named "<u>Bringer of Light, the</u> <u>Morning Star, Intellectualism, Enlightenment</u>."

On 14 March 2013, **Grand Master Gustavo Raffi** of the **Grand Orient Lodge of Italy**, speaks of Pope Francis as if almost prophesying a very accurate profile of the man, as well as the actions and words he will soon display in front of the world. Here is the translation of his entire speech – which can be seen in the screenshot below, taken directly from the official website: www.grandorient.it. Translated below into English:

"A man of the poor and far from the Curia. Fraternity and dialogue are his first concrete words: maybe in the new Church nothing will ever be like before. Romano Guardini, who was mentioned by *Grand Master Gustavo Raffi*, is usually acknowledged as a major player in the theological and liturgical movements of the 1930s and 1940s that led to the reforms of Vatican II. The main lines of his theology opened the way for the adaptation of the Church to the modern world, especially the drastic changes of the Catholic Mass (the role of the priest; the facing toward the people rather than the altar; the diminishing importance of the altar as a sacred place).

He also was a continuator of Modernism as well as a progressivist. As early as 1927, Guardini was saying the Mass versus populum and in German in a redesigned chapel at Burg

Rothenfels. Discarding the Gothic altars and elaborate décor, he stripped the church, painted the walls white and installed a moveable altar surrounded on three sides by simple stools. Today, Romano Guardini remains Pope Bergoglio's main source of inspiration.


The Permanent Instruction of the Alta Vendita

In this supreme moment of need for the Church, the one who should speak will fall silent." ~ Our Lady of Good Success, Quito, Ecuador, 1610 A.D. "

The subversive plan to conquer the Bride, the Immaculate Spouse, dates back to the obscure corners of time immemorial, and after the first official take-over back in 1958 (as the Church was assaulted by the army of liberals, modernists, human rights and sexual liberation supporters during the tragic Second Vatican Counsel), it has come to almost its completion. With the entry of the False Prophet nothing shall ever be the same.

One of the most vital resources revealing the Masonic invasion within the Vatican walls is The Permanent Instruction of the **Alta Vendita**, a Masonic blueprint for the subversion of the Holy Catholic and Apostolic Church. This document, originally published in Italian in the 19th century, was purportedly produced by the highest lodge of the Italian Carbonari and written by <u>Piccolo Tigre</u>, the codename for Giuseppe Mazzini.

The document details a Masonic plan to infiltrate the Catholic Church and spread liberal ideas within it. The Carbonari, being part of Freemasonry, render this booklet a must-see Masonic document for whoever desires to know the truth behind the scarlet Vatican curtains.

So crucial was the issue of the infiltration of Freemasonry in the Mystical Body of Christ that in the 19th century, Pope Pius IX and Pope Leo XIII both asked for it to be published. It was first published by Jacques Crétineau-Joly in his book '*L*'Église romaine en face de la Révolution' in 1859. It was popularized in the English-speaking world by Monsignor George F. Dillon in 1885 with his book the War of Anti-Christ with the Church and Christian Civilization. The important document is still being consulted by true Catholics as it accurately describes the changes within the Church during the post-Vatican II era.

The Strategy outlined in the Permanent Instruction of the Alta Vendita is astonishing in its diabolicalness, cunning and audacity. The document reveals a long process which will involve decades to accomplish in its final goal. Indeed, the authors of the plot were very well aware of the fact that they would not see the day of its fulfillment. Just like black widows spinning their webs of deceit while making sure they will continue to exist as a specie through reproduction, these masters of the craft began a task that will be carried on by the succeeding generations of initiated members. This concept is expressed very concisely in a statement contained within The Permanent Instruction saying "*In our ranks the soldier dies and the struggle goes on.*" The mandate sought for the propagation of liberal ideas and fundamentals throughout every country's society and within the institutions of the Catholic Church so that, over time, prelates, clerics, seminarians and laity would systematically be ingrained with such innovative principles.

Eventually this progressive outlook would be so ubiquitous that cardinals, bishops and priests would respectively be ordained, consecrated and nominated while having adopted the latter-day philosophies entrenched in the French Revolution's *Declaration of the Rights of Man and of the Citizen* passed in 1789. Let us remember that, among these, <u>are found the *separation of church and state*, the *equality of religions*, and *the religious pluralism*. Ultimately, the depraved members of these altered ranks would elect a Pope from these same hierarchies: a vicar who would lead the Catholic Church on the revolutionary path of *enlightenment* and *renewal* from the Chair of Peter. Their initial goal was to ignite the circumstances necessary in order to induce a Pope (and a hierarchy) to embrace and promote the ideas of liberal Catholicism, all the while believing themselves to be *faithful* Catholics. These Catholic leaders, then, would no longer oppose the modern ideas of the French Revolution the same way it was done by those Popes who were given authority between 1789 and 1958, but would amalgamate them into the church. From what one can see, the plan of the Church's enemies has come to accomplish its wanted objective. Francs–Macons, or identified by whatever other designation according to the variety of idioms in which men of any religion and sect whatsoever, satisfied by a certain feigned appearance of natural honesty, are mutually united by a strict as well as impenetrable covenant according to the laws and statues established by them, and which at the same time they both secretly dedicate themselves to by a strict oath administered on the Sacred Bible, and which under the accumulation of severe penalties they are bound to conceal by an inviolable silence...We have established and Decreed, that from the counsel of several of Our Brother Cardinals of the Holy Roman Church, and especially by Our own motion and from the fullness of Apostolic Power, those same societies, assemblies, meetings, gatherings, fellowships, or associations commonly called de' Liberi Muratori or Francs–Macons, or called by any other name whatever, must be condemned and prohibited, as by Our present Constitution, perpetually valid, We condemn and prohibit them.]

THE MYSTERY OF THE HIDDEN HAND



Duncan's Masonic Ritual Monitor by Malcolm C. Duncan:

Master of Second Veil: "Three Most Excellent Masters you must have been, or thus far you could not have come; but farther you cannot go without my words, sign, and word of exhortation. My words are Shem, Japhet, and Adoniram; my sign is this: (thrusting his hand in his bosom); it is in imitation of one given by God to Moses, when He commanded him to thrust his hand into his bosom, and, taking it out, it became as leprous as snow. Interestingly, the prophecy given above from Jesus Christ in The Book of Truth speaks of this pope as the 'Little Horn' from the Book of Daniel. In the photograph above, the 'little horns' might be a signal. Obviously, we do not attest given signs as absolute truth but rather, as curious data.

Prophecy? It might, as said above, be the fruit of mere coincidence, but nonetheless: as you scroll down this page, a picture can be put together in a puzzling series of suspicious hints

which are hard to believe if compared to the lack of prophecy interest among the catholic faithful.

We have emphasized in red the words in the photo above. They have nothing to do with the content related to the pope and yet: if connected, they read '**Bilingual after the end**'. It is curious to analyze the meaning of such phrase as broken down here below:

BILINGUAL: It is further to be observed, that the mouth of the **serpent** was occasionally opened by means of a horsehair skillfully adjusted for the purpose, at the same time that by similar means the animal darted out its **biforked (bi-lingual) tongue** to the terror of the amazed bystanders.

Lingual comes from Old Latin *dingua* which is a cognate (kindred) with Old English *tunge*, The change of *d* (in Old Latin *dingua*) to *l* (in Latin *lingua*) was probably due to dialectal influence (the so-called "Sabine I"). It was facilitated by a folk-etymological association with lingere, "to lick", the tongue having been conceived as "**the licking organ**". BI-LINGUAL represents the DOUBLE TOUNGUE, or FORKED TONGUE of a snake.

Also, the 'two red horns' of the devil appearing on top of Francis' head, are a representation of the forked tongue of the serpent. <u>Bilingual after the end</u> might signify the revelation of the serpent after the end –*the fall*– of the Catholic Church.

Could there be an element of cynical truth meant to obscure Pope Francis? You decide. But there is more to this strange series of facts. It gets stranger as we peel back the proverbial onion.

Sources are telling 'Church Militant' privately that during last week's meeting between Pope Francis and the U.S. delegation of Cardinals Daniel DiNardo and Sean O'Malley, as well as Los Angeles Archbishop Jose Gomez, the Pope basically told them to go take a hike! DiNardo went to the Pope with three proposals to address the burgeoning clerical sex abuse crisis which is largely homosexual in nature. The three proposals the Americans laid in front of the Pope were:

Cardinal DiNardo has previously said publicly that all three goals "will be pursued according to three criteria: proper independence, sufficient authority and substantial leadership by laity."

Of course, because of the way the Church is governed, and its bishops — including the bishop of Rome — that is being discussed, all of the plans, of course, need the explicit approval of the Pope. That's why the delegation was in Rome, to begin with, to petition His Holiness to launch these investigations. So imagine the utter shock of the men when the Pope just cut them off at the knee and said: Nope; ain't going to happen — no investigations, no lay oversight, forget it. I'll take of all this in the two-day long meeting of bishops in Rome I've called for February. Thank you gentlemen and just like that, the meeting was over.

Michael Voris of "Church Militant" said, "Of course, this isn't how it's being discussed publicly, but this is exactly what happened privately. Pope Francis himself — personally and directly — simply cut the legs out from any investigation of any of this evil. When you consider the run-up to this meeting — can't really be a surprise."

First, it took Cardinal DiNardo and the others a couple of weeks to get the meeting in the first place — that's telling all by itself. Then, while stalling and ignoring the request for a meeting over the most grave situation in the Church — probably ever in America — the Pope does find time to meet with embattled and beleaguered homosexual kingpin Cardinal Donald Wuerl as well as another homosexual Cardinal Blase Cupich.

Pope Francis was 'a little devil' says school nun

"He was a devil, a little devil, very mischievous, like every boy," the 71year-old nun said with a smile.

"Who would have known that he would become pope!"

Pope Francis Fired Cardinal For Refusing To Cover Up Child Sex Crimes

A senior Cardinal was fired by Pope Francis for refusing to cover up sex crimes against children within the Catholic clergy, according to a highly placed Vatican source.

Cardinal Gerhard Müller served as Prefect of the Congregation for the Doctrine of the Faith until an increasingly desperate Pope Francis suddenly removed him from office in 2017. Cardinal Müller characterized the nature of his dismissal as "unacceptable" at the time. "He did not give a reason," Müller said of his dismissal. "Just as he gave no reason for dismissing three highly competent members of the CDF a few months earlier."

Cardinal Müller and the three "highly competent members of the CDF" all had one thing in common — they were working to shine a light on the pedophile abuse crisis in the clergy and they were all trying to ensure the perpetrators were brought to justice.

The 'Daily Wire' reports: According to the Vatican source, Müller and the competent priests working alongside him in the Curia were "dismissed by Pope Francis because they all had tried to follow loyally the Church's standing rules concerning abusive clergymen."

Prayers-not-Prison

One example cited is the case of Don Mauro Inzoli, a priest who had been found guilty of abusing boys as young as 12. Historian Henry Sire writes in his book '*The Dictator Pope*' that, despite Inzoli being convicted by an ecclesiastical court of abusing minors in 2012, Pope Francis reduced Inzoli's sentence by reinstating his priestly functions while admonishing him with a "*lifetime of prayer*."

Inzoli had also been ordered "to stay away from children, [while] giving him permission to celebrate Mass privately."



Don Mauro Inzoli, found guilty of abusing boys as young as 12, was protected by Pope Francis. However, none of those (inarguably lax) terms were respected, according to Michael Dougherty. By 2015, Inzoli had returned to public ministry and even participated at a conference on the family in Lombardy, Italy. Only when an Italian court sentenced Inzoli to nine months in prison for the abuse of minors did the Vatican call for a new canonical trial against the disgraced prelate.

"Cardinal Müller [as Prefect of the Congregation for the Doctrine of the Faith (CDF)] had always decidedly and most sharply followed up on these abuse cases, and that is why he was dismissed, just as his three good collaborators [the three CDF priests] were also dismissed," The Vatican source told 'LifeSiteNews'.

In *'The Dictator Pope'*. Henry Sire described an atmosphere in which the Pope's emphasis on "mercy" would allow abusive prelates to have sanctions lifted on them. Such was not the policy under Benedict XVI, who rarely granted clemency to abusive prelates:

It was rumored that Francis intended to revert competence for sex abuse cases from Cardinal Müller at the Congregation for the Doctrine of the Faith to the Rota and Congregation for Clergy. Instead, Francis merely changed personnel. He summarily removed two Congregation for the Doctrine of the Faith staffers in charge of handling sex abuse cases (declining to give any reasons to Cardinal Müller) and then dismissed Müller himself as prefect of the Congregation for the Doctrine of the Faith in July 2017.

Winfield wrote that "two canon lawyers and a church official" told her the pope's emphasis on "mercy" had created an environment in which "several" priests under canonical sanctions imposed by the CDF had appealed successfully to Francis for clemency through powerful curial connections. The unnamed official noted that such appeals had rarely been successful with Benedict XVI, who had removed over 800 priests from ministry.

The Vatican source also confirmed the testimony of Archbishop Vigano that Pope Benedict XVI did put restrictions on the sexually abusive Cardinal McCarrick, which other prelates in the Vatican were aware of. Wherever one turns we are finding information and evidence that Pope Francis is looking and acting like the False Prophet of the Bible. Consider the following number anomalies about Pope Francis.

Less than a week after the American delegation of Cardinals were told to take a hike by Pope Francis, another scandal broke in Germany and Denmark. The UK 'Guardian' headlines read: "Shocking' sexual abuse of children by German clergy detailed in report" Minister warns abuse of 3,677 children by about 1,670 clerics may be 'tip of the iceberg' for Catholic church. A "shocking" report into the sexual abuse of children by Catholic clergy in Germany is "probably only the tip of the iceberg", the country's justice minister has said.

The German Catholic church presented the results of an investigation into decades of sexual abuse of children on Tuesday afternoon. The report details the cases of 3,677 children, the majority of whom are male, who were sexually abused between 1946 and 2014. About 1,670 clerics, mainly priests, are implicated.

The justice minister, Katarina Barley, encouraged the church to work with the judicial system to bring as many cases as possible to court.

Ahead of the report's official release at the German bishops' conference in Fulda, the head of the German church, Reinhard Marx, said it urgently needed to rebuild trust with churchgoers and the public. "Many people don't believe in us any longer," he said, calling the report a "decisive, important turning point for the Catholic Church in Germany – and not only in Germany". Marx said he felt ashamed and wanted to apologize to the victims.

The report's release coincided with an acknowledgement by Pope Francis that people were being driven away from the church by the many abuse scandals and cover-ups, including most recently in the US and Chile.

On a recent visit to Ireland, while the issue of sexual abuse dominated the agenda, the pope was accused of failing to address victims' concerns adequately. Although Tuesday's report – details of which were leaked earlier this month – was the biggest of its kind for the German Catholic church, its authors were critical of church leaders for having denied them access to other Catholic institutions, including children's homes and schools.

The report detailed how 60% of abusive priests eluded punishment, and how many were systematically moved to other parishes in the hope their crimes could be hushed up. The practice exposed in Pennsylvania is not unique by any standard and reflects a corrupt and immoral church, if it can be called a church. It hides behind secrecy and the façade of religious morality.

The government-appointed envoy for sexual abuse of children, Johannes-Wilhelm Rörig, urged the church to pay compensation to the victims. He also said it should give state authorities access to its archives to allow state prosecutors to examine every allegation.

The first case of sexual abuse in the Catholic Church in Germany was uncovered about 10 years ago. Critics say the church has not done enough to prevent further clerical abuse.

Church leaders are under pressure to announce reforms before the end of the four-day conference on Thursday.

The report was compiled using data collected from 27 German dioceses, and included 38,000 mostly anonymous documents. But the authors, who were appointed by the church and spent four years working on the report, said they were not allowed access to any original files from the church's own archives and that the files from at least two dioceses had been manipulated or destroyed.

Christian Pfeiffer, a criminologist tasked with carrying out the study in 2011, said the church had made itself "untrustworthy" by not allowing full access to its archives. He has complained about alleged censorship and a lack of transparency on the part of the church.

Matthias Katsch, the co-founder of Eckigen Tisch, a pressure group representing victims, who oversaw the compilation of the study as an adviser, said while some bishoprics had cooperated thoroughly, others had not. *"The academics involved worked to the best of their ability with a lack of resources, to extract something out of the available information,"* he told *'Der Spiegel'*, Germany's major newspaper.

The study found that more than half of the victims had been younger than 13 the first time they were abused, and that 83% of attacks were planned, taking place most commonly in the private or service flats of those carrying out the abuse. On average, the abuses happened multiple times over a period of at least 15 months. Almost 1,000 of the victims were altar boys. Every sixth attack involved rape.

Among the well-documented scandals that have rocked the church in Germany is the systematic abuse of pupils by two priests at the fee-paying Jesuit school Canisius in Berlin in the 1970s and 80s, and the sexual and physical abuse <u>suffered by more than 500 choir boys</u> at the Regensburger Domspatzen school in Regensburg, Bavaria. The choir was led by Georg Ratzinger – the brother of the former Pope Benedict XVI – for 30 years until 1994, but he denied knowing about any abuse.

MYSTERY OF THE NUMBER 13 WITH POPE FRANCIS: COINCIDENCE?

But <u>this is to fulfill this passage of Scripture:</u> <i>'<u>He who shared my bread has turned against me</u>'.* Not to mention that the name <u>Judas</u> <u>Iscariot</u> contains 13 letters.

The number of languages spoken at the Tower of Babylon, according to later tradition were 72. The number of names of God, according to Kabbalah were 72.

The number of books composing the Holy Bible in the Catholic version is 72.

The Book of Revelation is the 72nd (and the last) book in the Catholic Bible.

The current distribution of the Book of Revelation is 22 chapters, adopted since the 13th

Number 13 as Rebellion in Scriptures

In the Old Testament, the number **13** appears with Nimrod. His name means <u>The Rebel</u>; he, the **13th** descendant of Adam, was also known for his *rebellion* in building the Tower and City of Babel. In 2nd Thessalonians 2:8, there is a parallel with the Antichrist figure called *The Lawless One* (...*He will use all sorts of displays of power through signs and wonders that serve the lie*). Nimrod was a *king* (the beginning of his *kingdom* was Babel) in Genesis 10:10 and, as we can see in Daniel 11:36, the Antichrist is also termed *king*. Also, Nimrod's headquarters were in *Babylon*, as he was its *King*, -(Genesis 10:10 and 11:1-9); in the same way, we also notice that the *Man of Sin* is called *the king of Babylon* -(Isaiah 14:4), while in the Apocalypse he is connected with *mystery Babylon* -(Revelation 17:3-5). Later we discover that Nimrod's ambition was to establish a *world-empire*.

Then, always in Genesis – this time in 14:4 – we find: "*Twelve years they served Chedorlaomer, and in the <u>thirteenth</u> year they <u>rebelled</u>." Here again, the number 13 represents <u>rebellion</u>, when the king of Sodom and the king of Gomorrah declared war against the four kings.*

Therefore, powerful *kings* of impure cities were connected with the number **13** of *rebellion*. Interestingly, in **Revelation 13:13** called '*The Beast Out of the Earth*', we read:

"He exercises all the authority of the first beast in his presence. And he makes the earth and those who dwell in it to worship the first beast, whose fatal wound was healed. ¹³ He performs great signs, so that he even makes fire come down out of heaven to the earth in the presence of men. And he deceives those who dwell on the earth because of the signs which it was given him to perform in the presence of the beast, telling those who dwell on the earth to make an image to the beast who had the wound of the sword and has come to life".

In Genesis 13:13 we find the following line, which contains 13 words: "But the men of Sodom were wicked and sinners before the Lord exceedingly."

Furthermore, in Deuteronomy 13:13: "Certain men, the children of Belial, are gone out from among you, and have withdrawn the inhabitants of their city, saying, Let us go and serve other gods, which ye have not known." Here, in this chapter under the title 'Idolatrous *Cities to Be Destroyed*' are the sons of Belial who *rebelled. Beli ya'al* means primarily that which is low, hence worthlessness, naughtiness, wickedness. In Deuteronomy 15:9, Belial is rendered in the Authorized Version as an adjective, '*wicked*'.

In the New Testament, Mark 7:21-23 says that there are 13 evils in the human heart: "For from within, out of the heart of men, proceed evil thoughts, adulteries, fornications, murders, Thefts, covetousness, wickedness, deceit, lasciviousness, an evil eye, blasphemy, pride, foolishness: All these evil things come from within, and defile the man."

We see another number 13 In Revelation 13:18, where it is written: "Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six. Here is wisdom: The one who has understanding must calculate the number of the beast, because it is the number of a man. His number is 666."

Indeed, everyone knows that the number **6** represents man. The <u>sixth word</u> of the <u>sixth</u> <u>verse</u> of the <u>sixth chapter</u> of the <u>sixth book</u> of the New Testament is the word 'man'. In **Romans 6:6** from the King James Bible, we read: *"Knowing this, that our old man is crucified with him, that the body of sin might be destroyed, that henceforth we should not serve sin."*

More facts about the number 13 in the Bible:

- The number 13 is used 28 times in the Old Testament and it is *never* used in the New Testament.

 - *I am the King* (John 18:37 and 19:21)
 - I am Son of God (John 10:36)
 - *I am in the Father* (John 14:10; 14:11; 14:20; and 17:8)
 - *I am* (John 8:24; 8:28; 8:58; and 13:19)
- 13 were the guests at the *Last supper of the Christ*.
- The 13th chapter of *Revelation* is reserved to the *Antichrist* and to the *Beast*.
- In the 13th Psalm, it is written: "The fool has said in his heart, There is no God".
- The mystery of the *Seven Churches of the Revelation* presents the winner of 13 rewards on the whole.
- The 13 sons of David were born when he was to Jerusalem. -(1st Chronicles 3:5-9)

- It is on the 13th day of the twelfth month, named Adar, that people celebrated the victory of Judas Maccabaeus on the army of Nicanor to Adasa. -(1st Maccabees 7:43-49)

What are we to conclude from the almost daily revelations about the Vatican's homosexual mafia? Daniel 2:22 states: *"He revealeth the deep and secret things: he knoweth what is in the darkness, and the light dwelleth with him."*

A top Asian cardinal has called the Pope's secretary of state to step down over a controversial deal between the Chinese government and Catholic leaders, saying any deal with Beijing would be an "incredible betrayal" to the Catholic faith.

The provisional agreement, which has the stated aim of allowing "the wounds of the past to be overcome," was announced on September 22. Under the agreement, the Vatican will recognize the legitimacy of bishops appointed by the Chinese government. The appointment of seven bishops approved both by Beijing and the Vatican will lead, said Pope Francis, to the "complete communion of all Chinese Catholics." The Vatican also expressed hope that the believers in the Asian country "will feel fully Catholic and fully Chinese."

Speaking to Reuters, Cardinal Joseph Zen, the most senior Catholic cleric in China, said he believed the two sides were making a "secret deal" and called on Parolin to resign. "They're giving the flock into the mouths of the wolves. It's an incredible betrayal," he said. "I don't think [Parolin] has faith. He is just a good diplomat in a very secular, mundane meaning. Because the Vatican is also under pressure for purportedly covering up a sex abuse scandal in the U.S., Zen suggested this China deal would further add to the Church's vulnerability.

"The consequences will be tragic and long lasting, not only for the church in China but for the whole church because it damages the credibility. Maybe that's why they might keep the agreement secret," said Cardinal Zen. While some have praised the deal for allowing the Catholic Church to gain access to potentially millions of converts across China, others have criticized Pope Francis for willingly join forces the increasingly authoritarian Chinese government, which is officially atheist.

China's roughly 12 million Catholics are divided between an underground Church that swears loyalty to the Vatican, and the state-supervised Catholic Patriotic Association. Speaking to Reuters, Zen said he believed only half the underground church in China would accept a deal and was concerned how the remainder might react. "I'm afraid they may do something irrational, they may make rebellion," he said, adding that any deal with atheist China would deal a significant blow to Pope Francis' credibility. "It's a complete surrender. It's a betrayal (of our faith). I have no other words."

Amnesty International China Researcher Patrick Poon told CNN the agreement created serious concerns for freedom of religion in China in the future. "Such an agreement will effectively set a very bad precedent for other religions (in China) ... It will put Catholics under a lot of pressure," he said.

On Twitter, Republican Senator and practicing Catholic Marco Rubio asked how the Vatican could justify the deal it had struck with the Communist Party. "They are giving a government (an atheist one) influence in choosing bishops which (the Church says) are regarded as transmitters of the apostolic line. How does secular (and atheist) interference in that decision not break that line?" Rubio said.
