

# The Beast Empire

## Part 22

I viewed a Judge Andrew Napolitano video clip on Monday following the confirmation of Judge Kavanaugh to the U.S. Supreme Court that shook me greatly, more so than the fact that I was already aware that he was a Jesuit-trained Roman Catholic. He is the second President Trump Justice nominated to the U.S. Supreme Court that attended the same Jesuit Prep School.

The essence of the video is the following:

Judge Kavanaugh worked on the PATRIOT Act and the Bush torture policy. Judge Andrew Napolitano explains why “Bart” Kavanaugh is the most anti-Constitutional Justice ever to be appointed to the Supreme Court.

Some things you didn’t know about him:

- He was instrumental in drafting the PATRIOT Act
- He was a Bush White House lawyer during that administration’s orgy of torture

It is a well-established historical fact that the Roman Catholic Institution has hated the U.S. Constitution since September 17, 1787, the day of its signing.

Because I receive news reports from different sites, I receive a steady flow of ads in my e-mail in-box for weeks, most wanting contributions, on behalf of the campaign to get Brett Kavanaugh confirmed or unconfirmed, whichever the news site represented.

Larry Klayman of ‘Freedom Watch’ raised the question of Brett Kavanaugh’s career has been to be a “pleaser”, noting that in Kavanaugh’s first day on the job hired all female law clerks. Larry Klayman notes that Kavanaugh spent his entire law career pleasing other parties. Larry Klayman was being interviewed by Jason Goodman of the web site ‘CrowdSourceTheTruth.com’ and he made many insightful points about Judge Brett Kavanaugh being not much of a 4<sup>th</sup> Amendment rights defender. Kavanaugh is very political, not a good sign for citizen rights. His ten years as a member of the District Court has been that of a “pleaser” to corporate interests.

When I first learned that Judge Brett Kavanaugh was a Jesuit, I began to study the nomination with much closer scrutiny. You see, a Jesuit does not have to wear the clerical robe or collar of the Society of Jesus. He is a Jesuit, at the call of the Jesuits simply because he or she has been raised and educated as a devout Roman Catholic. The Oath of a Jesuit or Jesuit-trained requires total and strict loyalty to the evil demonic order known as the Society of Jesus. Loyalty to religious power supersedes loyalty to the Constitution of the U.S.!

Conservatives and Christians are wildly ecstatic that Brett Kavanaugh was confirmed by the U.S. Senate as the newest justice of the U.S. Supreme Court. To hear all of the euphoria over Kavanaugh’s confirmation, one would think that he was heralding the Second Coming. He’s not. But his appointment does herald other things—many of them BAD.

Pastor Chuck Baldwin, and former Presidential candidate, noted how the public has been played in the Kavanaugh hearings. *“First, let me briefly discuss the Democrat and Republican rancor that was put on public display during the confirmation hearings. As I have tried to point out to the American people over the past several decades, the entire left-right, liberal-conservative, Democrat-Republican paradigm is pure propaganda. It is nothing but public theater. Both parties use the “us vs. them” demagoguery as a way to keep their constituents who buy into the charade happy enough to keep electing and reelecting them to public office.”*

*“To use an analogy that many sports fans can identify with right now, the Democrat-Republican rivalry is tantamount to the New York Yankees and Boston Red Sox rivalry. Each side is cheering like crazy for their team and rabidly booing the other team. But both teams are playing the*

*same game; they are throwing and hitting the same ball; and they are running the same bases. It's pure entertainment. And that's what the two major parties in Washington, D.C., are doing. They root and cheer for their party and boo and hiss the other party, but they are playing the same game. It's pure entertainment."*

*"All of the theatrics surrounding Kavanaugh's confirmation was nothing more than political posturing for the November elections by both parties. I promise you, had Kavanaugh been appointed by a Democrat president, the same game would have been played, except the two sides would have switched uniforms. The fix was in: Kavanaugh was going to be confirmed, and everyone inside the Beltway knew it. It was all a show, folks. Now, Republicans have a "win" in which to motivate constituents to go vote November 6, and Democrats have a "loss" in which to motivate constituents to go vote November 6."*

*"The left-right rivalry is pure theater. It's not about the Constitution, the Bill of Rights, the Declaration of Independence, truth, freedom or the American way; it's all about political power. Oh, there might be a handful of hardcore liberals and conservatives who are truly driven by ideology, but what drives the vast majority of these miscreants—otherwise known as politicians—is power: pure, unabashed, raw power."*

*"The other thing that the Democrat-Republican phony rivalry does is obfuscate the really important developments that are taking place that neither party wants the American people to know about."*

*"For example, while most Americans were transfixed on Brett Kavanaugh's version of Peyton Place (did I really say that? One must be at least 50 to even remember that TV series) on CNN and FOX News, they didn't notice that Israel manipulated the Syrian shoot-down of a Russian aircraft that took the lives of 15 Russian airmen, and in retaliation Russia delivered several S-300 missile defense systems to Syria. They didn't notice that the GOP and Donald Trump passed a massive \$854 billion spending bill that fully funds Planned Parenthood and fetal tissue research. They didn't notice that the government's annual spending report came out and Trump and the GOP exploded the federal deficit by over \$1 trillion. I could keep going, but you get the point."*

*"Before continuing, let me briefly digress to point out one of the most egregious hypocrisies of President Trump and Republicans in the U.S. Senate: How was it that Trump and the GOP sat back and did absolutely nothing to assist Judge Roy Moore when he was accused of decades-old sexual improprieties? Trump and the GOP left Judge Moore to be devoured by the wolves but then came to a ferocious defense, like a hornet's nest defending its queen, when Kavanagh was accused in similar fashion. Why? Huh? Why?"*

*"And not only did the "she said, he said" circus that passed for confirmation hearings for a U.S. Supreme Court justice obfuscate serious developments on the national and international stage, it also obfuscated Brett Kavanaugh's REAL record."*

*“Confirming (or voting for) a judge should be all about his or her fidelity to upholding the U.S. Constitution. For a judge, nothing is as important as that. And the plain truth is, Judge Kavanaugh’s report card on defending the Constitution is a big, fat “F”.”*

*“I have already pointed out in previous columns that Kavanaugh is an “enemy” of the Fourth Amendment. And that accusation is made by many legal scholars, including Judge Andrew Napolitano. Kavanaugh helped create the Patriot Act that has done more to trample the Fourth Amendment to the U.S. Constitution than any act ever passed by Congress.”*

*“But as far as most conservatives and Christians are concerned, the Fourth Amendment doesn’t exist. It is the invisible Bill in the Bill of Rights. But it’s even worse than that. Not only do most conservatives and Christians not care about defending the Fourth Amendment, they are actually some of the most radical enemies of the Fourth Amendment. No wonder they like Brett Kavanaugh so much.”*

*“I’m telling you again: The Fourth Amendment is dead to most Republicans, Christians and conservatives. In fact, there wasn’t a single Republican senator—not even Rand Paul, the libertarian-leaning son of liberty champion Ron Paul—who even dared to broach the subject of Kavanaugh’s pathetic anti-Fourth Amendment record. The only senator from either party who called Kavanaugh out for his many Police State rulings was Montana’s Democrat senator, Jon Tester.”*

*“The Hill reports:*

*[Montana U.S. Senator Jon] Tester focused on [Brett] Kavanaugh’s judicial record rather than sexual assault allegations made against the nominee.*

*Tester spoke about researching the candidate deeply, finding a few issues that he felt were disqualifying for his vote, including his involvement in mass surveillance and the Patriot Act as two issues that violate the 4th Amendment.*

*I am not endorsing Senator Tester, of course, but I am pointing out the fact that Tester accurately addressed the singular issue upon which any court justice (or any elected office holder, for that matter) should be primarily judged: his or her fidelity to the U.S. Constitution (albeit, I seriously doubt that Tester would have been so concerned about the Constitution had the Supreme Court nominee been appointed by a Democrat President). But all of the theatrics surrounding the Kavanaugh confirmation hearings thoroughly obfuscated this most-important issue from public debate or public attention.”*

*“Neither did Judge Kavanaugh take a position against Obamacare, but used an obscure law to turn Obama’s “healthcare” law into a government “tax” to make it more palatable. In the Washington Examiner, Philip Klein writes:*

*Though nobody would question his credentials, there's fear among a subset of conservatives that as a Washington insider and former Bush administration lawyer, Kavanaugh could turn out to be overly cautious and fearful about upsetting elites, thus upholding unconstitutional laws and sustaining bad precedents.*

*Though Kavanaugh's hundreds of decisions in a dozen years as an appellate judge have been broadly conservative (particularly when it comes to reining in the regulatory state), there is one decision in particular that has divided conservatives — his dissenting opinion in an Obamacare case brought to the D.C. Circuit Court of Appeals in 2011. This has triggered a debate over whether Kavanaugh could be another Chief Justice John Roberts, who the Right still does not forgive for upholding Obamacare.*

*In the Seven-Sky v. Holder case, a forerunner to the landmark Supreme Court ruling, a three judge panel decided 2-1 that Obamacare's individual mandate was constitutional. While Kavanaugh dissented from the main opinion, he did not go as far as declaring Obamacare unconstitutional. Instead, he argued that the court was not yet in a position to hear the case, because under an arcane 19th-century law known as the Tax Anti-Injunction Act, courts could not hear challenges to a tax that had not been collected yet, and thus any decision would have to wait until 2015, when taxpayers had to file mandate penalties for the first time. In summary, Kavanaugh didn't uphold Obamacare, but he did not take the opportunity to strike it down, either."*

*"Furthermore, Judge Kavanaugh believes that a sitting President (ANY President) is exempt from criminal investigations and even civil suits. From Politico:*

*Kavanaugh's allies note that the 2009 Minnesota Law Review article he wrote addressing such subjects advocates for a congressional statute that would exempt the president from civil suits while in office, as well as immunizing him from criminal investigation and prosecution. He does use some pretty strong language about the prospect of a criminal trial of a sitting president, saying it would "cripple the federal government"—and assessment that one could imagine leading a Supreme Court justice to step in to avert such a prospect.*

*Earlier in the panel discussion, helpfully preserved for eternity by C-SPAN, Kavanaugh refers to the issue as "a question that has been a lurking constitutional issue for a long time which at some point here should be resolved so we can determine whether the Congress or an independent counsel should investigate the president when his conduct is at issue."*

*"I tend to think it has to be the Congress," Kavanaugh added, presaging the views he would offer in more detail in his law review article a decade or so later. Democrats are expected to press Kavanaugh hard on the topic at his confirmation hearings, arguing that Trump picked him as a kind of insurance policy against potential negative developments in special counsel Robert Mueller's Trump-Russia probe."*

*“Some scholars are of the view that a president could be indicted while in office, but could not be tried until he vacated the office, whether by impeachment, resignation or because his term expired. But the most recent Justice Department opinion, which is likely binding on Mueller’s office, says that even a sealed indictment of the president would be impermissible.*

*But Democrats did NOT “press Kavanaugh hard on the topic at his confirmation hearings,” did they? Instead, they focused on the accusations of sexual misconduct from over thirty years ago. Why didn’t they press Kavanaugh on his assertion that presidents are exempt from legal accountability? Because they want to reserve the same protections from criminal or civil accountability for future Democrat presidents, that’s why. Neither party in Washington, D.C., wants to be held accountable for crimes against the Constitution or other acts of illegality.*

*The Kavanaugh confirmation all but forever seals the deal that Robert Mueller’s investigation—or any other independent investigation against a sitting President—will never be allowed to have any teeth. And always remember that this is the same guy—Brett Kavanaugh—that helped cover up the government’s murder of Vince Foster during the administration of President Bill Clinton.”*

Joel Skousen wrote:

*“The Vince Foster cover-up wasn’t a simple case of an erroneous conclusion based upon weak evidence. This was a full blown conspiracy to intimidate witnesses that proved the official version was a lie. As Starr’s deputy, there is no way that Kavanaugh could not have known that there was a cover-up and conspiracy going on.*

*Kavanaugh will always be subject to the blackmail of “you knew what Starr did to Patrick Knowlton , and you went along with it.” That also implies a more lethal threat of “you know what they did to Vince Foster when he got cold feet about protecting the Clintons”.”*

Tim Brown wrote more about Kavanaugh’s collusion in the cover-up of Vince Foster’s murder.

“And let’s not forget that Trump is personally beholden to Kavanaugh for a judicial ruling back in 2012 regarding the attempted unionization of Trump Entertainment Resorts. Again, The Hill has the story:

President Trump Supreme Court nominee Brett Kavanaugh in 2012 sided with the future U.S. president’s casino in a case over unionization, Bloomberg reported.

Kavanaugh threw his weight behind Trump Entertainment Resorts’ successful attempt to end a unionization effort at one of its casinos six years ago.

He voted with two other Republican-nominated judges on the D.C.-based federal appeals court to set aside an order by the National Labor Relations Board (NLRB) that would have required the Trump Plaza Hotel and Casino in New Jersey to bargain with the United Auto Workers.”

And listen to this:

*“Kavanaugh worked for Kenneth Starr, the independent counsel who investigated former President Clinton. He once argued that a president could be impeached for lying to his staff or misleading the public.*

*He later recanted this stance after observing the discord caused by Clinton's impeachment, saying presidents should not be indicted or distracted by investigations while holding the office.*

*No wonder Donald Trump wanted Brett Kavanaugh on the Supreme Court.*

*But that's not all. Trump has very close financial ties to retired Supreme Court Justice Anthony Kennedy. Come to find out, Kennedy's Deutsche Bank gave Trump over \$1 billion in loans when no other bank would do so due to Trump's numerous financial failures. It seems that Trump encouraged Kennedy to retire, promising to appoint Kennedy's protégé, Brett Kavanaugh, to replace him. Talk about backroom deals!*

*And for the pro-life Christians and conservatives who believe that Kavanaugh is going to help overturn Roe v Wade, they are living in a fantasy world. NPR reports:*

*Republican Sen. Susan Collins says Supreme Court nominee Brett Kavanaugh told her he views the landmark abortion rights ruling Roe v. Wade as "settled law."*

*That assurance, made during a Tuesday morning meeting in the Maine senator's office that lasted more than two hours, likely goes a long way toward securing a key vote for Kavanaugh's confirmation.”*

*Collins supports abortion rights and made sure to point out she viewed the 1973 decision as "settled law" in her initial reaction to the news that abortion rights swing vote Anthony Kennedy was retiring from the Supreme Court.*

*"We talked about whether he considered Roe to be settled law," Collins told reporters after the meeting. "He said that he agreed with what Justice Roberts said at his nomination hearing, at which he said that it was settled law."*

*“I realize that many conservatives and Christians have been bamboozled into believing that Donald Trump is some kind of superhero who is engaged in a deep, gallant conspiracy with other covert superheroes to dismantle the Deep State, but it's all an illusion. Trump is not a superhero working to dismantle the Deep State. He himself is a Deep State toady; and so is Brett Kavanaugh.”*

*“Kavanaugh will indeed make some conservative rulings as a Supreme Court justice. That by itself is no indication that Kavanaugh is not a compromised shill for the Deep State. Many big-government Deep State toadies are known as “conservatives.” In fact, “conservatives” are often*

*the first ones to trample the Fourth Amendment and facilitate America's burgeoning Police State. And given Kavanaugh's track record, he is the perfect "conservative" to continue the Deep State's assault on our Fourth Amendment liberties.*

*Believe me, what you don't know about Brett Kavanaugh can and will hurt you."*

Pastor Chuck Baldwin and Joel Skousen are well-known and respected commentators about national and world affairs.

Here is what one religious web site has to say about the Kavanaugh name on the U.S. Supreme Court:

***"And I beheld another beast coming up out of the earth; and he had two horns like a lamb, and he spake as a dragon."*** (Revelation 13:11).

"The lamb-like horns and dragon voice of the symbol point to a striking contradiction between the professions and the practice of the nation thus represented. **The "speaking" of the nation** is the action of its legislative and **judicial authorities.**"

We will see shortly whether Donald Trump's judicial nomination of Brett Kavanaugh stands. But if we understand that the lamb-like beast (America) is to speak like a dragon through the "Judicial authorities", it may be of prophetic interest as to who is the next judge elected to the Supreme Court.

One of the front runners who were also nominated by Trump to the US Court of Appeals 7<sup>th</sup> Circuit was Amy Coney Barrett who has said in an article entitled "*Catholic Judges in Capital Cases*" that it is the duty of judges to put their faith above the Constitution. This was one of Trump's front runners for the Supreme Court which we are told is to speak like a dragon.

Interestingly however, Brett Kavanaugh was Donald Trump's pick as a nominee for the Supreme Court. And the first thing he talked about when elected was his Jesuit education. What's the big deal about the Jesuits? Don't miss this next quote from former President Abraham Lincoln:

"I will be forever grateful for the warning words you have addressed to me about the dangers ahead to my life, from Rome...The pope **and the Jesuits**, with their infernal inquisition, are the only organized powers in the world which have recourse to the dagger of the assassin **to murder those who they cannot convince with their arguments or conquer with the sword.** But it is more a religious than a civil war. It is Rome who wants to rule and degrade the North, as she has ruled and degraded the South... But it is very certain that **if the American people could learn what I know of the fierce hatred of the priests of Rome against our institutions, our schools, our most sacred rights, and our so dearly bought liberties,** they would drive them away tomorrow from among us, or **they would shoot them as traitors.**" —('Fifty Years in the Church of Rome', pages 294, 295).

They would shoot the Jesuits as traitors if they knew what the Jesuits were? Now with such a letter coming from former President Lincoln whom many say was assassinated by the Jesuits, should we be alarmed that President Trump just picked a second Jesuit educated judge to fill the spot of Justice Kennedy and in turn have 6 of the 9 Supreme Court judges being Catholic. Ecumenism has blinded the judicial selection process!

Here is some more history we should be aware of. From the book *'The Great Controversy'* [Although written by Ellen White, co-founder of the Seventh Day Adventists] we are told:

***"And he had two horns like a lamb."*** The lamblike horns indicate youth, innocence, and gentleness, fitly representing the character of the United States...***And the Constitution*** guarantees to the people the right of self-government, **providing that representatives elected by the popular vote shall enact and administer the laws**. Freedom of religious faith was also granted, every man being permitted to worship God according to the dictates of his conscience. ***Republicanism and Protestantism became the fundamental principles of the nation***. These principles are the secret of its power and prosperity." {*'Great Controversy'*, pg. 441}.

**I am in no way endorsing the SDA church/cult; however, it has never stood back and withheld its evaluation of the Roman Catholic Institution, or the Biblical Beast of history because of ecumenism or religious universalism. As such, the SDA input on the Jesuits and the RCC is very important in its role and claim to temporal and religious power!**

The government was considered a Protestant government. And they are elected to enact and administer the laws that are the constitution. Former Presidents like Thomas Jefferson explained that in order to ensure freedom in the United States the separation of Church and State was absolutely necessary. “Protestants have tampered with and patronized popery; they have made compromises and concessions which papists themselves are surprised to see and fail to understand. Men are closing their eyes to the real character of Romanism and the dangers to be apprehended from her supremacy. The **people need to be aroused to resist the advances of this most dangerous foe to civil and religious liberty.**” -('Great Controversy', pg. 566).

This was written over 100 years ago. It was well known what would come to pass in the United States.

### **Jesuit Oath – Spy, Get into Judicial Positions – Exterminate Heretics**

The Jesuit Oath of Induction is also recorded in the Congressional Record of the U.S. (House Bill 1523, Contested election case of Eugene C. Bonniwell, against Thos. S. Butler, Feb. 15, 1913, pgs. 3215-3216).there Notice what it says firstly:

“You have been taught your **duty as a spy**, to gather all statistics, facts and information in your power from every source; to ingratiate yourself into the confidence of the family circle of Protestants and heretics of every class and character, as well as that of the merchant, the banker, the lawyer, among the schools and universities, **in parliaments and legislatures, and the judiciaries and councils of state**, and to be all things to all men, for the Pope’s sake, whose servants we are unto death.”

Interesting that it tells us that they are to be spy’s in legislature, but also judiciaries. So it is interesting that the judge being appointed by Trump is Jesuit-educated. But furthermore, notice what else this shocking oath says:

“I furthermore promise and declare that I will, when opportunity present, make and wage relentless war, secretly or openly, against all heretics, Protestants and Liberals, as I am directed to do, **to extirpate and exterminate them from the face of the whole earth; and that I will spare neither age, sex or condition; and that I will hang, waste, boil, flay, strangle and bury alive these infamous heretics, rip up the stomachs and wombs of their women and crush their infants’ heads against the walls, in order to annihilate forever their execrable race. Wow, is it possible that former presidents like Abraham Lincoln knew what they were talking about. In an article recently written in the ‘New York Times’ we read:

“With the nomination of Judge Kavanaugh, 53, now a federal appeals court judge, Georgetown Prep, **an elite Jesuit high school** just outside Washington, D.C., could have the distinction of having two alumni on the nation’s highest court.”

This would be the second Jesuit-educated Judge that Trump has put on the Supreme Court.

### **Loyalty to Pope over Constitution Despite Vows**

Where does the loyalty of the Jesuit lie? “Whatever their nationality or their government, they are to regard the authority of the church as above all other. **Though they may take the oath pledging their loyalty to the state, yet back of this lies the vow of obedience to Rome**, absolving them from every pledge inimical to her interests.” -(Great Controversy pg. 580)

Did you get that? They make take an oath to uphold the Constitution, but like Amy Coney Barrett, their religion comes first above it. Donald Trump himself went to a Jesuit University, Fordham University for two years. Pope Francis is the first Jesuit Pope. Jesuits seem to be getting into the highest places of authority. And Brett Kavanaugh was very quick to mention his Jesuit- education as something very important. Why? When no religious test matters?

### **Jesuits Most Satanic Sect**

Former President John Adams once wrote to former President Thomas Jefferson saying: ***“I am not happy about the rebirth of the Jesuits. Swarms of them will present themselves under more disguises ever taken by even a chief of the Bohemians, as printers, writers, publishers, school teachers, etc. If ever an association of people deserved eternal damnation, on this earth and in hell it is this Society of Loyola. (Jesuits)”***

Do you think it might be possible that these former Presidents like Lincoln, Jefferson, Madison, Adams, would never have chosen a Jesuit as part of the Supreme Court of America? It was only recently that House Speaker Paul Ryan said that we need more Catholics in power. Why? President Donald Trump says newly confirmed Supreme Court Justice Brett Kavanaugh was “*caught up in a hoax that was set up by the Democrats.*” Trump says allegations of sexual misconduct against Kavanaugh were “*all made up, it was fabricated and it’s a disgrace.*”

Kavanaugh was accused by several women of sexual misconduct, including a California professor who testified under oath that he tried to assault her at a high school party decades ago. Kavanaugh adamantly denied the allegations. Trump had once said he found her testimony credible. Trump says he thinks many Democrats will vote Republican in next month’s midterm elections because they’re angry about Kavanaugh’s treatment.

Meanwhile, Senate Majority Leader Mitch McConnell is leaving the door open to taking up a nomination to the Supreme Court if a seat becomes vacant in the 2020 presidential election season. The Kentucky Republican made the remark after winning a hard-fought battle to confirm President Donald Trump’s second high-court nominee, Brett Kavanaugh.

In early 2016, McConnell refused to set hearings for President Barack Obama’s last nominee, Judge Merrick Garland, saying the seat left open by the death of Justice Antonin Scalia should be filled by the winner of that year’s election.

McConnell says an election-year vacancy isn’t filled if the party controlling the Senate is different from the party of the president. McConnell appeared on “Fox News Sunday” and CBS’ “Face the Nation,” on Sunday, October 7<sup>th</sup>, 2018.

It should be noted here that Jesuits are trained to be or hold whatever position their superiors tell them to be. Jesuits are trained to be of opposing views if need be. They operate from 50 and 100-year plans, and so manipulate the narrative to achieve their long-sought agenda goal. For example, at one point in the hearings where it was looking that Judge Kavanaugh was precariously likely to be withdrawn by President Trump, the Jesuit magazine ‘America’ did a bail out on the Judge.

The Editors of ‘America’ Magazine had withdrawn their endorsement of Judge Brett Kavanaugh for the Supreme Court, arguing that even if he is innocent “*this nomination is no longer in the best interests of the country.*” It is more like he was no longer in the best interests of the Jesuits!

“While we previously endorsed the nomination of Judge Kavanaugh on the basis of his legal credentials and his reputation as a committed textualist,” the editors of the Jesuit weekly state in their editorial Thursday, “*it is now clear that the nomination should be withdrawn.*”

The issue has moved beyond Kavanaugh innocence or guilt, *'America'* contends, to the symbolic value of the case.

*"In addition to being a fight over policy issues, which it already was, his nomination has also become a referendum on how to address allegations of sexual assault,"* they declare.

The message from the Jesuit editors would seem to be: if any group or individual opposes a candidate for any public office and brings accusations located sufficiently far in the past as to be impossible to adjudicate, the ensuing cloud of uncertainty is sufficient to disqualify that candidate.

The inevitable result of this line of reasoning is to push discussion away from candidates' demonstrable credentials and to encourage attempts to discredit him or her through unverifiable accusations, presumably of a sexual nature.

The editors argued that *ideally* Senate confirmation hearings might focus on evaluating a nominee's judicial character or qualifications as a legal thinker. *"But that time is long past."*

Ideology has so sufficiently used the political process that realism dictates playing by the same rules. *"Neither the country nor the court are well served by this arrangement, but refusing to recognize it does nothing to help reverse it,"* the magazine states.

*"What is different this time is that this nomination battle is no longer purely about predicting the likely outcome of Judge Kavanaugh's vote on the court,"* the editors state. *"It now involves the symbolic meaning of his nomination and confirmation in the #MeToo era."*

The merits of the Kavanaugh case must yield to its symbolic significance for larger social trends, the editors suggest, and his nomination is just a casualty in this battle. A Jesuit is expected to fall on his sword when he has become excess baggage to their cause. What is the cause? It is to install the Papacy to the pyramid of power, religious and temporal global power.

*"The hearings and the committee's deliberations are now also a bellwether of the way the country treats women when their reports of harassment, assault and abuse threaten to derail the careers of powerful men,"* they state.

The editors failed to address the compelling line of argumentation of Kavanaugh himself, who shows the other side of the coin. In his letter to the committee of the Judiciary Committee, Kavanaugh claims that the accusations made against him *"are smears, pure and simple. And they debase our public discourse."*

*"But they are also a threat to any man or woman who wishes to serve our country,"* he added. *"Such grotesque and obvious character assassination—if allowed to succeed—will dissuade competent and good people of all political persuasions from service."*

In their editorial, the Jesuits chose not to entertain this very probable fallout from the case, preferring to focus on Kavanaugh's inability to *disprove* the charges. Since Dr. Blasey's accusations have not been "conclusively disproved or shown to be less than credible," it is time for "Kavanaugh's nomination to be withdrawn," they stated. Kavanaugh's failure to conclusively disprove his guilt, *'America'* claims, is sufficient grounds to retire his nomination. Here, the presumption of innocence does not hold.

Which is, if nothing else, a sad commentary on the state of the Jesuits and their willingness to betray any principle for the sake of expedience.

The issue of President Trump nominating Kavanaugh is troubling for many reasons. He attended the same Jesuit-prep high school in Maryland as did President Donald Trump's first Supreme Court pick, Neil Gorsuch, another former Justice Kennedy clerk.

After graduating from Yale Law School, Kavanaugh spent his early career steeped in Republican politics and partisan warfare in the nation's capital. As a young lawyer for independent counsel Kenneth Starr, he investigated the death of President Bill Clinton's deputy counsel, Vincent Foster. (Kavanaugh concluded there was no doubt Foster had killed himself.) He laid out the grounds for impeaching Clinton after the president's affair with a White House intern. Vince Foster was a bag man for the Clinton's routinely transporting cash in diplomatic pouches between Washington, D.C. and Geneva, Switzerland. It is most certain that Judge Kavanaugh is a Lodge brother of the Freemasons, and given his academic excellence, he was most likely tapped by Skull & Bones, as was the case with former President George H.W. Bush and George W. Bush. They are more than close as we learn further below in this article.

Here are five faith facts about Judge Brett Kavanaugh:

1. **Kavanaugh is Catholic.** The judge is a regular lector at his church, the Shrine of the Most Blessed Sacrament in Washington, D.C., near his Maryland home. He also volunteers for the St. Maria's Meals program at Catholic Charities, according to his biography on the court website and has tutored at the Washington Jesuit Academy.
2. **He has ruled on issues important to religious conservatives, including abortion rights.** Nominated by President George W. Bush, whom he served as a White House lawyer, Kavanaugh has spent 12 years as a judge on the D.C. Circuit and has a long history of judicial decisions behind him. Among them: Kavanaugh dissented last year on a controversial decision that allowed an undocumented teenager who had crossed from Mexico into Texas as an unaccompanied minor to get an abortion while living in a government-funded shelter. The decision, he wrote, was "ultimately based on a constitutional principle as novel as it is wrong: a new right for unlawful immigrant minors in U.S. government detention to obtain immediate abortion on demand."
3. **He also opposed the Affordable Care Act's birth control mandate.** In 2015, he wrote a dissent opposing an accommodation to the birth control mandate. A panel had upheld the accommodation requiring religious organizations to sign a form facilitating contraceptive coverage for their employees. He wrote those regulations "substantially

burden the religious organizations' exercise of religion because the regulations require the organizations to take an action contrary to their sincere religious beliefs (submitting the form) or else pay significant monetary penalties."

4. **Some conservatives are worried he's not conservative enough.** His ruling on that abortion case involving the unaccompanied minor was less restrictive than other judges, giving some cause to worry that he is too pragmatic. Similarly, these voters favor his dissent opposing the birth control mandate, but worry it conceded that the government has an interest in providing coverage for contraceptives, but that "the government can achieve it in other ways," according to SCOTUS blog. Meantime, LGBTQ groups have expressed concern about his promotion by the conservative Family Research Council in 2005 when he initially was nominated for the D.C. circuit. Family Research Council is a Christian lobbying group that believes "homosexual conduct is harmful to the persons who engage in it and to society at large, and can never be affirmed."
5. **He preserves the current religious ratio on the court.** He replaces his fellow Catholic, Justice Kennedy, for whom he clerked. That means, if his nomination is approved, the religious makeup of the court would remain largely the same. That currently includes five Catholic justices, three Jewish justices and Trump's previous pick, Neil Gorsuch, who was raised Catholic but attends an Episcopal Church.

When you want to know the heart of somebody one of the best ways to discern that is by examining their heroes. And when it comes to the kind of judicial temperament and philosophy a potential Supreme Court judge will have, the best way to examine that is by examining their judicial heroes.

For Supreme Court nominee Judge Brett Kavanaugh, his judicial hero, in his own words, is the late Supreme Court Justice Antonin Scalia. The pro-life movement looks to Justice Scalia as the prime example of the kind of judge who is most appropriate for the Supreme Court. Scalia was ready and willing to overturn *Roe v Wade* and its allowance for virtually unlimited abortions because he understood the case was poorly decided because it had the court substituting its opinion for duly-elected legislators.

Thanks to conservative judicial reviewer Ed Whelan, writing at *'National Review'*, here are excerpts from a speech that Supreme Court nominee Brett Kavanaugh delivered at Antonin Scalia Law School in June 2016:

"Let me start with a few personal reflections about Justice Scalia. Many of you no doubt knew him better than I did. So I do not want to overstate my relationship with him. But I just loved the guy. To me, Justice Scalia was and remains a hero and a role model. He thought carefully about his principles, he articulated those principles, and he stood up for those principles. As a judge, he did not buckle to political or academic pressure from the right or the left...."

"He loved his wife and family. He was a man of faith. And he really was a man for others. Of course, at a prayer breakfast one time, I presented to a group of about 20 fellow judges about the influence on my life of my Jesuit high school Georgetown Prep and its motto "men for

others.” At the end of the talk, Justice Scalia said—in front of the whole group, I might add—about how I was not accurately interpreting the original meaning of the school’s motto and ought to get it straight. I don’t think he was kidding either.”

“That day and always, he has inspired me to try to do more and to do better in all facets of my life, and I hope he inspires all of us to do the same.”

“What did Justice Scalia stand for as a judge? It’s not complicated, but it is profound and worth repeating often. The judge’s job is to interpret the law, not to make the law or make policy. So read the words of the statute as written. Read the text of the Constitution as written, mindful of history and tradition. Don’t make up new constitutional rights that are not in the text of the Constitution. Don’t shy away from enforcing constitutional rights that are in the text of the Constitution. Changing the Constitution is for the amendment process. Changing policy within constitutional bounds is for the legislatures. Remember that the structure of the Constitution—the separation of powers and federalism—are not mere matters of etiquette or architecture, but are at least as essential to protecting individual liberty as the individual rights guaranteed in that text. And remember that courts have a critical role, when a party has standing, in enforcing that separation of powers and federalism limits. Simple but profound.”

*“Don’t make up new constitutional rights that are not in the text of the Constitution?”* That’s the exact concern Americans have had about *Roe v. Wade* since 1973.

Well, we know by now that Justice Antonin Scalia was far from the saint that he was being painted as in the media, or what the Papacy would want us to believe.

Gordon Duff, Senior Editor of *‘Veterans Today’*, posted on March 1, 2016 an incredible story about the esteemed Antonin Scalia. The report initially was on the web site for less than six hours before being removed under heavy pressure. Nearly a year went by before a mirror site re-posted the initial story about Justice Antonin Scalia’s death. Heavy pressure was lobbied by the Roman Catholic Church to deep-six the story from sight. ### **Scalia – What really happened?**

**Justice Antonin Scalia was surprised when he was ordered to the White House. This was not a man you gave orders to, especially not President Obama. It was Justice Antonin Scalia who vacated the long sacrosanct immunity from civil lawsuits, opening the door for a weakened presidency.**

Sources say that Scalia was the single actor behind the impeachment of Bill Clinton. President Obama was aware of this and had ordered the FBI to set out traps for Judge Antonin Scalia. We will now outline the downfall of Antonin Scalia. Yes, this is a story of secret societies, operating worldwide and ritual Satanic child abuse that permeates Washington.

***The crux of the story is how they got Justice Scalia. According to sources, Scalia had been providing protection for an international pedophile ring and was murdered by “friends” who he had informed of the nature of his visit with Obama and the doom it signaled for those around Scalia, prosecution, ruin and Citizens United reversed.***



The mechanism Scalia used to provide this protection was the 'Federalist Society' which chooses the judges throughout the U.S. judiciary system so should any unfortunate pedophile find himself in court, the judge was under Scalia's control, thus making a successful prosecution difficult to achieve.

The 'Federalist Society' grooms and recruits candidates to become judges at a young age – college age kids; they specifically seek out suitable candidates who have certain moral ambiguities that can be exploited and leveraged.

Thus a stranglehold is placed on the judicial system of the United States by a group which serves the interests of big business – corrupt corporations, big pharma, the oil and coal barons; this is how their interests are, time and again, placed ahead of those of, we the people with the result that our environment and our bodies are polluted by the products of these corporations, be it poisons like aspartame and GMO crops in our food, toxins in our ground water (see Flint, MI) or just plain old exploitation of poor people such as the coal miners of West Virginia and Kentucky.

Scalia met with the Order of Saint Hubertus, the patron saint of million dollar dude ranch hunting. Scalia's talk in Texas was said to have gone like this: *"They have us, we are all going down unless we can give them what they want and they are holding all the cards, they have everything."* There was no negotiation with the White House, instead Scalia got, we are told and multiple sources confirm, a pillow over the face and a heroic funeral, one that President Obama refused to attend. Now we know why.

Scalia was a pedophile according to SRA (Satanic ritual abuse) victim David Shurter. Justice Antonin Scalia, one of 9 judges on the US Supreme Court, died suddenly on February 12th/13th, 2016. Shurter is yet another in the long line of victims who have suffered Satanic ritual abuse. He tells how he was groomed in MK Ultra fashion until the age of 10. When he was 18, he went to Omaha, Nebraska to live with his biological mother, and soon got caught up in the massive international child sex slave and Satanic pedophilia network there. Senator John DeCamp, Ted Gunderson and others famously exposed the Omaha child sex ring in the 1990s, including in such books as *'The Franklin Coverup: Child Abuse, Satanism, and Murder in Nebraska'*. The documentary "Conspiracy of Silence" gives an overview of the issue. Like other victims such as Cathy O'Brien, Shurter names former NSA chief, colonel and open Satanist Michael Aquino as one of his abusers. Shurter not only claims that Scalia was a pedophile, but that Scalia was the head of the "cult" (i.e. the Satanic pedophilia ring) and that the abuse he perpetrated was just as extreme as Aquino's. He writes on his blog:

*"Scalia liked to f--k little boys. I know this from personal experience – as he was one of my primary abusers as a child and was one of the HEADS of the cult that abused me. I hated this man in ways that I can't begin to explain and he rivaled Aquino in my abuse as a child."* This was said by a victim of child abuse by a respected Justice and father of eight children.

Gordon Duff of *'Veterans Today'* wrote the article "Scalia Sleeps with the Fishes" exposing the fact that Scalia was a pedophile and that he was killed at a rent-boy ranch in Texas where the rich and famous go to indulge in pedophilia. Apparently the article was originally banned from viewing in the US, but is still active at that hyperlink at the time of writing.

Scalia was known for his provocative speech. Interestingly, he asked on several occasions why the Court should not also protect pedophiles since they protected gays. This may have seemed flippant at the time, as well as ignorant (by falsely lumping together homosexuality and pedophilia), but now these kinds of public statements can be read in a very different light ...

### **The Justice System and Judicial Branch are Implicated in Pedophilia Too ...**

Satanic pedophiles have infiltrated all aspects of society, including the justice system and judicial branch. There you can find both pedophiles and those who would protect them. The case of Scalia being a pedophile is certainly not the first time a judge or justice, even a high-up one, would be involved in the dark Satanic and pedophilic network that runs the New World Order.

In Australia, the Royal Commission set up to investigate the child sex trafficking ring there was headed by James Wood, named by Fiona Barrett as one of the perpetrators of the Australian VIP pedophile ring. These fancy “Royal Commissions” are normally a scam; they are controlled by the perpetrators themselves. Remember the Warren Commission, headed by then Supreme Court Justice and 33° Freemason Earl Warren, which controlled the official narrative about the JFK assassination and hid the true killers. JFK assassination mastermind Allen Dulles was a member of that commission! Commissions or investigations like these are all about manipulating public perception and keeping organized pedophilia hidden. In *A Case of Ritual Abuse and its Meaning for Society*, James Shanahan mentions that John Bjelke Petersen, a former Premier of Queensland, Australia, once famously said, “You do not hold a Royal Commission unless you already know what the answer will be”.

Hopefully more people will step forward to verify these claims against Scalia. Apparently, Scalia rubbed shoulders with Dick Cheney at Cibolo Creek Ranch owned by John Poindexter. Cheney, you may recall, was named by SRA and mind control victim Cathy O’Brien as one of her abusers. If Scalia was a pedophile, the world needs to know. For a seated president to not attend the funeral of a pedophile is unthinkable.

The computer itself belonged to a Sterling David Allen, arrested and charged with child rape and sodomy by the FBI after an investigation that began with a meeting in Rome, Italy. The FBI had known about Allen for some time, had wanted to arrest him since 2014 but had been blocked, they just didn’t know why or who was behind it, not until Justice Scalia died. Within 9 days, Allen was jailed, and the evidence he held began to yield gold. Allen is being held on these charges with bail set at \$250,000.

We were shown an email from Allen where he tells of his January 15, 2016 meeting with Agent Ross at which time his computers were seized by the FBI. What we are told was on Allen’s computer and what Allen told agents is astounding. Allen confessed, we are told, not only to his own sex crimes but to being recruited by a powerful international organization that provided him broad protection from prosecution. From Ian Greenhalgh:

***“It is very sick, but if you really want to watch and hear the ramblings of a mad man just watch this video where Sterling D. Allan says he is GOD in the flesh, admits to being a pedophile, admits he has committed sexual abuse with an underage child, and says that he is waiting to be arrested. Mr. Allan claims he chose this life before coming to Earth to be a “scapegoat” which of course is all foretold in his insane “alphabetics.”***

We are told that Allen became increasingly unstable as his own feelings of guilt and his own public confessions of child sex crimes were inadequate to bring about his own arrest, an arrest he openly asked for time and time again. Allen, who using his computer skills helped fellow pedophiles scour the internet for vulnerable children.

High level sources confirm that Supreme Court Justice Antonin Scalia was murdered, that in itself is neither an original claim nor beyond the realm of likelihood based on circumstances allegedly tied to his death. By that, we are speaking of the “pillow over the head”

and allegations of a “cover-up autopsy,” well outside legal requirements for someone of Scalia’s position.

Sources in the White House confirm that immediately prior to his flight to Texas, ostensibly for a hunting trip with 35 “close friends,” many of whom are members of the highly secret Order of Saint Hubertus. As is being reported, initially in the *‘Washington Post’* with broader allegations made on the *‘InfoWars’* website, tying the Hubertus Order to Bohemian Grove antics, long subject to speculation in the alternative media.

We became aware of the case in August 2015 when we were shown correspondence between Allen and representatives of the Keshe Foundation. Allen ran several popular websites on alternative energy and was a popular speaker, often appearing on the Coast to Coast radio show with Detroit native, George Noory.

Increasingly it became obvious that Allen had been using these venues for sexual trafficking of children. It wasn’t hard to figure out, he did it openly spoke of it constantly (as seen in the YouTube above and lived as though he were above the law. Over the next few months, particularly when confronted by Iranian born physicist M.T. Keshe, who ordered Allen and those around him banned from all Keshe forums, Allen openly flaunted his criminal activities.

What made this particularly insidious is that it was obvious not only that Allen was not acting alone but that he had broad support not only in his home state of Utah, where he was able to avoid prosecution, but in Belgium as well. There, Allen and associates Hans Bracquene, Dirk Laureyssens and Ad Van den Elshout moved against the Keshe group, securing against Keshe’s wishes technologies with defense related applications and passing them on to MI5 in Britain.

When Keshe moved against this group and tried to secure his patents, he found himself being chased down the highway, shots fired, and his car run off the road. Police arrested and soon “misplaced” the culprits, and soon thereafter, representatives of Belgium’s “royals” told Keshe to leave Belgium or be buried there.

On the European end of the FBI investigation, the trail, all of which is easily followed by the “breadcrumbs” Sterling David Allen has left, leads to the highest and most powerful of the scientific communities where blackmail, kidnapping and torture, threats against families and in particular, threats against children, have placed members of secret societies in positions of power at universities, think tanks, police and counter-terrorism agencies and even the European Space Agency.

Add to this revelation by *‘Veterans Today’*, posts by Dave Hodges of *‘The Common Sense Show’* and we begin to see a “connect the dots” scenario.

Dave Hodges of *'The Common Sense Show'* had even more concern about Judge Brett Kavanaugh. I share a post he had on his site some while ago.

*"There is much more that is surfacing on Supreme Court nominee, Brett Kavanaugh that deserves the attention of the American people. This report is not "the end all" report that some are looking for. The Kavanaugh controversy is only one part of full-fledged war going between the Deep State and governmental officials that are not compromised. I will touch on this latter point in the conclusion of this article; however, this point is still under investigation."*

*"With regard to the Kavanaugh nomination, I have vehemently expressed my concern over Trump's leadership skills. However, I have backed away from condemning Trump. There is a power play at work here that Trump cannot fully control and I have multiple reasons to believe that Trump is engaged in a strategic retreat that is not permanent. I am absolutely convinced that Trump did not want to nominate Kavanaugh. What was the leverage used against Trump to force this nomination? That picture is still emerging but the subject is touched upon in the conclusion."*

### **Body Language Speaks Louder Than Words**

*"Academically, I have taught the interpretation of body language, I understand the process well. Body language comprises over 90% of the communicated messages that we transmit to others. Our words are secondary, in importance, in comparison to expressed, non-rehearsed body language. Body language is very hard to control and as a result, normally conveys the true message."*

*"I decided to compare the body language of Trump's nomination speeches for Gorsuch vs. Kavanaugh. Trump's verbal content of his two SCOTUS nomination speeches were nearly identical. In both speeches the President expressed extreme verbal approval for his nominee as he was very complimentary of both men's professional backgrounds. Should we have expected anything else? However, the body language displayed by the President spoke volumes when the body language of the two speeches are compared side-by-side. Subsequently, I muted the volume and simply watched the President's body language and compared the two speeches. The results are striking."*

*"When I watched the Gorsuch nomination speech, absent of any sound at first, the President was extremely animated beyond his normal baseline of expression. His arm gestures frequently rose above shoulder level reflecting extreme excitement. His cheeks were raised indicating joy. When I watched his speech and compared his words to his gestures, the words were on beat with his verbal enthusiasm indicating congruence between body language and the message of the spoken word."*

*"In contrast, in the Kavanaugh speech, the President stood at attention and he almost appeared to be in a body cast. His body movement, was very minimal, and was totally out of beat with his words suggesting incongruence between the spoken word and the expressed body*

language. Most importantly, Trump's gestures were almost nonexistent. He appeared more like a soldier at attention that was guarding a royal palace than someone who was performing a landmark duty related to his position."

"Another giveaway to Trump's body language was revealed through his facial expressions as they told the entire story. If one would freeze the video, frequently, one would see what we call micro-expressions of anger. Please allow me to explain. Our conscious and unconscious minds have two different processing speeds. Typically, a micro-expression is not consciously detectable to the untrained eye. However, our unconscious mind can pick up micro-expressions, on an unconscious level, and the research shows us that we form "perceptions" as a result, even though most untrained people could not recite the specific body language that leads to the "perception". However, because we all have video with a pause feature, nearly everyone can use video and can isolate micro-expressions of the President. And my analysis revealed, without question, that the President micro-expressions were extremely negative and conveyed anger and even hostility. Frequently, when I paused the video, I witnessed the fact that President Trump's eyes would frequently narrow, his brow would contract toward the middle thus, forming a typical scowl. These expressions were extremely brief, hence the term MICRO-expressions. This happened in the Kavanaugh speech over and over. I did not see the same expressions in the Gorsuch speech."

"Based on my training, I would conclude that Trump was not pleased with the Kavanaugh choice. The fact that Trump's two speeches were not verbally individualized for each nominee, I concluded that Trump was only performing a perfunctory speech of approval for Kavanaugh. Therefore, I am confident in saying that the President's hand was forced with the Kavanaugh nomination."

"One other item that I cannot shake is that during the entire speech by Trump, Kavanaugh did not embrace his wife, which is nearly a universal behavior in these kinds of circumstances. Instead, he clung to his youngest daughter the entire time. I am not implying illegal or inappropriate behavior, except to say that I thought this behavior was very, very bizarre. Therefore, if you were "creeped out" by Kavanaugh's nonverbal behavior, you are not alone."

"Compare the two speeches, in question, and just focus on body language and note the differences. Even to the untrained eye, the difference between the two speeches, under similar environmental conditions, is striking!"

### **Choice of Mate Reflects the True Nature of One's Soul**

"In a previous article this week, I pointed out the Deep State and possible CIA connections of Rod Rosenstein's wife. She has seemingly represented, as an attorney, all of the swamp creatures (eg Comey, Clinton, Mueller, etc.). She was a shot blocker for FOIA requests with regard to protecting the FBI from public scrutiny. She used an NIH email, even though she has never been affiliated with the NIH. This is a ploy of the CIA to protect their assets from public

scrutiny. FOIA requests for a CIA-serving, U.S. attorney would not go to the NIH. Therefore, her communications would have a level of protection from prying eyes. Rosenstein, as if there was any doubt, is total "Deep State" and his wife stands as the primary testament."

"With Kavanaugh, it is not as dramatic as it was with Rosenstein. However, the pattern is nearly identical.

### **The Wife's Background**

"From 2001 to 2005, Kavanaugh's wife worked in the White House as George W. Bush's personal secretary and she was also Bush's personal assistant from 1996 to 1999 while he was the governor of Texas. She was the personal assistant for the Bush-Cheney presidential campaign from 1996 to 2000. The Kavanaugh's are close friends with the Bush family and they even attended their wedding. Remember, George H. W. Bush was the first American politician to use the phrase "New World Order" and the Kavanaugh's are friends with these family, close friends! With what we know about the Bush crime family, are you surprised? In case you have never been exposed to the Bush family crime syndicate, it rivals the Clinton Foundation. Here is a VERY brief recitation:

1. Prescott Bush was found guilty of violating the Trading with the Enemies Act in WW II. Because he was the head of the USO, he was given a pass because of the potential damage done to service personnel morale.
2. George Bush and 9/11 and the Presidential order that led to the concealment of physical evidence after the investigation was concluded. This is what LBJ did with the JFK assassination evidence.
3. George H. W. Bush was the director of the CIA and according to most researchers was involved in the assassination of JFK. He was the first to label the New World Order and predicted its success.
4. Neil Bush was involved in a dirty bank scandal in Colorado. President George H. W. Bush closed Fitzsimmons Army Hospital and Lowry AFB in retaliation for Colorado legal authorities pursuing Neil Bush.
5. The Bush crime family syndicate are major players in the growth of the private prison system which has ripped off all 50 states and their taxpayers of billions of dollars.

I want to emphasize this is only a small sample size of the Bush family corruption. Yet, the Kavanaugh's were and remain very close allies."

"Please consider the following: Didn't former Gov. J. Bush and Donald Trump have a relationship based upon hate during the 2016 Republican Primary? George H. W. Bush even slammed Donald Trump. And now, Trump nominates a close friend of the Bush family for the Supreme Court? This does not pass the smell test. I am not buying the fact that Trump is on board with this appointment, on multiple fronts."

*“There is also more we need to know about Kavanaugh. He has demons. He is the flawed kind of individual that the “Deep State” likes to use because he can be leveraged because of personal shortcomings.”*

*“Kavanaugh likes credit card debt and this would surely surface during the nomination hearings. The MSM has taken pre-emptive action to head off any speculation as to Kavanaugh’s debts and what they likely mean. I don’t work for the “Deep State”, so I can reveal what I have learned.”*

### **Kavanaugh Is a Compromised Useful Idiot**

*“Supreme Court nominee Brett Kavanaugh incurred tens and maybe even hundreds of thousands of dollars of **credit card debt**. No big deal, says the mainstream media (MSM). The MSM says that Kavanaugh was merely buying **baseball tickets** over the past decade and at times “reported liabilities that could have exceeded the value of his cash accounts and investment assets, according to a review of Kavanaugh’s financial disclosures and information provided by the White House”.*

*“The truth of the matter is that Kavanaugh had previously reported, in 2016, that he had between \$60,000 and \$200,000 in debt accrued over three credit cards and a loan. Which was it Mr. Kavanaugh? Was the amount of debt, \$60,000 or \$200,000? Subsequently, Kavanaugh reported that all 3 of his credit cards “held between \$15,000 and \$50,000 in debt, and a Thrift Savings Plan loan was between \$15,000 and \$50,000”. Sorry, but the math does not add up. However, there are even bigger issues than not being able to keep track of the actual amount of one’s own credit card debts.”*

*“On the surface, Kavanaugh only seems to have a money management issue. However, there is much more to this. The stated reason for the debt is simply not believable.”*

***“White House spokesman Raj Shah told The Washington Post that Kavanaugh built up the debt by buying Washington Nationals season tickets and tickets for playoff games for him and a “handful” of friends. Shah said some of the debts were also for home improvements.”***

*“It is a good thing that Kavanaugh is a judge and not a politician, because he and his supporters do not lie very well.”*

*“So, if the debt is not for baseball tickets (lol), then what is it for? In my most humble opinion, I believe that Kavanaugh might have a gambling problem and this could serve to compromise him and his future actions as a Supreme Court judge. You say that could never happen? Then you don’t know your FBI history. J. Edgar Hoover had a major gambling problem that the Mafia exploited to keep Hoover from admitting there was actually a Mafia. This deception went on for over 30 years until the revelation of the Valachi Papers blew the lid off of this cover up. So, do not make the mistake that this could not happen again.”*

*“If Kavanaugh does not have a gambling problem, it is surely something that is very compromising that the MSM doesn’t want the public to know because the MSM is getting out in front of this issue with pre-nomination hearing press releases designed to take the pressure off.”*

*“The **Washington Post** published that everything is OK with the credit card debt because “Kavanaugh’s friends reimbursed him for their share of the baseball tickets and that the judge has since stopped purchasing the season tickets”. Do the words, Bravo Sierra, come to mind for anyone else? This has to down in history of one of the worst cover stories I have ever heard! Kavanaugh is totally compromised. Oh, and one more thing, my email is blowing up with allegations that Kavanaugh and his wife are both SES members.”*

*“One more small thing about Kavanaugh. He was part of Kenneth Starr’s investigation into Bill Clinton related to the subsequent impeachment proceedings and the not guilty verdict. Those records, related to Clinton and the Starr/Kavanaugh investigation into Clinton are sealed. I am looking into the possible relevance as I write these words. Let’s not forget that Kavanaugh came into the phony investigation into the Vince Foster murder half way through and helped to perpetrate the cover up. Privately, I was told that he constructed the escape hatch that legally allowed Bill Clinton to avoid conviction when he was impeached.”*

*“It was just announced that Deputy Attorney General, Rod Rosenstein is requesting background information from all 93 US federal prosecutors on Kavanaugh. Remember, who Rosenstein’s wife is. She has served a shot blocker for FOIA requests to the FBI. She is also a US attorney. She is likely CIA. Rosenstein is attempting to gather all possible dirt on Deep State Kavanaugh in order to control the narrative. This, like the credit card issue, is a pre-emptive move to head off controversy in the upcoming nomination hearings. Also, Rosenstein has to be checking to see what information is out there about the sealed Bill Clinton impeachment related documents as well. The revelation of this cannot be allowed in order to protect the Deep State.”*

*“In conclusion, all conservatives need to raise their voice in unison and call for the rejection of Kavanaugh’s nomination to the Supreme Court. Trump will silently thank you.”*

*“The Deep State Wants Kavanaugh Confirmed At All Costs? Why?” Only time will tell, and considering Kavanaugh is a Jesuit, we can expect it will be tied to Roman Catholic concerns.*



*“A wolf in sheep’s clothing. Why do the elite want him confirmed so badly? It has become clear that Supreme Court nominee, Brett Kavanaugh, is being endorsed and pushed by some very nefarious forces. Both the “Deep State” and the Global elite want Kavanaugh confirmed.”*

*“It is perfectly clear, if Kavanaugh is confirmed, Americans will lose some very significant civil liberties and the Bill of Rights will lie in ruin. In this presentation, the reasons that the elite desperately want Kavanaugh on the Supreme Court are made crystal clear.”*

It is apparent to me that Judge Kavanaugh will one day down the road be instrumental on rulings where the Roman Catholic Church is concerned. Catholic Charities has received \$95-millions of U.S. taxpayer dollars to resettle illegal immigrants in this country that will be expected to vote for Demo-crat candidates when the time comes. The Catholic Church has an agenda of admitting illegals to this country, for the purpose of forming a Demo-crat block voting party.

It is necessary at this stage to reveal how the marriage between the Jesuit-Illuminati and Freemasonry was consummated. Soon after Jesuit Adam Weishaupt’s “new” order was created in 1776 he wrote: “The great strength of our Order [the Illuminati] lies in its concealment; let it never in any place in its own name, but always concealed by another name, and another occupation. None is fitter than the lower degrees of Freemasonry. The public is accustomed to it, expect little from it, and therefore take little notice of it.”

Jesuit Adam Weishaupt’s plan, in his own words, was to conceal the Illuminati within Freemasonry, so that it would “never appear in any place in its own name, but always concealed by another name, and another occupation. The Order of the Illuminati was to be a secret society within a secret society. Jesuits will front others supportive of their agendas.

Jesuit Adam Weishaupt himself was a Freemason, and knowing the inner workings of that Fraternity as a vehicle for the continual operation of His own Order. For this purpose he would use Freemasonry, for he said, “our order must always remain hidden.”

Weishaupt's Illuminati would come to be two secret societies in one – higher Masonry and Jesuitism – for he was a member of both.

The Illuminati hierarchy was not only to be modeled on that of the Jesuits, but Weishaupt would set up other higher degrees within Freemasonry, thereby using Freemasonry as the incubator and vehicle for the furtherance of the plans of his 'new' Jesuit Order.

Masonic lodges have been taken over by the Jesuit Illuminati because Weishaupt was himself a Freemason, the Illuminati's takeover of the Masonic lodges was seamless. With the Jesuit Superior-General already in control of all Masonry, an understanding was reached with the Masonic hierarchy at the Congress of Wilhelmsbad in 1782 to add the Illuminati degrees on to the first three Blue Lodge degrees of Freemasonry.

By the end of the Third Masonic Congress in 1786, the Illuminati virtually controlled all the Masonic lodges, which at the time represented at least three million members across the German provinces, Austria, Hungary, England, Scotland, Poland, France, Belgium, Switzerland, Italy, Holland, Spain, Sweden, Russia, Ireland, Africa and America. None of this was known to the rank and file members of the Lodges.

The "Illuminati – Masonic" combine was confirmed by Masonic Grand Pontiff, Albert Pike in a letter of January 22, 1870 to Mazzini his counterpart in Italy. He wrote about the creation of a "super rite, which will remain unknown, which we shall elect. Through this supreme (Palladium) rite, we will govern all Freemasonry which will become the one international center, the more powerful because its direction will be unknown."

In other words, this new Masonic rite or degree was to operate incognito – surreptitiously. In this way, Masonry – itself of occult origins – was to become merely an external manifestation of another secret power. Indeed, the power was so described by Madame Petrova Blavastsky in her work *'The Externalization of The Hierarchy.'*

So we see that Masonry, on the highest level, admit to being "of the Illuminati." Freemasonry is plain and simple, Luciferianism at its core. The 19<sup>th</sup> degree of the Rites and Rituals reveals this tenant. Do not doubt this. Masonic writers at the very top of Freemasonry admit to being of the Illuminati.

Aleister Crowley once wrote, "*the ignorance of the Mason is quite boundless.*" Crowley was himself one of the highest-ranking Freemasons of his generation. Crowley noted the vast majority of Masons have no idea of the intensely occult and sinister nature of their lodge.

Next to the Jesuit doctrines, we can charge no surer source of abuse and corruption of orality and pure religion and the manner in which it is represented, than in the Rites of Masonry. Much of Freemasonry is derived from the Hebrew Cabbala [Kabbalah].

Lady Queensborough, in her classic textbook, *'Occult Theocracy'*, states of the Masonic Lodge: "Every lodge is a Synagogue of Satan and its ritual is secrecy." The Father of Freemasonry is Rabbi Simeon Bar Yochai, who gave the world the corrupt and wicked Kabbalah with its mystical book of the *'Zohar'*. Delmar Darrah, 33<sup>rd</sup> degree Freemason, in his textbook, *'Evolution of Freemasonry'* (1979), emphasizes that *"If there were no Kabbalah, there would be no Freemasonry."*

In the *'Zohar'* we are told that the Kabbalah's Deity is named *"Ein Sof"* or (*"Ain Sof"*). His agent, man's companion, is none other the great *Serpent*. Rex Hutchens, 33<sup>rd</sup> Degree Freemason, and author of *'A Bridge to Light'*, published in 1988 by the Supreme Mother Council of Scottish Rite Freemasonry, pages 251-252 affirms that the Serpent is, in fact, a third member of the Holy Trinity. He is, writes Hutchens, *"the body of the Holy Spirit"*.

Masonry's Grand Pontiff, Albert Pike stated that the religion of Masonry *"is identical to the ancient Mystery religions."* The Holy Serpent is said to be he who elevates man to Godhood, and Masons believe, that they will become gods. Eventually the Masons believe they shall become divine gods. Eventually the Masons believe they shall become the *"Masters of the World."*

Revelation 2:9 and 3:9 refers to the ***"Synagogue of Satan"***, which we know as the Zionists and Khazars, who claim to be Jews but they are not. Therein shall be manifest the worship of the blatantly evil Serpent, the very creature blasphemously worshipped by Freemasons and falsely honored as the Holy Spirit of God. But who is the Serpent? Unmistakably we discover that the Serpent is, in fact, Satan. The Rites and Rituals of the 19<sup>th</sup> Degree of Freemasonry clearly identifies the god of Freemasonry is Lucifer!

Jonathan Cahn has been criticized for using teachings from the mystical rabbinical writings of the *'Zohar'* to influence the material in his book *'The Harbinger'*.

Cahn's answer: *"Unfortunately this kind of statements represents some of the extreme and bizarre opposition to 'The Harbinger' – It is an extreme false accusation. No, I have never in my life said that the 'Zohar' has greatly influenced my writing – nor has it ever. ... Rabbinical writings, mystical or otherwise, have been quoted for ages, in Bible commentaries, apologetics, works such as The Life and Times of Jesus the Messiah, etc.... "I found it in the mystical writings, Jewish writing of the Zohar."*

Berit Kjos provides valuable insights into Jonathan Cahn's mysterious Kabbalistic theology. They may also help to explain some of the puzzles in his popular book, *'The Harbinger'*, with its guru-like 'prophet', so-called mysteries, and bewildering misapplication of Scripture.

In a 2012 video, Cahn quotes from the Zohar [the mystical rabbinical writings behind the Kabbala] and presents his view of Golgatha [Gulgalta]. Notice in that partial transcript that the "god" who is credited with salvation, redemption, spiritual light and life is merely a place or

object — a skull or Golgalta — not Jesus Christ our Lord! Apparently, the rabbis behind the ‘Zohar’ have borrowed from the actual Bible but twisted God’s Word into their own esoteric message. Please remember this warnings from God’s true Word: **“You shall not add to the word which I command you, nor take from it...”**—(Deuteronomy 4:2).

Some say that the ‘Zohar’ is to Kabbalists what the Bible is to Christians. That’s partly true! Much of the ‘Zohar’ even sounds Christian to those who are not familiar with the Bible. But in reality, it presents a deceptive blend of distorted truth and Kabbalistic occultism.

In quoting from the ‘Zohar’, Jonathan Cahn affirms that an amazing life-changing event did occur at Golgatha. But his teaching is a corruption of our Lord’s redemptive work through the cross! It exalts a skull and a “thing” rather than our Savior and King!

**“...have no fellowship with the unfruitful works of darkness, but rather expose them.”** – (Ephesians 5:11).

I have watched a number of Jonathan Cahn YouTube messages and he twists Biblical truth, approves of mystical symbolism, and praises the mystical Kabbalistic traditions that distorted and ignore our actual Savior:

*“I found it in the mystical writings, Jewish writing of the Zohar.... The Zohar speaks, the rabbis are writing of the redemption of the worlds with Messiah’s coming. They speak of life from the dead, they speak of the resurrection — the redemption of the worlds....”*

What “worlds”? Our Lord doesn’t promise to redeem any ‘worlds. Instead He calls us to choose between this evil world and life with Him in His Kingdom. **“My kingdom is not of this world,”** He tells us. Only those who trust and follow Him — and who confess their (bondage to) sin — can share in the joy of His redemption and eternal salvation! Perhaps this page will help explain the many worlds that are part of the Kabbalah.

What “universe” would be redeemed? Will this corrupt world will be redeemed rather than destroyed? -(1<sup>st</sup> Thessalonians 5:2-6) This message is totally contrary to the Bible! Jonathan Cahn is a “false prophet”, and unfortunately, naïve Christian leaders and believers have been deceived by the likes of Jonathan Cahn, and the Hebrew Roots Movement. The Kabbalah is at the very heart of Chabad Judaism today. It is also the primary source for the world’s witches, occult teachers, and magicians. It is the manual for numerology, necromancy, astrology, and goddess worship, sexual ritual abuse of small children, psychic mind powers, serpent veneration and idol worship. It is also the very foundation of Masonry, constituting the Mystery religion of the Masonic Order.

The Kabbalah is claimed to be pure, but Christianity is flawed and has errors said Albert Pike. Many high-level Masons agree with Pike. Technically and formally its formal beginning was on June 24, 1717 at the Goose and Gridiron Alehouse. As the Free and Accepted Masonry, as it is organized today, it is the product of the Grand Lodge of England, bound together into a secret society.

Freemasonry is not merely a secretive society, it is a society with diabolical and unspeakable secrets.

The initial degrees of the Blue Lodge consist of three steps: Entered Apprentice, Fellow Craft, and Master Mason for the three degrees. It is at this level most Masons belong and remain in the Lodge. Thus, most Masons have no idea, not a clue, of the true nature of their Lodge. Most join the Masonic Lodge for the fellowship and business contacts that they make. I come from a long line of family Masons, as a pastor, I have been invited/recruited to become a Lodge brother six or seven times but politely chose to pass on the invites.

Masonic author Manley P. Hall explains the naivety of the part of the lower Masons as being due to the fact Freemasonry is a two-dimensional organization. Manley P. Hall states: Freemasonry is a fraternity – within a fraternity = an outer organization. Concealing an inner brotherhood of the elect... one visible society, is a splendid camaraderie of ‘Free and Accepted’ men endowed to devote themselves to ethical, educational, fraternal, patriotic, and humanitarian concerns. The invisible society is a secret and august [“of majestic dignity, grandeur”] fraternity whose members are dedicated to the service of a mysterious Arcanum arcandrum [i.e., ‘a secret or mystery’]”

What is this mysterious Arcanum arcandrum? When a Mason learns the key to the warrior on the block is the proper application of the living dynamo of living power, he has learned the mystery of the Craft, **The seething energies of Lucifer** are in his hands and before he may step onward and upward, he must prove his ability to properly apply energy.

Yes, the seething energies of Lucifer is the secret behind Freemasonry – the mystery of the Craft! Doubt it not. Satan is the Grand Master of the Masonic Lodge.

Why are these facts not well-known? Because every Mason takes a vow “to hide and to conceal” the truth of Freemasonry from the outside world.

On July 14, 1889, Albert Pike, Grand Commander, Sovereign Pontiff of Universal Freemasonry, said to have issued these private instructions to the 23 Masonic Supreme Councils throughout the world:

*“That which we must say to the crowd is – we worship a god, but it is the god that one adores without superstition. To you, sovereign grand inspectors general, we say this, that you may repeat it to the brethren of the 32<sup>nd</sup>, 31<sup>st</sup>, and 30<sup>th</sup> degrees – the Masonic Religion should be, by all of us initiates of the high degrees, maintained in the purity of the Luciferian Doctrine....*

*Yes, Lucifer is god, and unfortunately Adonay is God. For the eternal law is that there is no light without shade, no beauty without ugliness, no white without black, for the absolute can only exist as two gods: darkened being necessary for light to serve as its foil at the pedestal is necessary to the statue, and the brake to the locomotive... The one and pure philosophical religion is the belief in Luciferian. Lucifer, god of light and god of good, is struggling for humanity against Adonay, the God of darkness and evil.”*

Note carefully how Albert Pike, the Grand Pontiff of Scottish Right Freemasonry deceives the Lodge brothers below the 30<sup>th</sup> Degree of Freemasonry. Masonry reverses reality. That which is good is called evil, and vice versa. The Bible warns us about the teachings of Masonry in Isaiah. **“Woe unto them that call evil good, and good evil; that put darkness for light, and light for darkness; that put bitter for sweet, and sweet for bitter!”** –(Isaiah 5:20).

Every Masonic Lodge that is found in virtually every small town and major metropolitan city is a Worship [Church]. If you go into any Masonic Lodge in any community, the floor will be a black and white checkerboard pattern, a visible sign of this corrupted reality.

Freemasonry's syncretistic view of God is subtle deception at the core. In Freemasonry the god of the secret societies is covertly substituted for the One True God. This false god is identified in the Masonic lodges as "the Great Architect."

John 14:11, 13 tells Christians to call upon God the Father in the name of Jesus Christ. Yet in Masonic lodges prayers are always directed to the generic 'Great Architect of the Universe'. Masons deliberately omit the holy name of Jesus Christ from their prayers

Masons have mixed idolatry, paganism, the occult, Gnosticism, Kabbalah, fertility cults, Satanism, spiritualism, demonology, and put it into a blender and come up with the Masonic religion. It is not of God! It is a false religion; the Harlot of Babylon. Masons say they offer new candidates "the light". The light they are actually giving is: Lucifer. The Christian Bible says that Satan walks to and fro on this earth masquerading as an "**angel of light**", that many might be deceived. As initiates complete the rites and rituals of the higher degrees, they are asked what it is that they are seeking? The initiate replies "*More Light!*" Ex-33<sup>rd</sup> Degree Mason Jim Shaw says that this promised "Light" is never found. "The Candidate receiving the 32nd Degree is told he still has not reached the light". –(*The Deadly Deception*, Jim Shaw, pg. 156).

Freemasonry's teachings on how a Mason makes himself fit for heaven are in profound conflict with the Christian faith. Masons wrongly believe that their own good works - without the need for God's grace only gotten through faith in Jesus Christ - will allow them to enter into the 'celestial lodge above'. The goal of Masonry has always been to change America from a Christian nation into a secular society. While this may be hard for many to read, most of the signers to the Declaration of Independence were members of the Masonic Lodge. That is clearly seen in the street layout of the District of Columbia. President John Quincy Adams was convinced Freemasonry was Luciferian, noxious, detrimental and highly evil. So convinced was Adams of the devilish and negative effects of Freemasonry in the affairs of men that the former President of the United States helped to found the Anti-Mason Political Party. In 1830, he was elected to the U.S. House of Representatives on the Anti-Mason Party ticket.

The homosexual agenda, now supported by many Protestant denominations that are now in apostasy, is seen as a means of undermining the faith of Catholics. Freemasons support and promote this agenda. They also support the breakdown of religion through the use of media that is pro-immorality, pro-abortion, pro-homosexuality, pro-pornography, and pro-population control. This latter is already seen as destroying Europe, North America, Japan and Israel through negative natural replacement birth rates.

Albert Pike, the Boston-born one time Confederate Civil War General, and some say a leader of the Klu Klux Klan (actually co-founder) -- intended the degrees leading up to the thirteenth degree to serve as a training school to gradually condition and prepare the candidate for the ultimate acceptance of Luciferian initiation. There are many sections of Pike's book '*Morals and Dogma*' which show that Pike was very interested in the occult the 'Luciferian philosophy'.

In Masonry, everything has a double or dual meaning. Thus, the Mason candidate is practicing occultism throughout his degrees without knowing it. False interpretations are given to keep him from suspecting the institution to be anything less than noble and upright in purpose. This deception, this false interpretation is called allegory. Allegory is defined as; something where the language is one thing and the meaning is another. Through the use of "dualism" allegory masks the true from the profane.

Freemason theology, like Knights Templar theology is not compatible with Christianity. Although Masons will admit to a history only as far back as 1717, research indicates that the same Masonic rituals and beliefs were in use by the Knights Templars. The Lodge idea came from a fraternal beginning. For a period of 700 years (900 A.D. to 1600 A.D.), England went through a period of cathedral building. Masons (men in construction trades who specialized in brick or stone) formed guilds or craft organizations for self-protection. In current terminology we would call them "unions." At that time structures called "lodges" were used by workers as shelter. Later this became the basic unit of Freemasonry. It is for this reason that most symbols are founded on the tools and practices of the building profession. Their rituals are mostly occult, with building trade rituals mixed in. These stonemasons were called "free masons" because they were not indentured servants which local guild masons were at the time. Before the Enlightenment years masons were Christian. That all changed with the formation of the English lodge in London in 1717, however. More to share and more to come in the next segment.
