The Oxford Academic Dictionary defines “Metamorphosis as a process in which somebody/something changes completely into something different.” What I am about to share with the reader is extremely alarming. The term “Metamorphosis” most aptly defines what this segment of the Biblical “Beast Empire” is all about. So much has happened since I posted part 24 of this series. I have held off writing anymore about the Beast Empire until I could digest and analyze world events as they have been unfolding in one continuous event after another, far faster than the public can fathom! There are forces at work that can only be termed as “Satanic” in origin!

Bible prophecy historically has remained sparingly elusive in our lifetime, thus making it near impossible to interpret with any significant level of accuracy. Remember, that it was Daniel the Prophet, who was told in Daniel 12:9 to shut up the book and go about his way. I will come back to this very point shortly, and repeatedly as the book is now opened. The point is that some prophecies are fulfilled without recognition until after the fact. This is why the Lord implored the faithful to always be awake, at watch, and at work in a prophetic way.

I consider myself uniquely blessed and encouraged by what I have been able to see in the world of global news unfolding over the past twenty years, and particularly so the past five years. Infinite numbers of people are oblivious to what is taking place. I have had the benefit of being retired and able to devote full time to the ‘Word of God’ and how it is being confirmed in the geo-political world in which we live. Individuals like me, born in the 1930’s, are classified as members of the ‘Silent Generation.’

The 'Silent Generation' was born between two World Wars and many of us remember World War 2. Like the previous generation, they have experienced both good and bad. Saving and rationing is in their blood. Hard working, family oriented, and minding their own business defines this generation.

I recall anti-aircraft balloons tethered from ground ropes over the industrial and defense plants along the Monongahela River of Pittsburgh, PA, they were designed to snare potential German fighter bomber aircraft. Apartment buildings and homes were required to have black-out curtains drawn shut after sundown. Air-raid block wardens instructed neighbors in civil defense measures. We used ration coupon books for essential food stuffs like sugar, shortening, and butter. They were also used to purchase such items as tires, fuel, and leisure driving was restricted. I am of this silent generation. My dad worked for a company that built truck bodies for the military during the 1940's. I digress, but not for long.

I have been studying the sway affects President Donald J. Trump has had over much of the country. Regardless of what you think of him, he is not who you really think he is! His power is not from God as this article will illustrate. He has been an enigma since he first announced his candidacy for the presidency in June of 2016. I kept an open mind on him, wary of his words and deeds, up until January of 2019. Today, I do not believe that President Trump has the best interests of the American public at heart. The President boasts about the stock market records being broken. That is nothing more than trash talk propaganda, and if you knew how and why the Dow/S&P is being pumped you would know I am right. In June 2019, the real unemployment rate (U-6) was 7.2%. It's almost double the widely reported unemployment rate (U-3) of 3.7%. Yes, he talks about how many jobs he has created and how 'great' the economy is, but one has to ask, and I mean seriously, at what cost? I see President Trump as detrimental to the American public for four specific reasons:

- He embraced the LGBTQ agenda, even designating his sodomite ambassador to Berlin, Richard Grenell, to travel around the world and apply pressure to countries where sodomy is illegal to adopt the U.S. position of accepting, embracing, and legalizing an unnatural act that the Bible condemns. Previous civilizations, empires and societies collapsed when their cultures embraced this perversion as acceptable and normal. It is a mental illness, sodomy is known as the "**Secret Doctrine**" in the Roman Catholic Institution, and is known as the "**Royal Secret**" of Freemasonry. It is a satanic rite in both. God made us male and female; the sex chromosomes are the X chromosome and the Y chromosome. In a man, both an X and a Y chromosome are present, giving an XY configuration. - He has embraced the 5G technology and even 6G without any industry safety testing whatsoever. 5G was originally a weapons system, now being promoted to the public as a communications system. 5G is part of all U.S. military crowd-control systems. 5G will be an integral part of the “666” “Mark” of the Beast in Revelation. Remember, “666” is all about CONTROL ENSLAVEMENT of humanity. 20,000 satellites are currently being deployed in low atmosphere orbit and will engulf the world in an “electronic fence” net radiating the world of Wi-Fi with toxic EMF microwave energy. 5G is 1,000% more powerful than existing 3G and 4G. A 5G antenna has to be mounted every 500-ft, and each will be 1,000% more powerful than existing cell towers that have a signal range of 25-miles per tower. 5G operates on a straight-line millimeter wave length signal requiring a direct line of sight for transmission of its signal, and thus a mini-cell tower will be needed on nearly every other telephone pole. The U.S. Navy knew of the dangers of 5G as early as 1972. Because the U.S. Federal Government has been in possession of hard scientific research studies that conclusively proved numerous medical ailments and health conditions caused by exposure to microwave and radio-frequency radiation. Mike Adams, “*The Health Ranger*” reported on July 30, 2019, the telecommunications industry will be installing 1-million 5G cell tower over the next 2-4 years. This is a fact: 5G technology was developed in Israel, but the State of Israel will not be installing it! What does that tell you? Dr. Katherine Horton, PhD, Oxford University has said: **5G is the Ultimate Directed Energy System to KILL PEOPLE!** Her videos are on You Tube by her name. As I was finishing this article, it was reported on August 2, 2019 that bees were falling dead at a 5G cell tower in a California community!
- He has signed off on GMO food legislation. According to a new report from the Center for Food Safety organization (which just launched this petition), President Donald Trump just signed a new executive order, specifically for the purposes of agriculture, to create sweeping changes within the system that could be a major coup for Monsanto and other GMO producers. As the petition states, the executive order will create a 180-day review process to “identify and eliminate” what Trump says are “*unnecessary regulations.*” The Presidential order will also create a new task force that will “recommend eliminating food and agriculture legislation, policies, and regulations that might hinder the profit-making of agribusiness.” The executive order could be the best news companies like Monsanto, Bayer and Dow Chemical receive all year, and bad news for fans of organic food and the non-GMO movement. Even livestock refuse to eat GMO corn.
- He is complicit with the Vaccine Industry. In April of 2019, he backed the big-pharma agenda by saying “*they have to get the shots*”. Amazon has banned the

sale of the documentary “VAXXED – From Cover Up to Catastrophe.” A documentary alleging that the CDC, the government agency charged with protecting the health of American citizens, destroyed data on their 2004 study that allegedly showed a link between the MMR vaccine and autism. Robert F. Kennedy Jr. recently won a huge law suit showing that none of the scheduled vaccinations ever underwent scientific studies for efficacy or what might be the harmful effects to children. President Trump lied to the American Public when he caved and said “*They have to get the shots!*”

These four issues are the end of human civilization. President Trump either ignores the harm to human life from these or lacks the courage to stand up for truth based upon the scientific evidence showing the harm caused to human life. Again, we see a President owned by the Fascist Wall Street corporate/government tyranny.

With President Donald J. Trump, it is all about the money that can be made, irrespective of matters of public health, safety, or public well-being. But what I am about to share with the reader is more dangerous and will become the impetus as to why the United States is not in Bible prophecy. But it really is! **The United States will be destroyed by China, Iran, North Korea, and Russia.** You may not want to believe this but the die has already been cast. The fact is **President Trump is owned by the Rothschild’s.** He walks to the drum-beat of Jacob Rothschild and other members of the House of Rothschild. I have repeated this point numerous times, cited the evidence, and proof that requires President Trump to deliver Syria and Iran into the fold of 189 nations with a Rothschild central bank. China has had a Rothschild central bank since the late 1970’s.



President Donald J. Trump has played the American public like a fine violin! He is a Pied Piper of the USA, for the ultra-Orthodox Chabad Lubavitch Cult of Zionism. In December of 2015, Jeb Bush said: “*Trump is playing the media 'like a fine Stradivarius violin'.*” He was absolutely correct, but who is a Bush to call the kettle black?

In 2016, Donald J. Trump, without question, was the lesser of two evils. The State of Israel has equated President Trump with the Biblical Cyrus through mysterious ties between Trump, Cyrus, and the Messiah revealed through two mystical methods of

understanding the Torah. In Hebrew numerology, known as Gematria, gives Hebrew letters and words numerical values which uncover hidden meanings, while Bible Codes are used to search the Torah for secret patterns and connections. This is mostly a phenomenon celebrated by Zionist Chabad Lubavitch Jewry. However, Gematria is not evil per se but rather what men choose to use it for. Gematria confirms the Bible as the Word of God through the “Heptadic Design Feature”, a mathematical property whereby God “self-authenticated” His Word. The Chabad Lubavitch Jews are satanic to the core. Jared Kushner and his wife Ivanka are devout Chabad Jews and it has been reported that Donald J. Trump converted to Zionist Chabad Judasism more than two years ago; and, did not share his conversion so as not damage his Evangelical Christian base.

Cyrus’s connection to the Messiah is found in the Book of Isaiah. The Persian king is the only non-Jewish leader to be referred to in the Bible as **‘Moshiach’**, literally ‘His anointed one’. The word for ‘anointed one’ in Hebrew is **‘Moshiach’** (משיח), which means “Messiah”. Trump’s connection is found through Gematria. Using the method to break down the value of Hebrew letters, Donald Trump’s name in Hebrew (ד טראמפדונל) equals 424 – which is also the numerical equivalent of **‘Moshiach** for the House of David’ (משיח בן דוד).

Rabbi Matityahu Glazerson, a Bible codes expert, also discovered Trump’s ties to Cyrus and Messiah within the codes. One week after the 2016 elections, Rabbi Glazerson produced a video in which he described clues found in Leviticus. Rabbi Glazerson found the words ‘D. Trump’ and ‘president of the USA’ adjacent to the word **‘Koresh’** (‘Cyrus’ in Hebrew). All of these words were adjacent to the word **‘Moshiach’**, used in that instance explicitly as a characteristic of an anointed priest. The Zionist Chabad Lubavitch picked up on this and has not let up in their pumping up and fawning over Donald J. Trump. They see Trump as their **‘Moshiach’**.

Rabbi Glazerson found the words “D. Trump’ and “president of the USA” adjacent to the word **‘Koresh’** (‘Cyrus’ in Hebrew). “Definitely Trump is not **‘Moshiach’**,” Rabbi Glazerson cautioned, explaining the unique connection. **‘Koresh** was called **‘Moshiach’** because he helped the Jews to settle Israel and to start building the Second Temple. Trump is like **‘Koresh’** because he is supposed to help the Jews in Israel, maybe to build the Temple.”

The Trump-Cyrus connection was acknowledged even before the election by many Evangelical Christians, who supported Trump’s campaign promise to establish Jerusalem as Israel’s capital. Evangelical speaker Lance Wallnau wrote a best-selling book on the subject titled *‘God’s Chaos Candidate’*. One of the latest individuals to come to the forefront is a guy by the name of Mark Taylor, a retired firefighter. According to him, he says he was “given” a very specific prophecy in 2011 and apparently it has unfolded so that now he realizes that God has told him (definitively) that Donald Trump is God’s choice to bring America back from utter destruction. He co-authored a book called *‘The Trump Prophecies’*, published by Charisma Publishing, a charismatic magazine and book publisher. It was made into a movie in 2018. What they fail to tell you is that his prophecy was in 2011, before the 2012 election but we all

know Donald J. Trump was not even the candidate in 2012, let alone win the presidency, won by Barack Hussein Obama.

There is no evidence or proof of what Taylor did any of that at all, but it appears he simply assumed that what was being revealed to him was of the Lord. End of story. There are many instances of Taylor saying "God told" him or "God showed" him without any possibility of Taylor being wrong. He simply assumes that God is speaking; not a demon, or not the devil, not even his own imagination. It was God, period. The ramifications to this – like every other "prophet" who has marched across the horizon – is that if you do not believe what is being revealed, then you do not believe God. These people really need to watch what they say and how they say it! That said, it has not kept Internet journalists from giving Taylor a platform to deceive his viewers.

People will ultimately believe what they want to believe and often times, Satan doesn't have to work that hard to have his lies accepted as truth. Too many people want to believe what is false because it sounds good. No one wants bad news at all and this is what we are being faced with here. Rather than accepting it, knowing that God is still in the business of saving souls (not necessarily countries), Christians prefer to chase after things that offer light in the darkness. Mark Taylor and Lance Wallnau are false teachers and false prophets. His "Batting Average" percentages on his prophecies have yet to meet the criteria of a "True" prophet in the Bible, which is 100%.

Deuteronomy 13:1-3, ***"If there arise among you a prophet, or a dreamer of dreams, and giveth thee a sign or a wonder, And the sign or the wonder come to pass, whereof he spake unto thee, saying, Let us go after other gods, which thou hast not known, and let us serve them; Thou shalt not hearken unto the words of that prophet, or that dreamer of dreams: for the LORD your God proveth you, to know whether ye love the LORD your God with all your heart and with all your soul."***

The Word of God says plainly, if the prophet IS correct, but then preaches biblical error; do NOT trust him at all! The teaching of the prophet must always be 100% in line with that which is written. If he or she is swaying in any way with the Word of God we are told not to place any trust in him or her. For it is written plainly in Isaiah 8:19 & 20, ***"And when they shall say unto you, Seek unto them that have familiar spirits, and unto wizards that peep, and that mutter: should not a people seek unto their God? For the living to the dead? To the law and to the testimony: if they speak not according to this word, it is because there is no light in them."*** Unfortunately, many so-called modern-day prophets don't know their Bible, or count on others to know their Bible.

This Chabad Lubavitch sect of Judaism is adherents of the Luciferian Talmud, and they consider Jacob Rothschild their king! Thus the equating of Trump with Cyrus set off a messianic storm that God put Donald J. Trump in as the 45th President. Was it really God or was it Jacob Rothschild responsible for Donald J. Trump's election they all want their Messiah, and it is not Jesus Christ, on that you can bet your last dollar!

Before going further, I need to share a news story that goes back to the disappearance of Malaysian Airlines Flight MH370. It speaks to the power of the House of Rothschild in Jewish affairs and global finance. This is about something that occurred five years ago and the President is connected to its consequences in a roundabout fashion. Malaysia Airlines flight MH370 went missing on March 8, 2014, after taking off from Kuala Lumpur airport bound for Beijing, China. It lost all contact with air traffic control 40 minutes after take-off over the South China Sea and disappeared from radar. In July, 2014, four months later, a Malaysia Airlines plane crashed over the Ukraine, near the Russian border. It was Malaysian Airlines Flight MH17. It is connected the MH370 by what was in its cargo hold at the time of its downing!

The disappearance of four members of a semiconductor patent traveling on Malaysia Airlines Flight MH370 resulted in the famous trillionaire Jacob Rothschild as becoming the sole owner of the important patent of a super-controller microchip.

The mystery surrounding the Malaysian Airlines MH-370 grows by the day, now into the fifth year of its disappearance. Many conspiracy theories were thrown up to confuse and distract the world. One of the so-called conspiracy theories is that of **Freescale Semi-Conductor's** ARM microcontroller 'KL-03', which was a new improved version of an older microcontroller KL-02. The story about how the Illuminati Rothschild exploited the airlines to gain full Patent Rights of an incredible KL-03 micro-chip went viral on the Internet, days after the disappearance of the Boeing 777, flight MH370, especially when it's involving Jacob Rothschild as the evil master plotter became public.

"Steemit.com" reported that Jacob Rothschild was killed in a crash between a small plane that collided with a small helicopter.

The event was hidden in the fake news story of a collision of a single engine Cessna 152 airplane and a two man helicopter the Cabri-G2 on Friday 17 November 2017. The helo has a range of 380 nm and is used for emergency channel dash meetings by JR. The crash occurred over the Rothschild Buckingham shire estate in England surrounding Waddesdon Manor that resulted in the deaths of four people, two in each aircraft.

A U.S. technology company which had 20 senior engineers and programmers on board Malaysian Airlines flight MH370 had just launched a new electronic warfare gadget for military radar systems in the days before the Boeing 777 went missing.

Freescale Semiconductors has been developing micro-processors, sensors and other technology for the past 50 years. The technology it creates is commonly referred to as embedded processors, which according to the firm are "stand-alone semi-conductors that perform dedicated computing functions in electronic systems."

Why were so many **Freescale** employees traveling together? What were their jobs? Were they on a mission and if so what was this mission? Can these employees be the cause of the disappearance of this plane? Could the plane have been then hijacked and the passengers kidnapped? Did these employees hold valuable information? Did they have any valuable cargo with them? Did they know company and technological secrets? With all the might of technology why can't this plane be located? Where is this plane and where are the people?

"The 20 Freescale employees, among 239 people on flight MH370, were mostly engineers, programmers and other experts working to make the company's chip facilities in Tianjin, China, and Kulala Lumpur more efficient," said Mitch Haws, vice-president of global communications and investor relations.

In Malaysia, **Freescale's** modern operations facility that manufactures and tests integrated circuits is based in Petaling Jaya. Based on information obtained from **Freescale's** website, the facility began operations in 1972 covering an eight hectare site and is specifically designed for the manufacturing and testing of microprocessors, digital signal processors and integrated radio frequency circuits. It also owns **Freescale RF** which is involved in creating solutions for Aerospace and Defense listed below:

1. Battlefield communications
2. Avionics
3. HF Radar – Band L- and S-
4. Missile Guidance
5. Electronic Warfare
6. Identification, friend or foe (IFF)

Freescale's shareholders include the Carlyle Group of private equity investors whose past advisers have included ex-U.S. president George H.W. Bush, and former British Prime Minister John Major. The KL-3 is pictured below, on the dimple of a golf ball to better visualize its miniature size.

Carlyle's previous heavyweight clients include the Saudi Binladin Group, the construction firm owned by the family of Osama Bin Ladin. The fact that **Freescale** had so many highly qualified staff on board the disappeared Boeing 777 had already prompted wild conspiracy theories about what might have happened.



Experts have been baffled how a large passenger jet seems to have flown undetected and possibly beaten military radar systems for up to six hours. Avoiding radar via “cloaking technology” has long been one of the objectives of the defense industry and Freescale has been active developing chips for military radar. On its website, the company says its radio frequency products meet the requirements for applications in “avionics, radar, communications, missile guidance, electronic warfare and identification friend or foe.”

Last June, 2018, **Freescale** announced it was creating a team of specialists dedicated to producing “radio frequency power products” for the defense industry. And on March 3, 2019, it announced it was releasing 11 of these new gadgets for use in “high frequency, VHF and low-band UHF radar and radio communications”.

Critical information reveals that four days after flight MH370 disappeared, the semi-conductor patent was approved by the U.S. Patent Office; the patent is divided in parts (shares) of 20% between five partners. One of the owners is the company itself,

Freescale Semiconductor, of Austin, TX, and the other four Chinese employees of the company: Peidong Wang, Zhijun Chen, Cheng and LiYing Zhijong. They and all the passengers of Malaysian Airlines MH370 disappeared on March 8, 2014.

Here is your motive for the missing Beijing 777 plane as all four Chinese members of the Patent holders were passengers on the missing plane. Patent holders can alter the proceeds legally by passing wealth to their heirs. However, they cannot do so until the Patent is approved. So when the plane went missing, the patent had not been approved. Approval occurred subsequently to MH370's disappearance!

However, the absurd theory does not add up. Although a **Freescale** patent does exist under number US8650327, none of the names listed actually appear on the passenger manifest released by the Malaysian authorities. But maybe the names have been removed from the flight manifest.

If the patent holder dies, the other owners share equally in dividends from the deceased. That four of the five patentees die, then the patentee left alive gets 100% of the patent. That remaining patent holder is the company **Freescale Semiconductor**. Who owns **Freescale Semiconductor**? The answer is: **Jacob Rothschild**. The British Trillionaire owns the company known as **Blackstone**, which in turn owns the company **Freescale Semiconductors**. Several speculations on the Internet now begin to pay attention to the circumstances. The Rothschild's are a legend dynasty of financiers and international bankers of German-Jewish origin. The family is from the 19th century one of the most influential families of bankers and financiers of Europe.

Jim Stone, an independent journalist broke the story on the missing MH370 Boeing 777, two days following its disappearance. The facts known confirm this is not a conspiracy theory, but conspiracy fact! Great efforts have been extended to debunk the story of IBM senior engineer and passenger Phil Woods on the MH370 flight. Phil Woods had a brand new Iphone10 tucked away in the crack of his behind which fortunately contained GPS locater technology in the smart phone. He sent out a message which included two blank photos to his girlfriend back in Kuala Lumpur. The photos were black but the prints revealed the GPS coordinates from which the pictures were clicked while on the plane, which strangely, was sitting at the end of the runway on the US/UK air base at Diego Garcia in the Indian Ocean.

We can know with absolute certainty that the aircraft did not crash. Rolls-Royce, the manufacturer of the jet engines of flight MH370, a Boeing 777, monitors the performance of their engines, sending hourly telemetry data back to its facilities in Bristol, England. They announced that they had monitored the aircraft for more than eight hours after it had supposedly disappeared from radar. That had to be a big kick in the pants surprise to those wanting to deceive the world.

It appears from the shoot-down of another Malaysian Boeing 777 flight MH17 over the Ukraine, the aircraft debris sight where it crashed, first responders found the aircraft full of decaying and rotting bodies in the cargo hold. This would be precisely

what we would expect to find approximately 4 months later after MH370 disappeared from all public view. The Russians were immediately blamed for the downing of the aircraft on July 17, 2014. Halfway through a flight from Amsterdam to Malaysia, a passenger plane was shot down over the war-torn Ukraine-Russia Border. All 298 people on board, most of whom were citizens of the Netherlands, died in the explosion. Russia was accused of shooting the flight down with a missile; however, examination of the aircraft debris, the forward portion of the 777 cabin shows the fuselage riddled with bullet holes that showed entry from the outside, confirming it was shot down by a Ukrainian fighter aircraft, and hoping to pin the blame on Russian 'buk' surface-to-air missiles. The ruse might have succeeded had it not been for the 239 bodies decaying and rotting away in the cargo hold.

Currently there is an ongoing struggle over an alleged cover-up of the downing of the MH17 flight over the Ukraine. I watched a video on July 30, 2019 dealing with this cover up scandal. The dispute is between Dutch, Ukrainian, and Malaysian authorities. An independent group began their own investigation to determine the real attackers. They interviewed farmers in and near the crash site, who confirmed the presence of two Ukrainian fighter planes circling the MH17, and firing an air-to-air missile and firing machine gun blasts at the MH17. Dutch and Ukrainian authorities blamed Russia for the shoot down and continually stone-wall by refusing to give copies of official records to the Malaysian government. The decaying and rotting 239 bodies found at the debris site of MH17 are paramount in this drama in the alleged cover up dispute!

The plane took off from Amsterdam at 10:31 GMT. It was expected to fly over the Ukraine-Russia border which, due to a war between Ukrainian fighters and Pro-Russia separatists, had instituted a minimum-altitude restriction just three days earlier to keep planes from being caught in any potential crossfire. The plane made contact and flew into country lines in accordance with restrictions, but disappeared a few hours later, just 30 miles from the border. No distress signal was ever received from the crew of MH17.


Questions arose about the flight path. Was it safe? As it turned out, the path had been approved by the International Civil Aviation Organization, and by the countries that controlled the airspace through which the plane was set to travel.

While it wasn't clear in the beginning, it was suspected the plane had been shot down by "ill-trained" Russian separatists. President Putin's personal airplane was returning from a Summit in South America, and following behind just minutes behind the path of MH17, but in-route to Moscow, Russia. President Putin was aboard his assigned personal jet. Four days later, after investigators were finally able to get their hands on the plane's black box, these suspicions were confirmed. The explosion had definitely not come from within. The recorder revealed that, as the plane approached the border, a "high-energy object" exploded a yard from the cockpit, breaking it completely off from the rest of the plane. The pilots were killed instantly. The rest of the plane flew for more than five miles before finally breaking apart. The debris was scattered over more than 20 square miles of open fields. The decaying rotting bodies

were likely the passengers and crew members of the earlier disappeared MH370 Boeing 777. But the decaying bodies had all been drained of their blood!

It took 15 months to figure out which side of the war the projectile had come from. In October, 2015, Dutch investigators were able to discern that the blast had been caused by a Russian-made missile. In June 2016, over two years after the plane was shot down, an international group of investigators published a photo of large part of a Russian-made Buk missile that was found at the crash site. However, the evidence was far from convincing as to the cause of MH17's destruction.

Finally, in May of 2018, after four years of gathering evidence, a release from the Netherlands and Australia said that it wasn't just a Russian-made missile that had taken down Flight 17, but that they were officially holding Russia accountable.

"We call on Russia to accept its responsibility and cooperate fully with the process to establish the truth and achieve justice for the victims of flight MH17 and their next of kin," The Dutch foreign minister Stef Blok said. The families of the victims have also begged them to take responsibility. For their part, Russia has repeatedly denied the accusation, claiming that the missile "more than likely belongs to the Ukrainian armed forces." Photos of the downed aircraft revealed that it was riddled with machine-gun bullets that could have only come from a Ukrainian fighter aircraft.



The evidence suggests that the original disappeared aircraft landed for a brief time, less than two hours to refuel at Diego Garcia, then flew on to Israel's southern-

most city of Eilat, Israel, at the tip of the Red Sea. It remains a mystery as to where and how the aircraft was re-introduced back into service so as to later depart Amsterdam as MH17. There is a twist in this story, as the missing Boeing 777 had an identical twin aircraft that came off the assembly line, side by side, which had been sitting in a hanger in Israel, both of which were identical models on the assembly line at Boeing's plant in Everett, Washington.



The two also had different door and window configurations than other Boeing 777 aircraft coming off the two assembly lines building the model 777 aircraft, pictures which were photographed at the site of the shot down flight MH17 confirmed the unique door/window configuration were identical to that of a Boeing 777 sitting in a hanger in Israel. Airplane buffs who had taken photographs of the “twin” or mate of this particular Boeing 777, thus confirming the fact, MH17 was identical to the one in Israel.

ISRAEL'S SECRET MALAYSIA AIRLINES TWIN IN TEL AVIV – In the summer of 2013, the Israeli-run GA Telesis company of Florida obtained a Malaysia Airlines 777, which was virtually identical to the missing plane(s), and secretly sent the plane to Israel in November 2013. 8 Signs That Prove MH17 and MH370 Were The Same Planes! Conspiracy Alert!

When it was first announced that flight MH-370 disappeared without a trace, there had been voices suggesting that the same plane will be later used in a false flag operation.

Personally, I tried to ignore the speculations thinking that no secret agency could ever conduct such an insanely-obvious operation, expecting that the rest of the world is stupid enough to buy it.

Boy, was I was wrong!

1. THE ALLEGED MH17 WAS THE SAME PLANE MODEL AS MH-370

The missing MH370 was the same model, 777-200, but with a different ID number M9-MRO.

The US military base Diego Garcia is conveniently located within flying distance of the spot where MH-370 disappeared from the radar.

The *'Journal'* notes that Kushner's Cadre stake “means the senior White House official is currently a business partner of Goldman Sachs Group (a Rothschild bank) and billionaires including George Soros and Peter Thiel.” The Journal also reports that Kushner didn't disclose a number of loans “totaling at least \$1 billion, from more than 20 lenders,” on properties and companies he co-owns; and Kushner “has also provided personal guarantees on more than \$300 million of the debt.” An analysis of the debt on these assets *“found ties to a broad swath of U.S. and foreign banks, private-equity firms, real-estate companies and government-owned lenders.”* Most of them are Rothschild affiliates.

[Kushner's lawyer Jamie Gorelick] said the Cadre stake is described in a revised version of [Kushner's] financial-disclosure form that will be made public after it has been

certified by ethics officials. She said Mr. Kushner has previously discussed his Cadre ownership with the Office of Government Ethics and that Mr. Kushner has “resigned from Cadre’s board, assigned his voting rights, and reduced his ownership share.” A spokesman for the Office of Government Ethics didn’t immediately respond to a request for comment on journalist requests.

Mr. Kushner co-founded Cadre in 2014 with his brother Joshua and Ryan Williams, a 29-year-old friend and former employee of Kushner Companies, the family-controlled business that Mr. Kushner ran until recently. Cadre markets properties to prospective investors, who can put their money into specific buildings or into an investment fund run by Cadre, which collects fees on each deal.

To get off the ground, Cadre turned to a Goldman Sachs fund and a number of high-profile investors. Among them were the venture-capital firms of Mr. Thiel, Silicon Valley’s most prominent supporter of Mr. Trump, and Vinod Khosla, a co-founder of Sun Microsystems Inc., according to Cadre’s website. Other backers include Chinese entrepreneur David Yu, co-founder with Alibaba Group Holding Ltd.’s Jack Ma of a Shanghai-based private-equity firm, hedge-fund manager Daniel Och and real-estate magnate Barry Sternlicht, people close to Cadre said.

Cadre also secured a \$250 million line of credit from the family office of George Soros, a top Democratic donor whom Mr. Trump criticized during his presidential campaign, the people close to the company said. Mr. Soros’s family office is also an investor in Cadre. I have not shared all of the Trump/Kushner real estate dealings and their methods and sources of their financial sources, other than to present a picture where leverage can be applied by Jacob Rothschild’s diabolical scheme.

At this point, it is fairly obvious that the United States and possibly the UK and France are about to launch strikes against Iran, with that possibly developing an all-out Gulf War. The U.S. has sent far too many troops and too much equipment for this all to be simply saber-rattling. Everything points to the U.S. re-establishing a long-term military presence in the region, just as it did at the start of the Iraq war in 2003. The unknown factor is how much will Russia involve themselves with their ally Iran should hostilities break out, but I cannot imagine them sitting passively on the sidelines if it does. In June the U.S. military began moving equipment and hundreds of troops back to a military base in Saudi Arabia that the U.S. deserted more than 15 years ago, according to two U.S. officials familiar with the deployment.

Over the coming weeks the deployment to Prince Sultan Air Base, intended to counter the threat from Iran, will grow to include fighter jets and Patriot long-range missile defense systems, the officials said. The Patriots have already arrived at the base and should be operational in mid-July, while the aircraft are expected to arrive in August. There are 3 or 4 squadrons of F-22’s and F-35’s stationed in and around the region that will be the theater of command.

And it turns out that the U.S. military has used this base during all of our previous wars in the Middle East. For example, according to ‘*Air Force Magazine*’ the U.S. military first occupied Prince Sultan Air Base for a few months during Operation Desert Storm.

The US Air Force first occupied the sprawling base in two frantic months from November 1990 to January 1991, then departed. Five years later, USAF and coalition forces moved back into the base. It quickly became a massive facility, home to a state-of-the-art air operations center and serving as the hub for air activity in the region. Then later on, the base played a key role during the U.S. invasion of Afghanistan. The following comes from the ‘*Military Times*’.

Starting with the January 1991 air war against Iraq after its invasion of Kuwait the previous summer, the U.S. flew a wide range of aircraft from Prince Sultan air base,

originally known as al-Kharj. Supported by an all-American array of creature comforts like fast-food restaurants and swimming pools, U.S. forces there flew and maintained Air Force fighters and other warplanes.

The base also served as a launch pad for the December 1998 bombing of Iraq, code-named Operation 'Desert Fox', which targeted sites believed to be associated with Iraq's nuclear and missile programs. In 2001, the base became home to the U.S. military's main air control organization, known as the Combined Air Operations Center, which orchestrated the air war in Afghanistan until it was relocated in 2003 to al-Udeid air base in Qatar.

But U.S. activity at the base didn't reach a crescendo until Operation 'Iraqi Freedom' in 2003. Other delicate negotiations came down to the wire just before the start of 'Operation Iraqi Freedom'. *"We've had very productive meetings regarding military cooperation with Saudi Arabia in the event of military action against Iraq,"* State Department official Richard Boucher announced Feb. 26, 2003.

That day, newspapers reported that the Saudis granted formal permission for PSAB to be used in the war against Saddam Hussein's Iraq. Operation 'Iraqi Freedom' began March 19.

Once again, PSAB pulled its weight in the air campaign. Fuel is a metric showing just how far PSAB had come since 1996. Prince Sultan Air Base operated at maximum rates during major combat operations in Operation 'Iraqi Freedom' from March 19 to May 1, 2003. During that time, the 363rd Fuels Management Flight issued more than one million gallons per day. Officials had previously expanded the fuel storage capacity at Prince Sultan from two million to more than 15 million gallons.

So as you can see, every time the U.S. has decided to go to war in the Middle East, Prince Sultan Air Base has played a leading role. And now after all this time we have suddenly returned once again.

This time around, it appears that the U.S. is planning for a very long stay. According to NBC News, existing roads and runways will be reinforced and expanded, and the U.S. military is even going to "build a medical facility"... , a confirmation that it anticipates this to be a large scale operation. David Elias Goldberg's "Trump War Plan" sounds to be both credible and somewhat similar to what is occurring in this building up of Prince Sultan Air Base.

While Prince Sultan Air Base is an active facility, portions of the base will need an upgrade to accommodate the U.S. military, including reinforcing and expanding roads and runways, one U.S. official said. Base housing will also need updating, the official said, and the U.S. will build a medical facility. Many of the U.S. service members deployed there over the past few weeks are engineers preparing the base for the new mission. Apparently whoever is in charge of making these sorts of decisions is not very optimistic about peace with Iran.

A tremendous amount of money and effort is required for a project like this, because it is basically the equivalent of putting up a small American city in the middle of nowhere. The base covers “well over a hundred square miles”, and all the way back in 2002 Wolf Blitzer called it *“a little sliver of America in the middle of the Arabian Peninsula”*...

“By the time the base complex was completed in 1999, it had cost the government of Saudi Arabia more than \$1 billion and covered well over a hundred square miles,” found Air Force historian Daniel L. Haulman.

Food was also a priority. Baskin-Robbins ice cream set up shop as did other popular vendors such as Pizza Inn and Burger King. In time, the exchange provided a small haven of food, shopping, and diversion. *“It’s a little sliver of America in the middle of the Arabian Peninsula,”* enthused CNN’s war correspondent Wolf Blitzer, who visited the base in December 2002 as forces there prepared for intensifying action against Iraq.

I suppose that the Saudis want us to be as comfortable as possible if we are going to fight a war that will greatly benefit them. After all, the Saudis and the Iranians have been engaged in a proxy war for many years, and so the Saudis would be absolutely thrilled to see the U.S. military bomb the living daylights out of them. And Saudi Arabia’s minister of state for foreign affairs actually sounds quite eager for the action to start... *“Any attack on the freedom of navigation is a violation of international law,”* Adel Aljubeir said in a Twitter post.

Think about the fact that President Trump’s very first foreign State visit was to none other than Saudi Arabia, in May of 2017. The leaders inked a deal for Saudi Arabia to purchase \$350-billion over ten years, \$110-billion that took place immediately, in military weapons and munitions. After sealing the deal, two days later he went to Israel to keep Netanyahu abreast of his plans no doubt!

“Iran must realize its acts of intercepting ships, including most recently the British ship, are completely unacceptable. The world community must take action to deter such behavior,” Adel Aljubeir added.

“In the third year of Cyrus king of Persia a thing was revealed unto Daniel, whose name was called Belteshazzar; and the thing was true, but the time appointed was long: and he understood the thing, and had understanding of the vision.” - (Daniel 10:1).

In the role of George Soros as an agent of the House of Rothschild, it is important to know that Soros gave \$18-billion of his personal wealth to groups committed to the overthrow of the U.S.; and, he has bank-rolled the illegal alien invasion from 42 countries through the U.S. southern border. It seems difficult to believe that President Trump is oblivious to this well-known fact, especially since a “Wall” is “priority one” with the President! What has President Trump done about George Soros, a citizen

of the U.S. Absolutely nothing!!! He should be arrested and prosecuted for treason and sedition.

I need to move on in what I call "*The Metamorphosis of the Beast Empire*". There is so much more, it is hard to know where to begin at in this story.

It was just days ago that Israel's Prime Minister Benjamin Netanyahu reported what is happening in the transfer of power from the New World Order's American headquarters to Jerusalem. Netanyahu would tell Israel 'Hayom News': "*We have turned Israel into a rising world power, in security, in foreign relations, the economy, science and technology, water purification, energy resources,*" Netanyahu said. "*We send a spacecraft to the moon, and on the ground, we make the desert bloom.*"

The transfer of power of the Leviathan drilling rig from the Gulf of Mexico to the Leviathan gas field in Israel's Mediterranean waters is symbolic of the New World Order transfer of power from Washington to Tel Aviv; Benjamin Netanyahu was making the same pronouncement: Israel has become a central world power! And now, let's see how the Israeli and American economies are on track to fulfill a big economic prophecy in the end of days.

DOR BEACH, Israel (Reuters) - Israeli Prime Minister Benjamin Netanyahu on Thursday inaugurated the foundation of the Leviathan natural gas rig, effectively stomping out protests from residents and environmentalists who say it is too close to shore.

The Leviathan, discovered in 2010, is one of the world's largest gas discoveries of the past decade. The rig's foundation, known as a platform jacket, arrived on a barge that sailed from Texas. Its topside is expected in several months. It is expected to be completed by the end of this year. "*Israel is becoming an energy power. Israel is independent, and is not dependent on anyone for its energy needs,*" Netanyahu told reporters at the site, about 120 km (75 miles) off Israel's Mediterranean coast.

Leviathan will be connected by a subsea pipeline to a production platform much closer to shore, just 10 km from a popular beach, angering some opposition lawmakers, environmentalists and residents. They have demanded, with several unsuccessful petitions to Israel's Supreme Court that the rig be pushed farther out to sea. But the arrival of the platform's massive legs effectively stomps out the protest and any doubt it created around the completion of Israel's largest energy project ever. The project operator, Texas-based Noble Energy (NYSE:NBL) has a 39.66 percent stake in the field, while Israel's Delek Drilling holds a 45.34 percent share, and Ratio Oil has the remaining 15 percent.

Up until now, in this installment, I have not addressed or mentioned "**MYSTERY, Babylon the Great**" as an entity that is for all intent and purpose, composed of the Vatican and Washington, D.C. But there is another aspect of this term "MYSTERY" that has been in a process of Metamorphosis". "Babylon the Great" is becoming larger than

life. Yes, we have been witness to another dimension of why the Bible calls it a “Mystery”. Pastor Chuck Baldwin has defined it sufficiently enough so that we can clearly extrapolate its message for our day. Remember this most important fact, it is the financial arm of the House of Rothschild that represents the Vatican financial interests, but it unifies its own agenda of establishing a false messiah for the modern state of Israel simultaneously. Scripture makes it clear that its goal is to relocate the Vatican headquarters of the Roman Catholic institution to Israel. Since the beginning of the Illuminati in 1776, the House of Rothschild has financed the launching pad for Jesuit Adam Weishaupt’s larger grandiose plan of a global government. The House of Rothschild provided the financial wherewithal for the Illuminati to grow and prosper, and ultimately rule the world.

Many Bible students have errantly concluded that the Roman Catholic Vatican is the great city of Revelation 17:18 that reigns over the kings of the earth, but remember, the Antichrist when he appears doesn't stand up in the Vatican and proclaim to be God - (2nd Thessalonians 2:4; Daniel 9:27; 11:31; 12:11; Matthew 24:15); but rather, from the soon to be rebuilt temple in JERUSALEM. If the Vatican reigns over the leaders of the world's nations, then it wouldn't make sense for the Antichrist to declare his Godhood from Israel. I believe the False Prophet (the Second Beast in Revelation 13:11-15) will be the Catholic Pope. Revelation 11:8 plainly tells us that “the great city” is Jerusalem, where our Lord was crucified, which is spiritually called Sodom and Egypt (two of the most wicked of places on earth throughout history).

The Bible says that the woman (whore) rides the Beast. The Beast in this context represents the brutal and militant conquering powers of Egypt, Assyria, Babylon, Medo-Persia, Greece, Rome and the coming World Government. The woman is not God's holy nation, Israel, which has been made unholy today by the Illuminati. The woman is not the Jews, most of whom are blasphemous Christ-rejecters. The woman (whore) is the prostituting of the things of God for the Devil's purposes. Present-day Israel is of the Devil, a counterfeit nation waiting for her counterfeit messiah (the Antichrist).

Mystery Babylon includes Catholicism, both Greek/Russian Orthodox and Roman, Freemasonry, Skull and Bones (all occult groups), all false religions, all worldly corporations displaying the All Seeing Eye and the Pyramid, Hollywood, and the music industry. Vladimir Putin is a Freemason, always quick to place his thumb over the knuckles of the one he is shaking hands with. It is the foremost sign of who is and who isn't a Freemason. A Lodge brother knows well the meaning of the “press” of his knuckles when shaking hands with a brother Freemason!

There is a body of the scholars who see the entities spoken of in the Bible as the **House of Judah** and the **House of Israel** playing a prominent role in final day's events. Heretofore I have hesitated to identify them by their Biblical name. The facts be known, suggest they are part of the “**MYSTERY, Babylon the Great**”.

A “whore” is someone (which could include a nation) who is used, exploited or manipulated for the benefit of others. Present-day Israel was established in 1948 by the


Rothschild-led international banking cabal as a means of exploiting the Middle East to bring to fruition World War III. Lucifer-worshipper and Freemason legend, Albert Pike (1809-1891); before his death predicted World Wars I, II and III with disturbing accuracy. Now, over a century later, the Arab nations are continually fighting with Israel, just as Albert Pike predicated, which he said will ultimately lead into World War III between the Jews and Arabs, dragging the rest of the world into the major conflict. It is all simmering before our very eyes in the Middle East. The escalated conflicts are increasingly worse each year. Freemasonry and Kabballah pull the strings of the players (nations) on the world stage!

The third Jerusalem temple is ready to be constructed. The priests are trained. The materials have been secured. The livestock for sacrifices are ready. There's only one big problem hindering them. The Arabs control the Temple Mount where Solomon's temple once stood. The Jews cannot build their temple until the Arabs let them. This is where the soon appearing Antichrist will come into play. The Antichrist will work out an agreement between the Jews and Arabs, which will be violated half-way through the Tribulation Period -(Daniel 9:27). This is fascinating Bible prophecy.

Roman Catholicism is a part of Mystery Babylon, but not the only part! It took me years to figure this out, because so many writers of Bible commentaries have been deceived and continuing to deceive the church today, that Mystery Babylon goes far beyond just Roman Catholicism. The occult symbols of the All Seeing Eye and Pyramid extend far beyond the reach and influence of the Roman church. Literally, thousands of businesses, religious singers, musicians, religions, entertainers, actors, educators, politicians, judges, teachers, pastors, etc., are a part of the Mystery Babylon religion (a.k.a., the New World Order). The world is following after the Beast (the coming Antichrist), worshipping Satan today. [Hint, hint] – Freemasonry-Kabballah-Chabad Lubavitch Judaism. Thus, Israel today is no different than any other heathen nation, like France, the United States, China, Russia, Iran, etc. Israel is just another wicked nation without God today. It mocks God by promoting the entire month of June to debauchery of the LGBTQ life style. It's the world's largest purveyor of pornography. Judaism strongly rejects Jesus Christ as their Messiah. God does not honor such a satanic religion! Furthermore America is a proxy for Masonic Zionist Israel, and I believe the destruction of Babylon as foretold in Revelation 18 is the United States!!! President Donald J. Trump is a Freemason, and has acknowledged that fact as well.

While it seemed easy to identify **“MYSTERY, BABYLON THE GREAT”** as the two components of Rome and Washington, D.C., many related questions remained unanswered. And some questions when answered, they did not quite fit this entity of the “Beast System”. I do not like loose ends as it suggests to me that I have missed something important or my analysis is incorrect. Actually it was a number things, none in particular, but the “ah ha” moment came in the exposing of the Trump War Plan on Iran, first exposed by David Elias Goldberg that finally began to shake out in crystal clear clarity. My belief is this “Beast System” is a tri-unity, an entity made up of three entities:

beyond. They are used to think through and depict how items relate to each within a particular “universe” or segment. Venn diagrams allow users to visualize data in clear, powerful ways, and therefore are commonly used in presentations and reports. They are closely related to Euler diagrams, which differ by omitting sets if no items exist in them. Venn diagrams show relationships even if a set is empty.



I am using a 3-part Venn diagram to better visualize “**The Beast Empire Metamorphosis of MYSTERY, Babylon the Great.**” The illustration above is another way of expressing how one goes about identifying this concept. Since God is the Master Mathematician, I began to look at this “**MYSTERY**” in mathematical terms, as perhaps how God was implying through mathematical concepts what God meant in this term “**Mystery**” and what it is that we could take away from the term.

Time permitting, all of what I am referring to in defining “Mystery Babylon, should be the focus of Chapter 26 of this series, and perhaps the final installment of what God has revealed to us through the pages of the Bible.

Back in the mid-1990’s, a statement made by Pope John Paul II, during an interview in his native Poland, broadcast in Italian over a Polish radio station, and was noted by one of the Italian journalists. In the transcript of the interview, which included one particularly startling reference, made by the pope, regarding the Vatican’s ultimate goal of transferring its headquarters from Rome to Jerusalem? How will the Papal throne be moved from Rome to Jerusalem?

Have you taken notice to how much time Pope Francis attends to his Muslim counterparts? The Vatican and Islam are talking about this topic when they met for interfaith dialogue. They have already agreed on the most important issues:

1. The Holy land is occupied by Zionists and needs to be liberated.
2. Both Roman Catholicism and Islam are included in God's plan of saving mankind, since both represent the children of God of Abraham.
3. All religions express some truths about God, and needs to be included to make an fulfilled picture of the creator.
4. Jesus is the son of Mary.
5. World peace will first flow out from Jerusalem when the three present main religions are able to live in peace, and come together as one voice and offer God interfaith prayers.

As of January of 2013, Israel has handed over the throne of King David to the Papacy! It is only a matter of time before the 3rd Jewish Temple is built and the 8th Pope since 1929 will sit there claiming that he is God! The Pope will have an official seat in the Last Supper room on Mount Zion in Jerusalem. Deputy Foreign Minister Danny Ayalon: *"This is a historic achievement and a symbol that will encourage tourism."*

A historical agreement has been signed between Israel and the Vatican, ending a 20 year dispute. Israel has granted the pope an official seat in the room where the Last Supper is believed to have taken place, on Mount Zion in Jerusalem. Israel did not give up its control over the room, as the Vatican had demanded, but Israel did decide to allow Vatican representatives a special modicum of control over the site. An additional caveat of the agreement is a tax-exemption that Israel will grant to all of the Vatican's institutions in Israel.

Deputy Foreign Minister Danny Ayalon and Monsignor Ettore Balestrero, Undersecretary of the Holy See for the Relations with States, sealed the deal on a Tuesday. It was signed in June, 2009 at the Vatican. Recall what I said about the fact some prophecies are not recognized until after the fact?

On October 17th 2013, Pope Francis & Mahmoud Abbas openly showed their intentions for wanting to sign a Peace Treaty with Israel. This is a fulfillment of the prophecy of Daniel 8:25. During their first meeting in the Vatican, Palestinian Authority President Mahmoud Abbas invited Pope Francis to visit the Holy Land. Francis welcomed Abbas and presented him with a gift in appreciation of his efforts to achieve peace in the Middle East, the PA's official news agency Wafa reported. After the private part of the meeting, the pope gave Abbas a pen, telling him, *"Surely, you have a lot of things you have to sign."* Abbas responded: *"I hope to sign a peace treaty with Israel with this pen."*

The Israeli President Shimon Peres told the bishops visiting Jerusalem that Jews, Muslims, Christians of the Holy Land will welcome Pope Francis I with love.

President Shimon Peres invited Pope Francis to visit Israel, the day after the former archbishop of Buenos Aires, Cardinal Jorge Mario Bergoglio, was elected as pontiff by the College of Cardinals. Speaking to a visiting delegation of Church leaders from Poland, Peres said he wanted to *“invite the newly elected pope to pay a visit to the Holy Land at the earliest possibility. The new leader of the world’s Catholics would be a “welcome guest,” Peres said, as “a man of inspiration that can add to the attempt to bring peace in a stormy area. All people here, without exception, without difference of religion or nationality, will welcome the newly elected pope.”*

The Israeli president also said that Vatican-Jewish relations were *“now at their best in the last 2,000 years.”* Israeli officials are bullish on the pope, with the Chief Rabbinate expressing confidence that *“Pope Francis, whose good relations with the Jewish People are well known, will keep the same spirit, and strengthen and develop the Roman Catholic Church’s connections with the State of Israel and the Jewish People.”*

Daniel 8:25 - ***“And through his policy also he shall cause craft to prosper in his hand; and he shall magnify himself in his heart, and by peace shall destroy many: he shall also stand up against the Prince of princes; but he shall be broken without hand.”*** Few in the west know much about Peres, and his willingness to give away Israel to achieve peace and safety for Israelis.

Shimon Peres had a massive stroke on September 13, 2016, and two weeks later he died September 29, 2016. Reuven Rivlin is the Israeli President since 2014. He is Israel's 10th president. Rivlin is an Israeli politician, lawyer and a member of the party. Rivlin was Minister of Communications from 2001 to 2003 and subsequently served as Speaker of the Knesset (Israeli Parliament) from 2003 to 2006.

It seemed to me that we (the church and Bible prophecy scholars in general) have been overlooking certain aspects that do identify who it is that really embodies all the qualities of their prophetic names, **“MYSTERY, Babylon the Great, the mother of harlots and the Daughter of Babylon.”** Millions of Christians have been seduced into the folds of Christian Zionism, forerunner of the Antichrist Beast System.

Christian Zionism can be defined as Christian support for the Zionist cause — the return of the Jewish people to its Biblical homeland in Israel. John Hagee can best be credited with this doctrine turned national obsession. The thinking is simply God supernaturally brought Israel back from the grave as a sign in these end times, thus we must support modern Israel, no matter what, because it is a work of God and fulfillment of prophecy. Love for Israel in the mainstream church has become a blind love, a love that leaves no room for criticism of Israeli policy of Palestinian extermination and aggressive warring in the Middle East. Pastor Hagee’s website says we have a Bible mandate to defend Israel. Last time I checked God didn’t defend Israel in 70 A.D. instead He demolished the whole of the Jewish nation and religion. From a reasoned and historical perspective, God did not want any trace of the Jewish religion to resurface

after the destruction of Jerusalem, yet here we are, watching Christians fall all over themselves in support of this fraudulent Zionist Jewish state.

So, we need to honestly address this interpretation of the Bible: Did God bring to pass all of this, or perhaps, did Satan achieve it and have we all been a victim of misunderstanding or perhaps satanic deception? It was the Rothschild's who secured the Balfour Declaration of 1917. The Balfour Declaration, (November 2, 1917) was a statement of British support for "the establishment in Palestine of a national home for the Jewish people." It was made in a letter from Arthur James Balfour, the British foreign secretary, to Lionel Walter Rothschild, 2nd Baron Rothschild, and a leader of British Jewry. It was done as an act of appreciation for Rothschild's assets that created "smokeless" gun powder, a factor in winning World War 1.

John Hagee Ministries states: *"We believe in the promise of Genesis 12:3 regarding the Jewish people and the nation of Israel. We believe Christians should bless and comfort Israel and the Jewish people. Believers have a Bible mandate to combat anti-Semitism and to speak out in defense of Israel and the chosen people."*

Most troubling is that Hagee, who has popularized this passion for Israel and literally teaches that Jews have an alternative covenant and route to Heaven outside of Christ called dual-theology. This is totally inconsistent with Jesus words in John 14:6: ***"Jesus saith unto him, I am the way, the truth, and the life: no man cometh unto the Father, but by me."***

The Evangelical Christian segment of the church has allowed itself to be aligned with Israel as the victim in the Bible. Pastors like John Hagee are well-known for their support of the Zionist movement by raising money, building political support for Jewish causes, and giving Israel a "free pass" when the Jews should have been held accountable for its reprehensible acts against the U.S., who have been Israel's greatest ally. I am referring to the deliberate relentless attack on the USS Liberty.

On June 8, 1967, an unarmed American naval vessel, the USS Liberty was sailing in the Mediterranean, when Israel's military purposely attacked it. They killed and injured over 200 Americans. After 57 years, the 34 sailors killed and 174 wounded in Israel's unprovoked, outrageous attack on the USS Liberty continue to deserve justice, and for the public to know the truth about America's so-called "best friend" in the Middle East.

It was a day of shame when Washington, D.C. turned its back on the U.S. Navy. It was June 8, 1967 when the USS Liberty, a surveillance ship stationed off the coast of Egypt was attacked by Israeli fighter aircraft and torpedo boats. The Israelis were unable to sink the Liberty but managed to kill 34 American sailors and wound 174. Seventy percent of the crew were casualties of the Israeli attack.

The White House (LBJ), fearing the Israel Lobby, prevented the U.S. Navy from going to the defense of the USS Liberty, thus sacrificing American lives, and further

dishonored the U.S. Navy by ordering Admiral McCain, father of the late Senator John McCain (R-AZ), to orchestrate a cover-up. The surviving crew were threatened with court-martial and imprisonment if they spoke about the event. It was 20 years before one of the surviving officers wrote a book about the greatest act of shame the U.S. government ever inflicted on the U.S. military.

Zionism was first exposed by Benjamin H. Freedman in a speech made in 1961 at the Willard Hotel in Washington, D.C. One can find it by searching the title on the Internet or more recently in a "Millennium Report" posted on July 29, 2019. It is my conclusion that Christians have been deceived by the Zionist Chabad Lubavitch, an ultra-Orthodox element that is maniacal and messianic obsessed. **My point is that the Bible records prophecy as history told in advance, but without taking a side in the outcome of events as they unfold in the present.** Christians have read into Scripture a narrative that has made them complicit with the crimes of Israel. This has played out in such a way as to bias the U.S. role at the United Nations as well, along with the attitude that "ISRAEL CAN DO NO WRONG!" How is it that a Christian can be so blinded to the truth and to believe Palestinians are basically evil? Israeli soldiers are trained to shoot Palestinian protesters in the ankles, for the purpose of inflicting the severest and greatest pain for life.

The Book of Revelation is misunderstood because people look for the entities revealed in there to already be present on the earth before it is time for them to be present on the earth. I've heard people say the seals are opened and the horses are riding. Some, who have not been able to figure out who the entities are, have declared the Book of Revelation's prophecies as already past history, fulfilled under Nero and other Roman despots. Martin Luther, during the Protestant Reformation, declared that the Catholic Church was the fulfillment of every character listed in Revelation. None of these interpretations fully and totally work. The use of Venn Diagrams should aid us in sorting out names, characteristics, data points, etc. to the identity of "Mystery Babylon!"

Yes, all throughout history, we can see elements of fulfillment for everything in the prophets and the Book of Revelation. That is because the prophecies are also processes. There is one over-arching and important principle that has not been met even today. That is that Revelation is written to a specific time to a specific group of people (the people of Daniel's Seventieth Week!). Understanding Revelation will only happen in that time for those people who need to know. I believe we are there now! This is one of the blessings of Dispensationalism in interpreting the Bible. Dispensationalism eliminates so much of the confusion that comes from trying to reconcile issues and apparent inconsistencies. Something as simple as baptism divides Christianity today because people fail to understand the Bible. It mentions many baptisms, and they are not all the same when studied closely. They can be differentiated but you need to **"Rightly divide the Word of God"**. There is not one baptism in the Bible, the Bible names 14 and not all are for believers today.

The same principle applies to Revelation as was told to Daniel. We can know with certainty when the Book of Revelation's prophecies begin by understanding how

connected Daniel is to Revelation. So, let's look at Daniel to see if we can figure out when the Books of Daniel and Revelation will become available for widespread understanding for God's people.

Daniel 12:4 – ***“But you, Daniel, shut up the words and seal the book, until the time of the end. Many shall run to and fro, and knowledge shall increase.”***

Daniel 12:5 – ***“Then I, Daniel, looked, and behold, two others stood, one on this bank of the stream and one on that bank of the stream.”***

Daniel 12:6 – ***“And someone said to the man clothed in linen, who was above the waters of the stream, “How long shall it be till the end of these wonders?”***

From Daniel's viewpoint, the fulfillment of all of that he was shown would take 2500 years, all the way to a specific amount of time which we will see in a moment.

Daniel 12:7 – ***“And I heard the man clothed in linen, who was above the waters of the stream; he raised his right hand and his left hand toward heaven and swore by him who lives forever that it would be for a time, times, and half a time, and that when the shattering of the power of the holy people comes to an end all these things would be finished.”***

Time, times and half a time – 1 year plus 2 years plus half a year. Using a Hebrew 30-day calendar =1260 days.

Daniel 12:8 – ***“I heard, but I did not understand. Then I said, “O my lord, what shall be the outcome of these things?”***

Even Daniel did not understand. He was already looking for the restoration of the Kingdom of David with 12 tribes while living in captivity in Babylon! How could Daniel even begin to comprehend that God had given Him prophecies that would span 2500 years? Daniel was unable to comprehend this. It was impossible for him! So, he was told...

Daniel 12:9 – ***“He said, “Go your way, Daniel, for the words are shut up and sealed until the time of the end”.”***

Daniel's prophecies will only be understood in the end times. This is perhaps the most important detail to recognize as these prophecies come into view.

Elements of all the prophecies by all the prophets can be seen on earth as humanity has moved through time, but these processes won't be fulfilled or understood in their totality until the end times. The fog has been lifting and we are seeing clearer as to the larger picture of events unfolding in real time.

Daniel 12:10 - ***“Many shall purify themselves and make themselves white and be refined, but the wicked shall act wickedly. And none of the wicked shall understand, but those who are wise shall understand.”***

Daniel 12:11 – ***“And from the time that the regular burnt offering is taken away and the abomination that makes desolate is set up, there shall be 1,290 days.”***

Daniel 12:12 – ***“Blessed is he who waits and arrives at the 1,335 days.***

Daniel 12:13 – ***“But go your way till the end. And you shall rest and shall stand in your allotted place at the end of the days.”***

What has struck me time and time again, contrary to everything in men who want to understand prophecies before they are fulfilled, the truth is that no one can understand the most cryptic prophecies until it is time for them to be understood. That reality speaks to the incredible mind of God in how He gave man a message that transcends everything in our space-time continuum. It could only have been revealed by a Creator who is fully omnipotent, omnipresent, and omniscient. For those of you not familiar with those theological terms, they simply mean: Omniscient is the word to describe someone or something that has no restrictions on knowledge. In other words, one who is described as omniscient is supposed to know everything there is to be known. Omnipotent signifies the ability to be capable of anything and everything.

Even though I will discuss Mystery Babylon and the Daughter of Babylon, these are not yet fully formed, they are in process or development, and their elements and conditions of their fulfillments are only now becoming clearer in this time preceding the Great Tribulation; beginning to be understood by those who need to understand. Who needs to understand? The end-time generations that will witness how all the characters come together like a puzzle to completely fulfill what John and Daniel said about them.

Revelation will only be understood as we approach that end time. People are beginning to understand more the closer as we draw to the Great Tribulation. The Book that Daniel sealed has yet to be unsealed (almost but not yet). Think of it as akin to driving down an interstate highway, where the distant signs appear but not in sharp focus. As one gets closer and closer they begin to appear sharper in focus and definition, where at a given point the sign is clearly understood.

Revelation 5:1 – ***“And I saw in the right hand of him that sat on the throne a book written within and on the backside, sealed with seven seals.”***

Daniel’s book was sealed and will be unsealed at the time of the end which has not yet occurred because the Book of Revelation was written for a specific time – the last seven years – to a specific generation – those who will go through the Great Tribulation that will last 3.5 years (Israel and the rest of the world that chose to pass up the Gift of Jesus Christ!).

Are you starting to understand, or beginning to “see” what will happen in the short time leading up to the Great Tribulation so God’s people can prepare for what is coming, but the full force of understanding won’t happen for God’s people until the Great Tribulation is very near. In 1967 the prophecies of John and the other prophets meant very little to me, other than the fact of being the fulfillment of Isaiah 66:8, which spoke about the State of Israel being born in a single day, May 14, 1948. I was a college student-pastor and oblivious to the events of June 7, 1967. My church recording-secretary raised the question, “Was this Armageddon?” My denomination did not attempt to teach prophecy! I did not know the answer but I began studying the Bible to soon discover it was not Armageddon but it was a beginning of a 50+ year unfolding process! Since 1967, we have witnessed so much more in the events of Israel’s existence; and, we are close to seeing the realization of Isaiah 17:1-2, and Ezekiel 38/39.

Revelation and Jeremiah have much to say about wealth and power in the time of the Great Tribulation. The elements of the world’s peculiar economy are now self-evident in a way that has not happened before and these economic elements are specific to Mystery Babylon, the Mother of Harlots and her Daughter of Babylon.

We need to identify who these are because they are not yet fully formed entities but are only now [in process] in the forming stage. The New World Order’s transfer of power as symbolized in the Leviathan drilling platform going home to its Mother is a sign of the formation of the final characters of Revelation. We are looking at the **“Metamorphosis of Mystery Babylon the Great”** taking place right in front of our eyes!

Let’s start with **Mystery Babylon, the Mother of Harlots**. But first, let me remind you that God plays hide and seek in His word. Anyone that tells you that there are no mysteries in the Bible is spiritually blind and Biblically illiterate. The Scriptures are full of mysteries that we are encouraged to search out, collect the clues and follow the bread-crumbs in order that they remain mysteries no more. That was the message of Proverbs 25:2: **“It is the glory of God to conceal a thing: but the honor of kings is to search out a matter.”** God loves to play hide and seek with His children, you and I, and has ordered His word in such a way that it invites careful and serious study in order to discover its truths. We are told to search the Scriptures, not just read them. We are also told ahead of time what it is we will find when we search diligently with all our heart, a heart that loves God and wants to please Him.

“Mystery Babylon” refers to a city, according to Revelation 17:18.

Revelation 17:18 – **“And the woman that you saw is the great city that has dominion over the kings of the earth.”**

This Babylon is not in the geographic place of the original Babylon. This city is Jerusalem and she is now the Mother of Harlots. How do I know Jerusalem is being called a whore, a Mother of Harlots? Because she has been called a whore before!

Ezekiel 16:2 - ***“Son of man, make known to Jerusalem her abominations,”***

Ezekiel 16:15 - ***“But you trusted in your beauty and played the whore because of your renown and lavished your whorings on any passerby; your beauty became his.”***

Jerusalem is described as a city of great beauty but one who would commit spiritual adultery, idolatry, with anyone and everyone.

Psalms 48:2 – ***“Beautiful in elevation, the joy of the whole earth, Is Mount Zion in the far north, The city of the great King.”***

There are other Scriptures that describe Jerusalem as a whore, so, when Revelation 17:18 talks about the ***“great city”*** it is the same city as in the other prophecies. God did not change His definitions from what are written in the prophets and the Psalms to something different in the end of days. He is not cruel like that. He wants the end times generation to understand so they can escape.

To understand how Jerusalem is the city God called ***“Mystery Babylon, the Mother of Harlots”***, we must also understand which tribe was given ruler-ship of her. This was Judah even though Jerusalem is the capital city of all 12 tribes of Jacob.

What did the House of Judah do to cause Jerusalem to become a city of prostitution instead of God’s holy city?

Jeremiah 3:8 – ***“She saw that for all the adulteries of that faithless one, Israel, I had sent her away with a decree of divorce. Yet her treacherous sister Judah did not fear, but she too went and played the whore.”***

The House of Judah played the whore even better than her sister, the House of Israel. Her whoring will have become so great that by the time of the end, she will be birthing other whores. She will become the mother of whores.

The beginning of defiling her happened when Solomon committed idolatry in her. His son carried out splitting the Kingdom as God declared should be done. The message is clear. Idolatry in Jerusalem will always result in death and destruction.

In the end of days, this destruction will happen in Jerusalem who will have become the literal Mystery Babylon, the city of secret religious rites and enslavement of followers. Literally, Jerusalem will give birth to Harlots because she is one herself. No greater whores will there have been in the history of the earth than Jerusalem by the time of the end.

Revelation 17:1 – ***“And one of the seven messengers who had the seven bowls came and spoke with me, saying to me, “Come, I shall show you the judgment of the great whore sitting on many waters”.***

Mystery Babylon, Jerusalem, the city, and the 70 nations with their capital cities are her harlots. She will have spread all over the earth, sitting on many waters governing many peoples. But there is one particular harlot who will assist the Mother more than others: the Daughter of Babylon.

This Daughter is not mentioned in the Book of Revelation, in case you have not noticed. Don't forget this very important fact in understanding this "Mystery".

Jeremiah speaks of the difference between the Daughter of Babylon and the Mother of Babylon.

Jeremiah 50:11 - ***“Though you rejoice, though you exult, O plunderers of my heritage, though you frolic like a heifer in the pasture, and neigh like stallions,***

Jeremiah 50:12 - **“Your mother shall be utterly shamed, and she who bore you shall be disgraced. Behold, she shall be the last of the nations, a wilderness, a dry land, and a desert.”**

The Daughter of Babylon became a nation before the Mother did. It was the Mother, not the Daughter, as some claim, that Jeremiah said would be the last or hindermost nation on earth. Until 1948, America was the hindermost or last of the nations, but now the last nation is Israel and America had much to do with forming the State of Israel.

One could argue that Jeremiah's Daughter of Babylon is simply a young version of Revelation's Mother of Babylon. But there is another important reason these are not the same entity besides the mother being the last of the nations to arise on earth as a separate entity from the Daughter. This is because when Babylon is destroyed, her land will never again be inhabited -(Jeremiah 51:62). But Jerusalem will be inhabited again for a thousand years when Christ Jesus comes to reign and before the New Jerusalem comes down from Heaven at the end of the Millennium.

The Daughter of Babylon is distinct from Babylon in Jeremiah's prophecies. Thus, she is a different entity than Babylon, but Jeremiah's prophecy of Babylon is intermingled with prophecies about an end times entity called the 'Daughter of Babylon'. Isaiah and Zechariah also have prophecies about the Daughter of Babylon. The conditions of the original Babylon will be visited on the Daughter of Babylon who will be like her mother, Mystery Babylon, who is also a city – Washington DC.

Another of her names is the 'mistress of kingdoms' (or 'lady of the nations' in some Bible translations who is represented by the Statue of Liberty) in Isaiah 47:5,7. The Bible has told us the name of this Daughter but in cryptic terms.

The Daughter of Babylon is Washington D.C. because that city is the seat and headquarters of her other name, the House of Israel. This fact may come as a complete surprise to many of you but it is a recognized political fact of life. Washington,

D.C., more than any other city in the U.S., is under the influence of lobbying efforts which promote the two largest institutional agendas: 1. The Roman Catholic Church, and 2. The State of Israel. Georgetown University is the Vatican's lobby in Washington, D.C. By nature of its secrecy, the Catholic Church remains below the radar by operating from behind a cloak of secrecy emanating out of Georgetown University. The Jewish bloc is more vocal and aggressive in their agenda.


When I began to study these two powerful religious blocs closer, it struck me that we have so under-estimated the role of Israel and the Jews in the larger picture of **"MYSTERY, Babylon the Great"**. This term Metamorphosis resonates and speaks to the element of "process" or of an evolving or changing of something that is slowly changing into its ultimate form.

Richard Coombes published his book *'America, The Babylon'* in 1998, pictured below. Since 1998, I have read it more than a dozen times. We had numerous correspondence and conversations over the issue of his exclusion of the Vatican and the Roman Catholic Church. In my understanding of the text, it seemed to me that the Vatican was an integral part of **"MYSTERY, Babylon the Great"**. I encouraged him to do a sequel book on the larger role of Rome in this "Mystery". Years later since his passing from pancreatic cancer, I could not help but to think that I was probably narrower in scope back then and perhaps should consider a wider approach in defining "Mystery Babylon" that includes these three entities that make up the enigmas entity we know as "Mystery Babylon.":

- The Vatican
- The United States another name for [House of Israel]
- The State of Israel another name for [House of Judah]

So, my task has been to use mathematical logic through the Venn Diagrams approach to determine if this is the explanation as to who "Mystery Babylon" really is. The Scripture references are laying the foundation of this premise and the reader is encouraged to follow along in my Scripture analysis and how it fits with the geopolitical issues of the present time. Time permitting, I will illustrate this in the next chapter.

The Pro-Israel Lobby, headed by the American Israel Public Affairs Committee, (AIPAC) has been called the NRA of foreign policy lobbies, "a hard-edged, pugnacious bunch that took names and kept score". The almost-unilateral popular support of Israel in America, not to mention the nearly \$3 billion in aid the country receives every year, did not come about by accident. It's the result of over 50 years of hard lobbying. Politicians and pundits alike are quick to support the Jewish state, and reluctant to criticize it. They know well to expose or criticize can be career damaging and be called an anti-Semite. ADL, JDL, and B'nai B'rith are notorious attack dogs for Judaism. Pro-Israel groups such as AIPAC spent close \$4 million last year, ensuring that US-Israel ties will remain strong. The Pro-Israel lobby remains one of the strongest and most influential foreign-policy lobbies in the U.S.



The Congressional chart on page 41 is current as of January, 2019. The fact has changed little in respect to senators and legislators holding dual-citizenship (U.S./Israeli) for years has hovered around just under 90 in both houses of Congress. This type of thing is allowed because "Israel first" Zionists essentially own our government, which is because the Rothschild's own the central banking system and have money creation powers and they promote Zionism and the Zionist agenda. So you play by their rules, or you don't get big money access. This is why most industry monopolies are headed by Zionist Jews. It's not a random chance thing that the heads of most all industries are super gung-ho about Israel. This is also why they get the most aid, and why they have the biggest lobbying groups.

Furthermore, the Zionist lobbies are major benefactors of Congress and the Senate with their campaign donations, week-long expense-paid trips to Israel for new members of each session of Congress.

And to be clear, I'm not talking about Jews, half of whom reject Zionism. I'm talking about the ideological belief system that says the Israeli government deserves to own Mt. Zion, a.k.a. that Palestine needs to be removed and regional security for Israel needs to be ensured in the Middle East. There are about 12-14 million Jews in the U.S. and most prefer not to be identified with Zionism. They want nothing to do with temple worship and animal sacrifice. Secular Jews find the ancient animal sacrifice system as repulsive to contemporary Jewish life.

Unfortunately, the ultra-Orthodox sect of Chabad Lubavitch is beating the drum for their Messiah. As I noted earlier, the Chabad Lubavitch see Jared Kushner as a

messiah figure and are convince President Trump will help them build the third temple. I do believe that the President Trump is being kept alive for a specific reason and that is to do the bidding of Jacob Rothschild and his goal of installing a Rothschild central bank in Iran and Syria. President Trump has handlers pulling his strings and he knows that he is walking a tightrope. Secretary of Commerce Wilbur Ross and Treasury Secretary Mnuchin are his primary handlers.

His life and that of his family are on the line. That was evident in the words of Benjamin Netanyahu quoted on one of the last reports of David Elias Goldberg, before his murder, quoting that if he [meaning Trump] doesn't play ball, they would flush him down the toilet!

This is why all of President Trump's talk about taking over the Federal Reserve, and going to a gold-backed dollar is just that, talk. The House of Rothschild will take the world to a "cashless" economy long before we see a Trump gold-backed dollar. The Rothschild's have been stealing the world's gold for over two hundred years. Trump's rhetoric sounds good with the business world and those that are familiar with the Fed. It is interesting to hear all the pundits and commentators talk about what all President Trump is going to accomplish in his second term in office. However, such talk is not much more than lofty platitudes. Humanity's virtual enslavement to the House of Rothschild will be enhanced and tightened through the 5G technology being rolled out. The telecommunications industry has invested \$59-billion in AI or Artificial Intelligence to control every individual's life **24,7,365!** I have shared information on 5G and the "Internet of Things" in my article on "666, 5G and the UPC Bar Code" that will shake one into total fear.

Some of you may recall how the Iraqi Army melted and collapsed in the early days of Operation Desert Storm. An estimated hundred-thousand Iraqi soldiers melted and threw down their weapons and surrendered in those miles-long convoys in the early days of 2003. The U.S. military used 5G technology as a weapon to put voices into the Iraqi soldiers' heads and the message was to the effect in their language, *"This is Allah, throw down your weapons and surrender"*. It had to be a military first!

News reports out of the Persian Gulf war zone told of an Iraqi soldier spinning around and around with his hands in the air trying to attract the attention of the pilot of a small plane flying above him. Only it wasn't a plane. It was a pilotless drone, called an RPV (remotely piloted vehicle), and with a television camera mounted in its belly. But the real secret was in the use of 5G to put voices into the heads of the Iraqi soldiers.

That story -- and a second one about 40 Iraqis trying to surrender to another RPV -- made its way back to AAI Corp. in Cockeysville, where the craft is made. The stories repeated over and over. Asked for his reaction, Adam R. Fein, AAI's director of corporate communication, contemplated the question for a second and said, "Ah, what's the best way to put this? We think it's the first electronic capture in history." Even the folks at AAI were unaware of the 5G technology being used to achieve the surrender of the Iraqi army!

The stories were confirmed by consultants to the crews aboard the battleship USS Iowa that operated the drones. The surrenders were viewed on television monitors on the ship. The primary mission of the Pioneer RPV used in the war was to fly behind enemy lines and send back live television pictures of troop or tank movements.

The drones also were used as "spotters" for shelling, some of it from battleships in the gulf. If the first round was off target, the television picture from the RPV would show where it landed, and a computer would instantly calculate the adjustments needed to put the next shell on target. The RPVs also were used to assess bomb damage. But it had a secret mission, largely unknown to military personnel on the USS Iowa or on the ground in Iraq.

The Pioneer RPV has a wingspan of about 17 feet and is 14 feet long. It was powered by a 26-horsepower snowmobile engine. Workers at AAI built 90 of the small craft. Of the 34 that were assigned to the war, two were shot down. A number of others returned from their assignments riddled with bullet holes. The full story of 5G technology married to the RPV has never been told and may still be classified for all that I know. As stated at the beginning, I noted the fact that **5G is a weapons system**, not a communications system to give you faster download of your favorite movie. The Antichrist Beast System will be able to control you or kill you once you have received his "Mark" in the form of a microchip, which is one part of an evil sky net!

Ezekiel 20:30 - "Therefore say to the house of Israel, Thus says the Lord GOD: Will you defile yourselves after the manner of your fathers and go whoring after their detestable things?"

Both the House of Judah and the House of Israel are whores, and both have cities. And they both have many names. All these names are because the Bible sometimes gives more than one name for the same entity and uses them interchangeably.

I want to shift focus here on their rising economies because Revelation 18 really focuses on that, but so do other Scriptures, as well. Both their economies are booming while the global economy is falling apart. Why is that? It is because Revelation 18 tells us Israel's economy – the economy of Mystery Babylon – will be booming when it is destroyed. We can expect that her Daughter's economy will also be booming at the time of her destruction and I will explain why in a little bit.

Let's start with the rider of the black horse in Revelation 6:6 to understand a foundational aspect of Mystery Babylon's economy.

Revelation 6:6 – "And I heard what seemed to be a voice in the midst of the four living creatures, saying, "A quart of wheat for a denarius, and three quarts of barley for a denarius, and do not harm the oil and wine!"

That black horse and rider hears coming from the four living creatures, instructions to do no harm to the oil and wine. This is central to understanding the economic factors in Revelation 18 and elsewhere because oil and wine were major economic factors in John's day, but they are still today and will continue in importance through the entire process of Mystery Babylon's destruction.

One understanding of this is that there is a certain portion of global economics that is not to be touched because oil and wine, in John's day, were major commodities. However, while I believe there is an element of truth in this, consider another suggestion. What if the oil and wine have to do with the Temple? Let's read what was required the last time the Temple in Jerusalem was rebuilt.

Ezra 6:8 – *“Moreover, I make a decree regarding what you shall do for these elders of the Jews for the rebuilding of this house of God. The cost is to be paid to these men in full and without delay from the royal revenue, the tribute of the province from Beyond the River.”*

Ezra 6:9 – *“And whatever is needed—bulls, rams, or sheep for burnt offerings to the God of heaven, wheat, salt, wine, or oil, as the priests at Jerusalem require—let that be given to them day by day without fail,”*

Ezra 6:10 - *“that they may offer pleasing sacrifices to the God of heaven and pray for the life of the king and his sons.”*

Oil and wine are required throughout the Tabernacle's instructions in the Torah, and so, too, are the rest of the products listed in Revelation 18 that we will look at in a moment.

I submit to you that the oil and wine in Revelation 6:6 which is to not be harmed has to do with the rise of the Temple in Jerusalem at the same time as global economic destruction is happening. Don't destroy the oil and wine because it will be needed in vast quantities in Temple operations! What do we hear about most today in Israel? The rebuilding of the third Temple! *'Breaking Israel News'* had this to say in its July 29, 2019 internet edition.

The former Rabbi of the Old City of Jerusalem and one of the leading rabbis in Israel today said in an interview: *"We must do everything in our power to build the Temple"*. Of the half-dozen Israeli news sites that I monitor on the Internet discuss this topic is almost on a daily basis, and it is revealing a pattern of propagandistic rhetoric or predictive programming!

Rabbi Avigdor Nebenzahl is an Israeli rabbi and Posek (a legal scholar who determines the position of Halakha (Jewish law) in cases of law where previous authorities are inconclusive, or in those situations where no clear halakhic precedent exists).

He is the head of the Yeshiva (seminary) of Yeshivat Netiv Aryeh, a faculty member at Yeshivat HaKotel, and Rabbi of the Ramban Synagogue. Nebenzahl used to serve as the chief rabbi of the Old City of Jerusalem. Today, the post was taken over by his son, Rabbi Chizkiyahu Nebenzahl.

In a recent interview, the Rabbi stated that despite delays by Israel's High Court, explicitly stated that *"we must do everything in our power to build it and not wait for it to fall from the sky"*.

The rabbi emphasized that there has never been any sort of ruling from Chazal (Jewish sages of the Mishna) that states that the Jewish people should wait for it to fall from the sky contrary to what many ultra-orthodox Jews believe.

One piece of evidence Rav Nebenzahl submits comes from Midrash Rabah of Parshat Toldot, saying: *"When the Roman Empire gave the Jews permission to build the Temple, they built it. They didn't wait for it to fall from Heaven"*.

The rabbi added that there is a mitzvah (commandment) to build the Temple – even if we can't yet offer sacrifices. He added that questions surrounding the renewal of Temple sacrifices should not get in the way of the Third Temple being built.

Regarding Temple sacrifices, the rabbi states: "Indeed, regarding the sacrifices, there are some Halachic doubts and the sages of this generation should determine a plan of action".

Nebenzahl was also a faculty member of the prestigious Seminary Yeshivat Mir before lecturing at Yeshivat HaKotel and Yeshivat Netiv Aryeh. Nebenzahl's scholarly works include a commentary on the Mishnah Berura, books about the laws of Passover,

Succot, Shavuot, The Three Weeks and Shabbat (on the tractate Shabbat). He also writes weekly essays on the Torah portion readings.

I want to suggest something else to think about. Both the United States and Israel will be spared, for a time, from economic destruction: The U.S. because she is the seat of the Daughter of Babylon, whose destruction comes at a time of unprecedented economic power and growth; and, Israel because she will require prosperity to fulfill Temple operations. Indulge me here in thinking out loud.

Revelation 18 describes the fall of Babylon the Great who, in this same chapter, is also called 'Mystery Babylon'. One of Babylon's attributes – both of the mother and the daughter – at the time of her destruction will be her great wealth.

So, in watching today's news, we will cover the mother and her daughter since the power has now transferred and the Leviathan well-drilling rig has been shipped back to its homeland, Israel. This Leviathan symbolizes the Dragon that the Beast of Revelation 13, who associates itself with the lamb, will speak like.

The recent global economic news has been strange and is becoming stranger by the day. The US economy is booming and so is Israel's while the world's largest bank, Deutsche Bank, is reeling and it about to collapse taking the entire central banking system with it. If this happens, the U.S. and Israel will remain in power under the auspices of the second Beast of Revelation 13 who claims the lamb but speaks like Satan the dragon and their economies will continue unabated until the day the United States and Israel are destroyed in one hour.

Why will the United States 'Daughter of Babylon' and her mother, Jerusalem, remain wealthy while the rest of the planet, more particularly Europe, enters into dire economic straits? It is because God will use her economic power to cause her fall. Read what Revelation 18:7 has to say:

Revelation 18:7 – “As she [Babylon the Great, Jerusalem, Mystery Babylon] glorified herself and lived in luxury...”

More on this verse in a minute. Here is the list of the Mystery Babylon's, 'Babylon the Great', Jerusalem's, future purchases:

Revelation 18:12 – “...cargo of gold, silver, jewels, pearls, fine linen, purple cloth, silk, scarlet cloth, all kinds of scented wood, all kinds of articles of ivory, all kinds of articles of costly wood, bronze, iron and marble,”

Revelation 18:13 – “cinnamon, spice, incense, myrrh, frankincense, wine, oil, fine flour, wheat, cattle and sheep, horses and chariots, and slaves, that is, human souls.”

Let's pause right there! This is human trafficking! Connect this to what is already known about Jeffrey Epstein and his connection to Mossad. He was put at the head of a human trafficking ring by Mossad. You can read all about his Mossad connection on Mondoweiss.net. Jeffrey Epstein and Saint James Island is the key to the global trafficking in children, drugs, harvesting of body parts, and adrenochrome, which sells for \$8,000 a liter. Epstein's little black book contained the names of over a thousand well-known public figures, including President Trump and William Jefferson Clinton. The Epstein "Lolita Express" was a "honey-pot" trap to blackmail Epstein's guests. One of Jeffrey Epstein's planes even carried the same tail-number of a CIA-State Department aircraft, a clear proof of deep ties with the CIA and U.S. State Department.

Back to the list of Revelation 18:

Revelation 18:16 - ***"Alas, alas, for the great city that was clothed in fine linen, in purple and scarlet, adorned with gold, with jewels, and with pearls!"***

Most of this list is items found in the operations of God's Tabernacle and Temple. Some items like the pearls and ivory are not part of Temple operations, at least not the Temple of God. More on this shortly. Isaiah speaks of the Daughter of Babylon and her hubris:

Isaiah 47:8 - ***"Now therefore hear this, you lover of pleasures, who sit securely, who say in your heart, 'I am, and there is no one besides me; I shall not sit as a widow or know the loss of children:'"***

She says, in mockery of God, ***"I AM, and there is no one besides me". "I AM"*** is the same name given by God to Moses.

Exodus 3:14 - ***"And God said unto Moses, I AM THAT I AM: and he said, Thus shalt thou say unto the children of Israel, I AM hath sent me unto you."***

In the Book of Revelation, we read these words being spoken by the Mother.

Revelation 18:7 - ***"...I sit as a queen, I am no widow, and mourning I shall never see."***

The Daughter and the Mother speak slightly different words, but their attitude is the same - they are claiming godhead and usurping the authority of God in each of their statements.

By the way, both the so-called Christian Pope and the Israeli Rabbinate declare themselves to be God on earth. According to Roman Catholicism, the pope is God's direct authority on the earth, and his office has changed God's words for the last 1,700 years. The Jewish Rabbis declare that the Rabbis decree and God obeys, and this has been going since before Jesus Christ came to Earth.

What does Revelation 18 say will happen to her for her blasphemy?

Revelation 18:17 – ***“For in a single hour all this wealth has been laid waste.” And all shipmasters and seafaring men, sailors and all whose trade is on the sea, stood far off...”***

Revelation 18:8 – ***“For this reason her plagues will come in a single day, death and mourning and famine, and she will be burned up with fire; for mighty is the Lord God who has judged her.”***

What does Isaiah say will happen to her Daughter?

Isaiah 47:9 – ***“These two things shall come to you in a moment, in one day; the loss of children and widowhood shall come upon you in full measure, in spite of your many sorceries and the great power of your enchantments.”***

Pay close attention to this expression **“one hour” / single day** prophecy because it was first given to King Belshazzar of Babylon after whom the Daughter of Babylon is patterned. End times Babylon -both Mother and Daughter – will fall exactly as Belshazzar’s Babylon fell! Belshazzar saw the hand writing on the wall and asked Daniel for the interpretation in Daniel 5:24 - ***“Then from his presence the hand was sent, and this writing was inscribed.”***

Daniel 5:25 – ***“And this is the writing that was inscribed: MENE, MENE, TEKEL, and PARSIN.”***

Daniel 5:26 – ***“This is the interpretation of the matter: MENE, God has numbered the days of your kingdom and brought it to an end;”***

Daniel 5:27 – ***“TEKEL, you have been weighed in the balances and found wanting;”***

Daniel 5:28 – ***“PERES, your kingdom is divided and given to the Medes and Persians.”***

God has also numbered the days of the United States and Israel and has weighed them in His balances. Both are found wanting! Their Mother-Daughter Kingdoms will be divided and given to the Medes and Persians just as happened to Belshazzar! Babylon was at the height of its power and wealth when, suddenly, in one night it was gone! Thus, shall be the condition of the Daughter of Babylon. Wealthy, powerful, but gone in one hour, in a single day.

Who are the Medes and Persians today? Others have repeatedly said they are Russia and Iran! Only recently have I come to acknowledge this to be the case.

Michael Tsarion has said the Medes were an people of Indo-Iranian (Aryan) origin who inhabited the western and north-western portion of present-day Iran. By the 6th century B.C. (prior to the Persian invasion) the Medes were able to establish an empire that stretched from Aran (the modern-day Republic of Azerbaijan) to Central Asia and Afghanistan. Today's population of the western part of the Iranian Plateau (including many Persian-speakers, Kurds and Azeris) consider themselves to be descended from the ancient Medes. Now you may ask who is Michael Tsarion? Michael Tsarion is an Irish author, researcher and public speaker. He is a well-known for his research in the history of ancient peoples, including that group called the Medes.

Apart from a few personal names, the language of the Medes is almost entirely unknown. It was most likely similar to the Avestan and Scythian languages. The history of the Medes is lengthy and complex but Michael Tsarion has traced the people known as the Medes to the lands of modern-day Russia. They migrated further north after the Arabs invaded the lands of Eurasia and the Mongols invaded from the East. Out of this region north of the Black Sea came the Khazar's, individuals who converted to Judaism rather than to convert to beliefs of the invaders that came from the west and the east.

In Revelation 2:9 and 3:9, Jesus notes twice that these people call themselves Jews but they are not of Abraham, Isaac, and Judah. ***“I know thy works, and tribulation, and poverty, (but thou art rich) and I know the blasphemy of them which say they are Jews, and are not, but are the synagogue of Satan.”*** - (Revelation 2:9). Jesus repeats this point a second time: ***“Behold, I will make them of the synagogue of Satan, which say they are Jews, and are not, but do lie; behold, I will make them to come and worship before thy feet, and to know that I have loved thee.”*** -(Revelation 3:9).

This can only be a reference to an ethnic group that has co-opted the Jewish religion and culture. This people is identified as the Ashkenazi sect of Israel. Their king is Nathan Rothschild, of the House of Rothschild, which has been committed to the destruction of the Biblical “blood line” of the real Messiah, Jesus of Nazareth. The House of Rothschild is Satan worshippers. Their lineage comes from the Khazars in the region north of the Black Sea.

At America's economic height, when her citizens are enjoying themselves the most, when they have so much time on their hands that they can only make merry then go out to destroy each other as is happening now, she will be attacked by the Medes, Russia. And just when the Jews think they are living the high life, they will be attacked by Iran, the Persians, and probably in a simultaneous attack.

Daniel 5:30 – ***“That very night Belshazzar the Chaldean king was killed.”***

Daniel 5:31 – ***“And Darius the Mede received the kingdom, being about sixty-two years old.”***

Why did this happen? Daniel 5:2, 3, and 5:22, 23, tells us why.

Daniel 5:2 – ***“Belshazzar, when he tasted the wine, commanded that the vessels of gold and of silver that Nebuchadnezzar his father had taken out of the temple in Jerusalem be brought, that the king and his lords, his wives, and his concubines might drink from them.”***

Daniel 5:3 – ***“Then they brought in the golden vessels that had been taken out of the temple, the house of God in Jerusalem, and the king and his lords, his wives, and his concubines drank from them.”***

Daniel 5:22 – ***“And you his son, Belshazzar, have not humbled your heart, though you knew all this [that his power was given to him by YHVH, a lesson that his own father, Nebuchadnezzar, had learned the hard way, and most certainly Belshazzar had seen him learn it the hard way],”***

Daniel 5:23 – ***“but you have lifted up yourself against the Lord of heaven. And the vessels of his house have been brought in before you, and you and your lords, your wives, and your concubines have drunk wine from them. And you have praised the gods of silver and gold, of bronze, iron, wood, and stone, which do not see or hear or know, but the God in whose hand is your breath, and whose are all your ways, you have not honored.”***

The President of the United States, considered as one of the wealthiest men on earth, and the Prime Minister of Israel, both embody this attitude of Belshazzar! Israel is about to use God’s Temple objects for their own whoredom! Death happened to Belshazzar because of his mishandling of God’s holy objects of the Temple and it will happen to the Mother of Harlots, “Mystery Babylon” and the Daughter of Babylon and their leaders.

Belshazzar abused the Temple of God and defiled its holy objects. His destruction will be visited on Israel and America for what they are about to do building a Temple that will be not to God’s glory, but to their own!

The coming Temple to be built will not be from God, but from Zionist Chabad Judaism and Freemasonry. Many believe the Catholic Church will play a part in the building of the coming Temple as well, but let’s not forget that it isn’t merely the Catholic Church that wears the colors of the Great Whore. Those same colors come straight out of God’s instructions for the building of the Tabernacle and they are prominent in Judaism and, especially, the secular version of Judaism – Freemasonry and also in the Kabbalah!

Pearls and ivory are mentioned in the Revelation 18 list of goods being purchased by Mystery Babylon. These are not part of God’s instructions, but they will be part of something Mystery Babylon has in store for God’s Temple. Pearls are an item of immodesty, the kind of immodesty of a whore.

1st Timothy 2:9 – ***“...likewise also that women should adorn themselves in respectable apparel, with modesty and self-control, not with braided hair and gold or pearls or costly attire...”***

That’s the attire of whores. But look what the Whore of Revelation wears:

Revelation 17:4 – ***“The woman was arrayed in purple and scarlet, and adorned with gold and jewels and pearls, holding in her hand a golden cup full of abominations and the impurities of her sexual immorality.”***

I’m going to suggest to you that her golden cup is a reference to Belshazzar’s golden cups from the Temple. Her pearls are the announcement of her harlotry! Now, let’s take a look at the ivory.

1st Kings 10:18 – ***“The king also made a great ivory throne and overlaid it with the finest gold.”***

This was Solomon’s throne. His successor, the Antichrist from his line that the Zionist Chabad Lubavitch Jews will reveal as the Jewish [false] messiah, but who will be the Son of Perdition, is to be revealed and seated inside God’s Temple on this kind of throne where he will declare himself to be God! While the US and Israeli economies will be prospering, the rest of the nations will be starving. We know this from the weeping of the merchants of the earth who, apparently, will be in need her money and for whom the lack of her will mean destruction.

Revelation 18:11 - ***“And the merchants of the earth weep and mourn for her, since no one buys their cargo anymore...”***

The reason for the lack of her means their destruction is because other nations will not be exporting their products to this whore anymore. She will be gone! Utterly destroyed! The world has the conditions for this economic destruction arising right now. At a time when the global markets are now panicking and the central banking system is breaking down – something which the mainstream media is not telling you – don’t you think it’s just a little weird that Israel’s and America’s economies are running like a speeding train?

Let’s take a look at the global economy, then look at America’s and Israel’s beginning with what is happening to Deutsche Bank. This is the most important bank in all of Europe, it has \$49 trillion dollars in exposure to derivatives, and most of the largest “too big to fail banks” in the United States have very deep financial connections to this bank. The top eight major U.S. banks have more derivatives than their total book value of their actual assets. In other words, the global financial system simply cannot afford for Deutsche Bank to fail, and right now it is literally melting down right in front of our eyes.

This situation is occurring because of the burgeoning derivatives market that market that is trying to control 100's of trillions of dollars in debt!

We know that Deutsche Bank's derivative tentacles extend into most of the major Wall Street banks. ...The IMF concluded that Deutsche Bank posed a greater threat to global financial stability than any other bank as a result of these interconnections – and that was when its market capitalization was tens of billions of dollars larger than it is today. Deutsche Bank is a Rothschild Bank, and it is not out of the realm of possibility that the Rothschild's might let it fail intentionally. They did this with Lehman Brothers in 2008, another Rothschild bank!

The fundamental structural problems that were exposed during 2008 and 2009 were never fixed. In fact, many would argue that the global financial system is even more vulnerable today than it was back during that time. And now it appears that the next "Lehman Brothers moment" may be playing out right in front of our eyes.

Now, here's the surprise! The U.S. has been the beneficiary of Deutsche Bank's problems since 2007. It might be assumed that Wall Street's banks will fail when Deutsche Bank fails, but that is not what the pundits are predicting.

Deutsche Bank, whose assets plummeted from €2.2 trillion euros in 2007 to barely €1.3 trillion euros, lost the competition against the U.S. global financial corporations in the new conditions. Also, the magic money tree, a modern monetary theory that attacks austerity policies as damaging, has yielded heavenly fruits for U.S. banks and financial institutions, whereas their rivals on the other side of the Atlantic have had to make do with carry trade and a trickle of capital flows, according to ValdaiClub.com.

America is doing well even though the global economy especially that of Europe, is failing. Europe will fail because the black horse of Revelation 6 is the same as the black horse of Zechariah 6 which rides its economic disaster from Jerusalem to the north, to Europe, which is already experiencing high inflation and other economic problems.

According to KingWorldNews.com, at some point in the next few years the debt and asset bubbles will implode with dire consequences for the global economy and for most people on the planet. but according to the Bible, "most people on the planet" does not include America and Israel. KingWorldNews.com also says it will be the \$1.5 quadrillion derivatives market that will totally kill financial markets.

So, the world markets will suffer, and I might add, have been suffering for a while. The merchants of the earth will suffer unless they have Israel and America to buy their products. And for those nations of the world who are suffering economically, guess what will be the way they dig themselves out of their depression? War!

The war industry is big money. Always has been, always will be, and it is getting bigger. The other superpower on earth – Russia – will reach a point where constant economic struggle will no longer be tolerated. Russia will stop talking with Israel. Russia will stop talking with America. Russia will just form an alliance to go after and bomb the smithereens out of her! We can now see the components and elements of the conditions that must be present in the world to make Israel's and America's enemies come after them. The fact is the U.S. has been in an economic war with Russia for several years. What you have been paying at the gas pump tells you who is winning!

Now, let's briefly turn our attention to Europe and take a look at how it will fall. It all starts with Brexit, that New World Order agenda to break up the European Union so the New World Order can fix the world in a different way. The New World Order must break things so they can fix them again.

Global trade tensions, continued uncertainty and rising prospects for a no-deal Brexit are sapping the strength of the world economy, which faces a "precarious" 2020, the International Monetary Fund warned recently. Trade conflicts are undercutting investment and weakening manufacturing, and the IMF urged countries to avoid using tariffs to resolve their differences. President Trump is hated for his use of the tariffs as a way of disrupting or delaying of the New World Order. China is enraged by the Trump tariffs imposed at the beginning of August, 2019. China has expressed that a war with the U.S. is likely at this point. If President Trump doesn't want to set America up for military retaliation because of his economic sanctions globally, he needs to stop the practice without delay. My thoughts are that he will not do so and will turn the screws tighter, so as to provoke a war!

It was reported that Iran's Revolutionary Guards seized a third oil tanker on 8/4/2019, surely testing the resolve and will of the U.S. and NATO states in the Straits of Hormuz!

Vice Adm. Michael Gilday spoke on Wednesday, July 31st, 2019 during his confirmation hearing about ongoing efforts to ensure safe passage of commercial vessels through the Strait of Hormuz.

There have been multiple reports in recent months of Iran's Islamic Revolutionary Guard Corps (IRGC) harassing, attacking and seizing vessels transiting the strait, which have prompted responses from both the U.S. and Europe.

Gilday, who was confirmed to serve as the next chief of naval operations, said that the United States is working to build a coalition of nations dedicated to ensuring safety and freedom of navigation in the Strait of Hormuz. He stated that the United States' role will be providing intelligence support and escorting or assisting the few U.S. vessels that transit the Strait. The effort is called "Operational Sentinel."

The Strait of Hormuz is a narrow waterway, 21 nautical miles wide at its narrowest point that connects the Persian Gulf to the Gulf of Oman. The shipping lanes are a mere two nautical miles wide in either direction, with a two-mile buffer zone between them.

The Strait of Hormuz is the only sea route to transport cargo from the oil-rich countries of the Persian Gulf to the rest of the world. In 2018, more than 20 percent of the world’s oil passed through this relatively small gap between Iran and Oman. About 21 million barrels of oil pass through the Strait of Hormuz each day.

To transit the Strait, vessels pass through the territorial waters of both Oman and Iran. There is dispute regarding the type of transit rights that apply to the Strait under international law. However, under either possible rite of passage, merchant vessels are entitled to transit the strait absent some justification.

The United States has consistently stood for freedom of navigation on the world’s seas. One of the U.S. Navy’s first missions was defending U.S. commercial vessels in the Atlantic Ocean and the Mediterranean Sea from maritime threats. The War of 1812 was fought, in part, to defend U.S. rights to conduct commerce on the seas. President

Woodrow Wilson declared “absolute freedom of navigation upon the seas” as one of the goals of World War I.

In his statement on U.S. ocean policy, President Ronald Reagan declared that the United States would not “*acquiesce in unilateral acts of other states designed to restrict the rights and freedoms of the international community in navigation.*”

International law permits nations to defend themselves and each other in the event of an attack at sea. This authority provides for the use of proportionate force when necessary to protect U.S. or foreign vessels from unlawful violence.

Things become more complicated when the unlawful acts take place within the territorial waters of another nation. Coastal countries generally have jurisdiction and control over foreign vessels within their territorial waters and are also responsible for protection of vessels lawfully in those waters. Nonetheless, if that country is unable or unwilling to assist, international law authorizes the use of proportionate force to protect vessels within the territorial seas of other countries.

The U.S. Navy has been tasked with protecting vessels transiting the Strait of Hormuz in the past. The strait is a vital chokepoint, and the United States has vehemently defended the right of vessels of all nations to transit the Strait. The United States has maintained a presence in the Persian Gulf for decades to ensure freedom of navigation and security of oil supplies.

One of the more notable operations, “Operation Earnest Will”, involved U.S. Navy escort of Kuwaiti-owned tankers in the Strait of Hormuz in the 1980s during the Iran-Iraq war. Less formally, the United States has periodically provided escort or support to vessels transiting the Strait. Following Iran’s seizure of the Marshall Islands-flagged Maersk Tigris in 2015, the U.S. Navy accompanied U.S. flag vessels and some foreign vessels in the Strait of Hormuz for about a week.

Instead of simply providing escort or accompanying support for U.S. flag vessels and possibly foreign vessels by agreement, the United States is now proposing a coalition of nations in a maritime security initiative to ensure freedom of navigation in the Strait of Hormuz and stability of the international economy. The proposal involves U.S. Navy command vessels to lead surveillance efforts in the area and other nations to provide patrol boats and escort vessels through the strait. A number of countries have indicated an intent to take efforts to ensure freedom of navigation in the Strait of Hormuz, though it is yet unclear how each country will contribute and work together.

I mentioned a stunning new development that has occurred and bring the reader back to this event the last week of July, 2019. It has profound implications for all parties in the Middle East. It is a first for Israel!

Even though most Americans do not realize it, Israel and Iran are already shooting at each other. Israel has been striking Iranian military targets inside Syria for

months, but now the rules of engagement have apparently changed, because in recent days the IDF has started conducting airstrikes against Iranian targets inside Iraq.

In an unprecedented move, Israel has expanded its attacks on Iranian targets, with two bombing strikes on Iran-run bases in Iraq in the space of ten days. The Israeli Air Force carried out the military strikes with F-35 jets, according to Asharq Al-Awsat, an Arabic-language newspaper published in London. News of the attacks comes just a day after the US and Israel tested a missile defense system which used targets “similar to Iranian nuclear missiles”. The U.S./Israel successfully tested the new “Arrow” anti-missile system in Alaska last month in July, 2019.

The reason this is being called “an unprecedented move” is because this is the very first time since 1981 that we have seen Israeli airstrikes inside Iraq, and attacked in daylight for the first time as well. Needless to say, these latest airstrikes have absolutely enraged the Iranians. It looks like the Israeli government has determined that any Iranian military targets outside of Iran itself are fair game, and it is probably only a matter of time before Iran strikes back in a major way. Iran is facing severe economic pressure due to U.S. sanctions, yet recent reports indicate that the Islamic Republic is still investing significant resources in building up attack capabilities throughout the Middle East, with a new focus on Iraq.

Israeli stealth F-35 jets hit an Iranian rocket depot northeast of Baghdad on July 19, and on July 28, a base in Iraq that lies just 80 kilometers from the Iranian border in an airstrike. That base reportedly contained a shipment of Iranian ballistic missiles, as well as Iranian “advisers,” the report stated.

Iran’s apparent shift to Iraq comes after an intensive Iranian push in recent years to turn Syria into a missile, drone, and terrorist launchpad against Israel. That attempt ran into a brick wall, in the form of hundreds of Israeli airstrikes that largely prevented the rise of an Iranian war machine in Syria. Iran already established a forward division in Lebanon in the form of Hezbollah, and Israel has no intention of allowing Iran to replicate that success in Syria.

Iran appears to have responded to Israel’s intelligence superiority by repositioning itself in Iraq. If the latest reports are true, Israel is signaling that it is prepared to use the same effective combination of intelligence and precision firepower to thwart Iranian threats as they form in Iraq, just like it did in Syria. In addition, it seems that the shadow war between Tehran and Jerusalem in Syria is far from over. Last week, Israeli jets reportedly struck a target in southern Syria’s Tel al-Hara, apparently to stop Iranian-backed forces from seizing control of a strategically important hill that can be used to gather intelligence on Israel.

Israel’s “War Between Wars,” the low-profile campaign designed to stop Iran from setting up attack and weapons bases in Syria and beyond, seems to remain highly active. It is a direct response to Iran’s own intensive attempts to build up threats against

Israel, including the attempt to flood Syria with missile factories, rocket launchers, drone bases, and terror cells.

Iran has failed to achieve many of its central goals in Syria, so the Iranian Quds Force, led by the notorious Qassem Soleimani, looks determined to set up some of the missile bases on Iraqi soil instead.

From a practical perspective, Iran's commitment to expanding its forces around the region while its economy crumbles makes little sense. But Iran's fundamentalist Shi'ite ideology and hegemonic ambitions have fused to keep this effort going.

And if Iran ultimately decides that one of the best ways to strike back is to start hitting targets inside of Israel that could be the spark that sets off a major war in the Middle East.

In the quarterly update of its *'World Economic Outlook'*, ...the report sounded the alarm, saying things could easily go wrong. *"Global growth is sluggish and precarious, but it does not have to be this way, because some of this is self-inflicted,"* IMF chief economist Gita Gopinath told reporters. And here is the self-infliction referred to above:

"Dynamism in the global economy is being weighed down by prolonged policy uncertainty as trade tensions [sparked by Donald Trump] remain heightened despite the recent U.S.-China trade truce... and the prospects of a no-deal Brexit have increased," she said at a briefing in Santiago, Chile.

Trade tension between the U.S. and China, and the failing of Brexit are like falling dominoes. The US will come out on top in the China trade war. Europe, on the other hand, will suffer because of Brexit.

Can you see how these situations are setting up the conditions spelled out in Revelation 18 where Mystery Babylon continues as an economic power to the point that the world's merchants can't do business without her? This peculiar economic condition of the Mother will be the condition of the Daughter, as well, and as the condition of original Babylon was when it fell. Understanding the dynamics can be hard if one is not familiar with the global markets. President Trump's MAGA has disrupted the Global Plan; however, it will come back to bite the U.S. in spades!

The report further says ...the United States, which is at the center of most of the trade tensions, saw one of the rare upgrades in the report, as it got a short-term boost from strong economic growth in the early part of the year. Foreign investors have been putting their money into the U.S. stock market, and giving a misleading image about the stock market.

The U.S. is in the middle of all this global economic mess, receives an upgrade while Brexit is causing the fall of the European and British economies. U.S. economic growth is expected to slow to 1.9% in 2020, but America will still be strong enough to

import goods. The Bureau of Economic Analysis (BEA) has released the data for the second quarter of 2019. The Q2 GDP growth rate of 2.1% beat all economic expectations, and highlights strong consumer spending throughout the U.S. economy.

The two primary drags on the Q2 release are also the most volatile: Export/Import contributions (-.65%), and Inventory contributions (-.86%). However, consumer spending was much stronger than anticipated (+4.3%) showing the internal strength of the U.S. labor market and the impact of wage growth which still exceeds 3.6%.

The inflation index is still low at 1.5% year-over-year, and highlights a point all economic pundits overlook. With countries attempting to stop the impact of tariffs on their exports they are devaluing their currency (EU and China) and subsidizing their export industries (China). This has China livid! This has the cumulative effect of lowering their price. As a consequence, and with a strong dollar, the U.S. is importing deflation. The official inflation rate, however, is quite deceptive when you go to the supermarkets.

Wall Street wants bad news because Wall Street wants a lower fed rate. As a direct consequence Wall Street's multinational corporate media bias over the GDP data release is hilarious. The headline from NBC is typical: *"Economic Growth Slows Less Than Expected in Second Quarter"*. Sometimes you just have to laugh. When you boil it all down you see the same battle continues: Wall Street -vs- Main Street.

We are in the space of flux where President Trump's economic policy and trade reset is favoring Main Street blue-collar workers and companies.



Another way to look at it is where the multinationals (Wall St) are Globalists and fighting the economic Nationalists (Main Street). This really is the heart of the back-and-forth, and there are trillions at stake. Both time and history are on the side of the

Globalists. This is bigger than Donald J. Trump! Unless Trump delivers on a war with Iran, the Rothschild's are likely to derail the Trump Train on or about March of 2020! President Trump is running out of time regarding the stock market. It is roughly 15 months until the 2020 election, but that is far too long to avoid a financial crash, the likes of which have never happened before. The Fed announced a 25 basis point cut in interest rate on July 30, 2019, while under huge pressure by President Trump for most of July. President Trump is using this quarter of a percent drop in interest rates to keep the consumer train rolling on in order to get him re-elected. He was declared winner of the first and second Democratic debates, and should see an easy re-election in 2020. But don't hold your breath on that happening! Trump has to deliver soon on the Rothschild extortion, or face a number of punitive steps that will derail his re-election next year.

Technically the S&P index is finishing a long-term bearish wedge. As the chart above shows, the momentum indicator shows divergence with a price to pay. The last 4 higher tops in the S&P from January 2018 have been accompanied by lower momentum each time.

This action is extremely bearish and it is what happened at the 1999 and 2006 tops, with major collapses following. The difference this time is that we are most likely at the end of a secular bear market and the duration and magnitude of the coming fall will be massive.

How far down will this bear market go? In 1929-32, the Dow fell 90% and the global economic circumstances were nowhere near as bad as they are today. The market is likely to find support initially in the 8,000-10,000 area but may eventually reach the 600 to 1000 range (in real terms — vs. gold).

Right now the U.S. middle-class is driving the economy, hugely so. The problem is it cannot be sustained for any length of time. Meanwhile the investment class is trying to keep their old globalist process in place. Wall Street wants the U.S. to be a "service driven" economy. President Trump wants the U.S. to be a "balanced production" economy, with an expanding middle-class. Want to bet me who wins? Remember, the Globalist system is rigged to the benefit of the House of Rothschild. It has been that way for over 250-years! What others may say, the deck is stacked for the House....! What lies directly ahead will destroy President Trump's chances for an easy landslide victory! This is especially true if the cycle yields another October surprise, like October of 1929.

The Wall Street economy generates a wealth disparity; rich and poor with little room in the middle [a limited pie]. A Main Street economy closes the wealth gap by expanding the wealth of the middle-class through higher wages and opportunity [unlimited pie making].



Overall the 3.1% GDP growth in the first quarter and 2.1% GDP growth in the second quarter, puts us on track for typically stronger Q3 to generate a higher than 3.0% average.

All of the internals, measurable statistics centered on Main Street, are excellent. It is the externals, measurable stats centered on Wall Street multinational interests that are weak. This is exactly what we would expect to see as President Trump focuses on Main Street USA. It is not a coincidence that the U.S. and Japan are the world's two strongest economies as the dynamic of Globalists -vs- Nationalists continues. But it will not happen if President Trump decides not to play ball with the Rothschild's extortion concessions. They like their Jesuit masters do not take "NO" for an answer.

Always an excellent reliable barometer of the economy is rail freight shipments. The AAR (American Association of Railroads) has reported rail car shipments have been in retraction for the past 30 weeks. For the first 30 weeks of 2019, U.S. railroads reported cumulative volume of 7,549,879 carloads, down 3.2% from the same point last year; and 7,690,683 intermodal units, down 3.6% from last year. Total combined U.S. traffic for the first 30 weeks of 2019 was 15,513,354 carloads and intermodal units, a decrease of 3.4% compared to last year. As to the trucking industry, 4 regional trucking firms with 500+ or more drivers closed their doors abruptly during the last three months, all without warning or notice. These statistics are not reflected in the data being reported by the White House and Bureau of Labor Statistics. So the White House is lying or manipulating the data, or both, to deceive the American people into thinking things are good and reason for people to spend!

When I said I don't believe Trump has enough time between now and election time next year, I am aware of huge cuts coming; Lowes announced August 2nd, 2019 huge layoffs (as large as 30%) in the thousands in the near future. Lowes employs about 300,000 at 1,800 stores. American Greetings of Cleveland, OH recently closed a greeting card and gift wrapping printing plant that employed 500 employees recently amidst a corn field within a couple miles of where I live in Kentucky. Even the 164,000 new jobs reported for July, 2019 will likely be revised downward in a few weeks as virtually every month this year has been revised downward, these figures do not get headline coverage in the business media.

The European and global economies are on the brink of collapse, but Israel's and America's, the Mother's and the Daughters of Babylon, are booming. This is such a contrast that can only be explained by the Bible prophecies.

Let's return to the oil and wine before looking at the Israeli economy because I believe those oil and wine exports will be significant in the future for the wars that will destroy Israel and America. The other listed commodities in Revelation aside, I want to concentrate on the oil and wine because it was mentioned specifically in Revelation 6 as an important economic factor and that these are not to be destroyed.

The main exporters of olive oil and wine are Europe. Spain, Italy and Greece are the top three exporters of olive oil, according to WorldAtlas.com in August 2017. The top exporters of wine are France, Italy and Spain, according to WorldsTopExports.com.

What this means for the black horse riding north is that the exports of certain European nations of olive oil and wine will become almost the entire basis of their European economy.

Couple this with the fact that China is also failing but there are also two nations who are not failing and now you have a big reason for the economic wars to turn into military wars. Historically, economic wars ultimately spread to military confrontation.

China's woes will cause it to be part of the Russia-Iran-North Korea axis to militarily wipe out America, Israel and their allies. In fact, Trump's sanctions will be part of what harms Europe! After the JCPOA was signed, the European nations began exporting and importing goods to and from Iran. Trump will make good on his threat to cause those European exports and imports to cease for Iran which will in turn cause economic decline in Europe. In fact, this has already begun. Trump has alienated virtually every European Union member state.

What card does Trump have to play that is causing the European nations to kowtow to his economic demands? It is NATO! He has made it clear that he thinks America should pull out of NATO. NATO members have yet to come up with their share of the cost that NATO requires. Before Trump was elected, the U.S. footed the bill of NATO by 2/3rds of the total bill for NATO defense of Europe.

I don't believe for one minute that Trump actually ascribes to his NATO doctrine. What I do believe he is doing is setting it up to use a U.S. withdrawal from as a hammer to hang over the heads of the Europeans if they don't obey his economic edicts!

Although there are rumblings of a coming recession (the description of the Daughter of Babylon economy shows it standing strong. Here is what Bloomberg had to say about the Federal Reserve going global!

For all the anxiety about America's retreat from the world, a vital U.S. institution is becoming more global than ever. While the Federal Reserve's impulse to juice the

economy is laudable, it's worth asking whether this mission creep is sustainable; Or even desirable, over a long horizon. The most compelling reason Fed officials have put forward is concern about sluggish growth abroad, trade difficulties and references to business confidence... [is because] ...the dollars might make the Fed a global economic policeman. I raise this point in reflection, has there ever been any doubt that the U.S. rules the New World Order? I do not believe time is on the side of President Trump. I look for the House of Rothschild to derail the Trump train, if for any reason President Trump does not deliver Iran and Syria on a silver platter before the end of 2019.

A decline from the current level of the Dow at 27,000 to the 2nd support level would mean a 97% fall. That clearly seems impossible today but is not that much different from the 90% fall between 1929 and 1932.

So let me be absolutely clear. My interpretation of the U.S. stock market is that we are likely to see a major reversal of the long term trend begin as soon as August 2019 and at the latest in the next three months. The reversal could initially start gradually but will very soon turn into a crash. What we must remember is that wealth preservation means trying to protect your assets from total destruction rather than making high returns. Physical gold and silver is the best insurance you can own. If they go to the levels that we expect, you are also likely to achieve major capital appreciation but that is not the primary reason for holding precious metals.

Egon von Greyerz of KingWorldNews.com says, *"I would say that there is a 95% certainty that stock markets will crater this autumn and that gold and silver will reach much higher levels. The autumn of 2019 will see a major shift in sentiment as markets turn from a secular bull to a secular bear. We are likely to see major crashes in many global stock markets. Virtually no one is prepared for this so there will be both panic and despair."*

Egon von Greyerz has an excellent track record in predicting stock market moves and trends. His record is among the top experts. I trust him more than I do President Trump's hype on the stock market casinos. The imminent collapse of Germany's Deutsch Bank will have a huge impact on whether President Trump can kick this can down the road for the next 15 months. I see this as a remote possibility with a probability of little to none. Deutsch Bank fired 15,000 employees a few weeks ago in an effort to pair its losses. It comes down to a question of who do you trust, a President who over uses the word "great" for everything or a professional financial analyst with an impeccable track record?

Let's look at Israel for an overview in what is building. According to a July 18, 2019 'Forbes' Magazine article (Amir Mizroch): "Israel rises as an industrial technology power.... For a country that doesn't make cars, Israel has one of the world's hottest automotive technology industries, with globally recognized names like Mobileye (bought by Intel for \$15.3BN), WAZE (acquired by Google for \$966MN), Moovit (with over 480 million users), as well as up-and-coming companies like Argus and Innoviz. Almost

every single global carmaker has an innovation center and research and development facility in Israel to engage with the sector's +400 Israeli companies.

"Israel's on course of further growth" was the title of a September, 2018 report on Israel by Pitchbook, a Seattle-based global leader of financial and marketing assessment: "The private market ecosystem in Israel has been maturing rapidly over the past few years, underscored by several big deals and the emergence of a technology cluster known as the Silicon Wadi. Despite its relatively small size and a population of around 8.9 million, Israel has become one of the most technologically influential hubs in the world due, in part, to a young and well-educated workforce and a favorable entrepreneurial environment...."

"Israel has developed into a real draw for foreign investors. Its expertise in IT and cybersecurity, combined with its focus of healthcare-related trends, has been an integral part of building and maturing its evolving ecosystem. While there are undoubtedly headwinds ahead – be they geopolitical or stemming from a slowdown of the global economy – it is no stretch to see Israel's private markets overall growth trajectory continuing."

Foreign investors, eh? You mean like what the Bible calls ***"the 'merchants of the earth'?"***

It is difficult to separate the economies of Israel and America now, the Mother and the Daughter. They rely on each other now. They import and export each other's goods. Israel and America are connected spiritually, economically, historically, Biblically and every way one is able to think of them as well. Two sisters in one sense as the House of Judah and the House of Israel, but in another sense Mystery Babylon, the Mother of Harlots and the Daughter of Babylon. And they both use the nations of the earth, the merchants, to fulfill their desire to turn Jerusalem into the "great city" that will be notorious before God in the adulteries against Him. I described the uniqueness and peculiarity of the current global economy vs. the Israeli-U.S. economies. That the global economies should be failing so that they become totally dependent on the Israeli and U.S. economies for sales also lends itself to the ultimate implementation of the “Mark” of the Beast coming straight out of Judaism and Jerusalem. The people of the nations will be so desperate they will take the “Mark” to survive!

God gave His people instructions to get out of Babylon! The destruction that will happen to the Mother, Jerusalem, will happen to the Daughter, the United States. Vladimir Putin has been noted several times making a statement, that “*when you know your enemy is going to hit you, you hit him first.*” Rosh Hashanah is less than two months away, and Trump’s War on Iran was slated for late September, 2019. The rhetoric and tension continues to build and many factors are driving this agenda, including “Deep State” Democrats and others wanting a war with Russia. President Trump announced August 1st, 2019 an additional \$300 billion in tariffs on China. Economic wars are self-fulfilling in that more often than not they always lead to military conflict.

Iran acquired nuclear weapons as far back as the early 1990’s from the North Koreans. The quantity reported was between 10 and 20 nuclear missiles. I was stunned just a few days ago to learn from an interview with former CIA spy/Marine intelligence officer Robert David Steele and Dave of X22 Report, when he let out that Iran has 200 nuclear weapons. Until that moment, I have never seen or heard any informed reports other than the report Iran had purchased several nuclear weapons from North Korea. In that interview with Dave of the X22 Report interview with Robert David Steele, it was reported that Iran’s semi-official news agency has quoted an MP as saying that Iran intends to restart work on the Arak Heavy Water Reactor site, among to get it back to the state it was in before the P5+1 nuclear deal was reached.

Arak was intended to replace the Tehran Research Reactor (TRR), built by the US in the 1960s, as a source of medical isotopes. Western officials objected to the design, which was at the time still under construction, so under the P5+1 deal it was agreed the existing site would be scrapped in favor of a newer design.

This announcement is most alarming and an ominous move upon the part of the Muslim regime in Tehran, Iran. This will be keeping Israel's leaders up nights assessing their next moves.

The Arak, or IR-40 nuclear reactor is a Heavy Water nuclear reactor located in northeastern Iran. At its conception in 2003, Arak was intended to be a large-scale producer of Heavy Water for Iran. This was concerning because of Heavy Water's usefulness in producing and enriching weapons grade Plutonium.

Upon the completion of the P5+1 Joint Comprehensive Plan of Action, Arak was one of the facilities which required alteration in order for sanctions to be lifted. In 2016, Iran reported having filled in the core of the Arak facility, from which Plutonium would have been produced, with cement. This was a major step in the process of lifting the sanctions off of Iran. Despite filling in the reactor's core, there are still problems with the Arak plant under the Iran deal. In February of 2016, Iran exceeded its allowed limit of stockpiled Heavy Water for the first time. It exceeded the limit once again on November 9th of 2016. Iran has also transferred over 80 metric tons of Heavy Water, initially intended to be used at Arak, to Oman. Iran still controls these resources, but they do not violate the agreement because they are not within its borders.

The Arak nuclear facility has huge strategic implications. The Arak nuclear facility was initially concerning to the United States and its allies because it had the capability to produce weapons-grade Plutonium. Despite Iran's insistence that Arak was not intended to produce nuclear material for weapons, their failure to provide the IAEA with access to the plans for the facility called this into question. Arak, combined with the introduction of a spent fuel processing facility, would give Iran the propensity to create a Plutonium-based nuclear weapon. Plans for the Arak facility initially included a reprocessing site, but that was scrapped early on in the construction process. Iran is also prohibited from creating such a facility under the Iranian nuclear deal.

The other strategic implication of the Arak reactor is that it was intended as a model upon which Iran could base a much larger Heavy Water plant at Darkhovin, Iran. This plant, which is still under construction, would have nine times the power of the Arak nuclear facility. When you consider the points below, one has to ask is there an out to all of this depressing information. Trusting in POTUS 45 flies in the face of any human hope! It is my view that Trump is playing out a scripted hand prepared by his Zionist Masonic Jesuit handlers.

A [statement from the White House](#) reads:

Mr. Nahmani is a non-violent, first-time offender with no criminal history. He has five young children at home and his wife is suffering from terminal cancer. These extenuating circumstances underscore the urgency of his request for clemency.

Oh, that poor man! He has a family that is suffering without him, so the only humane thing to do is to set this criminal free and let him and his family go to Israel. There is no mention of all the people he harmed (and possibly killed) with his "non-violent" offense, and most articles out of the Jewish press only glance over his conviction in order to focus on his distressed family in Israel. The Jerusalem Post relays the following:

Ronen's three children, Ariella (11), Oriel (10) and Danielle (8), each wrote a letter to Trump requesting his presidential pardon. These include several distinguished senior Department of Justice Officials, numerous prosecutors and judges, and many reputable legal scholars. Among his supporters are former United States Attorneys General Edwin Meese and Michael Mukasey, former Solicitor General Seth Waxman, former Senator Orrin Hatch, Senators Marco Rubio and Rand Paul, Representatives Mark Meadows, Matt Gaetz, Anthony Brown, Bradley Schneider, Darren Soto, Debbie Wasserman Schultz, Eliot Engel, Frederica Wilson, Hakeem Jeffries, Lois Frankel, Ted Lieu, Tom McClintock, and many others.

The campaign to release the drug smuggling Israeli was organized by Moshe Morgatran, a New York Skver Chassid follower. Alan Dershowitz was also fighting for the release of the Orthodox Israeli, just as he fought for the release of meth kingpin, fraudster, and illegal alien employer Sholom Rubashkin. [The Jerusalem Post](#) writes:

Fighting for Nahmani’s sentence to be shortened were first-rate lawyers, including Alan Dershowitz and Gary Apple, who previously represented American Chabad member Sholom Rubashkin, who was also released from prison following Trump’s intervention. The president dismissed Rubashkin’s sentence in December 2017 and he was subsequently released from prison.

Dershowitz is quoted by *Hamodia* as saying that Trump should be praised for doing a *mitzah*.

This is a real case of pikuach nefesh (saving of life), because there are children here whose mother is seriously ill with cancer and whose father would have been in prison – and in the event the mother were to [pass away, they] would have been all alone. So what President Trump did was the right thing; he ought to be praised for saving lives and doing a mitzvah (commandment). This was a team effort involving lots of people, including Gary and many others who acted selflessly to bring about this pidyon shivuyim [redemption of captives].
